1 Introduction

To comply with data protection regulations such as the European General Data Protection Regulation (GDPR), all person-related data must be destroyed unless a legitimate purpose for processing or storing that data exists.

The majority of data in an SAP system is structured in database tables and can be managed with SAP Information Lifecycle Management (ILM). This data often has unstructured data attached to it, for example images, PDF documents or any other file type that can be stored in an SAP system. Once the retention period for the leading (structured) data object is over, these attachments must be destroyed together with the object they are linked to.

The central frameworks Generic Object Services (GOS), ArchiveLink (ARL), or Business Document Service (BDS) enable linking unstructured data to business objects (that is, BOR objects). The underlying framework of GOS and BDS is the Knowledge Provider (KPro) framework, which enables the connection to the Content Server infrastructure or to a storage location on the database.

The frameworks all use one or more central tables to store the links between BOR objects and the data file identifiers in the document storage system. Once table data defining the BOR object instance is destroyed, the link to the attachment file must be destroyed as well. In some cases, multiple BOR objects are linked to a single attachment. The attachment file itself must be destroyed as soon as no further links to any BOR object exist.

In section General Information: Destruction of Attachments [page 5] of this document, you get a general overview of how the destruction of attachments (GOS, ARL, BDS) is handled for ILM objects delivered by SAP. For nonstandard ILM objects that you created yourself, refer to section What to Consider with Customer ILM Objects [page 9] to get more information about how these objects can be enabled for attachment destruction.

For an overview of SAP Notes/ Support Packages with which the functionality is available, see section How To Enable the Destruction of Attachments [page 13].

i Note

The information given in this guide does not apply to Document Management System (DMS) documents that are archived with ILM object CV_DVS. These documents inherit the relevant ILM rules from the business object they are linked to.

2 General Information: Destruction of Attachments

Before data is destructed, in most cases it is archived and moved to an ILM Store. Archiving is typically performed on a regular basis to keep the database size at a manageable level. In addition, moving data to the archive restricts data processing. In case of personal data, this might be required to comply with data protection regulations.




Figure 1: Archiving of Business Partner Master Data with Attachments

The example in figure 1 shows the archiving process for business partner master data (BUS1006) that has attachments assigned. Its main data is stored in table BUT000 and can be archived using archiving object CA_BUPA . Archiving data from the SAP system is a two-step process: First, the data is written to an archive file in the ILM Store (black arrow). Secondly, the data is deleted (red arrow) from the relevant database tables (in this case BUT000).

Attachments are stored on the Content Server (orange database icon) and are connected to the relevant BOR objects via links. These links are stored in the respective tables of the attachment frameworks:

- For GOS: Table SRGBTBREL
- For ARL: Tables starting with TOA*
- For BDS: Tables starting with BDS CONN*

When data is being archived, the link entries remain in the link tables, although the leading data object was written to an archive file and deleted from the database. The same applies to the actual attachment files, which remain in the attachment store. The destruction of both the leading data object and its attachments is possible (and in case of personal data even mandatory) after the retention period is over.

Data destruction is typically performed in transaction <code>ILM_DESTRUCTION</code>. The following ways of destroying data are possible:

- Destruction of Archived Data [page 6]
- Destruction from the Database [page 7]
- Destruction of Attachments and Print Lists. This option refers to the destruction of ArchiveLink attachments referenced to ILM and will not be discussed in this documentation. For more information, see Destroying Data from an ILM Store.

2.1 Destruction of Archived Data

You can schedule the destruction of archive files by choosing *Archive Files (ADK)* from the selection criteria in transaction <code>ILM_DESTRUCTION</code>. For this, you must first define <code>ILM</code> policies and rules and set up a file storage in a certified <code>ILM</code> Store.

After the retention period has expired, archiving sessions can be collected in a destruction worklist. The processing of this worklist is called a destruction run (marked in red). During the destruction run, the BOR object instances contained in each archive file are identified by the ILM framework (see ILM Object-Specific Customizing for Link Identification [page 9]). The system identifies the links to the relevant attachments via the respective implementations of *BAdl: Clean Up Activity Before Deleting an Archive File* (BADI ILM PRE DESTR FILE ACTION) and deletes them from the link tables (light green arrow).

As soon as the last link to an attachment was destroyed, the ARL and BDS Frameworks automatically destroy the attachment file in the attachment storage. For GOS attachments, however, the periodical execution of cleanup report *Reorganization of Documents and Send Requests* (transaction RSBCS_REORG) is necessary to delete the orphaned attachment files and metadata.




Figure 2: Destruction of Attachments when Destroying Data from Archive Files

2.2 Destruction from the Database

From a technical point of view, ILM destruction reuses large parts of the archiving processes. Therefore, to destroy data without archiving it first, select the *Data Destruction* checkbox under *ILM Actions* in the Write program of the relevant archiving object.




Figure 3: Destruction of Attachments when Destroying Data from the Database

As shown in figure 3, a temporary archive file is created, which is deleted after the successful execution of the delete program. The destruction of attachments is performed via implementations of *Badl: Clean Up Activities Prior to Destroying a Data Object with Data Archiving* (BADI_ILM_PRE_DESTR_OBJ_ACTION) that exist for each of the attachment frameworks. The implementations are called during the execution of the delete program. The identification of BOR object types and keys (see ILM Object-Specific Customizing for Link Identification [page 9]) is the same as the one for destroying data from the archive.

2.3 Destruction Using ILM Destruction Objects/ Non-ILM Destruction Reports

The destruction of data from the archive or from the database is handled with SAP ILM. Whereas when using destruction objects, the destruction of attachments must be realized by calling the following methods or functions:

- For Generic Object Services attachments, call method DELETE AL ITEM of class CL GOS API.
- For ArchiveLink attachments, call function module ARCHIV DELETE META.
- For **Business Document Service** attachments, either call method DELETE of class CL_BDS_DOCUMENT_SET or function module BDS_BUSINESSDOCUMENT_DELETE.

3 What to Consider with Customer ILM Objects

The information given in section General Information: Destruction of Attachments [page 5] applies to SAP-delivered ILM objects. If you have created your own ILM objects, refer to the following sections to find out what additional actions are required to enable these objects for the destruction of attachments.

3.1 ILM Object-Specific Customizing for Link Identification

As discussed in General Information: Destruction of Attachments [page 5]., attachments are connected to their respective BOR objects via links. The regular archiving process is performed for table entries only though. Therefore, you must maintain the following Customizing settings to enable the destruction of attachments.

Let's have a look again at the example given in figure 1: The related BOR object instance (BOR type and key) must be determined. The (archived) table entries are analyzed generically by method GET BOR KEYS FROM DATA OBJECT of class CL ARC DAS ROUT ADK.




Figure 4: Defining the BOR Object Type and Key in ILM Customizing (IRM_CUST_BS)

In order for the relevant BOR objects to be identified, you must make the necessary Customizing settings in transaction <code>IRM_CUST_BS</code> (see Figure 4). Determine the BOR object type and the BOR object key. The key is created based on the source table and source field you specify, the field values are concatenated in the specified order to construct the BOR key.

In most cases, an ILM object is related to a single BOR object type. Multiple BOR object types are only supported, if their key definitions are identical. For more complex ILM objects related to multiple BOR object types and different or varying BOR key definitions, you must implement Badl method <code>GET_OBJECTS</code> of <code>BAdl: Determination</code> of <code>BOR Object Instance Key for Destroying Attachments (BADI_IRM_ATTACHMENTS)</code> must be implemented to construct the BOR key. The standard key determination is skipped as soon as the BAdl implementation provides the key definition.

For examples of such complex cases, refer to the BAdl implemementations created for the customer/vendor master data ILM objects (FI ACCPAYB) and the ILM object FI DOCUMNT.

3.2 GOS-Specific Requirements

3.2.1 Skipping the BOR Existence Check

The existence check is a nonmandatory method of a BOR object. It determines if a specific BOR instance exists on the database. If the method EXISTENCECHECK is not implemented in a BOR object, the existence check always returns the message *Object instance exists* (*sy-subrc* = 0).

For GOS attachments, this existence check is used to verify that the leading BOR object was successfully removed from the database. Consequently, the destruction of GOS attachments cannot be performed if the method is not implemented in the respective BOR object. In some cases, it is not possible to implement the existence check due to issues with certain workflows.

By implementing method SKIP_EXISTENCE_CHECK of *BAdl: Determination of BOR Object Instance Key for Destroying Attachments* (BADI_IRM_ATTACHMENTS), a flag is added to the list of BOR object instances found by the standard logic or by an implementation of Badl method GET_OBJECTS. For all flagged BOR object instances, the existence check used by the GOS framework during the destruction of the attachment links are skipped.

Make sure to implement the following SAP Notes to enable skipping of the BOR existence check:

3.2.2 Archiving Class SGOS

The archiving of GOS attachments together with their leading data object is possible by including archiving class sgos into the leading archiving object. In addition, the function module sgos_ARCHIVE_OBJECT must be called during the archive write report.

Although this solution is hardly used, it can simplify the handling of attachments during archiving and destruction. However, neither the ARL nor the BDS framework offer a similar archiving class. Therefore, making ILM object-specific customizing setting is still necessary to support the destruction of these attachment types.

3.3 ARL-Specific Requirements

3.3.1 Handling of ArchiveLink References to Attachments and Print Lists

The destruction of ARL attachments and print lists is one of the options in transaction <code>ILM_DESTRUCTION</code>. References to the leading BOR objects can be created, which can then inherit the retention rules from the leading object. The destruction of ARL link entries is skipped in case such a reference is found for a particular ARL link.

3.4 BDS-Specific Requirements

3.4.1 Other Types of Attachments in BDS

Apart from BOR objects, the BDS framework allows you to store other types of attachments. The type of leading entity is defined in the BDS link tables <code>BDS_CONNxx</code>: BO (BOR object), CL (Class type), or OT (other type).

Only leading entities of type BO are supported by ILM destruction, as described in General Information:

Destruction of Attachments [page 5]. The types CL and OT cannot easily be linked to a clearly defined leading object and therefore must be treated individually by the application. One way to achieve this is by implementing Badl: Clean Up Activities Before Deleting an Archive File (BADI_ILM_PRE_DESTR_FILE_ACTION) and Badl: Clean Up Activities Prior to Destroying a Data Object with Data

Archiving(BADI_ILM_PRE_DESTR_OBJ_ACTION).

A Appendix

A.1 Overview of Attachment Frameworks

Generic Object Services (GOS)




Figure 5: GOS Menu

In GOS, any file type can be attached. Files can only be added or deleted and are otherwise read-only. GOS also supports the creation of notes and URLs linked to the business object, as seen in figure 5. GOS documents can be archived together with the BOR object data using archiving class SGOS, however, this class is not widely used in standard ILM objects.

ArchiveLink (ARL)

ARL documents can also be accessed from the same menu as shown in figure 5, if the respective BOR object was configured in transaction OAD5. Select the option *Store Business Document* and *Enter Barcode* to store documents using ArchiveLink.

Business Document Service (BDS)

Like GOS, the BDS-Framework is based on the KPro Document Management Framework. BDS offers a richer functionality for documents, such as MS Office integration, versioning, and document variants.

A.2 Activity Diagrams: Destruction of Attachments

A.2.1 Destruction from the Archive

Generic Object Services (GOS)




Figure 6: ILM Destruction Run for GOS Attachments

As shown in figure 6, the destruction of attachments is performed in a two-step approach. For this, the two methods of *BAdl: Clean Up Activity Before Deleting an Archive File* (BADI_ILM_PRE_DESTR_FILE_ACTION) are used.

During the processing of the archiving files (ADK resources), BAdI method OPERATE_ON_DESTRUCTION is called to identify the BOR object instances. These instances are buffered in an internal table. The section colored in purple shows the determination of the BOR object instances derived from the settings made in ILM Customizing. Alternatively, the BOR keys can be determined by implementing *BAdI: Determination of BOR Object Instance Key for Destroying Attachments* (BADI IRM ATTACHMENTS).

ArchiveLink (ARL)




Figure 7: ILM Destruction Run for ArchiveLink Attachments

Figure 7 depicts the process for destroying ArchiveLink attachments. Again, standard ILM functionality is used to determine the BOR object instances. The difference to GOS is that attachment files are automatically removed from the Content Server once the last link is deleted.

The implementation for BDS documents is similar to the ARL implementation, therefore it will not be further explained at this point. The only difference is the handling of ILM references, which is specific to ARL. It skips the destruction as soon as a reference was found.

A.2.2 Destruction from the Database

Generic Object Services (GOS)




Figure 8: ILM Destruction from Database with GOS Attachments

Figure 8 shows the ILM destruction process for GOS attachments. It uses implementations of *BAdl: Clean Up Activities Prior to Destroying a Data Object with Data Archiving* (BADI_ILM_PRE_DESTR_OBJ_ACTION). Similar to the destruction during archiving, the BAdl method OPERATE_ON_DESTRUCTION first collects the BOR instances to be destroyed. After successful deletion of the leading data, the second method OPERATE_ON_FILE_DESTRUCTION is called to find and destroy the attachments links to the BOR objects gathered in the first step.

ArchiveLink (ARL)




Figure 9: ILM Destruction from Database with ARL Attachments

In figure 9, the ILM destruction run is shown for ARL attachments. The same similarities and differences to GOS and BDS attachments apply as for archive destruction.
