1.1 About this Document

This document contains the information on installing SAP Farm Management by Vistex on SAP S/4HANA 2022 system using Transaction SAINT. To be able to use these solutions, Customer must be on SAP S/4 HANA 2022.

1.2 Purpose

This Installation Guide provides a central starting point of the technical requirements for installation/upgrade and uninstall of SAP Farm Management by Vistex solutions.

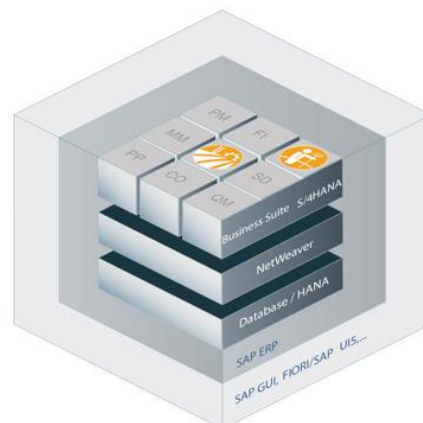
2 Product Overview

2.1.1 SAP Farm Management by Vistex

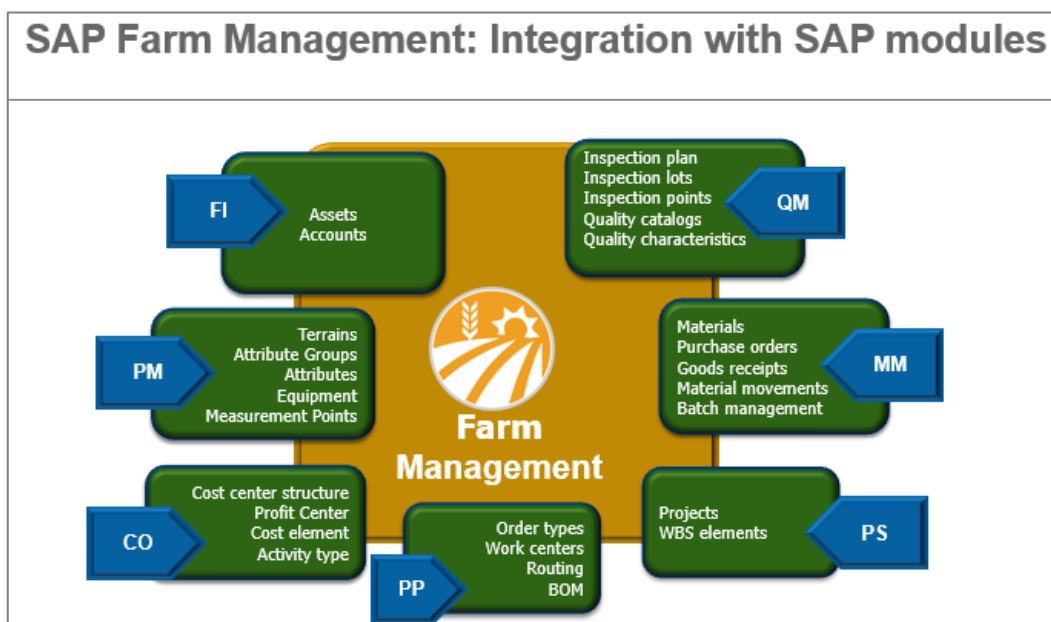

With a toolset that enables efficient day-to-day management, and meets the needs of top managers, SAP Farm Management by Vistex covers the crop life cycle, compliance, and harvest operations, and provides critical data and analytics. No agricultural software brings field and management closer together, enables operational efficiency as effectively, or provides as much business insight. Embedded in SAP ERP, SAP Farm Management by Vistex centralizes data execution from the many different agriculture processes and automatically generates controlling, quality, planning and maintenance information. Eliminating the ongoing challenge of costly and inconsistent data entry, SAP Farm Management by Vistex empowers management to set common goals and establish a shared vision through the interpretation of real-time synchronized data, while increasing end-user productivity.

FM - SAP Farm Management by Vistex

V4ABS - Agribusiness Solution Core Component (common to both FM and GM solutions)

V4ABSUI - Fiori UI Component (common to both FM and GM solutions)

3 Planning

3.1 Explanation of Vistex Licenses

Each Vistex add-on solution for SAP S/4HANA 2022 is licensed separately. The solution add-ons will be available from the [SAP Help Portal](#) download site according to the customer's licensing agreement. For missing solutions add-ons, please contact the customer's SAP account executive.

4 Solutions Overview

4.1 Vistex delivers the following add-on solutions for SAP S/4HANA 2022

- SAP Farm Management by Vistex
- SAP Grower Management for Perishables by Vistex (*)

4.2 Add-on components required for each solution

V4ABS and V4ABSUI are common add-ons required for either SAP Farm Management by Vistex. Additionally, at least one of the following add-ons for the FM solution are required depending on your license agreement.

If you have purchased a license for SAP Farm Management by Vistex, you need the common add-ons V4ABS and V4ABSUI, and then respective solution add-on specific to the solution licensed. V4AFM add-on is only for SAP Farm Management by Vistex.

Vistex Agribusiness Solution	Add-On Components Required
SAP Farm Management by Vistex	V4ABS, V4ABSUI V4AFM

The V4VUI add-on can be installed either on the SAP S/4HANA 2022 On-Premise back-end system for embedded scenario or on a separate SAP Gateway/Frontend server based on SAP_UI 7.57 with U5 libraries 1.102 level for central HUB Deployment scenario.

5 Preparation

Vistex license for V/4 2022 Solutions. Each V/4 2022 solution is licensed separately. The solution add-ons will be available from the SAP portal download site according to the customer's licensing agreement. For missing solutions add-ons, please contact the customer's SAP account executive.

You should install SAP Farm Management by Vistex for SAP S/4HANA 2022 into an SAP S/4HANA on-premise version 2022 system--or upgrade an existing V/4 1809/1909/2020/2021 versions to 2022 version.

5.1 Minimum requirements

The following minimums are required for running the Vistex V/4 2022 solutions:

The solution is developed for an SAP S/4 HANA 2022. You need to ensure that your system is exactly on the following release level:

S/4 system Minimum Requirements

SAP S4_CORE 107
S4_ABA 75H
SAP_BASIS 757

FIORI Minimum Requirements (if installed on S/4 server)

SAP_UI Version 7.57 & Minimum UI5 libraries 1.102

FIORI Minimum Requirements (if installed on standalone FIORI server)

Minimum SAP_UI Version 7.57, and Minimum UI5 libraries 1.102

5.2 Preparation for installing the solutions

5.2.1 Import the SPAM/SAINT update patch 75 or higher

Make sure that you have imported the SPAM/SAINT update patch level 75 or higher into your system. If the [SAP Help Portal](#) contains a newer version, carry out the new SPAM/SAINT update.

5.2.2 Import the latest R3trans and tp

Make sure that you have imported the latest R3trans and tp version into your system.

5.2.3 Notes that you should obtain before the installation

Add-ons: General conditions: 70228- Add-ons: Conditions and upgrade planning

5.2.4 Download the required Vistex Add-ons

Please refer to section "Solution Overview" that explains how to identify the required add-ons for your installation as licensed from SAP. The solution add-ons will be available for download in the software download center.

6 Installation

6.1 Important Considerations

The Vistex Add-on software can be installed simultaneously with the SAP S/4HANA 2022 software--or installed alone--using SAINT.

The components V4ABS and V4ABSUI are common to all licensed software solutions. The other software V4AFM (SAP Farm Management by Vistex) component is to be installed as authorized in the customer's license agreement.

6.2 Vistex Components Installation Process Flow

6.2.1 Unpack and Log-on

Unpack each downloaded Vistex add-on installation package into SAP transport directory, if needed.

Log on as user

<sid>adm on UNIX

<SID> OFR on AS/400

<SID>adm on Windows

- Switch to the directory of your SAP S/4HANA system (usually /usr/sap/trans/EPS). The directory is displayed after you execute the RSPFPAR report with input value of the profile parameter DIR_EPS_ROOT.
- Switch to the higher-level directory.
- Unpack the SAR archive files using the following statement:
SAPCAR -xvf<downloaded package SAR file with full path>
- The extracted PAT files should now be in the /IN directory. Please refer the section 4. "Solutions Overview" for PAT file name archived in the respective Package SAR file.

6.2.2 No Password Required

No password is required for Vistex add-ons installation

6.2.3 Install the Vistex Add-ons in SUM along with the SAP components

If you use HUB Deployment for front-end component V4ABSUI, do not install the V4ABSUI add-on on the S/4HANA 2022 On -Premise system.

6.2.4 Issues

Any known issues are documented in section "Problems Importing the Add-ons". If any other issue occurs, open an incident with SAP Support using component BC-UPG-ADDON.

6.3 Problems Importing the Add-ons

There are currently no known issues when installing the Vistex Add-ons. If an issue occurs, open an incident with SAP Support using component BC-UPG-ADDON.

6.3.1 Vistex Add-on Installation Packages

The Vistex Add-on installation packages are available at the software download web site [Software Downloads - SAP ONE Support Launchpad](#).

6.4 Vistex Components Installation Procedure

6.4.1 PAT files

Copy software PAT files to the SAP transport directory /usr/sap/trans/EPS/in (when the SAP Central Instance server is UNIX server) or Drive Letter: \usr\sap\trans\in (when the SAP Central Instance server runs on Microsoft Window OS).

6.4.2 Download

Download and install the latest "tp" and "R3trans" transport tools from [SAP Help Portal](#).

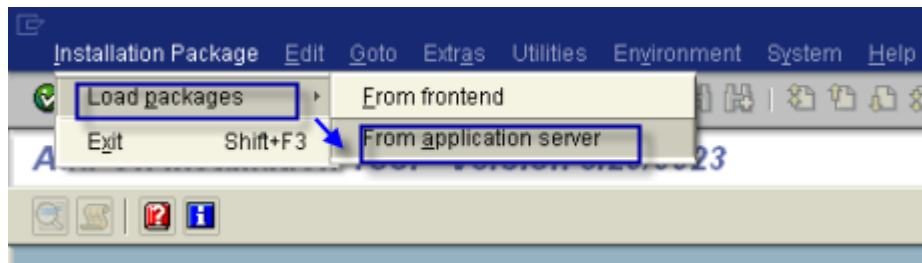
6.4.3 SPAM Version

Apply the latest SPAM version available at [SAP Help Portal](#).

6.4.4 Load Packages

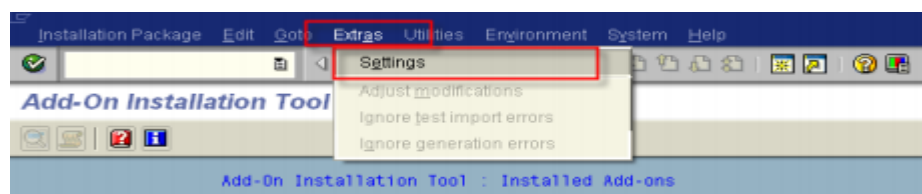
Load packages in SAINT:

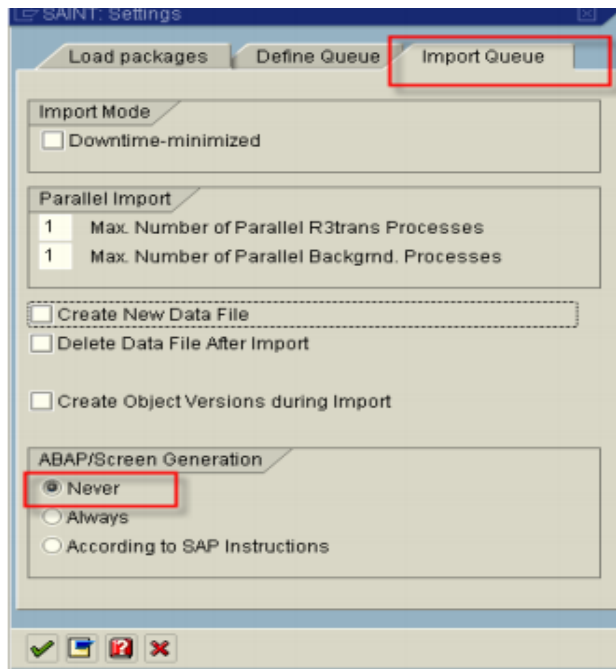
from the initial menu of SAINT in client 000, follow the menu path "Installation Package" --> "Load Packages" --> "From application server"



6.4.5 Settings

Verify settings in SAINT: from the initial menu of SAINT, follow the menu path "Extras" --> "Settings" and on the Import Tab, make sure the option "Never" is set for the "ABAP/Screen Generation" setting





6.4.6 Component installation

Install the V4ABS, V4AFM and V4ABSUI add-ons in single installation queue using SAINT transaction code in client 000 (i.e. combined installation of all Vistex add-ons).

6.4.7 Run SGEN

Once the installation is completed, run SGEN for the Vistex software components (e.g. V4ABS, V4AFM and V4ABSUI).

Note: The V4ABSUI package contains the Fiori UI and must be installed on the Gateway system. If the Gateway is not located on the same S/4 system, please install the V4ABSUI package separately in the Gateway system and adjust the instructions below accordingly.

6.5 Upgrade Process Flow to release 2022

6.5.1 For an Upgrade from 1809/1909/2020/2021 to 2022, use the following sequence:

Download the required Add-on packages according to the license(s) purchased from SAP.

For an upgrade from 1809/1909/2020/2021 to 2022, download the required Add-on packages according to what is already installed in the system.

Upgrade paths to Release ABS S/4 2022:

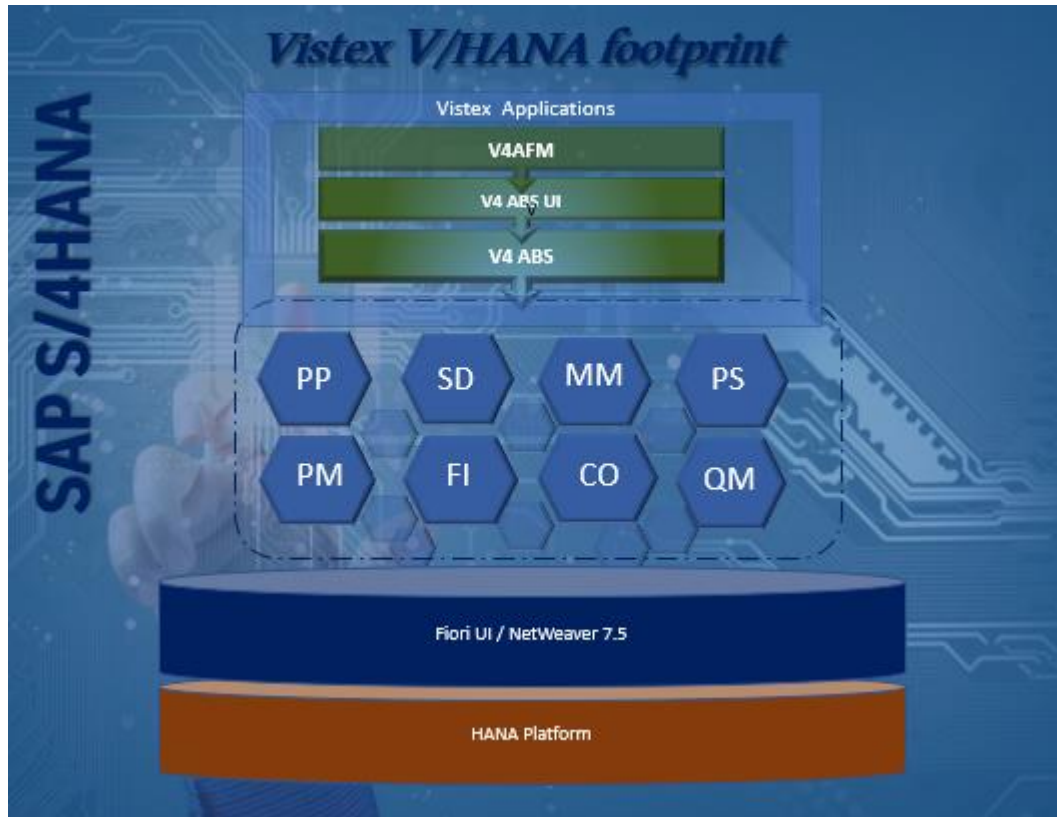
From ABS S/4 2021 (any support pack level) -> Upgrade from ABS S/4 2021 to ABS S/4 2022

From ABS S/4 2020 (any support pack level) -> Upgrade from ABS S/4 2020 to ABS S/4 2021

From ABS S/4 1909 (any support pack level) -> Upgrade from ABS S/4 1909 to ABS S/4 2020

From ABS S/4 1809 (any support pack level) -> Upgrade from ABS S/4 1809 to ABS S/4 1909
