Subsoil use contract

According to the Tax Code of Kazakhstan, if an organization performs mining activities, it is to calculate its profit and losses in terms of contracts and non-contract activities for the Profit Tax.

A new system object, subsoil use contract, has been added to the system. You can now create subsoil use contracts and customize their mapping with FI postings in FI-SL. This mapping is necessary to fill in contracts details in the profit tax declaration.

Data provider

New data providers were added to the system to fill the VAT Return and Import Tax Return forms using the XML Reporting Hierarchy generation program. The data provider is used for extracting the data for the forms and supplying it to the XML program for export to XML, viewing and printing.

The Import Tax Return data provider cannot fill Appendices 5-12. Only the main part, Appendices 1-4 and Appendix 13 are supported.

Multi-digit account numbers

According to current Russian legislation, banks are now to use multi-digit account numbers not only for operations involving their banking counter-agents, but also for internal accounting (e.g., material management or logistics) and non-banking operations.

Account numbers are generated along with a new memorial order for each position of a memorial order (one for debit and one for credit). The account number is made up from parts derived from the system data.

Account number parts are brought together using a template that is applied according to the rule for generating that account number.

The data for the account numbers is taken form constants, accounting document records, functional modules with predefined call parameters, static methods, or from a convertion table.

Memorial Order System

Memorial Order Creation

All bank accounting transactions that don't contain information about general ledger account offsetting are to be supported by memo orders with multi-digit accounts on debit and credit sides.

The accounting transactions can be different from business transactions, for example, two business transactions can be stored in one memo order (merge) or several memo orders might be created from one accounting document (split). Each memo order has to have the reference to the original document. You can customize which business transactions are supported by memorial orders.

When an accounting document is processed, a Memorial Order is created if the document applies to the set of rules defined in Customizing.

You can use to assign Standard text IDs with Memorial Order base text to appropriate document types and company codes.

When a memorial order is not created inside the standard procedure or needs to be manually re-generated, use the Memorial Order Generation report: SAP Menu -> Accounting -> Financial Accounting -> Banks -> Country Specifics -> Russia -> Memorial Orders -> Generate Memorial Order.

Memorial Order Approval

A memorial order that was already created but not checked by responsible employees yet is subject to approval.

The main step of the approval workflow is a dialogue step. The work item of this step will be found by the responsible

users in their own inbox of SAP Business Work Place. The Memorial Order can then Accepted, Rejected, otherwise the approval will be incomplete. This step may be performed sequentially by one of the assigned users or in parallel by more.

After approval, the new memorial order will have a collective approval status: either 'Approved' or 'Rejected'. If at least one approver rejected it, then it will be flagged is rejected and the FI document author will be notified by e-mail.

To set up the list of approvers and their order, go to SAP Menu -> Accounting -> Financial Accounting -> Banks -> Country Specifics -> Russia -> Memorial Orders -> Assign Memorial Order Approvers.

View and Print

The memorial order browser allows the user to display the memorial order database, work with consolidated memorial orders, and allow direct access to the following memorial order-related information:

- o Status icon with pop-up approver list in view.

Pair accounts

In accordance with Russian legislation all accounts are either active or passive. In practice that means that on a passive account there can be no debit balance at the end of the day and for an active account – no credit balance. However there are some operations for which both debit and credit balances are possible at the end of the day. For their accounting the Bank of Russia has segregated a group of accounts called "Paired Accounts".

If at the end of a banking day one of the pair accounts has balance opposite to its account criterion (for example, debit balance on credit account), such balance is transferred to the other account. In case of both accounts having balances, the balance is transferred to the right account (lower balance to higher balance and debit balance to active account, credit balance to passive account). This is done by running the SAP Menu -> Accounting -> Financial Accounting -> Banks -> Country Specifics -> Russia -> Pair Accounts -> Everyday Pair Account Balance Transfer report daily.

Account registration book

An account registration book contains all the data about multi-digit bank accounts. After maintaining the selection criteria on the selection screen, the user will be able to view the data for selected accounts in an ALV-grid output form. To run this report, go to SAP Menu -> Accounting -> Financial Accounting -> Banks -> Country Specifics -> Russia -> Account Profiles -> Account Registration Book.

Account profile browser

An account profile browser allows the user to view the account's properties, as well as opening balance and turnovers for a selected period of time.
