It continues to be interesting how much focus the Federal Government continues to place on the rail transportation of Bakken crude oil when so many other highly toxic and flammable chemicals and fuels pass through the nation's cities every day on railroads. **Under the threat of a \$175,000 daily penalty, the Dept. of Transportation now demands that crude oil shippers provide estimates of how much crude oil is moving each county weekly with updates on when those volumes change by 25%.** The intent is that information will be made available to first responders in the event there is a catastrophic train crash in their town. BNSF Railway said it is providing those reports but the State of North Dakota refuses to sign a confidentiality agreement. **That, of course, is a**

ND Land Board Sells Limbo Leases For \$5.7M

The ND Board of University and School Lands this month accepted an offer from Oasis Petroleum to buy Missouri River oil and gas leases in McKenzie and Williams counties for \$5.768 million, which had been in limbo since 2010 because of litigation over the Ordinary High Water Mark.

In addition to the \$8,000-an acre lease payment, the state also accepted Oasis' offer to pay a 20% royalty rate—higher than the 3/16th rate four years ago—an overriding royalty of 1.25%.

They cover acreage in sections 27 & 34, T153N-R102W for the Oasis Schmitz Federal 44-34H-2 well; sections 26 & 35, T153N-R102W for the Missouri 5302-44-35H well; and Sec. 29, T153N-R102W for the Aune 32-29H well.

The day-long celebration commemorating North Dakota reaching 1 million barrels of daily oil production kicks off at 10:30 am with an address from Gov. Jack Dalrymple and welcoming speeches from Ron Ness, president of the ND Petroleum Council, and geologist Kathy Neset.

Neset, who owns Neset Consulting Service, which is hosting the event at

ND Commission Revokes Drilling Two Well Permits

Emerald Oil Co. of Denver convinced the ND Industrial Commission May 27 to revoke two drilling permits for wells in Stark County that had been issued in January to Fidelity Exploration & Production Co., also based in Denver.

The commission noted that Emerald owned 52.5% of the working interest in the spacing unit in sections 26 & 35, T140N-R98W while Fidelity owned a lesser amount at 47.5%.

The law provides that majority ownership can be the deciding factor. "The Industrial Commission regulations provide that a presumption exists in favor of a party who owns a majority of the working interest, along or with the support of others," said Emerald attorney Larry L. Boschee.

The commission also noted that Fidelity has more experience than Emerald in drilling Bakken wells but both have the technical ability to drill the wells. However that information "did not overcome the presumption created by a majority ownership and support," Boschee said.

Permits for the Gilbert T Ridl #26-35H and the Rosalie J. Ridl #26-35H were revoked by the commission, allowing Emerald to apply for them.

State Land Commissioner Lance Gaebe said the board is not obligated to seek competitive bidding and recommended the board accept the Oasis offer. He pointed out the price paid for nearby tracts in 2010 was \$4,409 an acre and in May, 2014, it jumped to \$14,100 an acre.

Oasis said that because those lands—most under water at Lake Sakakawea—were not offered for leasing, it has been detrimental to the company not to have "protective leases" before spudding the three wells in the summer of 2010.

The state was waiting on the outcome of the Supreme Court decision, which ruled in its favor earlier this year that OHW was the proper boundary.

"Oasis, at an investment of over \$30 million, developed these three spacing units without the ability to nominate the unleased river portions," said Ken Beers, senior vice president of Oasis, "and without knowledge that the state was claiming an additional 720.99 net mineral acres in these spacing units, and has carried the substantial wells costs without an ability to nominate, lease or even bill a different lessee of the acreage for over four years."

Beers said that Oasis offer the overriding royalty because factual issues on the OHW relating to Garrison Dam and Hwy. 85 Bridge (Williston) have not yet been determined.

Oasis Tops MT Sale Bidding

Oasis Petroleum's high bid of \$1,500 an acre for a section in Roosevelt County accounted for the bulk of revenue from the small Montana state oil and gas lease sale June 3.

Houston-based Oasis paid a total of \$960,000 for 640 acres in Sec. 36, T28N-R58E while bonuses totaled \$1.3 million for leases on 7,840 acres in five counties, where the overall bid average was \$166 an acre.

The auction sponsored by the Montana Dept. of Natural Resources and Conservation saw the second highest bid in Richland County where Irish Oil & Gas, Inc. of Bismarck paid \$475/acre for 640 acres, totaling \$304,000 in Sec. 36, T27N-R53E.

The high bidder for the only tract in Fallon County was El Tigre Oil & Gas Inc., which paid \$26/acre for 640 acres in Sec. 16, T7N-R61E.

With only seven tracts in Lewis and Clark County, JP Furlong Co. of Charleston, IL paid \$5/acre for 480 acres in Sec. 26, T19N-R6W and \$4.25/acre for 320 acres in Sec. 23, T19N-R6W. The remaining bids ranged from \$1.50 to \$3.25 an acre.

Of the six tracts offer in Wheatland County, Furlong was also high bidder at \$7/acre for 640 acres in Sec. 26, T6N-R14E and for another 640 acres at the same price in Sec. 32, T6N-R14E.

The remaining bids ranging from \$3.25 to \$2.25 were posted by Herco, LLC.

Oasis Restoring Disposal Site Destroyed By Lightning

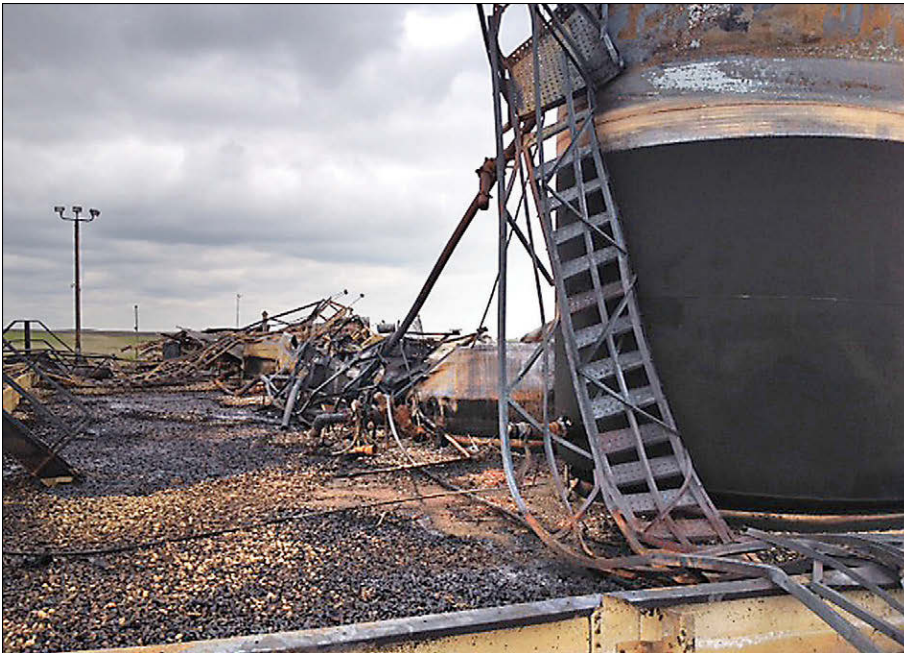
Oasis Petroleum continues to work on the restoration of a salt water disposal site in North Dakota's Williams County where a June 1 lightning strike demolished equipment and sent storage tanks careening into the air.

About 1,200 barrels of salt brine and one barrel of crude oil was splattered on to a nearby stubble field and a roadside ditch as fire and explosions destroyed all the tanks, pump house and pipelines on the Belle Salt Water Disposal well in Sec. 2, T155N-R104W.

Kris Roberts, a field inspector for the ND Dept. of Health, said no waterways were impacted and about 995 barrels of fluids were recovered.

Oasis has been doing field testing for salt contamination and other remediation included soil removal and building new dikes.

The company did not respond to numerous inquiries from the Hotline.



A June 1 lightning strike demolished this salt water disposal site owned by Oasis Petroleum 12 miles north of Williston, ND and sent tanks soaring into the air—one flew into a nearby stubble field and another was speared by a telephone pole.

ND Commission Seizes Oil Well

The ND Industrial Commission in late May moved to confiscate production equipment from a Williams County oil well after the operator failed to pay a \$75,000 fine.

The commission now has the option of selling the equipment and oil seized from Rio Petro Ltd. of Dallas, which failed to get approval for remedial work on the Sundhagen #1 well in Sec. 10, T158N-R96W.

The commission said the operator failed to increase its bond from \$20,000 to \$50,000 and did not report work details in response to three letters from the commission.

Administrative law Judge Rosellen M. Sand issued a default order in January after Rio Petro failed to show up at a hearing in Bismarck and did not hire an attorney to represent the company.

separate controversy that needs to be examined as well. In the meantime, all this government noise is becoming expensive. While most Williston Basin operators have cut long term deals on leasing or buying tanker cars, they are not immediately impacted by new rate increases. **The monthly rates for tank cars have gone from \$1,500 to \$2,000 a month.** As more of the newer cars come on line that are reinforced with more steel plating to resist punctures during collisions, they will also drive up shipper costs. **“Our oil marketing guys have said they expect the transition to be gradual and the eventual additional cost to us to be minimal—about 25 cents or a little more per barrel shipped,”** said J. Warren Henry, vice president of research and policy for Continental Resources. Another executive for a major producer told us confidentially the costs could be as much as \$1 a barrel more for shipping.

You will see in this issue that Continental is also pushing the envelope by applying for a US Commerce Dept. permit to ship crude oil overseas. The latest word from Washington is the Obama Administration is considering relaxing the ban on crude oil exports. **“We’re taking an active look at what the production looks like, particularly in the Eagle Ford in Texas and whether the current refinery capacity in the US can absorb the capacity increase to refine the product that is being produced,”** said John Podesta, a White House

Statoil's Effort To Reduce Flaring:

CNG In a Box

When it comes to reducing flaring, Statoil is thinking outside the box by putting "CNG in a box".

Earlier efforts involved stripping natural gas on location and feeding it into the diesel engines of drilling rigs. At that time when

Statoil was formerly known as Brigham Oil and Gas, the engines were bifuel models and could automatically switch back and forth between diesel fuel and natural gas.

Working with GE and Ferus, Statoil strips out LNGs such as butane and propane, which are injected into pressurized tanks and delivered by truck to North Dakota gas processing plants.

The remaining gas is compressed as "CNG in a box" and is later used to replace 40% of the diesel fuel. "We have calculated that if all the Bakken rigs were converted to run even partly on natural gas, roughly a fifth of the gas now being flared could be saved every day," said Lance Langford, vice president for Bakken development and production.

As new wells come on line, they often "overwhelm the existing system", forcing Statoil and other companies to flare.

"A mobile capture system is needed to go to where the flaring problem is today and then quickly move to where a new flaring problem develops tomorrow," Langford said.

SD Frac Sand Mine Proposed

With an investment of \$66 million, the owner of 950 acres in the Black Hills area of South Dakota hopes to have a frac sand mine up and running in two years.

Patric Galvin, owner of South Dakota Frac Sand in Denver, said once permits are approved by the Bureau of Land Management and Forest Service, he will be able to deliver frac sand for a price that is substantially less than the \$180 per ton price some operators pay now in the Williston Basin.

Once the project starts up seven miles west of Hill City in Pennington County, Galvin anticipates producing 1 million tons a year from the mine that would employ 150 people.

There are an estimated 350 million tons of frac sand deposits and perhaps as much as 700 million tons, he said. Semi-trucks can carry an estimated 40,000 pounds per load to delivery points in North Dakota and Colorado, he said.



Targa Resources is expanding its crude oil storage at the Enbridge Pipeline terminal in Stanley, ND. Targa bought the assets of Saddle Butte Pipeline in late 2012 that included at the time 155 miles of crude oil pipelines and 70,000 barrels of crude oil storage facilities.

NOV Buys ND Rental Generators

Industrial Rental LLC of Dickinson, ND has sold its fleet of rental generators to NOV Portable Power of Houston, which already provides diesel and natural gas generators. The sale price was not disclosed.

The newly acquired generators range in size from 52 kw to 420 kw.

"This timely acquisition of Industrial Rental's reliable and high-capacity generators allows NOV Portable Power to continue to consistently meet the high demand for generators in the Bakken Shale," said Norman Padalino, vice president for NOV.

NOV will be delivering generators from its two store locations in Ray and Dickinson, where there is also a full service facility for maintenance and overhauling.

Continental Pushes For Formal US Okay Of Crude Exports

Continental Resources, the largest operator in the Williston Basin, confirmed that it has applied for a permit with the US Commerce Dept. to export crude to foreign markets. US production has reached 8.2 million BOPD.

Steve Bradley, vice president of oil marketing for Continental, told a Texas conference recently, that since the Commerce Department has not denied the application, that is good news.

"For the government to sit on something is actually a positive sign," Bradley said, "Until they say no, we think we're in play."

Congress was urged earlier this year by Continental Resources CEO and Chairman Harold Hamm to lift the ban on crude oil exports, which he said would lower gasoline prices and improve energy security.

"Now we need to focus our efforts on doing away with the reactionary crude export ban and that was enacted during that era (the seventies), a ban that was largely symbolic in the first place, as we had no oil to export," Hamm told the House Committee on Foreign Affairs in March.

"Americans and consumers worldwide will all benefit from lower prices at the pump and lower home heating and cooling bills when oil and gas distribution channels become more efficient and competitive," Hamm said.

The US allows refined petroleum products to be exported.

Allowing crude oil to be exported would attract \$746 billion in investments between 2016 and 2030, according to a new study by IHS.

Statoil Sees 575,000 EUR For ND Wells

Statoil estimated it could recover 575,000 barrels of crude oil from each of the dozens of wells it is planning in Mountrail County on 23 overlapping 2560-acre spacing units.

The company estimated well costs at \$10.3 million and at a May 29 hearing before the ND Industrial Commission. It plans on drilling wells on or near section lines of existing 640-acre and 1280-acre units.

It also estimated the same recovery and well costs for 18 overlapping 2560-acre spacing units in Williams and McKenzie County.

In other business, Samson Resources asked the commission to approve a 1280-acre spacing unit in Divide County in sections 3 & 10, T162N-R98W and four overlapping 2560-acre spacing units in the same county.

Samson estimated drilling costs at \$6.5 million with an EUR of 373,400 barrels per well with a 23% return on investment and a net income of \$24.4 million.

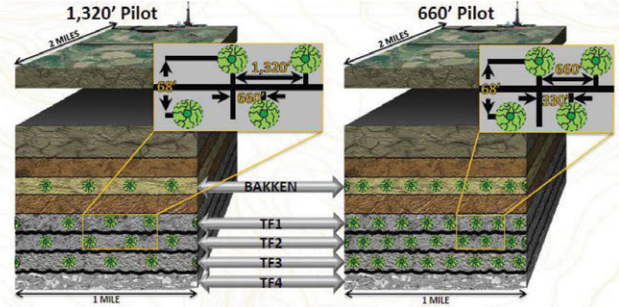

NATURAL GAS PRICES

New increases in natural gas inventories brought down pricing during trading at the New York Mercantile Exchange, where traders on June 10 paid \$4.59—down five cents—per mmbTU for July delivery.

The latest information from the US Energy Information Administration said that inventories increased by 119 Bcf for the week ending May 30, bringing up current inventories to 1,49 Bcf.

US Rig Count

The nationwide rig count on June 6 dropped six rigs for a total of 1,860 rigs, but was 95 more than were drilling at this same time last year, according to Baker Hughes.

There were 1,536 drilling for oil and 320 drilling for gas—down 6—while four were listed as miscellaneous in the latest tally.

In the last two weeks, North Dakota dropped five rigs and Wyoming went up three.

CRUDE OIL PRICES

Speculation that crude oil inventories are declining pushed prices higher during trading on the New York Mercantile Exchange June 10, where the price of West Texas Intermediate (WTI) crude for July delivery went up 32 cents to \$104.73 a barrel. Brent crude rose 10 cents to \$110.09 a barrel.

Bloomberg surveyed analysts who believe US crude supplies went down to about 388 million barrels, compared to 399.4 million April 25.

“Brent is bumping up against a ceiling of \$110 a barrel on the charts while West Texas has got room to move up to about \$105.25,” market trader Michael McCarthy told Bloomberg.

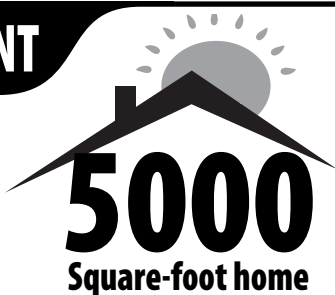

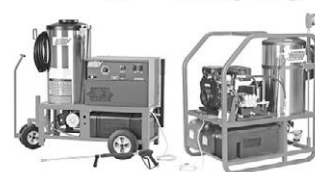

Nabors' Directors Ignore Shareholder Demands

Directors of Nabors Industries Ltd., the largest drilling contractor in the Williston Basin, turned down at its meeting June 4 a majority shareholder vote that rejected the three members of the board's compensation committee.

The board, instead refused to fire the three directors and expanded the board to eight members from the current seven, adding Dag Skattum, managing director of one thousand & one voices, a family-backed investment group.

The three directors who were targeted by the shareholders are: John Lombardi, John Yearwood and Michael Linn.

Nabors came under fire when shareholder-advisory firms objected to giving the Chairman and CEO Anthony Petrello a \$45 million compensation package in 2013.

Petrello ignored the shareholder votes and said the appointment of Skattum "reflects our ongoing commitment to adding qualified independent voices with diverse experience and backgrounds".

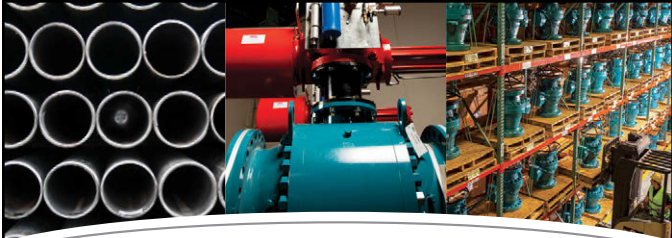

Three ND Waste Plants Seek Commission Approval

The ND Industrial Commission in late May was asked to approve three new waste oil treating facilities in three different counties.

Apollo Resources LLC is seeking a permit for an oil waste treating facility in Williams County in Sec. 9, T157N-R100W; Newalta Environmental Services wants to build a treating and recycling plant in McKenzie County in Sec. 20, T150N-R101W; and Dyad Corral Creek, LLC wants to build a treating and recycling facility in Dunn County In Sec. 19, T147N-R95W.

Corral Creek's proposed plant near Killdeer uses a ceramic treatment process to convert waste to a non-hazardous concrete like product that is poured into pre-cast forms for such products as jersey barriers, sound panels and crushed aggregate.

In addition, the company said that it can convert waste salt water to be refined as a road spray for dust control.

Newalta said it would install two 400-barrel tanks at its Alexander plant to receive incoming waste drilling mud and tank bottoms. Materials will be separated during processing and solids will be taken to an approved land fill.

Slawson Sees 600,000 Barrel EUR

Slawson Exploration Co. of Denver estimated it could recover as much as 600,000 barrels of oil from the Bakken on wells it is proposing at a cost of \$8.2 million each in Mountrail County under 2560-acre spacing.

In the same area, it also asked the ND Industrial Commission at a May 29 hearing for approval of 1280-acre spacing and estimated the ultimate recovery (EUR) would be 450,000 barrel with drilling and completion costs running \$5.2 million.

Three Forks, 2nd bench wells would have an EUR of 250,000 barrels under 1280-acre spacing, and under 2560-acre spacing the EUR was estimated at 375,000.

The middle Bakken wells would have a payout in 9 to 11 months with \$21.1 million undiscounted profit, while the Three Forks wells would have a payout in 25 to 36 months with an undiscounted profit ranging from \$6.8 million to \$11.2 million.

Slawson's request covered sections 8 & 9, T151N-R92W and sections 16, 17, 20 & 21, T151N-R92W. It would also cover Sec. 13, T152N-R92W, Sec. 18, T152N-R91W and sections 35 & 36, T151N-R92W.

CO Commission Holds June 17 Hearing in Rifle

Several producers including the Bill Barrett Corp. will seek approval from the Colorado Oil and Gas Commission for spacing and drilling orders in Weld County when it meets at 9 am, June 17 at the Rifle Branch Library, 207 East Ave., Rifle, CO.

Barrett wants to vacate existing 640-acre spacing and establish a 1280-acre spacing and drilling unit in sections 35 & 36, T5N-R62W.

Noble Energy, Inc. wants commission approval to allow 300-foot setbacks in Sec. 7, T9N-R58W, which has already been approved by the Bureau of Land Management. The commission in 2011 approved 160 Niobrara formation 640-acre drilling and spacing units.

In the same county, Encana Oil & Gas (USA) Inc. is seeking approval to pool all interests in the Codell formation of the Wattenberg Field in Sec. 4, T3N-R68W for the drilling of the Peppier Farms 1H-4H well.

In other business, Caerus Piceance LLC wants approval for three drilling units in Garfield County—560 acres in T7S-R96W; 70 acres in T7S-R96W; and 10 acres in T7S-R96W to drill the Island Ranch #11D-24 well in Sec. 24.

Ward Petroleum Corp is seeking approval of 640-acre spacing in Sec. 25, T1S-R67W in Adams County.

CO Commission Drafts New Tank Rules

The Colorado Oil and Gas Conservation Commission has issued new rules on the installation and operation of modular large volume tanks that hold 5,000 barrels or more of water after five catastrophic failures occurred between 2011 and 2013.

The tanks have been installed in oil and gas locations to reduce truck trips.

Under the new rules, the commission imposed strict guidelines on the use, liners, site preparation, testing of seams and leak inspection.

Operators are also required to have a contingency plan in place in case the tanks fail including methods to prevent injuries or property damage.

The regulations require them to be located at least 75 feet from a wellhead, heater or compressor and 50 feet from a separator, well test unit or other equipment.

\$150 Million Pipeline

Construction Starts In July

Construction will start in July on a \$150 million crude oil pipeline gathering system in Dunn County and be completed in late 2015.

The pipeline will be built by Tesoro Petroleum's subsidiary, High Plains Pipeline Co., and move 60,000 BOPD from various locations to existing Connolly Pipeline Station in the central part of the county.

In addition, the company has proposed crude oil gathering pipelines in Williams and McKenzie counties along with expansion of its Bakken Area Storage Hub holding tanks at the Ramberg station of up to 1 million barrels.

Construction is already underway on 360,000 barrels of storage capacity that will feed into the Enbridge Pipeline system as well as crude rail loading terminals at Berthold and Epping.

High Plains is proposing to move 70,000 BOPD from several field locations south of Lake Sakakawea, running north to its Ramberg station. An additional pipeline system of up to 90,000 BOPD will run from Ramberg to its station at Stampede in Burke County and be in service in the second half of 2015.

Crude Oil Train Car Fixes Targeted By Rail Firms

Greenbrier Companies and Watco Cos. formed a joint venture to retrofit and repair tanker cars that carry crude oil from the Williston Basin and other regions in the US.

About 14 of the 37 combined repair shops would focus on beefing up DOT-111 tanker cars to make them sturdier and more puncture proof.

Only light repairs will be done at the Watco facility in Dickinson, ND.

The new 50-50 joint venture will be called GBW Railcar Services and it anticipates revenues from this work will be \$325 million a year.

"We are getting in front of a general need for tank car fixes," said Greenbrier Chief Executive William Furman. "Working together, we will drive improvements in public safety while preserving the economic benefits of crude by rail and North American energy renaissance."

Most of the work will be done on DOT-111 tanker cars—about 68,000 are being used to transport crude oil nationwide.

Attention on these cars by the Federal Government stepped up following two explosions and fires involving crude oil unit trains in Canada and North Dakota last year.

Major producers such as Hess Corp. chose to buy new tank cars while others have leased unit trains to move Bakken crude.

At a May 29 hearing before the ND Industrial Commission, EOG asked for approval to drill the wells at a cost of \$9.6 million in the Clarks Creek-Bakken Pool on 1280-acre spacing in sections 30 & 31, T152N-R94W; 1440-acre spacing in sections 13, 24 & 25, T151N-R95W; 1920-acre spacing in sections 25 & 36, T152N-R95W and Sec. 1, T151N-R95W; and 2650-acre spacing in sections 6, 7, 18, 19, T151N-R94W.

EOG has already drilled six existing wells with an anticipated net income of \$271.6 million.

The company also asked for approval in McKenzie County of a 640-acre spacing unit in Sec. 4, T149N-R94W with an overlapping 90-acre spacing unit in Sec. 17 and N/2 of Sec. 20, T149N-R94W and an overlapping 2560-acre spacing unit in sections 9, 10, 15 & 16, T149N-R94W.

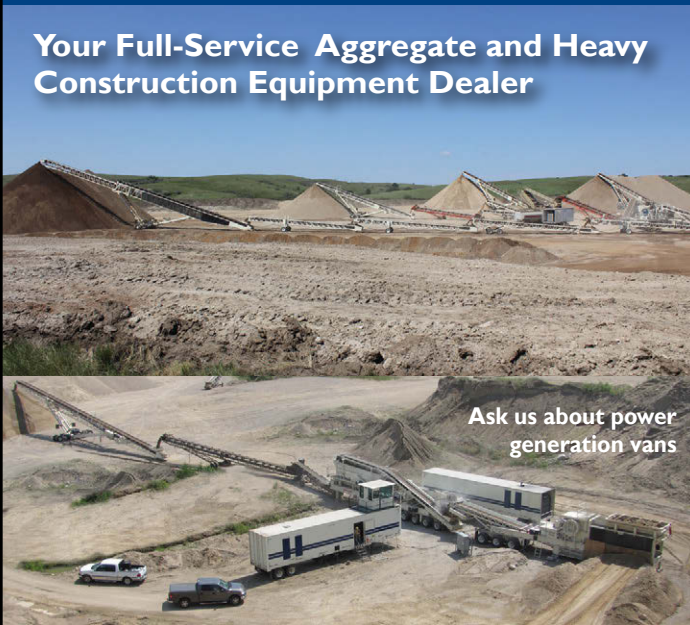

ND Pipeline Summit Set For June 24

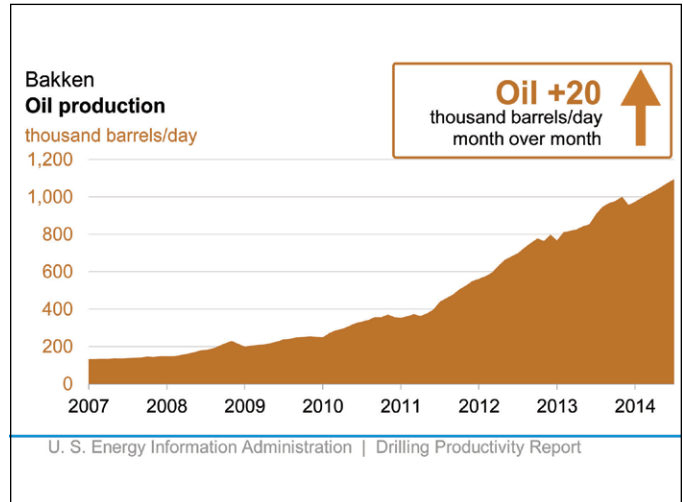
The latest trends in oil and gas pipeline development along with crude by rail issues will be discussed at the Governor's Pipeline Summit, June 24 at Bismarck State College in Bismarck, ND.

Gov. Jack Dalrymple will kick off the morning session at 8:40 am followed by several presentations from government and industry officials.

"Increasing North Dakota's pipeline capacity, both gathering lines within North Dakota and larger, interstate pipelines, is critical to meeting the needs of an energy industry that continues to produce greater supplies of high-quality oil and natural gas," Dalrymple said. "By bringing together pipeline companies and government officials at this summit, we continue to encourage the development of more pipelines to safely ship oil and natural gas to markets throughout the United States."

Justin Kringstad, director of the ND Pipeline Authority, will detail the latest development on major pipeline projects and the outlook for future infrastructure growth.

Several issues including right of way acquisitions and regulation compliance will also be addressed. Several industry executives will participate in a 10:35 am panel before the conference wraps up at noon.



The North Dakota Pipeline Authority said Bakken rail outflow capacity totaled 965,000 BOPD at the end of 2013, compared to 515,000 BOPPD of pipeline capacity. While some refineries are being built or planned for the area, most Bakken crude oil will continue to be moved out of the region to be processed at refineries in other parts of the country, according to the Energy Information Administration.

advisor. **Continental Resources Chairman Harold Hamm told a Congressional Committee earlier this year it would be a win-win for consumers if the export ban was lifted.** "Americans and consumers worldwide will all benefit from lower prices at the pump and lower home heating and cooling bills when oil and gas distribution channels become more efficient and competitive," he said. **So while the US lingers on lifting the ban, Canada is already cutting deals to start exporting its crude oil to foreign buyers because it has no limitation on shipping overseas.**

While excitement builds for the **June 25 celebration** at Tioga, North Dakota for commemorating daily oil production reaching 1 million barrels a day, it appears that it will not officially reach that mark when the ND Dept. of Mineral Resources issues its monthly production figures later this month. The figures are two months behind. So in May, the March production was at 977,051 BOPD so June's figures will reflect the April tally. **For sure, we know that North Dakota has exceeded the 1 million barrel mark, it just won't be official yet.** However, that is not slowing down plans for the celebration event where geologist Kathy Neset and the ND Petroleum Council will host a busy, fun-filled day with an air show, barbecue and speeches.

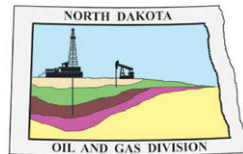

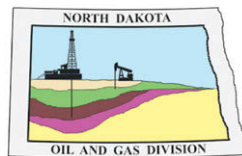
