MESSAGE FROM THE PRESIDENT

This past year was one of significant achievement for the Housatonic Community College Foundation (HCC Foundation) as we continue to support the goals of Housatonic Community College (HCC) and work to position it as a major educational and cultural force in the Greater Bridgeport area.

The HCC Foundation received a \$400,000 gift from the Allison Foundation in support of the Scholarship Program, and a gift of \$100,000 from the Klein Family Foundation in support of the Advanced Manufacturing Program – both exceptional contributions from first-time donors. The HCC Foundation also received nearly \$250,000 in new gift and grant funding from other sources in support of those programs as well as other HCC educational initiatives.

Those monies would not have been realized without the efforts of Christopher Carollo, Director of Institutional Advancement and Executive Director of the HCC Foundation, who secured this record-breaking funding and has worked to strengthen the Foundation's ties with the business community through the development of the Distinguished Citizen Award (see page 4).

And certainly, none of these accomplishments would have been made possible without the efforts of the HCC Foundation Board, which has grown to include highly talented individuals in recent years. Their vitality, ingenuity and steadfastness are at the core of our strength.

At this time, I would like to highlight some of their contributions. Kudos to Bob Mihalcik in his important role as Treasurer; to Ken Lisk for his work on creating a strategic plan for the future; to new Board Member Dan Wisneski for his efforts on the Marketing Committee; and to Christopher McCormack, for his solid support as Vice President.



All funds received in connection with a program are managed by the HCC Foundation on behalf of the College. The HCC Foundation supports funding for student scholarships, student emergencies, child care costs for parents enrolled, program enhancements and support of the Housatonic Museum of Art.

The HCC Foundation was established in 1990 when a dedicated group of citizens from the region joined together to raise funds to assist local students. Today, the HCC Foundation works in partnership with the College to bring a broad range of financial assistance to men and women from the Greater Bridgeport area who have the desire to learn and the determination to build a better life.

In addition to assisting students, funds raised by the Foundation help provide supplemental support to the College to meet needs including staff development and educational resources not covered by state funding.

The HCC Foundation also provides necessary funding for strategic initiatives and capital improvements that enhance HCC's ability to thrive as a quality academic institution, and serves to strengthen and expand community support for the educational, cultural and community programs the College offers.

News from the Executive Director

Over the past year, the HCC Foundation succeeded in accomplishing several major objectives. We secured large gifts from Fairfield County and other areas; added additional board members; brought greater awareness to the communities HCC serves by creating a new fundraising event; established two new Foundation committees – Marketing/Communications and Planned Giving; and developed a new Foundation website, <u>www.housatonic.edu/hccf.</u>

This fiscal year, approximately 56% of all pledged/ received donations represented new dollars to the College. Approximately \$700,000, which includes multi-year donations, was secured mainly through the efforts of Foundation Board Members and Administrators from the College. HCC received a gift of \$400,000 – the largest gift in its history, to be used for scholarships and financial assistance for full-time students taking a minimum of 12 credits.

In addition to cultivating important new donors, Institutional Advancement – in conjunction with the HCC Foundation – expanded its efforts this year to secure an increase in grant funding. Those efforts paid off. Whereas for the 2011-2012 fiscal year the Foundation submitted 13 grant applications and secured \$83,010 in funding, for the 2012-2013 fiscal year, we submitted 34 grant applications and secured \$263,250 – a 217% increase in funding. Additional grants submitted this year are still pending and could result in even more funds being generated.

Significant inroads also were made this year in strengthening the HCC Foundation's ties to the Greater Bridgeport business community and in further engaging business leaders in the Foundation's efforts. Last spring, a luncheon – sponsored by the Foundation – was created to introduce the Distinguished Citizen Award, which is presented to an individual who exemplifies the ideals of the College by having supported education, flourished within his or her profession, and shown a commitment to the community.

The first recipient of this award was Armando Goncalves, Market President of People's United Bank, who oversees the overall strategic direction for branches in both retail and business banking in Southern Connecticut. He was honored at the luncheon in HCC's Beacon Hall Event Center. Approximately 120 guests were in attendance to congratulate him on his achievement. In addition to his role at People's, Mr. Goncalves is highly involved in the Greater Bridgeport business community. He serves on numerous boards, provides his talents and time to many community organizations and projects including the Barnum Festival, and participates as an active member in several civic organizations. The event was sponsored by People's United Bank, First Niagara Bank, Pullman & Comley LLC and TD Bank.

In addition to attracting the business community to HCC's campus, the HCC Foundation works to connect with its alumni as potential mentors, ambassadors, donors and volunteers. This is facilitated through Institutional Advancement's Office of Alumni Relations (see page 13).



As we move forward in the 2013-2014 fiscal year, our goal is to continue our efforts to expand our financial resources, continue to bring new friends onto the HCC Foundation Board and involve the community at large in the efforts of the Foundation and the College.

SUPPORTING THE WORK OF THE FOUNDATION

There are many reasons to contribute to the HCC Foundation. Whether personal, business or civic in nature, the result is the same: all contributions support the work of the College in educating its students and in strengthening the economic and cultural integrity of the community it serves.

The HCC Foundation offers many options that provide you with flexibility in your contributions while also giving you the opportunity to increase your current income, secure additional retirement income and/or maximize tax advantages. Some of these options are listed below:

- A monetary contribution is, by far, the most popular way to make a donation to the HCC Foundation. We gratefully accept cash, checks, and charge cards including American Express, Visa, MasterCard and Discover.
- A Matching Gift program through your employer is an easy way to increase the value of your donation. Check with your Human Resources Department to see if your company participates in a Matching Gift program, or any other donation-based incentive program.
- Gifting Appreciated Securities can be an extremely advantageous way to give. Such gifts may eliminate your capital gains tax liability and provide income tax savings.
- IRAs are an excellent vehicle for charitable giving. Individuals over seventy and one-half years of age can distribute up to \$100,000 from an IRA directly to the HCC Foundation without incurring income tax on the assets (although the charitable deduction is not available). Individuals also can designate the HCC Foundation as the beneficiary of all or part of their IRA or other qualified plan upon their death.

- A Charitable Remainder Trust (CRT) is a taxadvantaged philanthropic strategy that allows you to direct your wealth in ways that reflect your charitable values and beliefs, while providing you with an income stream during your lifetime from the contributed assets (cash, securities, real estate or other property), as well as income tax benefits.
 After your death or a term of years, the assets in trust would either belong to the HCC Foundation, or the HCC Foundation could choose to continue receiving the income stream.
- A Charitable Lead Trust (CLT) is another type of tax-advantaged split interest charitable trust. The difference, however, is that the CLT directs the charitable interest *during your lifetime*, enabling you to enjoy seeing the benefits of your gift. That is, the HCC Foundation would receive the income stream generated by the trust during your lifetime, and after your death or a term of years, the remaining assets in the CLT – which will often have appreciated – will pass to your beneficiaries without further gift or estate taxes.
- A Planned Gift, which can be stipulated in your will, is an excellent way to contribute for those who appreciate the work of the HCC Foundation, but may be financially unable to contribute during their lifetime. Bequeathing personal assets through your will may be the most appropriate way for you to contribute.
- Life insurance plans will allow the HCC Foundation to be your beneficiary and all premiums are tax deductible. This is an excellent way to give a substantial gift with only a small amount of financial outlay. Annuities are also to be considered.

Before considering a contribution, it is best to consult with your financial advisor to determine which vehicle will work best for your individual financial situation. Once you know how you want to proceed, please make an appointment with the Foundation to discuss your plans. GIFTS AND GRANTS

Supporting Financial Goals

The HCC Foundation actively pursues financial gifts and grants from individuals, private and public foundations, and other organizations in an effort to meet the expanding needs of the College and its students. During the past year, the Foundation succeeded in securing funding from a number of organizations – including important new donors – to benefit HCC programs. This funding was largely due to the collaborative effort by Janet Zamparo, HCC Foundation's grant writer, and Andrea Macnow, HCC Grants Development Specialist, both of whom have done an excellent job in increasing the dollars raised by significantly increasing the number of grant applications to viable funders.

The HCC Foundation's Scholarship Program

The **Allison Foundation** of Westport made a firsttime donation of \$400,000 to establish a full-time scholarship fund for students attending Housatonic

The fund provides \$200,000 a year for two years for scholarships, stipends for academic success and emergency assistance for students in need.

The William H. Pitt Foundation, established by the late Stamford-based real estate entrepreneur and community leader William H. Pitt, has been a long-term supporter of the Scholarship Program. This year, the Pitt Foundation provided a generous grant of \$34,000. The Near and Far Aid Association, whose generosity to the Scholarship Program has spanned many years, committed to a grant of \$10,000. GE (General Electric) awarded a continued donation of \$10,000, and the Xerox Foundation granted \$4,000. These funds will help finance the education of students enrolled in HCC's many Associate Degree and Certificate programs.

The Regional Advanced Manufacturing Center

This year, the HCC Foundation was the recipient of a \$100,000 donation from the **Klein Family Foundation**. The donation will be used to build the College's manufacturing endowment and to fund scholarships for both new and current students enrolled either full-time or part-time

in HCC's Advanced Manufacturing Program. It also will

fund scholarships for students in HCC's engineering programs, which provide the education and credits they need to transfer to Bachelor's Degree programs in engineering at four-year academic institutions. This donation will be awarded in sums of \$20,000 a year for five years.

The Foundation also received a donation of \$10,000 from an **Anonymous Donor** to support scholarships for students enrolled in the Advanced Manufacturing Program. **Bank of America** awarded a grant of \$5,000 to help support the part-time position of the Academic Associate, who will maintain the labs or classrooms, storage rooms and equipment, and provide assistance to the Director and faculty for the operation of the Manufacturing Center and lab.

Smart investing@your library Initiative

The Financial Industry Regulatory Authority (FINRA) Investor Education Foundation and the American Library Association (ALA) have granted \$100,000 to the Housatonic Community College Library as part of the "Smart investing@your library" initiative. The HCC Community College Library and the Bridgeport Public Library will work together and with other partners during the 2013-2014 fiscal year to help young Bridgeport residents acquire the knowledge and skills essential for sound financial decision-making before, during and after college. Among other topics, the instructional sequence will encompass banking basics, introduction to credit, how to pay for college and maintain financial aid, introduction to investing and how to avoid financial fraud.

Housatonic Community College Bridges Program

Developed several years ago, HCC's *Bridges* Program is an Achieving the Dream Initiative designed to forge strong partnerships with area high schools in an effort to close the gap between high school preparation and college expectations and to help students make a seamless transition from high school to college.

This year, the HCC Foundation was notified that it would be in receipt of a grant of \$20,000 from **Citibank** to support the *Bridges* Program in six high schools that met the requirement of having 50% or greater of their student bodies receiving free or discounted lunch. Those schools are Ansonia High School; Bridgeport's Bassick, Bullard-Havens Vocational, Central and Harding High Schools; and Derby High School. **People's United Community Foundation** awarded \$7,000 to help fund an Assistant Coordinator's position to help facilitate this cooperative program.

The Early Childhood Laboratory School

HCC's Early Childhood Laboratory School (ECLS) provides quality early care and educational programs for children of HCC students, faculty and staff as well as for the Bridgeport community. The ECLS also serves as a laboratory setting and observation site for students and teachers studying in the field of early childhood care and education.

This past year, **The Bridgeport Public Education Fund** awarded the school a \$960 First Book Grant to facilitate the purchase of books for children's home libraries. The school also received a **Mohammad Ali Center Peace Garden Grant** valued at \$500 from the National Gardening Association. The grant included a \$100 check and a gardening package valued at \$400 that included raised gardening beds, tools and curriculum. It was awarded to the ECLS because the school recognizes "the important role the environment plays on the lives of students, teachers and the community."

THE REGIONAL ADVANCED MANUFACTURING CENTER

"We believe there can be a manufacturing renaissance in this country," Gene Perling – Director of the National **Economic Council and a point person for President** Obama said recently - "if we are smart."

Over the years, HCC has maintained long-term relationships with several local manufacturers, developing credit and non-credit courses to meet their specific business and/or industry needs for the education or retraining of their workforce. HCC's efforts have helped those employers to sustain their operations and take advantage of emerging trends and commercial opportunities in the global market.

During the 2011-2012 academic year, HCC was advised it would receive significant funding from the State of Connecticut to open a Regional Advanced Manufacturing Center and offer an Advanced Manufacturing Program. The state funding was designated to support construction and equipment purchases for the Center. This was an important opportunity for the College to further distinguish itself as an institution having a longterm impact on the economic viability of the Greater Bridgeport region.

HCC's Regional Advanced Manufacturing Center opened in the fall of 2012 with an enhanced manufacturing laboratory equipped with state-of-theart precision equipment and an impressive engineering design studio offering students the opportunity to develop and execute manufacturing projects from concept to reality. Additional state funding will also support construction and equipment purchases for the second phase of the project - the addition of a welding lab that will officially open in the fall of 2014.

Many of the students who participated in the 2013 program are in internships now and some have already been offered positions pending their completion of the program and graduation. Currently, there are openings for approximately 750 manufacturing jobs in the Bridgeport and New Haven areas.

HCC's Advanced Regional Manufacturing Center is not only enabling HCC to establish itself further as a valuable resource for employees and employers in the manufacturing industry, but the important role it is playing in strengthening the regional economy has attracted monetary support from significant new donors, such as the Klein Family Foundation, which gifted \$100,000 to the Center this year. In addition, an Anonymous Donor gave \$10,000 and Bank of America granted \$5,000. (Please see Gifts and Grants on page 10.)



Under the auspices of Institutional Advancement, the Office of Alumni Relations is committed to developing lifelong relationships between HCC and its alumni by working to cultivate and encourage alumni as leaders, volunteers, advocates and donors for the College.

An excellent example of a successful alumni relationship is that of Kevin Russo. Kevin is the Supervisory Assistant State's Attorney for the State of Connecticut, and is Chief Administrative Assistant for all criminal matters within the Judicial District of Ansonia/Milford. He is also an adjunct professor at HCC, teaching Microeconomic and Macroeconomic Theory and Application.

Last November, Kevin was inducted into the HCC Alumni Hall of Fame in recognition of his professional achievements and community service. He has agreed to join the HCC Foundation Board and take on the role of Chair for the Alumni Committee - a subcommittee of the Board's Resource Development Committee. The Alumni Committee was formed to help the Foundation further identify, reconnect with and engage alumni. His commitment to HCC is greatly appreciated.

Each semester, the HCC Foundation awards scholarships to a wide range of students in recognition of their outstanding academic performance and/or their financial need. Scholarships often make a major difference in the lives of the recipients - sometimes determining whether or not the student can enroll at HCC, or if already enrolled, complete his or her course work and graduate.

Many scholarship recipients graduate with Associate Degrees or Certificates and enter rewarding careers in the workforce. Others transfer their credits and continue their education at prestigious four-year colleges and universities including Yale, NYU, Johns Hopkins, Columbia, Smith, Wesleyan, Fairfield, and the University of Connecticut, to name a few.

Throughout the past, scholarship grants from generous individuals, organizations and foundations have helped support the HCC Foundation's efforts to provide a wide range of scholarship opportunities to deserving students.

One such couple is Marianne and Bob Laska. Marianne, an alumna and HCC Foundation Board Member, has been working with Institutional Advancement and the HCC Foundation for the last eleven years. She has devoted considerable time and energy developing both awareness building events and fundraising events for the Foundation, including numerous

wine tastings, a fashion show, the HCC 40th Anniversary Party and the Alumni Hall of Fame Gala. These events have netted significant funding for the HCC Foundation's Scholarship Program.

Marianne and Bob also created the Mercy Learning Center "Mother's Advantage Scholarship." The Mercy Learning Center - whose motto is "Educate a woman, educate a family" - serves low-income, Bridgeport-area women who are mothers, and provides them with basic literacy and life skills training. The "Mothers Advantage Scholarship" is awarded annually to a graduate of the Center who is a mother and who attends HCC.

Scholarships for Incoming Students

Allison Foundation Scholarship Fund – Provides scholarships to be used for tuition, fees and book purchases for students attending HCC academic programs which lead to a degree or certificate. Full-time recipients of scholarships from the Fund are eligible for a stipend of \$250 for a GPA of 2.5 – 2.9, \$400 for a GPA of 3.0 – 3.5 and \$500 for a GPA of 3.6 or higher, at the end of the fall and spring semesters. This stipend may be used for any purpose so designated by the student.

Klein Family Foundation Fund – Awards full/partial scholarships to be used for tuition and fees for students attending HCC to obtain a certificate in Manufacturing and/or a degree in Engineering.

Karen D. Torres Memorial Scholarship Fund – Provides scholarships to be used for tuition and fees for students registered in Allied Science program, Nursing, Occupational and/or Physical Therapy.

Richard E. Parent Memorial Scholarship Fund – Provides scholarships to be used for tuition, fees and book purchases for students who are registered for a Chemistry course. The scholarship was established in memory of HCC Chemistry Professor, Richard E. Parent.

Pay It Forward Scholarship Fund – This student scholarship, established in 2010, is funded 100% by students to assist current or incoming students who demonstrate financial need, are in good academic standing and are not receiving financial aid.

William H. Pitt Foundation Scholarship Fund – Awarded to full-time Housatonic students who are in good academic standing with a GPA of 2.3 or better and who are not receiving financial aid. Students are not required to have nine credits for this particular scholarship.

MUSEUM HOUSATONIC MUSEUM OF ART

The Housatonic Museum of Art (HMA) is home to one of the premier community college art collections in the United States. Its collection offers students and the community alike the opportunity to view works that span the history of art from the ancient to the contemporary. This permanent collection is on continuous display throughout the 300,000 square foot facility, offering a rare opportunity for both art enthusiasts and casual observers to view and interact with the art on a daily basis.

The Museum serves as a rich cultural resource for the Greater Bridgeport area, presenting lectures, programs and changing exhibitions in the Burt Chernow Galleries for viewing by HCC students and the community at large. More than 10,000 people visited the Museum last year to enjoy a series of exhibitions including the following:

- Paper Trail: 15th Anniversary Celebration of the Burt Chernow Galleries, Curated by Maura Brennan
- Reimagining the Distaff Toolkit, Curated by Rickie Solinger
- The Art of Business: Collectors Press Lithographs, Curated by Maura Brennan
- Gil Scullion: UP ALL NIGHT, Curated by Robbin Zella
- Eye of the Storm, Curated by D. Dominick Lombardi
- POEMobile, HMA and City Lore poetry event in partnership with Bridgeport's ARTSFest

In addition, two small shows were on view in the Community Gallery in Beacon Hall. The first show featured artwork by third graders from six Bridgeport elementary schools who had participated in a modified version of the Werth Family Foundation Peer Docent Program. (See more on the Peer Docent Program below.) The show was based on the Last year, seventh and eighth graders from Bridgeport's St. students' interpretation of works in the HMA's permanent Raphael School and St. Augustine School participated in collection and was funded through grants from the Annie the program, which focused on the Reimagining the Distaff E. Casey Foundation and the Rotary Club of Bridgeport. Toolkit exhibit and works from the Museum's permanent The second exhibit featured posters created for the collection. Bridgeport Arts and Cultural Council "Heroes" Campaign by award-winning graphic designer Greg Chinn of Fairfield. Funding from the Werth Family Foundation and the This exhibit highlighted the contributions of inventors, Fairfield County Community Foundation supported the scientists and industrialists, among others. With works by Warhol, Wesselman, Christo and Jeanne-Claude, Yoko Ono, Rodin and Picasso in its trust, it is imperative the HMA maintain the highest levels of conservation. Last July, the Museum completed a **Conservation Assessment Program (CAP)** – funded by the Institute for Museum and Library Services – to determine what Museum staff could do to improve the care, storage and environment of the collection. Based on CAP recommendations, improvements to the air handling system were made to stabilize the gallery environment, and preliminary design work began for the installation of additional painting racks and shelving to safely store framed objects. Museum staff also completed the inventory, cataloging and photographing of the entire paper collection.

The Museum has a long history of outreach to the community. Last academic year – in partnership with HCC's Continuing Education Department – the HMA developed an Arts Handling Certificate Program that was conducted as a weekend workshop in December. The program was developed in conjunction with Brent Powell, Chair of the Preparation, Art Handling and Collections Care Information Network (PACCIN), a committee of the American Association of Museums (AAM). The program includes both fundamentals and advanced training in short but intensive programs designed to introduce the principles of art handling to those new to the field, as well as strengthening and building the skills of experienced art technicians. The first workshop was extremely successful with attendees from California, Canada and throughout New England. The workshop was offered again in May, and will run for a third time in September.

None of these efforts would be possible without the strong support of HMA funders. Recently, the Museum received \$70,000 as the second of three installments (totaling \$210,000) from the **Werth Family Foundation**. The funds will help support the Museum's on-going conservation programs and special exhibits, as well as the Arts Handling Certificate Program and the Werth Family Foundation Peer Docent Program – a highly successful after-school enrichment program that introduces students to art and art history, teaching them how to look at art critically, and ultimately providing them with an opportunity to develop visual and analytical skills that will assist them in all areas of learning throughout their lifetimes. Funding from the **Werth Family Foundation** and the **Fairfield County Community Foundation** supported the *The Art of Business: Collectors Press Lithographs* exhibit. In addition, grants of \$3,750 each through the **Department of Economic and Community Development's Office of Culture and Tourism** and from an anonymous donor enabled the HMA to bring City Lore's *POEMobile* to Bridgeport to participate in Arts Fest this past July.



Up All Night, curated by Robbin Zella, HMA Director, was inspired by the sleep disorders that the artist, Gil Scullion, has wrestled with for several years. This theme evolved through the recognition of insomnia's intriguing formal relationships, especially its foundation as a presence defined by an absence: insomnia is the absence of sleep, which is itself the absence of consciousness.
