# Social ills need church intervention - Modukanele

**PALAPYE** – The world is faced with a myriad of challenges that need the intervention of churches.

Speaking at the Seventh Day Adventist Northern Camp in Palapye on Tuesday, Assistant Minister of Local Government and Rural Development, Mr Sethabelo Modukanele said individuals, the nation and the entire world were faced with trials and tribulations that called for people to seek solutions from God.

Mr Modukanele, who is also the MP for Lerala/Maunatlala, cited senseless and gruesome murders, mostly affecting women and shockingly young innocent children, skyrocketing divorce rates, delinquent children associated with alcohol and drug abuse as well as indulgence of high performing substances, among others, as challenges that bedevilled the nation.

Therefore, he said it was paramount to introspect and find the right path.

On the theme: How Far From

Home, Modukanele noted that it called for every believer and Motswana to do self-introspection and ask themselves what kind of Botswana they wished to live in.

He said the question would help come up with solutions for a myriad of situations that the nation was grappling with, adding it was therefore appropriate that the theme begs for reflection and introspection.

He said as participants pondered the theme, they should turn to the church for comfort. Minister Modukanele said he trusted that the church would help guide the nation back to the right path as well as restoring hope and tolerance. "I want to believe the church is still around and capable of restoration. However, this does not refer to the physical structures of the church, we are referring to the congregants for we are the ones afflicted by these social challenges," he said.

As for the role of the church and alignment to the national vision pillar number two on Human and Social Development, he said faith was the foundation upon which society built its moral and ethical

standards for social development and cohesion.

He said through the Vision 2036 Botswana aspired to be morally upright and tolerant of one another irrespective of gender, age, location, religion or creed, ethnic origin, sex, disability, language and political opinion.

He said freedom of worship would continue to be guaranteed to promote tolerance, peace and cohesion across all sections of the society.

He shared that the principle of Botho would continue to be an anchor that guided the nation.

He appreciated faith-based organisations for playing a significant role in shaping the morality of society, adding that churches contributed significantly to raising leaders who were morally upright, citing educational structures of SDA church.

He lauded the church for its contribution to the health sector through health facilities in Kanye and Gaborone.

He said he was also aware of the church's contribution in the

education sector through pre-schools, primary and secondary schools across the country.

Furthermore, he said another SDA primary school would soon be opened in Maun.

He advised congregants that

their biblical waiting would be in vain if their time was not filled with labour, adding there was need to multiply the resources that God had placed in people's hands, invest talents and money in God's course. **BOPA**

## Ambassador hails Botswana, US relations

**FRANCISTOWN** - Botswana's long standing relationship with United States of America is underpinned by the two nations' commitment to democracy, human rights, and the rule of law.

This was said by US Ambassador to Botswana Mr Howard Van Vranken at a meet and greet session with journalists in Francistown on Monday.

"There is also a strong military relationship, with the US providing training and assistance to the Botswana Defence Force," he said.

Also, Mr Van Vranken stated, the US had collaborated with Botswana on public health initiatives such as HIV/AIDS prevention and treatment.

He noted that US had also worked with Botswana to combat cross-border crimes.

Ambassador Van Vranken said this done through training and support to law enforcement agencies in Botswana to help them better detect and investigate such crimes.

"These crimes include human trafficking, drug trafficking and wildlife trafficking and poaching," he told journalists.

The two nations according to the US Ambassador also share intelligence.

He disclosed that these efforts were having a positive impact in the fight against cross-border crime.

Concerning the press, Mr Van Vranken said although a lot of progress had been achieved towards press freedom, the

local media could learn a lot from the vibrant US media and be impactful. **BOPA**

## Mokhawa assumes United Nations role

**GABORONE** - Botswana's newly appointed Ambassador and Permanent Representative to the United Nations, Dr Gladys Mokhawa on Tuesday presented her credentials to United Nations secretary general, Mr António Guterres, in New York.

Ambassador Mokhawa, who is the country's first female Ambassador and Permanent Representative to the United Nations in New York, takes over from Ambassador Collen Kelapile following her appointment by President Dr Mokgweetsi Masisi, earlier this month.

A press release from the Ministry of Foreign Affairs states that Ambassador Mokhawa has a wealth of experience in international relations, diplomacy and public policy fields.

She joined the Ministry of Foreign Affairs in 2020 and was appointed as the ministry's first female permanent secretary in 2021.

As the executive head of the ministry, Ambassador Mokhawa was a key driver in advancing Botswana's national interests on the bilateral, regional and multilateral platforms.

Prior to joining the Ministry of Foreign Affairs, Dr Mokhawa worked extensively in academia and among her various roles, she headed the department of political and administrative studies at the University of Botswana. She is also widely published.

As Botswana's Ambassador and Permanent Representative to the UN, Dr Mokhawa is positioned to promote the country's interests at the UN, as well as, strengthen relations with two countries that the mission is concurrently accredited to, namely, Jamaica and Cuba.

Botswana's Mission to the UN is one of the country's oldest diplomatic missions having been established in 1966. **BOPA**

## Morwaeng assures constituents of development projects

**MOLEPOLOLE** - Numerous development projects have been earmarked for Molepolole South, area MP Mr Kabo Morwaeng has said.

Responding to concerns raised by the residents in Gamodubu and Mmanoko during kgotla meetings on Wednesday, Mr Morwaeng said amongst the projects to be undertaken was construction of the road connecting Gamodubu to the Gaborone-Molepolole road.

He said the 3-kilometre stretch had been allocated P5.6 million.

MP Morwaeng, who is also the Minister for State President, said he made a decision to develop roads in his area from the constituency fund.

Previously, each ward shared the

P10 million annual fund resulting with incomplete roads and the minister said it was important to have completed roads rather than having incomplete patches all over the constituency.

In addition, the pavement connecting Mmanoko to the A12 road would also be extended to the kgotla and the primary school.

Also in the pipeline is development of the 22-kilometre Molepolole internal roads.

Mr Morwaeng said the contractors undertaking these projects would be required to employ locals, especially for semi-skilled or unskilled jobs.

He disclosed that upgrading of the kgotla shelter at the Molepolole main kgotla was complete.

He said the P600 000 project

as well as construction of the P26 million kgotla offices were implemented as a result of his efforts. Mr Morwaeng said the Gamononyane-Molepolole water project was expected to be completed in September.

He explained that the project schedule was extended as it was affected by high steel prices due to the Ukraine/Russian conflict.

He pledged to help develop the local kgotla shelters.

Some residents complained about the slow allocation of residential plots in their areas, which however was explained to be due to the reluctance of ploughing fields' owners to cede them to the land board.

Others decried the high crime rate. In Gamodubu, where it was explained that currently there

was one police officer after the other was transferred but never replaced, the residents requested more law enforcement officers.

Mmanoko residents complained that they had to rely on the police in Molepolole, which was far hence it took a long time to get assistance.

They also talked about unavailability of medications in clinics, which compelled them to travel to Scottish Livingstone Hospital in Molepolole.

Ms Patience Kago of the District Health Management Team (DHMT) said nurses had stopped dispensing drugs as they said it was not their duty.

There are 64 health facilities in Kweneng district, while there are only nine pharmacy technicians, hence the challenge. **BOPA**

# PulaThebe building opens

**GABORONE** - President Dr Mokgweetsi Masisi has hailed the re-development of Bank of Botswana (BoB) headquarters building, saying its symbolic and iconic features are linked to the national development aspirations as espoused in National Vision 2036 and set out in the Reset Agenda.

The President was speaking at the official opening of the BoB PulaThebe building in Gaborone yesterday. He noted that the central bank's location within the government enclave clearly projected it as an important complementary institution in national governance and policy-making.

"Its work is deliberately in alignment with the Reset Agenda, and the 'A Re Chencheng' initiative in the quest of Botswana ultimately transitioning from an upper-middle income to a high income status. Indeed, an important dimension of this economic transformation is technological adaptation and digitalisation," he said.

On this note, President Masisi said the building was in alignment with transition to a knowledge-based economy and what transpires with respect to SmartBots, adding that it was pleasing that the bank also had a digital BoB 2024 initiative. The initiative, he said, translated into transformation of working arrangements, platforms and approaches to interaction with the public and delivery of the bank's mandate. Further, President Masisi said the bank was in the process of deploying resources to enable preparedness for any transition to the issuance of digital fiat money and central bank digital currency as and when necessary.

"The continuing relevance and impact of Bank of Botswana requires addressing modernisation of related legislation as well as governance and institutional arrangements, thus the necessary reforms have been undertaken very meticulously," he said.

He said at the apex of the reforms was the recent promulgation of the Bank of Botswana (Amendment) Act, 2022 through whose mandate of domestic price and financial stability aimed to establish a statutory Monetary Policy Committee with four out of nine members being external independent experts.

Dr Masisi further said the Act aimed to establish a statutory Financial Stability Council for

the effective coordination and collaboration of all financial sector regulators in addressing any potential systemic financial sector instability as well as set up a Deposit Insurance Scheme to compensate.

"Viewed holistically, the re-enactment of the Act was aimed at aligning the central bank with evolving global, regional and domestic financial regulatory developments," he said.

Such reforms, he said were to strengthen the financial sector's capacity to mobilise and deploy resources sustainably and ensure continuing compliance with international norms and standards for a sound, stable and healthy financial sector in a vibrant and rapidly transforming economy.

BoB Governor Mr Moses Pelaelo said the PulaThebe project was quoted to the value of P850 million with a lifespan of over 50 years and was completed within schedule with no cost overrun.

Mr Pelaelo said the project created over 5 000 jobs during its construction with youth as the majority of those employed.

Part of the building, he said, consisted of very impressive aesthetic elements, which were envisioned and designed by local curators and artists. Mr Pelaelo noted that over 160 local artists were supported by Bank of Botswana Art Programme since its inception while an art and crafts collection of over 300 pieces was procured from local artists.

He thus commended BoB for its contribution to the re-invigoration of the creative industry and assisting the country in fulfilling the post-pandemic cultural renaissance. **BOPA**

## Commercial courts in offing

**FRANCISTOWN** - The Administration of Justice is in the process of establishing commercial courts that will deal with tender disputes cases only.

The envisaged commercial courts are expected to speed up the disposal of tender dispute cases in Botswana.

Responding to comments by some members of the local authorities in a one-day meeting to introduce the development manager model in Francistown on Monday, the Minister of Transport and Public Works, Mr Eric Molale explained that the establishment

of such courts was necessitated by the fact that there was too much litigation on such disputes which stalled developments.

He said the courts would be efficient and cost-effective with a focus on resolving disputes quickly and fairly.

The leadership had complained that some court cases on tender disputes took long to be resolved.

Also, local authorities' top brass suggested that the government should consider introducing toll gates as a cost-recovery measure.

Mr Molale said tolling was provided for in the law and that the government was awaiting completion of the drafting of the

toll-gates regulations.

However, the minister said toll gates must be complimented with alternative routes, stating that the government had already identified certain roads in the country that would be used as alternative routes.

Minister Molale also informed the leadership that P570 million had been set aside for community constituency projects in the 61 constituencies.

He stated that government had taken a decision to augment the figure with another P570 million from road levy, adding that the money would only be used to pave internal roads under the labour-intensive public works.

"All major roads are maintained by central government including the Kenneth Nkhwa interchange in Francistown," he informed them.

Okavango District Council Chairperson, Mr Gaopalelwe Ronald said the development manager model would help in ensuring that the projects met regulatory requirements.

He decried the slow maintenance of government facilities such as health posts and clinics, noting that some of them were in a dilapidated state. Mr Ronald suggested that government put more emphasis on the decentralisation of powers to local authorities to fast-track service delivery.

In his welcome remarks, the Mayor of Francistown, Mr Godisang Radisigo, raised concern about the number of fatal road accidents along the A3 highway.

On the introduction of toll gates, he said they would help recover costs and the revenue would be spent on maintenance of roads.

Mr Radisigo explained that there was a countrywide public outcry about the slow pace of project delivery which also slows economic growth.

He appealed to government officials to desist from using COVID-19 as a scapegoat for not delivering projects on time.

"We in Francistown have reached an agreement that we are not going to use the pandemic as a scapegoat for not delivering services and projects on time," he disclosed. **BOPA**

## Science week opportunity for learners

**LETLHAKENG** - The National Science Week commemoration which aims to raise awareness through sharing of some technological developments will inspire the youth to develop interest in science.

Assistant Minister of Education and Skills Development Ms Nnaniki Makwinja said this when officially opening the National Science Week in Letlhakeng on Tuesday.

Ms Makwinja said the engagement of diverse stakeholders such as policy makers, researchers, scientists, learners and the communities created ample opportunities for pupils to gain insight about science and technology.

She said the National Science Week theme: Leveraging Science, Technology, Engineering, Arts and Mathematics (STEAM) Education for Socio-economic Development was in line with country's aspirations of becoming a high income economy propelled by knowledge.

Ms Makwinja said the commemorations were a culmination of a month-long celebrations of science technology and activation, which included the hosting of satellite activities

across the country by various stakeholders.

She noted that such a development showed growth and increased awareness of each stakeholder's contribution and role in the development of the country through STEAM.

As the winds of change blow across the world, no country wants to remain behind in adopting the fourth industrial revolution (4IR), she said, describing that as a new developmental phenomenon that would help reinvent and reshape labour, skills and production which require new skills for employment and ability to adapt quickly to the needs of the new market.

She further said key technologies that drive 4IR included artificial intelligence, robotics, internet, 3D printing, quantum computing and biotechnology. "During the week, we will witness the commissioning of a biogas digester, which is a technology brought by our own research institution (Botswana Institute for Technology Research and Innovation), and this technology, cow dung and similar biological materials are used as inputs to produce gas that is used for cooking," the assistant minister said.

When sharing the highlights of planned activities, BIUST Vice Chancellor Professor Otlogetswe

Totolo said the national science month was launched on August 1, declaring STEAM activities with the recognition of the importance of Arts as a national interest.

Prof. Totolo thanked all science and technology institutions for collaboratively working with BIUST in view of their unique scientific mandates and shared responsibilities.

Professor Totolo further said they had converged in Letlhakeng to showcase a diverse range of STEAM applications, research, developments and indigenous knowledge.

He said policy makers would have a high level panel discussion on Botswana STEAM education curriculum and there would also be a teacher training session, where responsive methods of teaching science and mathematics would be shared. The vice chancellor also said some teachers would attend a workshop on Astronomy provided by a team of experts from University of Botswana, BIUST and Diamonds on the Sky

Giving a vote of thanks, Letlhakeng/Lephepe MP, Mr Liakat Kablay said network infrastructure was critical especially in the financial systems of government to ensure that Batswana were served without complaints of poor network. **BOPA**

# Maun experiences severe water shortage

**MAUN** - Maun is experiencing water shortage following the vandalism of the main transmission line from Kunyere wellfield to the pump station.

Water Utilities Corporation (WUC) head of business, Mr Thabo Ndadi, confirmed in an interview that the village was experiencing water supply interruption due to the damaged pipeline that supplies the area with water.

Mr Ndadi said all main boreholes were offline to allow the ongoing maintenance.

To mitigate the situation, the corporation is currently supplying water through rationing because of the limited supply from Shashe wellfield.

Kunyere wellfield supplies Maun with 70 percent its water while Shashe and Sexaxa produce 30 percent of the water.

With Thamalakane River having received the annual floods, he said, there was high expectations among residents that the water situation would improve, but the challenge

was the high colour concentration.

"There is a chemical limit we have to dose to remove certain level of colour concentration," he said.

"But with the improvement in colour levels, we anticipate to start Borolong Water Treatment Plant soon."

The plant sources water from the river and waters some parts of Maun. Normally the corporation switches it off when the river completely dries up.

Some residents decried water shortage, saying they had been without water for weeks while some experienced limited water supply despite the arrival of the water inflows into the river.

Persistence water shortage in Maun, they said, had been experienced for many years despite the fact that the village was surrounded by surface water including that from the Thamalakane river.

They complained that the situation had affected households and a number of economic activities including those related to tourism.

Residents said they pinned their hope on the long awaited Maun Water and Sanitation Phase II project that it would provide a long term solution to water woes but the project was reported to be behind schedule.

The project aimed to improve the water supply and waste situation of Maun and the outlying villages.

It was expected to take 36 months to complete and had been packaged into four contractors, as the plan was to have all the contracts completed by October 2022 because they were so dependent on each other.

"I wish the contractors could accelerate efforts to deliver the project as we pinned our hope on to rectifying the situation," Mr Seboko Bathobangwe of Gxhabara said. "Water situation has had a dire impact on our livelihood."

Mr Bathobangwe said he appreciated the fact that the corporation had been trying to tackle water shortage but it looked like the situation was beyond its control. Maun, he said, was a tourism hub and located in area

where surface water was abundant and if the situation persists, it would negatively affect the tourism industry.

Mr Bathobangwe urged the

contractors engaged in the Maun water project to up their game, saying the project could be a permanent solution to their water woes. **BOPA**

## Land board issues new certificates

**PAJE** - Residents of Paje have been cautioned against land transfers between individuals only for transferers to return to the land board for another allocation.

The residents were told to desist from that as the new secure land title certificate was not only overloading the land board but also a costly exercise.

This was highlighted by a land board official, Mr Moses Kesamang, during the issuance of the first Secure Land Title certificate handing over ceremony at Paje Subordinate Land Board recently.

Mr Kesamang told the people who have been allocated land, especially those who received the new Secure Land Title certificate, that the Tribal Land Act forbids one individual to be allocated more than one piece of land in Botswana and that those who transferred their land will never be allocated another land.

He said this certificate was a treasure because it was not done by the land board but by the Deeds Registry and was the same as a title deed. He added that it enabled every Motswana to have their own title without having to go through the difficult process of paying for survey.

He said some of the advantages about this new Secure Land Title was that it could be used as security to acquire financial assistance from banks, mortgages and other funding.

Mr Kesamang encouraged the recipients to value the certificates and ensure that they do not lose them.

If lost, a title holder will be required to pay P1500 to replace and endure the long process of waiting for long for a new title.

He said this process of making

a new certificate involved a lot of government departments, hence one must treasure the ones issued.

Mr Kesamang explained that the certificate bore a lot of security features that differed from one another to protect it. He explained that every certificate was unique and hindered fraudsters from making their own and cheating people with fake ones.

Land was not growing but the population continued to grow, and hence people should treasure the land allocated to them and jealously guard and protect it.

Mr Kesamang explained that this has forced them to reduce the size of the plot to the current size to spare for future generations.

"We all understand at first one would chose the size for themselves, went on to cut 60 by 40, reduced to 35 by 20 and still reducing because of the population increase we experience as a country so as to accommodate for most of the people."

Mr Kesamang encouraged those who have not registered their plots to do so for the land board to process, print them so that they can be left with the job of printing for the recent allottees.

One of the recipients of the new Secure Land Title, Ms Goabaone Pilatwe, expressed gratitude to the Paje Subordinate Land Board for allocating her the plot which she intends to develop and turn it into her permanent place of residence closer to her home in Serowe.

She encouraged other residents to apply for land and for plot owners to register them so they could be issued new certificates.

Ms Pilatwe said the Secure Land Title was important and must be handled with care.

She added that the recipients must make use of it to improve their lives. **BOPA**

He stated that since the COVID-19 pandemic had forced cessation of training activities, this course would assist the BDF personnel to catch up and complement for the skills loss that occurred because of inactivity during the pandemic.

The course coordinator, Major Boiki Selepeng, said BDF was grateful for the opportunity to learn from the United States military, which had a wealth of knowledge, technological expertise, and experience gained from many operational missions. **BOPA**

# Mindset change boot camp to ignite potential

**TSABONG** - A robust packed mindset change boot camp organised for upper class students of Tsabong Unified Senior Secondary School is set to ignite potential to improve results as part of the schools turnaround strategy.

Addressing more than 900 Form 3, 4 and 5 pupils in Tsabong on Monday, Kgalagadi regional chief education officer, Mr Daniel Zulu, said the world was moving at an unprecedented pace and therefore it was imperative to evolve the education approach.

Mr Zulu said the mission of the boot camp was to equip students with necessary tools for them to be able to thrive in the ever changing world.

He told the leaners that the world was dynamic and therefore their commitment to education must be unwavering.

The boot camp, he said, was a catalyst for them to embrace change which sought to instill 'Mind-set Change for the 21<sup>st</sup> Century Learner' as the theme for the boot camp.

The activities are about igniting potential and expected to be a turning point towards a brighter future and will also enable leaners to look at the challenges they faced

as stepping stones to build a better future for themselves.

Mr Zulu took note of the fact that the Tsabong Unified Senior Secondary School performance trend was low and kept on fluctuating.

"These declines and fluctuations present an opportunity for you to improve," he said. "It must be a starting journey towards results improvement and sustain progress."

He said just like everywhere, pupils faced challenges of gender based violence, peer pressure, teenage pregnancy, drug and alcohol abuse and smoking. He called upon leaners to focus on overcoming those challenges.

He said they were also aware of the sex parties that some students at the school engaged in, which must be stopped in order to improve academic performance.

He said they must see their challenges as unique opportunities to make a difference and do what was right.

As teachers, he said, they sought to curb indiscipline and prepare leaners for life beyond the school walls, foster holistic health and wellness and improve resource management habits.

He told them that mind-set change included changing of habits

to get better results.

For his part, Tsabong Unified Senior Secondary School Acting Headmaster, Mr Biliki Mooketsa, reminded the pupils that the school had not been performing well academically hence the need for them to make use of the five day boot camp.

As it stands, he said the 2020 Junior Certificate results showed a 31 per cent ABC pass rate, in 2021 they were at 31 per cent, while in 2022 they were at 33 per cent.

As for the Botswana General Certificate in Secondary Education in 2020 the ABC pass rate was 40 per cent, in 2021 it was 50 per cent, while in 2022 it was recorded at 51 per cent. Therefore, he said, it was important to focus on improving such results.

Mr Mooketsa said the 21<sup>st</sup> century learner must have strong survival skills and display acceptable behavior at home and in public and therefore he said they sought to build a well-rounded product.

Currently, he said, they were experiencing challenges of indiscipline, alcohol and drug abuse, smoking, teenage pregnancy, delinquency and school drop outs.

He however warned learners that drugs were illegal and chances were high that they could destroy them mentally and warned them to guard against that.

Mr Mooketsa implored pupils to change their mind set, do things differently to be able to perform better.

He reminded them that government invested heavily on their education hence the need for students to pull up their socks and do better.

Motor Vehicle Accident Fund occupational therapist and boot camp opening ceremony guest speaker, Ms Lesedi Molatedi, said the theme, 'mindset change for the 21<sup>st</sup> century learner' was aligned to President Mokgweetsi Masisi's call for all citizens to unite behind the vision and reignite the values of 'botho, bofelo, bothaga, botswere, bonatla' in the national development framework.

She said that it was incumbent upon every individual to run with it, embrace their full potential, unravel talent and capabilities and adopt the culture of innovation and self-worth.

"It takes you to change, no one is responsible for taking charge

of your journey but yourself," she advised.

Ms Molatedi emphasised that it was important for them to consistently undergo personal development, do self-retrospection and watch self-discipline.

"We are living in fast paced world today, and therefore we must embrace challenges, set goals and grow positive mind set," she said.

She implored leaners to develop strong study habits and a passion for learning and generally work hard to achieve self-actualisation, bearing in mind that education goes beyond text books thus they must always be prepared to face challenges ahead.

The school pastoral care head of department, Ms Omogolo Ramolapong said the boot camp was lined up with fun and exciting activities that started on August 21 and will end on August 25 and it was designed to prepare learners for life after school, to change mind sets and improve academic performance, to develop learner with holistic approach to health and wellness issue, improve resource management and habits of participants as well as improve personal hygiene. **BOPA**

## Monnawatsheko's house to get facelift

**MAUN** - Plans are underway to extend and refurbish the house of Ms Nkoketsang Monnawatsheko of Disana ward, courtesy of The Simon Phuthogo Organisation (TSPO).

Ms Monnawatsheko and her daughter, Cecilia lost their forearms in a crocodile attack while harvesting tswii (water lily) in the Thamalakane River in Maun in 2020.

TSPO director, Mr Simon Phuthogo, confirmed in an interview that the family needs a decent house to restore their dignity, indicating that their current house is not in a good condition.

Shelter, he said, is a basic human right, which enables one to have a sense of pride, privacy and protect them from harsh conditions.

He said plans to extend their two-roomed house with a kitchen, laundry room and a bathroom are afoot so that they enjoy a healthy home.

In addition, he said, they also want to refurbish their tuck shop and put up a stock so that they make ends meet as their means of survival following the incident has been drastically impacted as they are no longer able to harvest the much relished water lily tubers.

The family earned a living by selling the water lily at the Maun Old Mall.

According to Mr Phuthogo, all the logistics such as designs of the project have been completed and he has appealed to locals and the business community to assist in kind to ensure that the project becomes a success.

He noted that having access to

safer, good quality housing could have a positive impact on a person's health and wellbeing.

"Botswana are known to be a sympathetic nation that lent one another support in times of need and I believe we all share the same perception that a safe home is the cornerstone on which individuals and families build a better quality of life and gain greater independence," he said.

Initially, he said, his organization wanted to help provide the duo with artificial limbs but financial constraints hindered their efforts as both needed more than P300,000.

Providing prosthetic arms, he said, was quite expensive but promised that they would continue to raise funds to ensure the victims are assisted so that they regain hope, independence and opportunities to live happier and more fulfilling lives.

Meanwhile, the organization raises funds through the Kanvango Zambezi Transfrontier Conservation (KAZA) Co-existence Charity walks with an aim to assist victims of the human-wildlife conflict.

The organization also promotes conversation and raises awareness about the KAZA, a four-country conservation initiative in Southern Africa.

Mr Phuthogo noted that issues of human-wildlife conflict are a serious concern in the KAZA region, a conservation block covering Botswana, Angola, Zambia, Namibia and Zimbabwe in the wildlife rich areas.

He said preparations for this year's charity walk are ongoing but he could not disclose the date. **BOPA**

## 'Psychosocial support important for mental health'

**SHAKAWE** - Psychosocial support services are key in addressing mental health illnesses.

The observation was made by University Botswana's Okavango Research Institute (ORI) director, Prof. Joseph Mbaiwa, when officiating at the Mental Health Psychosocial Support Forum in Shakawe on Monday.

Prof. Mbaiwa observed that mental health challenges affected people of different age groups and status.

He noted that psychosocial support services assisted people with mental health problems to have resilience to withstand such

challenges.

Okavango District Health Management Team (DHMT) Chief Registered Nurse, Mr Boikaego Kgaodi, said the common mental illnesses in the Okavango region were schizophrenia and bipolar disorder. He indicated that at east there were about 350 patients with mental health disorders in the district.

He said some mental health disorders were associated with traditional beliefs such as witchcraft. There was also stigma attached to people with mental health challenges.

"I encourage you to have a positive attitude towards mental health and seek professional help

where necessary," he said.

Mr Kgaodi said Botswana addressed mental health disorders with three interventions under primary health care: preventative, rehabilitative and curative.

Okavango Children's Consultative Forum's representative, Ms Kelapile Kanyodi, said that children faced challenges of being bullied by fellow learners and some teachers who used derogatory words in schools which negatively affected their mental health.

Ms Kanyodi said there was need for disability-friendly environment and facilities for children in schools as well as counselling services. **BOPA**



## Botswana taps from Texas A&M Agrilife University

He highlighted that there were tremendous opportunities in the country, which they were interested in such as livestock production.

However, he said their main strategic areas were development of new technologies for agriculture, sustainable production, economic strength of their tasks and health for both livestock and humans.

Dr Lamb said at the end of their week long visit in the country, there should be a schedule of

action items, adding that the agreement between Botswana and Texas State would not be beneficial unless opportunities were exploited.

While in the country, Texas A&M Agrilife Research University delegation will meet other stakeholders and researchers.

Dr Lamb will also officially open the national agriculture show on Friday at Sebele Show Ground. **BOPA**

## SOEs key drivers of economic development

**GABORONE** - State Owned Enterprises (SOEs) have played a key role in the country's socio economic development, hence it is important to ensure alignment of their mandates with the national development agenda, including Vision 2036.

State Owned Enterprises were established to achieve some public policy objectives, such as the regulation of businesses and to serve as investment arms of government.

Office of the President's Public Sector Reforms coordinator, Mr Thuso Ramodimoosi said in his welcome remarks during the Stakeholder Validation Workshop in Gaborone on Tuesday that the workshop afforded stakeholders an opportunity to comment on the draft policy and give feedback to the consultants tasked with developing the SOEs Ownership Policy for Botswana.

"The fact that Botswana has, overtime, attained an upper middle income status, is largely due to their contributions," he added.

However, he expressed concern that the performance of SOEs remained unsatisfactory in terms of delivering their mandates and providing fair return on investments, which was a great concern to government.

"This concern was also expressed by the Permanent Secretary to the President, Ms Emma Peloetsetse, when she recently met with the leadership of the respective SOEs, on a one-on-one basis," he said.

For that reason, he stressed that it was important for SOEs, as key

stakeholders, to be invited to the workshop to contribute to the development of their ownership policy.

"Please feel free to critic the document, while also offering constructive input for a sound policy," he added.

In an effort to improve SOEs performance, the Public Sector Reforms coordinator said in 2020 government established a Cabinet sub-committee on the performance of SOEs to improve performance of these enterprises by considering all aspects in relation to their establishment, corporate governance, funding, performance and oversight.

"The sub-committee, which I believe was chaired by the Minister of Finance, was expected, amongst others, to review the SOE landscape with a view to strengthen accountability, create efficiencies and achieve service excellence," he said.

Furthermore, in pursuit of its mandate, he said the sub-committee immediately noticed that the SOE landscape was characterised by incoherent and unstructured approaches, in relation to issues of governance, oversight and monitoring and evaluation.

To address these deficiencies, he said the sub-committee came to a conclusion that there was need for a government policy on SOEs, which would clearly articulate the stakeholders' expectations on the role of SOEs in the country's development and also ensure alignment of their mandates with the national development agenda, including Vision 2036.

Subsequently, in 2021, Mr Ramodimoosi said the then Ministry for Presidential Affairs, Governance and Public Administration mandated Public Enterprises, Evaluation and Privatisation Agency (PEEPA) to undertake the task of developing an SOE Ownership Policy for Botswana.

In fulfilling this task, he said PEEPA in turn engaged Botswana Institute for Development Policy Analysis (BIDPA).

He, therefore, commended PEEPA and BIDPA for delivering on the task, as well as the Reference Committee for spearheading the task.

Once the validation exercise has been completed, the coordinator said the draft policy would go through the normal government process of approval 'and I think you are all aware that the ultimate approval body is Parliament'.

"Let us remember that we are creating an enabling environment for the economy and the country to attain high income status, as envisioned in Vision 2036.

It will please one, or us all, that when we submit the document to the relevant authorities for approval, especially Cabinet, it sees that indeed we have really done a great job," he added.

Mr Ramodimoosi noted that in certain instances Cabinet would defer, or even reject a proposal, because it was not thoroughly done, not well assessed, not comprehensive enough, did not meet the objectives or it was not aligned to the National Development Agenda.

However, having gone through

the document himself, he opined that after the validation workshop, and with the enrichment of the process, the draft policy would see the light of day.

PEEPA acting chief executive officer, Mr Ishmael Joseph also emphasised that it was important for SOEs, as key stakeholders, to have an input into the draft policy and also interrogate its every aspect.

The contributions, he said, would help provide valuable insights on issues that might have been missed during the stages of development and address all outstanding questions.

"We are here to confirm validity and reliability of the policy, as it sits. We are not building a policy for the past.

We are looking ahead, so as we look at validity, in terms of whether it represents indeed what we have experienced, but for the most part how it leads us into the future.

There is a great future for us ahead and we need to be working the path in the next five to 10 years of delivering on this policy," said Mr Joseph.

Presenting the draft SOE Ownership Policy, BIDPA lead consultant, Dr Molefe Phirinyane explained once developed, the policy would; ensure efficient and effective performance of SOEs and create value for their shareholder, create a level playing field and expose SOEs to private sector competition and set out important principles and appropriate frameworks for the governance of SOEs, as well as their leadership with the shareholders and other stakeholders. **BOPA**

## Batlokwa celebrate culture

**TLOKWENG** - Batlokwa on Saturday gathered at Tlokweng Village Development Committee (VDC) grounds to celebrate their culture in an event they dubbed Mafifatshwana Cultural Festival.

Celebrated under the theme; My Culture, My Pride, Journey to 2025, the festivities were low key because of poor attendance.

Nevertheless, organisers went all out to stage a good show in a bid to pave way for the main celebrations billed for 2025 when they would be celebrating 145 years of the tribe's existence.

Officiating at the event, Minister of Youth Empowerment, Sport and Culture Development, Mr Tumiso Rakgare commended Batlokwa for celebrating their rich cultural heritage.

"As a ministry we are here to give support and bear witness that culture is celebrated and preserved," he said.

He further said celebration of culture by different tribes in Botswana showed unity in diversity.

Cultural activities on display such as music, dance, traditional games and many others, Minister Rakgare said demonstrated a sense of belonging and pride, which made the Setswana culture unique. Kgosi Puso said the main objective of the day was to remember the origins and heritage of Batlokwa so as to preserve them for the future generations.

Also, he said the tribe wanted to demonstrate economic benefits that could be derived from celebrating cultural activities.

He said such celebrations started in 2009 with an intention to

celebrate the day annually until the main event in 2025.

He was however concerned that their proximity to the city was a threat to preservation of culture due to influx of other tribes who had now been integrated into the tribe. Therefore, he said the tribe vision was to have a smart model village to help stop modernisation from eradicating their culture and value systems.

He said in Botswana Batlokwa were found in Tlokweng, Mogobane, Ramotswa, Mmatseta and Maun.

Giving words of encouragement, Oupa Bogatsu, representing Batlokwa from South Africa, said Batlokwa were spread throughout Southern Africa.

He Batlokwa were also found in Lesotho, Zimbabwe and Zambia.

He encouraged fellow tribesmen to be proud of their identity.

He cautioned them to desist from selling land as it was the case with those in South Africa.

He said land was an important resource with an intrinsic value.

A representative of Batlokwa from Zimbabwe, Sindile Mdlhongwa shared that Batlokwa were scattered throughout Zimbabwe.

He explained that they arrived in Zimbabwe during the time of the Difecane wars.

He said while some Batlokwa tribesmen remained in Botswana, his clan ended up in Zimbabwe while others went further north into Zambia.

He also said although they had lost the language in the process because of integration, that had not caused them to lose their cultural identity, hence his name is Mdlhongwa, which means

Motlokwa.

He said Batlokwa were by nature brave and decisive, so he encouraged them to hold on to those traits as they believed in greatness. According to Kgosi Ramonnye Matlapeng, the Batlokwa tribe was one of those that arrived in Botswana in the 1800s from South Africa during the Difecane wars.

They split with Bakgatla in South Africa and found refuge in Botswana.

When they arrived in Botswana they sought refuge from Bakwena tribe under the leadership of Kgosi Sechele I, who gave them land.

He explained that the story of Batlokwa was one of courage and strife from other tribes who

wanted to swallow them, but always found a way to split from those dominant tribes to preserve their own identity and survival.

Their totem is Thakadu since the animal is believed to have rescued them during a time of turmoil.

He said they were referred to as Mafifatshwana as they were revered to carry out their cultural ways in secrecy just like their

totem, hence they still bury their dead in their home steads.

The festivities were characterised by presentation of dikgafela to Kgosi Puso, poetry, traditional games such as morabaraba, traditional cuisine and lots of entertainment.

Biggest performances were from Cultural Spears, Mma Ausi and Mafithhakgosi traditional dance troupe among, others. **BOPA**

Safety, Health and Environment Coordinator in the Ministry of Health, Ms Ellen Kahovere, in her overview of the games, said they were established in 2012 by the health care workers from Rakops, Palapye, Gantsi and Maun.

She said workers from the Chobe DHMT, Sefhare Primary Hospital, Masunga and Gweta joined the following year as the games grew.

She said when they started, the main mandate of the games was to tackle issues that affected men.

She said during their gathering they would invite other stakeholders to come and address issues such as HIV/AIDS, financial literacy, as well as men's sexual health.

Ms Kahovere said interest grew in the games as time went

on and more DHMTs started participating.

She said the games had now turned into a forum for health care workers to converge and collectively look at their health and wellness by getting screened for illnesses and carrying out physical exercises.

The games brought together teams from Greater Lobatse,

Kgalagadi South, Kgalagadi North, Southern, Greater Gaborone, Kweneng and Kgatleng DHMTs.

There were also teams from Sbrana Psychiatric Hospital, Kanye SDA and Ministry of Health headquarters.

He booked a spot as one of the fastest non-automatic qualifiers after finishing in position four in the heats with a time of 1:45.60 on Tuesday.

Tonight, he will line up against polish Mateusz Borkowski, Mohamed Attaoui of Spain, Ben Pattison of Great Britain, Joseph Deng of Australia, Benjamin Robert from France two Africans Slimane Moula and Abdelati El Guesse of Algeria and Morocco respectively.

National team coach Chilume Ntshwarang said they would go all out in the semi-final as their main aim was to make it to the final.

"He should run and go with the front pack.

He should avoid being boxed in because to come out of the box is other story. The idea is to increase the pace and see if we will get a Personal Best time and a final spot," he said.

Former Botswana Athletics Association secretary Patrick Moesi said the athlete ran a good race, though in the mix, adding that he had dug in a little bit more he would even have qualified automatically

"His race management has improved greatly this season and he is sure to develop into a world class athlete from this experience.

In the semi-finals, he needs to stay up there with the leading pack and finish strongly.

He may be in with a chance for the finals if he fights until the end," he said.

Meanwhile it was a bad day in office as three 400m runners did not proceed to the finals.

Bayapo Ndori could not complete his race due to an injury while Leungo Scotch and Coleen Kebinatshipi both finished last in their different heats with 45.96 and 46.39 respectively.

Athletics coach Boxah Kootshabe said Scotch and Kebinatshipi were both slow in their first 200m.

"It looked like they gave up when they saw that they don't have a chance of better position and times.

I hope they will recover and give us better performance in a relay," he said

On the other hand, Moesi said it was not a good day for the 400m trio and that Scotch was in the strongest heat and his lane draw did not do him any favours.

He said running from that lane against fast athletes, he needed to have started very quickly but he did not seem to kick it off too well hence the result.

The coach said Kebinatshipi, a junior, did well to have made it to the semi-finals, adding that he too was affected by the lane draws.

Moesi said while known for his fast take offs, he did not start off too well and was already trailing in the back straight.

"It's a learning curve for the youngster and he will grow from strength as a result.

Our athletes need to be aware of the new rules for lane draws and should strive to qualify automatically for better lanes," he said. **BOPA**

## Osasuna faces Bruges in Conference League preliminary round

**MADRID** - Osasuna will make their European comeback for the first time since 2007 as they face the Belgian team, Bruges, in the preliminary round of the Conference League on Thursday night.

The team from Pamplona, which secured a seventh-place finish in LaLiga last season, endured an uncertain period before their European spot was confirmed.

This was due to an investigation into match-fixing allegations from the 2013-14 LaLiga season.

While the club was initially ousted from the competition, their position was restored on appeal.

They received a fine of 100 000 euros and were directed to

surrender five per cent of their income from the group stage should they qualify.

UEFA determined that the match-fixing was orchestrated by the club's former directors, some of whom have since been sentenced to prison in Spain. Osasuna entered this match after starting LaLiga with a 2-0 victory over Celta Vigo but suffered a 2-0 defeat against Athletic Club Bilbao the subsequent weekend.

Winger Kike Barja, who sat out last weekend due to a minor muscle issue, is expected to be ready by Thursday. Coach Jagoba Arrasate plans to deploy his strongest lineup. Bruges, currently leading the Belgian league with three victories and one draw

from four matches, advanced to the preliminary round with an impressive 10-2 aggregate triumph over the Icelandic team, Knattspyrnufelag Akureyrar.

Their storied European history includes reaching the Champions League's last-16 in the previous season, emerging from a group that ousted both Bayer Leverkusen and Atletico Madrid.

With the subsequent leg in Belgium set for the following week, predicting the outcome of this tie is challenging.

Yet, considering Osasuna's athletic and legal battles to return to European competition after 16 years, it would be somewhat ironic if they faltered at this initial stage. **Xinhua**

## Tebogo set for semis tonight

**GABORONE** - Botswana's finest runner, Letsile Tebogo will tonight continue on his quest of clinching another medal at the ongoing World Athletics Championships in Budapest, Hungary as he lines up for the 200m semi-finals at 820pm.

Tebogo cruised to the semi-finals yesterday finishing ahead of the pack with a time of 20.22, beating among others Blessing Afrifah of Israel, who denied him a gold medal at the World Athletics Junior Championships last year.

From the start of the race, Tebogo was very conservative possibly saving the best for the semi-finals where most athletes will come with guns blazing.

Some of the athletics pundits are of the view that should Tebogo proceed to the finals tonight, the world should expect yet another good performance.

Former athlete and now a Senior Lecturer in the Department of Sport Science at the University of Botswana Dr Tshepang Tshube said it was clear in the 200m heat that Tebogo had been able

to monitor and regulate his mental and emotional state.

First, he said Tebogo was focused on the race and calm from the introductions to the end, adding that was important, particularly for self-awareness.

Dr Tshube said in the build-up and during the race, he had to focus on relevant cues only, such as his starting block, lane, and productive thoughts about the race.

Secondly, he said at a technical level, two things happened: the first thing was energy management.

He said Tebogo ran to qualify, adding that he expected him to continue with his good performance tonight.

"Secondly, Tebogo was aware that he was the favourite to win and controlled the race from start to finish.

He has built the confidence to control the race.

It was clear that other athletes respected him to win the race," he said.

Meanwhile, it was end of the road for Oratile Nowe as she failed to progress to the 800 metres semi-finals as she finished in position seven with a National Record of 2:01:62. **BOPA**
