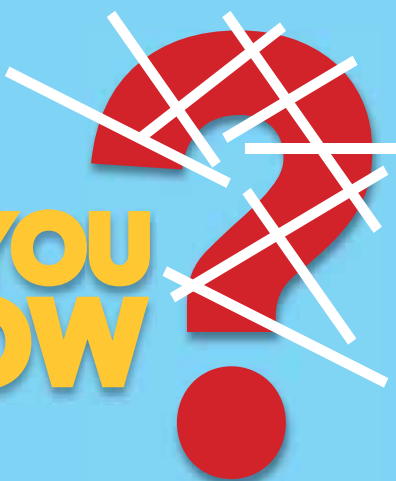

# Phillippines, Uruguay present letters of credence

GABORONE - President Dr Mokgweetsi Masisi yesterday received letters of credence from the Philippines and Uruguay envoys.

Receiving the letters from the Philippines ambassador-designate, Ms Noralyn Baja, President Masisi said he attached a lot of importance to the existing bilateral relations between the two nations that dated back to 1967.

He said the relations were built on shared bonds and cooperation in international organisations such as the United Nations as well as a shared commitment to democracy, respect for human rights, peace and security, economic and social development and an international trade system that benefited both countries.

President Masisi also said there were opportunities to enhance mutual knowledge and understanding between the two countries through

the establishment of political consultations as well as through bilateral cooperation.

He said Botswana could learn from Philippines strong regional leadership in education with well-established public school and university systems.

"The Philippines are renowned for skills export, an area that Botswana can benchmark on as the two countries strive to unlock more channels of bilateral cooperation," President Masisi said.

He urged the envoy to explore the country's tourists attraction areas which he said were endowed with flora and fauna.

For her part, Ms Baja expressed delight over the outstanding bilateral relations that existed between Botswana and the Philippines.

She commended Botswana for making significant strides in infrastructure development; the roads infrastructure and network connectivity.

She said her country was keen to establish a bilateral coordination manual with the aim to nurture the relations between the two countries.

Meeting the Uruguay ambassador-designate, Mr Jose Lopez, President Masisi reaffirmed Botswana's support to the people of Uruguay and the already strong diplomatic relations subsisting between the two countries.

"Botswana remains grateful for the relationship between Uruguay which dates back to 2007 and is premised on shared values of democracy, good governance, respect for the rule of law, mutual respect and understanding as well as continuous pursuit of sustainable development and a free market economy," he said.

He highlighted the need for Uruguay to introduce visa exemptions for Botswana travelling to Uruguay in an effort to strengthen the ties and promote trade between the two nations.

Similarly, Mr Lopez commended President Masisi for

the warm reception accorded to him.

He described Botswana as a true friend with lots of similarities to Uruguay in terms of multiparty state, democracy and obedience to the rule of law.

He said his country was actively looking at deepening and broadening ties with Botswana in the agricultural sector and water reticulation.

Mr Lopez said they were recently impacted by a severe drought which devastated the country's agriculture and food supply chains.

He further said the two countries had similar economic and investment interests that could create employment and economic development for the benefit of both countries. **BOPA**

# Tsogwane urges all to recruit new members

FRANCISTOWN - The Botswana Democratic Party (BDP) members have been reminded that they have a responsibility to recruit new members into the party fold.

Such a responsibility, according to the party Chairman and Member of Parliament for Boteti West, Mr Slumber Tsogwane was not the preserve for members vying for political office only.

He appealed to the BDP Francistown region special congress held at Adansonia Hotel in on Saturday.

Francistown region has five constituencies namely; Francistown East, Francistown West, Francistown South, Tati East and Tonota.

"You are advisors and leaders for this party and are duty bound to take it upon yourself to stand for the party and sell its manifesto to the electorates.

Moreover, Mr Tsogwane stated it was important that those entrusted with leadership positions should trust each other, openly tell each other the truth and accept they have different strengths and weaknesses. No one has the monopoly of wisdom, he said.

Democrats, he said should familiarise themselves with the party's guiding documents such as the constitution and the manifesto to be in a better stead to sell the party to the masses.

"Those vying for elections should be at the top of their game and be in a position to explain succinctly what the party stands for in terms

of its pledges, its development trajectory and priorities," he said.

It is Mr Tsogwane's wish that the democrats should have the determination and fire in the belly to take the nation forward like President Dr Mokgweetsi Masisi.

It is to this end the party has resolved that recruits should wait for two full years before they can contend for any position within the party.

The BDP chairman stated that the resolutions that would emanate from the regional meeting would be key going forward.

Member of the BDP Central Committee (MCC), Mr Machana Shamukuni said in his briefing that members were determined to work hard to ensure they win the 2024 general elections with bigger margins.

"The 2024 general elections will not be business as usual. We will have to put up a fervent campaign and pull out all the stops on our way to victory," he said.

Member of Parliament for Tonota, Mr Pono Moatlhodi challenged the democrats to know each other strengths and make sure they fielded strong people come elections.

He shared Mr Tsogwane's sentiments that the people who have sufficient knowledge of the party usually make good representatives.

He relayed that he was not happy with the current recruitment drive to lure people into the party's fold by BDP members.

Member of Parliament for Francistown East and Assistant

Minister of Youth, Sport and Culture, Mr Buti Billy called on the youth to take advantage of the Youth Development Fund which would be transferred to the Ministry of Entrepreneurship in the next financial year.

The programme focuses on sectors such as agriculture and its value chains, agro-tourism, and

ICT to scale down the country's import bill and increase the export bill; something he stated was in line with the BDP manifesto that pledged to create employment, ensure food security and better the lives of Batswana.

Francistown region Chairman who is also at the helm of Tonota district council, Mr Baemedi

Medupe agreed that the meeting created a perfect platform to come up with resolutions to present at the forthcoming BDP congress slated for Palapye.

General membership, he said also needed to change mindset and ensure they were hands-on in all the activities of the party. **BOPA**

# Africa CDC pledges support to Botswana initiatives

GABORONE - Botswana's ongoing efforts to engage in the manufacturing of medicines and human vaccines could do well with support from African states.

These sentiments were expressed by the director general of the Africa Centre for Disease Control and Prevention (Africa CDC) Dr Jean Kaseya during a courtesy call on President Dr Mokgweetsi Masisi at the Office of the President yesterday.

Dr Kaseya said African states should show support by procuring medicines and vaccines from the country as this would be beneficial to the continent.

He praised President Masisi for his visionary leadership in driving Botswana towards the production of medicine and said he would urge African states to offer the country a market.

"Your vision, President Masisi fits into what Africa needs. We need independence from relying on others, and Africa should open up its market, for what is from Botswana should be for all African states to procure and support our own since we have been heavily reliant on imports," Dr Kaseya said.

The leadership of Africa CDC, the public health agency of the African Union (AU), established in 2016 by the 26<sup>th</sup> AU Ordinary Assembly of Heads of State and Government to support the public health initiatives of member states and strengthen capacity to deal with disease threats, has been partaking in the WHO Regional Committee for Africa summit in Gaborone.

President Masisi assured Dr Kaseya and fellow Africa CDC leaders that Botswana would continue to offer support for their work, which from a domestic perspective, included complementing the effort of developing the capacity of the country's own healthcare system.

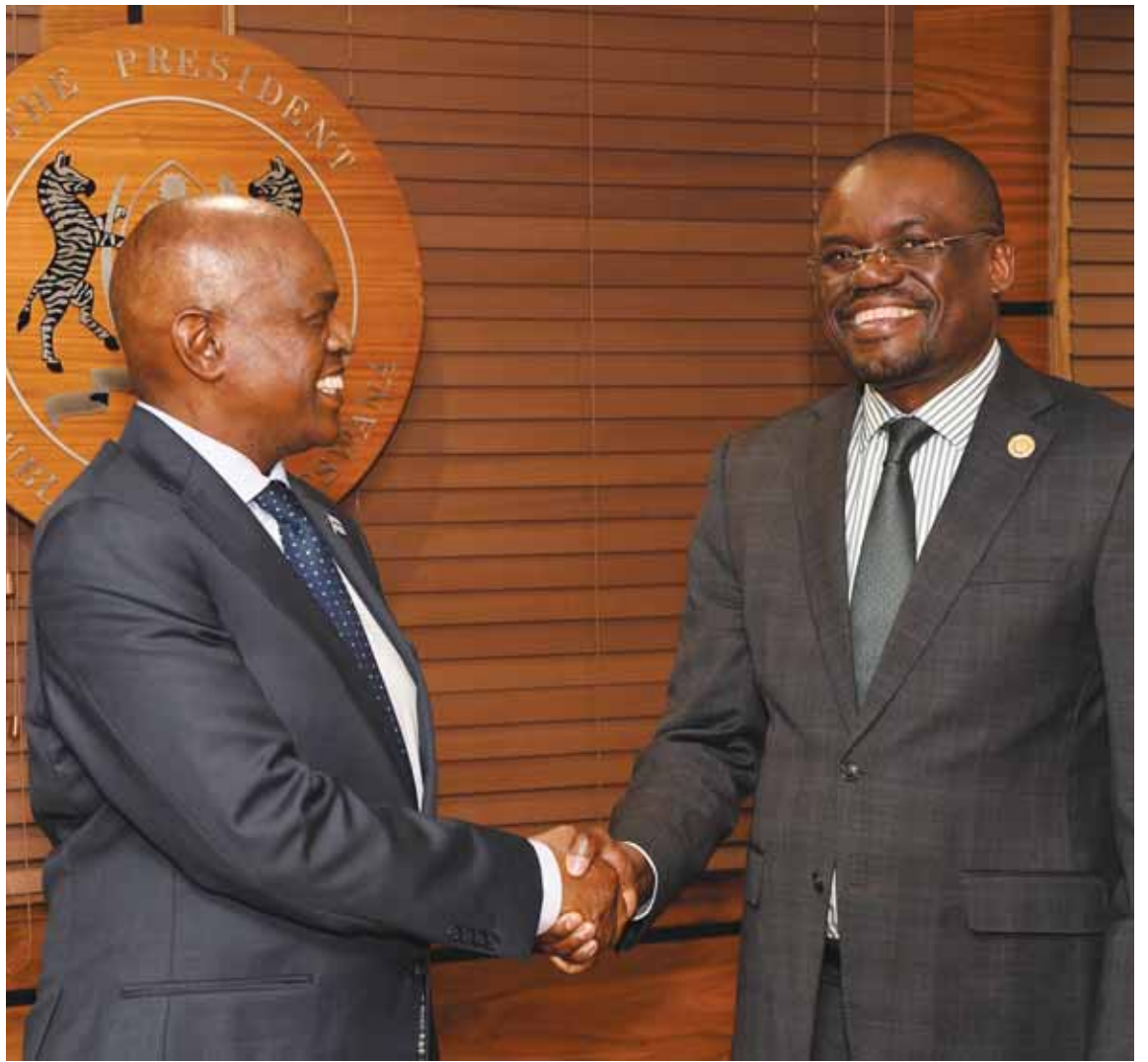
He said Botswana had taken 'baby steps' towards developing its healthcare ecosystem, including the production of drugs, vaccines and therapy saying the country sought to further strengthen the

Botswana Medical Regulatory Authority (BOMRA).

Dr Masisi added that Africa needed to build strong healthcare systems, which include, building human capital, industrial development, and technology, as well as the monitoring, detection and capacity to deal with disease burden along with research and analytics and drawing lessons from the COVID-19 pandemic.

President Masisi concurred with Dr Kaseya that the continent needed to be united in building regional synergy around its healthcare regulatory systems.

He added that the work of the Africa CDC should be seamless, rapid without being tied to bureaucracy and overcoming potential language barriers on the continent. **BOPA**

## Masisi commends Prisons for successful OPR

TLOKWENG - Botswana Prisons Service has been commended for developing a comprehensive Offender Reintegration Programme that encourages community participation in reintegrating ex-offenders.

Officiating at the Botswana Prisons National Ex-offenders Reintegration Conference in Tlokweng yesterday, President Dr Mokgweetsi Masisi said positive strides had been made in reintegrating ex-offenders into communities.

"Since the launch of the programme in 2021, out of 459 inmates handed to the reintegration committees, only eight or 1.74 per cent have re-offended. This is an indication that if all prisoners were to go through the same process, there was no doubt in the efficacy of attaining successful reintegration," he said. He said the programme through community participation in the form of Community Based Reintegration Committees (CBRC) was chaired by the village

leadership for aftercare and continuity.

"The reason for such a decision is that in Setswana, dikgosi are key in providing guidance in nation building," he said.

President Masisi said the reintegration programme was also important as it was purposed to change the way society perceived ex-offenders.

Therefore, he said the programme would positively influence ex-offenders to view life in a different perspective, leading to a reduced chance of re-offending.

He also underscored that Botswana prisons was also one of the departments that were doing well in the implementation of the Reset Agenda.

"I am not surprised that we are gathered here today in a conference of this magnitude, which is aimed at strengthening programmes geared towards promoting a safer Botswana," he said.

President Masisi reaffirmed government's commitment to support the Botswana Prison Service in all its efforts geared

toward enhancing the delivery of rehabilitation and reintegration programmes. To that effect, he said the amendment of the Prisons Act would adequately address issues of human rights in prisons.

"I wish to point out the significant role of the community in this challenging phenomenon. Reintegration takes place in the community, by the community and for the community. The most the state can do is to facilitate and support the endeavours of the community in this regard," he said.

Meanwhile, Minister of Defence and Security, Mr Kagiso Mmusi said the historic event for the Prisons Service was important for providing platform to appreciate and reflect on progress made since the launch of the Botswana Prison Service Offender Reintegration Strategy in October 2021.

Reflecting on the strategy, he said, the Prisons Service had taken a deliberate move to involve communities in the reintegration programme to create a seamless coherence between offender in-care and aftercare.

He said the reintegration programme was a living example of mindset change that was instrumental to addressing issues of crime-free Botswana by the year 2036.

"We drive this initiative leveraging on pillars two and four of the National Vision 2036 aspirations accentuating on Human Social Development and Governance, Peace and Security," he said. Mr Mmusi said the initiative was further important in driving United Nations Agenda 2030 on Sustainable Development Goals, pillar number 16 which focused on promoting peaceful and inclusive societies for sustainable development, providing access to justice to all and building effective, accountable and inclusive institutions.

Botswana Prisons Commissioner Ms Dinah Marathe said it was the first time Botswana Prisons Service conducted a dialogue and promised that more was to come.

This conference laid the foundation for social cohesion and acceptance of those who come from custody.

She said the mandate of Prisons Service was to ensure safe custodial care of offenders, whilst ensuring their rehabilitation and subsequent release from prison upon expiration of their sentences.

She said Prisons Service had evolved with regards to service delivery, human capital, and infrastructure and strived to be an institution of correctional excellence. Commissioner Marathe said the programme was intended to attain successful special/community re-entry of offenders upon release to accord them the opportunity to lead positive, productive and meaningful life free of crime.

She said there were 447 committees around the country which continued to capacitate through different programmes and actions. **BOPA**

# Mogae: HIV and AIDS champion

GABORONE - In 2001, when 40 per cent of all adults in Botswana were infected with HIV, the then President of Botswana, Dr Festus Mogae took to the global stage to warn that his people were 'threatened with extinction.'

He was the first head of state in the world to publicly test for HIV, and one of the first to chair his country's national AIDS council. This marked the beginning of his illustrious leadership in the fight against the pandemic, and the world was watching!

Dr Mogae was duly recognised in October 2008 when he was named the winner of the Mo Ibrahim Prize for Achievement in African Leadership.

Announcing the Ibrahim Laureate, the then United Nations Secretary General and chair of the Prize Committee, Dr Kofi Annan said 'President Mogae's outstanding leadership has ensured Botswana's continued stability and prosperity in the face of an AIDS pandemic which threatened the future of his country and people.'

The then UNAIDS Executive Director, Dr Peter Piot said 'Mr Mogae has demonstrated what leadership and perseverance can achieve in the face of extreme challenges.' He further said the Mo Ibrahim Prize represented a pinnacle in Mr Mogae's efforts to stop the spread of HIV, not only in Botswana but throughout Africa, and that he was a true visionary and exemplary to other leaders around the world.

Looking back at his journey, it is evident that his success in the fight against HIV and AIDS was no fluke. Dr Mogae's leadership made a difference in Botswana's AIDS response through a

number of initiatives.

From 1998 when he took the reins from Sir Ketumile Masire until he relinquished the seat in 2008, Dr Mogae made the HIV/AIDS response one of the top priorities of his administration.

BOPA reporter **Olekantse Sennamose** highlights some of the achievements that helped the country to be the darling of the international community in the fight against the pandemic.

The first step Dr Mogae made was to build a comprehensive national response to HIV/AIDS. Recognising the severity of the epidemic, he made it a top priority for his government. His administration then invested heavily in HIV prevention and public education campaigns. These efforts aimed to raise awareness about safe practices and reduce the stigma associated with the disease. Dr Mogae's stand to be vocal about reducing the stigma surrounding

HIV/AIDS helped encourage more people to test and seek treatment.

After ensuring that the nation was well educated on the basics of the pandemic and people were willing to come out in the open, Dr Mogae's administration then next introduced Antiretroviral Treatment (ART), a move that was considered one of the world's most ambitious programmes meant to provide free antiretroviral treatment to citizens living with HIV/AIDS.

This initiative significantly extended the lives of many people living with the virus as it delivered HIV treatment to more than 90 per cent of those who needed it.

Dr Mogae then ensured the extension of access to healthcare. This resulted in a notable improvement in access to healthcare services for people affected by HIV/AIDS, including testing

and counselling. From then, Dr Mogae's next strategic move was to collaborate with the international organisations and donors such as UNAIDS and PEPFAR through which he managed to secure the hard to come by funding and technical support for Botswana's HIV/AIDS programmes.

By then funding was a difficult to access especially that many African countries were in need of such. After ensuring that all the other basic services such as awareness, testing and preventative measures were in place, Dr Mogae's administration then established data collection and monitoring.

Robust systems for data collection and monitoring of HIV/AIDS cases was vital in that it enabled evidence-based decision-making and programme evaluation.

Perhaps one of Dr Mogae's strengths

was his demonstration of strong political will in the fight against HIV/AIDS. He used his presidency as a platform to advocate for a global response to the pandemic.

As a result of these efforts, Botswana made substantial progress in curbing the spread of HIV/AIDS and improving the lives of those affected. Dr Mogae's leadership in this area earned him recognition and accolades on the international stage, and his approach to tackling the epidemic has served as a model for other nations facing similar challenges.

In addition to treatment, the country made impressive strides in another key initiative, the prevention of mother-to-child HIV transmission (PMTCT) and caring for children orphaned by AIDS.

# You are a special one - Ghebreyesus tells Mogae

GABORONE - World Health Organisation (WHO) Director General, Dr Tedros Ghebreyesus has hailed former President Dr Festus Mogae for his contribution to health and peace in the continent.

Dr Ghebreyesus who was speaking at a cocktail dinner organised for delegates attending the ongoing WHO Regional Committee for Africa (RC73) Summit on Monday, said that he had known Dr Mogae for many years since the time he (Ghebreyesus) was Minister of Health in his home country, Ethiopia.

He said among significant and positive impacting assignments that Dr Mogae was engaged in, two of them stood out as per his judgement.

One of them, he said was his contribution to revitalisation of the Global Fund.

He said the fund was faced with some challenges and a taskforce to investigate the problems was setup, of which Dr Mogae was a member.

He said the taskforce carried out investigations which led to some recommendations and ultimately Global Fund was revitalised and continued with its work of supporting the world.

"This is so because of former President Dr Mogae's guidance and others," he said.

Furthermore, Dr Ghebreyesus said he worked closely with Dr Mogae on many other issues, praising him for his leadership skills in bringing peace to South-Sudan.

"He was chairing the committee assigned to mitigate for peace in South-Sudan and at that time I was the foreign minister. Of course it took some time but eventually peace was restored in South-Sudan," he said. The WHO

director general stated that Dr Mogae's legacy would not only be recognised locally, but in the global space.

"You are a special one. What Africa needs now are leaders like you, humble leaders. By the way, also in the hands of President Dr Mokgweetsi Masisi, Botswana is lucky," he said.

Dr Ghebreyesus also applauded Botswana for having grown from an aid-supported state to a developed country with a good primary health care.

Dr Ghebreyesus said Botswana had proven that everything was possible in Africa.

The year 2023 also marks the 75<sup>th</sup> anniversary of WHO, a significant year for the organisation as well as global health, he said.

Dr Ghebreyesus said the COVID-19 pandemic reminded all that health was a human right. He said challenges in the health system across the globe had proven that in order to win, team spirit was vital.

As such, he commended Botswana and other WHO member states for working together towards health of all.

Meanwhile, WHO Director for the Africa Region, Dr Matshidiso Moeti said WHO was committed to improving the health of African people hence she called on all to work together for it to succeed.

Despite underlying challenges, Dr Moeti was confident that working together would bring solutions.

For his part, Minister of Health Dr Edwin Dikoloti said health issues affecting African countries were more or less similar and therefore the gathering of RC73 was an opportunity to share experiences.

Dr Dikoloti said through WHO, countries around the world had made strides in developing their

respective health structures.

He said the African region had invested heavily on health care infrastructure and on health care issues among them managing

issues relating to HIV and AIDS, other communicable and Non-Communicable Diseases and recently the fight against COVID-19 pandemic.

Dr Dikoloti said Botswana was grateful and as such applauded WHO for its remarkable success in tackling health issues across the globe. **BOPA**

## WHO recognises Mogae

GABORONE - As part of its 75<sup>th</sup> anniversary celebrations, the World Health Organisation (WHO) yesterday recognised former president, Dr Festus Mogae and other African leaders who have worked to build the continent's healthcare system.

The award was in recognition of Dr Mogae's efforts in guiding the health system of Botswana and combating the HIV and AIDS pandemic. Through his visionary leadership, Dr Mogae prioritised the fight against HIV and led Botswana to become the first country in Africa to provide free ARV treatment to HIV positive patients. His efforts resulted in the reduction of deaths and the transmission of the virus by rolling out the Prevention of Mother-to-Child Transmission programme among others.

His work in fighting HIV and AIDS as well as improving Botswana's health system was commended for having a far reaching impact and strengthening the country's healthcare system.

WHO's director for the Africa region, Dr Matshidiso Moeti said Africa's capacity had been built over the years and that it would assist the continent in growing its health system and guiding future aspirations.

Established 75 years ago, WHO was tasked with attaining universal health for all, Dr

Moeti said. She noted that during its formative years between 1948 and 1958, WHO focused on infectious diseases that were affecting many people. She said over the years community-led interventions had proven to be effective.

Dr Moeti also noted that the first cases of HIV were recorded in sub Saharan Africa in 1982, and that the cost of fighting HIV and AIDS was out of reach for many African countries.

She said between 1988 and 2023, WHO supported African countries in strengthening their health systems and to effectively deal with emerging health challenges. She said national immunisation campaigns were strengthened, adding that vaccines played a major role in controlling tropical diseases.

Dr Moeti noted that through interventions that were driven by communities to support health systems, Africa was certified free of Polio in the 20<sup>th</sup> Century.

She said Africa must now ensure that policies were in place to foster opportunities to improve health systems.

She said WHO had over the years demonstrated the power of partnerships and collaboration and the ability to do more with less.

Additionally, she said WHO had established Centres of Disease Control in Africa, and that the organisation was looking forward to working with the African Union and

African leaders and governments in establishing resilient health systems.

She said WHO was devoted to supporting a multi-sectoral approach in developing health systems in the region, urging African countries to take advantage of research and innovation.

Meanwhile, Vice President, Mr Slumber Tsogwane said Botswana and the rest of the world were celebrating the work that WHO had been doing over 75 years.

He said the milestone provided countries across the globe with an opportunity to reflect on health challenges and to celebrate achievements over the years.

He applauded global leaders for their visionary leadership in facilitating and supporting WHO to tackle health setbacks over the decades. He noted that WHO had made notable successes in eliminating tropical diseases and controlling communicable and non-communicable diseases as well as strengthening health care systems.

Through WHO support, Mr Tsogwane said, Botswana had made commendable progress in advancing health programmes. He also urged WHO to continue supporting local and regional health systems in order to make health for all a reality. **BOPA**

This initiative played a significant part in ensuring that the virus did not become an inter-generational curse.

After he stepped down from the Presidency in 2008, Dr Mogae now had ample time in his hands, he used the opportunity to now take the fight beyond Botswana borders to the rest of Africa. In August 2008, hardly four months after he left the Presidency, he launched 'Champions for an HIV-free Generation,' which was a group of renowned African leaders calling on their peers to step up efforts to prevent the spread of HIV.

The collaborating partners of this initiative were the World Bank, UNAIDS, the World Health Organization, the Bill & Melinda Gates Foundation, the Global Fund to Fight AIDS,

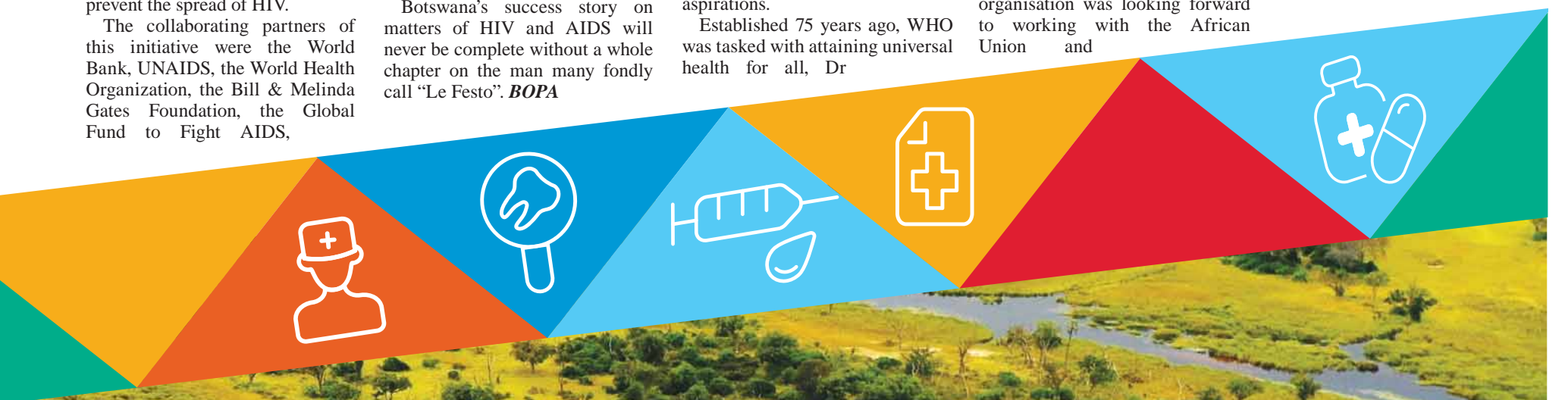
Tuberculosis and Malaria, and PEPFAR.

The Champions, highly visible leaders from all over Africa and different walks of life, helped mobilise leadership in Africa and advocate effective policies and action on HIV prevention.

As outspoken opinion-leaders, they sought to initiate a dialogue in changing behavioral and societal norms.

## Anti-money laundering conference in offing

GABORONE - The Botswana Institute of Banking and Finance (BIBF) and Financial Intelligence Agency (FIA) will co-host a conference on Anti-Money Laundering/Combating the Financing of Terrorism/Combating Financing of Proliferation (AML/CFT/CFP) to preserve the integrity of Botswana's financial system and prevent illicit financial flows.

The two-day conference will be held in Gaborone on September 21-22, under the theme, Effective Implementation of the AML/CFT/CFP Measure: A Responsibility for All.

Briefing the media on Tuesday, acting managing director of BIBF, Mr Molaodi Menyatso, said the theme underscored the importance of the participation of all stakeholders in the fight against money laundering, terrorism financing, and proliferation financing.

"The main objective of the conference is to raise awareness among AML/CFT/CFP stakeholders in the country and the public on their role in the fight against money laundering, terrorism financing, and proliferation financing," he said.

Mr Menyatso said the conference was intended to serve as a resource for policy formulation, particularly in addressing issues such as identification of current and future money laundering, terrorism financing, and proliferation financing techniques, and key areas of threats and vulnerabilities in the economy.

He said the conference

would focus on assessment of the adequacy and consistency of the AML/CFT/CFP legal, institutional, and operational frameworks.

Mr Menyatso said focus would be on policy measures and action-oriented programmes that could be adopted to effectively mitigate the risks of money laundering, terrorism financing, and proliferation financing.

He said there would be emphasis on the cooperation and coordination of public and non-public bodies in containing the risks of money laundering, terrorism financing, and proliferation financing.

Meanwhile, FIA Director of Legal and Compliance, Ms Diana Moabe, disclosed that the Eastern and Southern African Anti-Money Laundering Group (ESAAMLG) was expected to participate in the conference, and would update on the regional state of compliance to AML/CFT/CFP regulations.

Ms Moabe said ESAAMLG would also apprise on Botswana's AML/CFP/CPF compliance status.

She explained that Botswana exited the EU grey list in 2021, and emphasised the need for all parties to play their role for the country to remain compliant and stay outside the grey list.

Some of the entities that are expected to make presentations at the conference include Bank of Botswana, Real Estate Advisory Council, Gambling Authority, Non-Bank Financial Institutions Regulatory Authority, Law Society of Botswana, Registrar of Societies, and Botswana Institute Chartered Accountants. **BOPA**

## Samukuni implores church to revive role

# Moeti receives Presidential Award

GABORONE - WHO Africa director Dr Matshidiso Moeti has become the latest recipient of the Presidential Order of Meritorious Service, in recognition of her exceptional contribution to health services in the country and region.

Presenting the award on Monday during the 73<sup>rd</sup> Session of the WHO Regional Committee for Africa (RC73) Summit in Gaborone, President Dr Mokgweetsi Masisi said the award, which was in line with Botswana Honours Act, recognised Dr Moeti as an epitome of health services at a time the world was grappling with HIV/AIDS and COVID-19 pandemics.

According to her biography, Dr Moeti, a medical doctor with 41 years experience, is the first woman to be elected WHO Regional Director and is now in her second term.

Over the past seven years, she led a Transformation Agenda that is widely acknowledged to have improved WHO's performance on emergencies, enhancing accountability and driving progress towards Universal Health Coverage.

She leads WHO's support to the COVID-19 pandemic response in Africa. Under her leadership, tremendous progress has been made. Wild poliovirus was eradicated from Africa in 2020 following eradication of smallpox from the region 40 years ago.

The biography says that under Dr Moeti, investments in areas such as surveillance, training, innovation, community engagement and partnerships have improved country capacities to prepare for and respond to health emergencies and outbreaks of diseases like COVID-19 and Ebola.

More broadly, recognition of the need for strong and resilient health systems to manage external shocks, like health emergencies, is building, and most African countries are pursuing reforms to achieve Universal Health Coverage – to expand access to services with attention to equity and reaching the most vulnerable people.

Dr Moeti who has worked for WHO for more than 20 years, previously worked with the Joint United Nations Programme on HIV/AIDS (UNAIDS) as Team Leader of the Africa and Middle East Desk in Geneva between from 1997 through 1999; with the United Nations Children's Fund (UNICEF) as Regional Health Advisor for East and Southern Africa; and with Botswana's Ministry of Health as a clinician and public health specialist.

She is renowned for having led WHO's '3 by 5' Initiative in Africa at the height of the HIV/AIDS epidemic, resulting in a significant increase in access to antiretroviral therapy among people living with HIV.

This helped to shift HIV from a

death sentence to a chronic illness in Africa.

The biography says Dr Moeti is a great champion for women in leadership in global health and that she launched a partnership with the UN Volunteers programme, which recruited 100 young women from the global south as the next generation of health leaders.

In recognition of her excellent service to humanity, Dr Moeti has received accolades including membership of the United States National Academy of Medicine, an Honorary Fellowship of the Colleges of Medicine of South Africa (CMSA), an Honorary Fellowship from London School of Hygiene & Tropical Medicine, an Honorary Doctorate of Science from the University of Health and Allied Sciences in Ghana and Honoris Causa Doctorate by Instituto de Higiene e Medicina Tropical, Universidade NOVA de Lisboa, Portugal.

Dr Moeti was named COVID-19 Heroine by Ellen Johnson-Sirleaf Presidential Center for Women Development as well as featured among the Women of 2020 in the *Financial Times*.

She also received Special Recognition for African Health Leadership on COVID-19 from Amref Health Africa as well as a Global Health Equity Award from the Africa-American Institute. Dr Moeti obtained her Bachelor of Medicine and Bachelor of Surgery degree from the University of London and a Master of Science in Community Health from the London School of Hygiene and Tropical Medicine. **BOPA**

GABORONE - World Health Organisation (WHO) has committed P1.35 billion (US\$100 million) towards five priorities dubbed 5Ps: promoting, providing, protecting, powering and performing for health reform to accelerate its General Programme of Work, Triple Billion targets and related SDG's. Director general of WHO, Dr Tedros Ghebreyesus told delegates during the opening of the 73<sup>rd</sup> Session of the organisation's regional committee for Africa (AFR/RC73) here Monday that the five priorities focused on promoting health and preventing disease by addressing root causes.

"Promoting, providing and protecting health have been proposed as the three key priorities for all member states in the 13<sup>th</sup> General Programme of Work, while other two Ps; powering and performing for health are enablers of the first three", he said.

He said promotion included taking action to reduce tobacco use and harmful alcohol use, making diets healthier by reducing salt and sugar intake.

# Improved healthcare priority

GABORONE - Government is determined to achieve the health aspirations of Vision 2036, which highlight the attainment of improved healthcare services for the betterment of the citizenry, says President Dr Mokgweetsi Masisi.

Welcoming WHO director general, Dr Tedros Ghebreyesus during a courtesy call at the Office of the President on Monday, President Masisi said the country had made strides in improving its diagnostic and laboratory systems particularly in capacity building.

"It is pleasing to note that Botswana has been on an upward

trajectory in developing human capital which will yield positive results in delivering quality health services to the community," President Masisi said.

On other issues, President Masisi said global solidarity and the need to share experiences and successes in pursuit of good health and well-being of the populace were important aspects of establishing a healthy community.

In that regard, he said, Botswana would never shy away from co-investing and creating partnerships with like-minded organisations as was the case in designating the Botswana National HIV Reference Laboratory as a WHO Collaborating Centre of

Excellence.

The collaboration, he said, would recognise the laboratory's excellence in the field of HIV diagnosis, and the potential of deeper collaboration with WHO in advancing the health and well-being of people living with HIV.

President Masisi also said it was commendable for Botswana to have achieved the 'silver tier' status which moved the country closer to eliminating Mother-to-Child HIV (MTCT) transmission.

WHO awards the status to countries which have brought MTCT rate to under five per cent. "Such achievements are testament that government is making significant progress in the fight against HIV and AIDS, and I am cognisant [of the fact] that the support from the global fund will make the achievement sustainable," President Masisi said.

To further emphasise government's commitment towards improving the healthcare sector, President Masisi hailed the country's aspirations to house CTL Amedica Africa headquarters, saying it would position the country as a global leader in spine technology as well as improve the socio-economic development and the livelihoods of Batswana.

CTL Amedica is a medical device designer, developer and manufacturer of spinal fusion and fixation products, including innovative surface technologies and exclusive biomaterials.

For his part, Dr Ghebreyesus applauded Botswana for milestones achieved, particularly in the fight against HIV and AIDS.

He said the country was a living testament of how to deal with a pandemic.

He also commended government for facilitating the hosting of the 73<sup>rd</sup> Session of the WHO Regional Committee for Africa. **BOPA**

# WHO commits US\$100 million to 5Ps

Dr Ghebreyesus welcomed the regional multisectoral strategy to promote health and well-being and its framework for implementing the global alcohol action plan.

He congratulated Sierra Leone for passing a comprehensive tobacco control law and Kenya, which moved more than 2 000 tobacco farmers to alternative livelihoods.

The WHO director general also commended eSwatini for finalising its road safety strategy, while Ethiopia, Ghana, Niger, Nigeria and Zambia received accolades for joining the Coalition of Action for Healthy Diets from Sustainable Food Systems. He said across the region, hundreds of millions of people lacked access to essential health services, or were pushed into poverty by catastrophic out-of-pocket spending, hence the need for every member state to prioritise closing the gaps.

He said maternal and child health also remained a major challenge in the continent, adding two-thirds of all maternal deaths occurred in Africa, with the latest estimates indicating that the maternal mortality ratio in the region was

more than seven times higher than the SDG target.

On the positives, he said more than 1.5 million children had received the RTSS malaria vaccine, resulting in a 30 per cent reduction in hospitalisation due to severe malaria, and a 10 per cent drop in mortality among vaccine-eligible children. In the past year, he said, seven countries eliminated at least one neglected tropical disease.

"I am pleased to note that HPV coverage in the region increased from 26 per cent in 2021 to 33 per cent this year," he said.

Dr Ghebreyesus said progress had been made towards improved access to essential medical products and strengthened regulatory systems. He noted that 26 African Union member states had ratified the Africa Medicines Agency Treaty, and urged the remaining countries to follow suit.

He said powering health meant harnessing the power of science, research and development, data and digital technologies, pointing out that digital technology, including artificial intelligence, held great promise for improving health.

"The WHO Global Strategy on

Digital Health advocates people-centred, evidence-based, and inclusive solutions that empower patients and support countries on the path to universal health coverage," he said.

He further said that two weeks back, WHO launched the Global Initiative on Digital Health, for coherent global standards, best practices and resources for digital health transformation, rooted in people-centred and evidence-based solutions. Dr Ghebreyesus said one of the key focuses for the remainder of his second term was to strengthen country offices, noting that P1.35 billion had been channeled towards that. Dr Ghebreyesus urged all member states to take decisive action to provide health, by reorienting their health systems towards primary health as the foundation of universal health coverage.

"I ask you to work with us on the 'Big Catch Up', to close gaps in immunisation coverage and reduce the unacceptably high burden of maternal mortality by expanding access to services for sexual and reproductive health," he said. **BOPA**



# Climate change affects health systems

GABORONE - World Health Organisation (WHO) member states have been urged to act urgently and decisively to address the impact of climate crisis on health as it was creating a major strain on health services.

Speaking during the 73<sup>rd</sup> session of WHO Regional Committee in Gaborone yesterday, the organisation's regional director for Africa, Dr Matshidiso Moeti made an urgent call for global climate action to create resilient and sustainable health systems.

Dr Moeti said the world had watched Europe literally burning during the past few months. "Here in our region, prolonged drought in the Sahel and greater Horn of Africa and cyclones in southern Africa have increased morbidity, mortality, and human suffering."

She indicated that last May, on the margins of the World Health Assembly, with governments and other partners, WHO launched a regional initiative to tackle the health impacts of climate change on the continent and therefore made a call for climate action.

She said Africa had been witnessing increasing trends of climate-linked emergencies, saying out of almost 2 000 public health events recorded in the region

between 2001 and 2021, 56 per cent were climate change related.

She said climate crisis threatened to undo the last 50 years of progress in development, global health, and poverty reduction.

Sharing some of WHO observations from disease surveillance initiatives on trends in climate-related events, and persistent challenges facing Africa, Dr Moeti highlighted some policy initiatives that WHO was currently involved in to address the climate-health crisis.

She pointed out that Africa was witnessing various extreme weather events, including droughts, floods, hurricanes, and heatwaves – which harmed human health, adding that the recent climatic events had devastated the lives of millions of people across Africa.

She said in southern Africa, this year's cyclone season caused extensive flooding and damage, therefore raised the risk of water-borne diseases, worsening cholera outbreaks in several countries.

"Across the greater Horn of Africa, a prolonged drought continues to claim lives; it has displaced millions and pushed them to the brink of famine amid widespread malnutrition," she said.

She stated that in West Africa, climate change intermingled with political tensions, violent conflicts,

and complex humanitarian emergencies that must be addressed with integrated responses.

She highlighted that across the continent, climate change was driving increased vector and water-borne disease transmissions, pointing out that from the 1950s to the decade between 2012 and 2021, the number of months suitable for malaria transmission increased by 13.8 per cent in the highland areas of Africa, and the likelihood of dengue fever transmission rose by 12.0 per cent.

She indicated that climate change had also promoted an unprecedented surge in cholera outbreaks in Africa and globally.

"Many African countries that reported cholera outbreaks in 2022 experienced natural disasters like cyclones in Mozambique and Malawi, flooding in Nigeria, and drought in countries that make up the greater horn of Africa," she said.

She pointed out that displacements, natural disasters, and conflicts over natural resources came in as added concerns, as they exposed women and girls to higher risks of sexual violence, exploitation, abuse, and trafficking, leaving psychological stress, anxiety and depression in their wake.

She urged governments to

strengthen their links and use the output of WHO analysis for effective interventions, and encouraged them to embrace a health-centred response to climate change, so as to tackle the diverse array of health repercussions stemming from the climate change crisis and to safeguard public health and secure a sustainable future for generations to come.

Dr Moeti stated that WHO would support member states in conducting vulnerability and adaptation assessments, developing national health adaptation plans, assessing the carbon footprint of health systems, and planning for decarbonisation. **BOPA**

## Botswana commits to supporting AMR Strategy

GABORONE - Botswana commits to be part of and fully support the proposed Regional Strategy for expediting the implementation and monitoring of the National Action Plan on the Anti-Microbial Resistance (AMR) for the year 2023-2030 in the World Health Organisation (WHO) Africa Region.

The AMR strategy was adopted yesterday by the Ministers of Health and other health representatives from different African countries during the 73<sup>rd</sup> session of WHO Regional Committee for Africa (RC73) session in Gaborone yesterday.

The strategy was set to enable countries to strengthen health systems, find ways to tackle AMR related challenges and pave way for sustainable solutions to global threats.

It was also intended to facilitate collaboration among African countries, share best practices and innovative solutions.

Key priority interventions of the strategy were to raise awareness and disseminate information, build knowledge and evidence on AMR, make efforts to reduce the incidence of new infections and optimise the use of antimicrobials, among others.

In his presentation when adopting the strategy, the director of Public Health in Botswana, Mr Samuel Kolane said the country had embarked on a multi-sectoral approach to combat the emergence of antimicrobial resistance.

He said efforts to support and commit to the AMR strategy, a comprehensive National Action

Plan (NAP) was established to contain common bacterial infections, HIV and AIDS, Malaria and Multi-Drug-Resistance (MDR) Tuberculosis among others.

"Botswana commits to be part of the regional AMR strategy which aims to guide member states efforts to curb AMR challenges and continue to apply key interventions to enhance the NAP implementation in line with the One Health Approach."

Mr Kolane said national governance structures were set up and some technical groups had also been formed to support the strategy.

He said the multi-sectoral approach also provided a framework for countries in the region to work collectively towards a common goal of tackling issues of AMR matters.

Mr Kolane further appreciated the progress made by different member states in contributing towards the development of the National Action Plan (NAP) on AMR.

He said through the AMR attributable morbidity and mortality in the African region and the daunting possibility of countries across the region, efforts made by some African states in addressing the AMR challenges would make a difference.

"The progress made by some member states in finding solutions to the AMR challenges is notable and evidenced by a high number of African countries (45) endorsed by national authorities and contributing towards the development of National Action Plan on Antimicrobial Resistance," he said. **BOPA**

## Human capital government's priority - Minister Serame

GABORONE - Human capital development remains a key policy priority for the government, hence the health sector has been allocated the largest share in terms of development spending.

Minister of Finance, Ms Peggy Serame said during a panel discussion on financing for malaria at a side meeting at the ongoing 73<sup>rd</sup> session of WHO Regional Committee for Africa (RC73) session in Gaborone yesterday.

"Within health sector spending, the elimination of malaria remains an important national health agenda for Botswana as supported by a strong political will at the highest level and the availability of domestic and external financing," she said.

Ms Serame said in the past five years, the budget for malaria had increased by 28 per cent representing about 0.3 per cent of the total funds allocated to the Ministry of Health during the same period.

"This level of expenditure somewhat reflects our success towards eliminating malaria in Botswana," she said.

She further stated that government efforts were complemented by technical

and financial support from strategic bilateral and multilateral partnerships from organisations such as WHO.

"Such partnerships have strengthened our efforts of ensuring that output is commensurate with the resources allocated," she said.

Meanwhile, eSwatini End Malaria Fund chairperson, Ms Thandile Nxumalo said African countries needed a multi-sectoral approach to eliminate malaria.

"We need more public-private partnerships in order to advocate for more funding towards the eradication of malaria," she said.

She said with eSwatini on the verge of malaria elimination, King Mswati III launched the first-ever national End Malaria Fund in May 2019 to close over P74m funding gap and achieve the country's vision of eliminating local transmission of malaria by the end of 2022.

Ms Nxumalo said as a result, the country had achieved commendable progress in driving action and accountability from government, the private sector and civil society leaders, as well as increased funding and engagement from local communities.

"The idea was for every sector to take ownership over the fight the end malaria.

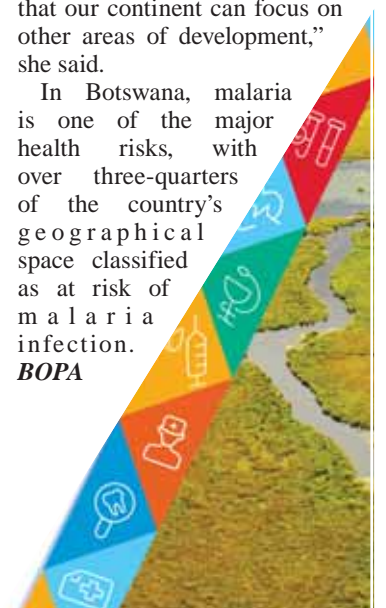
According to the latest WHO World Malaria Report, eSwatini recorded 268 cases and zero deaths from malaria in 2018 and is now classified as ready for malaria elimination," she stated.

For her part, African Leaders Malaria Alliance, Ms Joy Phumaphi stated that it was up to all African countries to assume the responsibility of eradicating malaria in the region.

"We need to implement data-informed strategies for tailored interventions to ending malaria so that our continent can focus on other areas of development," she said.

In Botswana, malaria is one of the major health risks, with over three-quarters of the country's geographical space classified as at risk of malaria infection.

He said the free Internet connectivity in dikgotla should not be abused but put to good use.

He applauded government for developments and urged residents to continue to ensure developments were a success. **BOPA**

# Men Speak Out conference successful

GABORONE - Social worker, radio personality and television presenter, Ms Lesego Bile says men should introspect and understand their emotional wellness in order for them to make informed decisions.

She said this at a one day conference themed Man Speak Out in Gaborone on Saturday.

He said it was important that men should tell their own stories, hence the need of this conference.

“Through this conference, we have learnt and understood and appreciated that

most men go through a lot.

He urged the public not to generalised men as abusers, instead he said, “we should appreciate where they coming from.”

Meanwhile Ms Shelly Apes, Motivational Speaker, GBV activist, author and mental health activist also said that the conference would enable and empower men to speak out in every situations that they found

themselves in.

“Botswana needs men who can speak out when they need help,” she said. ## Company vows to improve education facilities

GOOTAU - Vultures are crucial to the ecosystem but face a myriad of challenges including poisoning and disturbance at

breeding sites.

Director of wildlife and national parks, Dr Kabelo Senyatso said recently at Gootau at the official handing over of the Batho le Ditsatholego Conservation Trust.

He urged community members to own the project intended to conserve Cape vultures as well as conservation and sustainable rural livelihoods improvement.

The project will run for the next two years and was funded to the tune of P570 000 by Global Environment Facility (GEF) small grants and facilitated by the United Nations Development Programme (UNDP).

Dr Senyatso said government interventions were not sufficient to address all the threats facing vultures and that civil societies such as Batho le Ditsatholego Conservation Trust were crucial.

He encouraged the conservation trust to own the project and implement it diligently. In addition to saving vultures, he said the projects were also meant to boost local economies and create sustainable jobs for vulnerable groups such as women, youth and people living with disabilities.

He said sustainability was key in projects supported through the environment facility as sustainable development was the cornerstone of the Transitional National Development Plan and Vision 2036.

Dr Seyatso said the global environment facility was one of the initiatives that government, through the Ministry of Environment and Tourism, was implementing with support from the UNDP.

He said the launch of the grant marked a significant milestone for his ministry and UNDP as the first vulture conservation project in Botswana.

Further, he said Batho le Ditsatholego responded to the call for proposals aimed at addressing climate change mitigation and adaptation, biodiversity conservation and sustainable land management for

improved livelihoods that was advertised in local media and UNDP.

He said the global facility was aligned and contributed to the attainment of aspirations and visions at both the global, regional and national levels.

Since inception in 1992 the global environment facility programme has supported government in environmental conservation as well as driving the sustainable development agenda through supporting community led projects with the potential for up-scaling and replication by government and other partners.

Dr Senyatso said it was apparent that the rate of natural resource exploitation and the use of the physical environment would soon reach the threshold for our existence on planet earth.

He said scientific evidence showed that the natural resource stocks were being depleted at increasing rates and that the natural capital has diminished in quality and quantity.


He added that the increasing loss of biological diversity, land degradation, desertification, water stress, food insecurity, health pandemics and natural disasters had become regular concerns.

He said climate change threatened the sustainability of livelihoods and that poverty continued to overwhelm developments efforts.

He said it was critical than ever for humanity to pay more attention to getting the balance right between what was economically feasible, socially desirable and environmentally sustainable.

He said it was for that reason that they wanted to see initiatives funded contributing to protection and conservation of biodiversity and natural resources.

The founder of Batho Le Ditsatholego Conservation Trust, Mr Sentle Mosweu appealed to Gootau, Maledi and Goosekgweng residents to support the trust. **BOPA**

## Leather business thrives in Botswana

**PALAPYE** - In the vast landscapes of Botswana, where the cattle population is estimated at over 2.1 million and raw hides and skins are abundant, one small business owner has discovered a niche in the market in producing finished leather products.

Based in Palapye, Dineo Gobatilwe, a 34-year-old mother of two, operates a leather works company named Dinny Leather Works that produces goods such as school shoes, sandals, belts, hats and leather frames.

In 2014, the company was created with government financial support of about US\$7 504 (P98 000).

Gobatilwe has since bought equipment from China and deployed the machinery for manufacturing.

In an interview with *Xinhua*, Gobatilwe said she chose to pursue leather works after noticing a gap in the leather industry.

"I wanted to be unique because only Pilane Leatherworks and the Basarwa were involved in making traditional leather products, so I decided to combine Pilane and Basarwa skills to make modern products," she said.

To make better products, Gobatilwe uses vegetable-tanned leather, which is known for its natural feel, sweet scent, patina over time, and toughness.

And she picks the right leather without cracks.

"That's why my products look quality and last longer." Gobatilwe studied fashion design in Limkokwing University, which has a presence across Africa, Europe, and Asia.

Her company, which has three workers, is able to sustain itself through a partnership with Palapye District Council, where she provides more than 500 pairs of shoes to orphans and underprivileged students in the Palapye region and surrounding areas.

While the local market is promising, Gobatilwe already has her sights set on the international market. "I've had the opportunity to go to Dubai to exhibit my products.

I also work with the Botswana Investment and Trade Centre and participated in their workshop," she said.

Her firm also received support from the Visual Arts Office with the Ministry of Youth, Gender, Sports and Culture.

However, Gobatilwe said, running a leather company in Botswana was not without difficulties.

Even though the country produces about 300 000 hides each year, it does not have the means to process its hides into

fine leather.

Botswana sells 50 per cent of its raw hides and 100 per cent of its raw skins, with half of the hides treated to wet-blue (moist chrome-tanned leather), according to Botswana Meat Commission.

Despite the difficulties, Gobatilwe has capitalised on the tremendous opportunity given by the local cattle and leather industries and helped to contribute to Botswana's economy by seizing the potential in both local and export markets. *Xinhua*

## Former US president trial set for March

**WASHINGTON DC** - A US federal judge on Monday set March 4, 2024 for former President Donald Trump's trial on charges of attempting to overturn the 2020 election.

That is one day before 'Super Tuesday' a potentially decisive date in the Republican presidential nominating contest, when more than a dozen states, from California to Texas, will pick the party's candidate for the 2024 election.

In a hearing on Monday, US District Judge Tanya Chutkan rejected trial dates proposed by both the Justice Department and Trump's legal team.

Earlier, special counsel Jack Smith had asked for Trump's trial to begin on Jan. 2, 2024, while the former president's lawyers had asked for a trial date in April 2026.

"I want to note here that setting a trial date does not depend and should not depend on the defendant's personal or professional obligations,"

Chutkan said.

Trump is the first former US president to face criminal charges.

He has been indicted in four cases, two by the Justice Department and two by state prosecutors in New York and Georgia, separately.

The federal election subversion prosecution is one of four criminal cases against him.

A New York judge has set the trial date of March 25 for the criminal case against the former president surrounding the hush money payments to an adult film star.

In Florida, the trial on charges that Trump mishandled classified documents after leaving office has been set for May 2024.

The federal judge's latest decision could have a crucial impact on Trump's bid for recapturing the White House as well as the Republican presidential nominating calendar. *Xinhua*

# Chinese doctor helps old farmer walk again

**MATSITAMA** - Living in Matsitama in eastern Botswana, 78-year-old Ketsetletse Mosi staggered on the road after he undertook surgery 20 days ago.

He said it was a Chinese doctor who helped him walk again.

Mosi was rounding up goats on a chilly evening early this month when he fell on the ground and broke his hip. "Little did I know that the injury was serious because I struggled to wake up the following morning," he said.

He was later sent to Nyangabgwe Referral Hospital in Francistown, where a group of Chinese doctors work.

After arriving at the hospital, Mosi said he was received by Lyu Peimin, a Chinese doctor, whose hands are 'safe and warm'.

Lyu is a member of the 16<sup>th</sup> Chinese medical team to Botswana.

Over the past four decades, a total of 16 batches of more than 500 Chinese medical members have come to the country, delivering medical services to local people.

They have performed more than 130 000 surgeries and treated more than 2.8 million patients since 1980s, winning praise from the government and the people.

Lyu referred Mosi to a computerised tomography

scan and tried to comfort him by saying that the pain he was feeling would disappear.

"He then studied the scan and took me to an operating theatre to perform an implant of the broken hip bone," said Mosi.

Since then, Lyu started teaching Mosi to walk, and the old man made excellent progress with the Chinese doctor's help.

Mosi said many people could not believe that he was able to walk again.

"This Chinese doctor is very important. I wish he will remain working here in Botswana forever," Mosi said.

Kobamelo Motshidisi, clinical manager at Nyangabgwe Referral Hospital, said the contribution of the Chinese doctors had been affirmed by the local people.

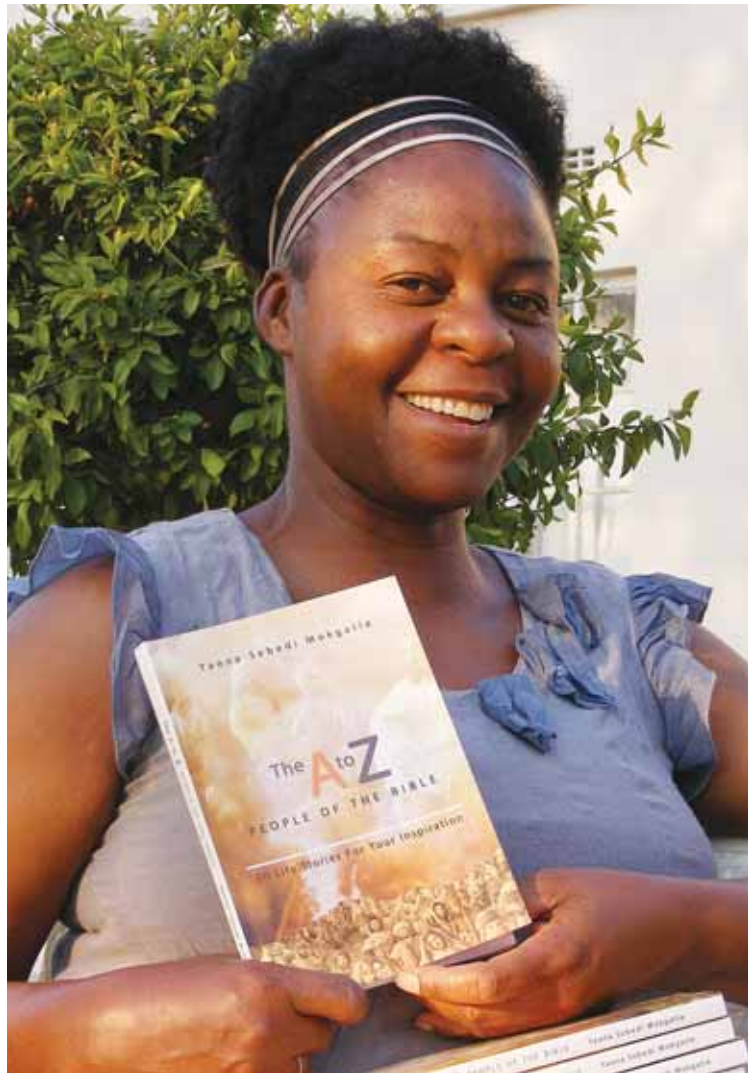
"In the past, patients at this hospital with similar injuries would spend months and months in the health facility," he said, adding that 'some of the patients with similar injuries would never walk again.'

Some people chose to seek treatment in South Africa, however, at a heavy cost, as Botswana does not have sufficient medical staff, he said.

After the Chinese doctors came to the country, 'we could perform complex surgeries at Nyangabgwe Referral Hospital,' said Motshidisi. *Xinhua*

**MAUN** - The high rate of unemployment amongst young people has propelled Thabari Yarae of Khwai and Elifase Lethusang of Rakops to discover and nurture their hidden talent as well as to exploit it to earn a living.

While many youths are struggling to secure jobs and end up indulging in drug and substance abuse and other social ills, the duo, who are devoted Christians and passionate about singing, turned their hobbies into an opportunity to beat poverty and unemployment.

Together with two members of their church, they formed a gospel group, Dikonyana tsa Morena, to drive a positive social change amongst fellow youths and to make ends meet.

"Everyone is born with a set of special talent that can be a source of income and employment for themselves and others. Young people have great talent but it is not tapped while some think success in arts is through the government," said Yarae in an interview.

He is of the view that identifying things that one loves and that is good at is a great way to unearth potential passion indicating that many have

neglected their naturally God-given talents, which they could nurture, develop and eventually turn into careers and increase employment opportunities.

Yarae said if young people could embrace the mindset change concept and focus on their talents, they could have fulfilling careers.

He revealed that after completing vocational training, together with other group members, they focused on their talents because they knew that there are multiple benefits when one focuses on what they love. "We managed to produce our first gospel album dubbed *Corona* in 2019, which aimed at promoting messages on safety and precaution measures as well as to give hope that the pandemic will pass if people focus their eyes unto the Lord," he added.

Surprisingly, he said, the album did exceptionally well in the market even though movement was limited. He attributed the album success to technology which resulted in the album selling like hot cakes.

For his part, Lethusang concurred that there were a handful of available jobs in the market all which were chased by a huge number of competent job seekers, adding that unemployment could lead to

depression, anxiety hence they saw it fit to discover their talents, nurtured it and eventually turned it into a career.

Although, he said it could be incredibly difficult to achieve one's dream, it required determination, perseverance and change of attitude.

Young people, he said, must embrace the mindset change initiative, which he described as

a wake up call for all to dream big and exploit their gifts for their benefit and of the country.

"All we have to do is to change our attitudes and do things differently. We should not be concerned if what we love is not practical or common as talent can be simply a clue," he added. Lethusang said their group was a testimony that utilising talents could beat unemployment and

poverty amongst youths.

He said they had completed their second album *Jeso ke Mmoloki*, comprising six hits which all carry joyful melodies that promote a spirit of hope, faith as well as to create an atmosphere of worship.

The songs, he said, call on people to change their minds and seek the face of God while there was still time.

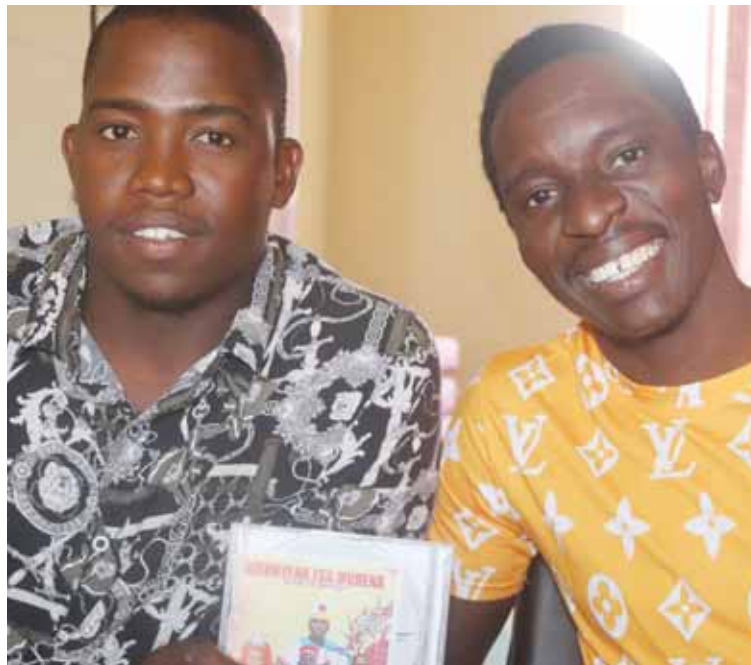
He also noted that currently preparations were underway to launch the album before end of the year.

# Tebogo to miss Zurich Diamond League

GABORONE - Botswana's sprint sensation, Letsile Tebogo, will miss the Zurich Diamond League meeting tomorrow due to a grade 1 hamstring strain.

According to his coach, Kebonyemodisa Mosimanyane, the athlete sustained the injury while they were preparing for the 200 metres competition in Budapest, Hungary.

"Just from the heat, he went into the semis with that pain and he lined up in the finals where he

finished in position three with that pain," he explained.

The coach said the scan results indicated that Tebogo sustained a grade 1 hamstring strain.

"Therefore, we won't be able to take part in any other Diamond League meeting expect the 100 metres final. For now, we are still waiting to see if we have qualified," he said.

Furthermore, he said they would now focus on recovery, which he said was more important in terms of preparations for the Paris 2024 Olympics.

Mosimanyane further said the injury was not career threatening, adding that they wanted it to be attended so that it was not aggravated.

He said if not attended properly and timely, it could end up being chronic, hence they took a deliberate decision to pull him out of the 4x400 metres relay at the World Championships and some Diamond League competitions.

The coach said Tebogo would only be ready to compete once the doctors had dealt with his injury.

The world was looking forward

to the World Championships 200 metres final repeat and also to see if Noah Lyles would continue to dominate the track, or if Tebogo would end his dominance.

The Zurich start list is made up of Americans World Championships champion, Lyles, silver medallist Erriyon Knighton and Kenneth Bednarek, Canadians Andre De Grasse and Aaron Brown.

There is also Zhanel Hughes from Great Britain and Swiss William Reais.

Meanwhile, according to research on the Internet, mild hamstring strains (grade 1) will usually cause sudden pain and tenderness at the back of the thigh.

It may be painful to move the leg, but the strength of the muscle should not be affected.

Partial hamstring tears (grade 2) are usually more painful and tender.

The expected recovery period is usually estimated between three and eight weeks with diligent home therapy. **BOPA**

"Today, marks a significant milestone in our ongoing efforts to uplift education, promote health and wellness and foster a stronger sense of community in our beloved country," he said.

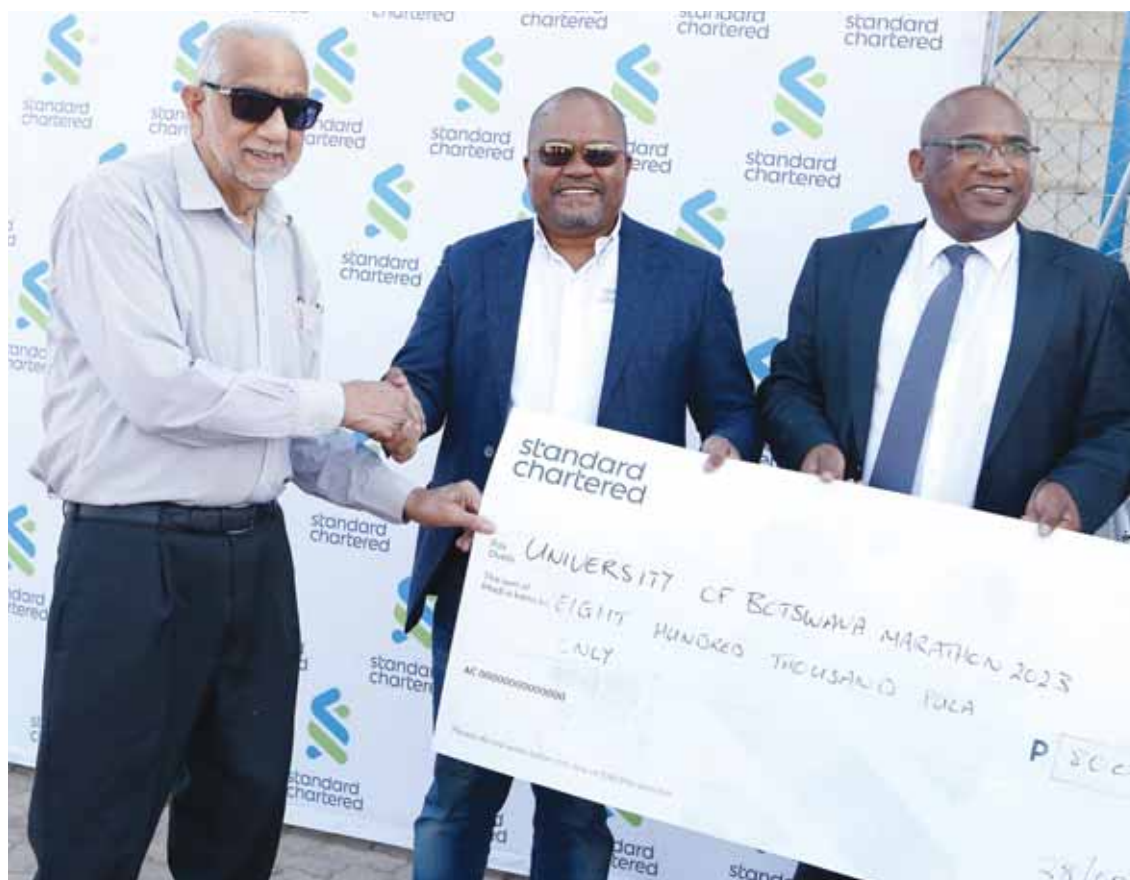

# Race tickets for 2024 F1 Australian GP sold out

SYDNEY - The ticket allocation for Sunday Grandstand and Park Pass to the Formula One Australian Grand Prix 2024 was exhausted within two hours after the official release on Tuesday.

According to a statement by the Australian Grand Prix Corporation, the ticket allocation for Sunday Grandstand and Park Pass as well as Saturday Grandstand were exhausted in less than two hours.

The organisers confirmed that over 100 000 people pre-registered for early access to tickets to next year's Australian Grand Prix, which made the race the biggest pre-registration for a sporting event nationally in Ticketmaster Australia's history.

The 2023 edition saw an estimated attendance of 444 631 over the four days, eclipsing the previous record of 419 114 set in 2022.

The total estimated attendances

on both Friday and Saturday were the highest day two and day three numbers since the first Melbourne race in 1996.

"The past two F1 Australian Grands Prix have broken Melbourne attendance records and next year's race is set to be bigger than ever," said Steve Dimopoulos, Victorian minister for tourism, sport, and major events.

Australian Grand Prix Corporation CEO Travis Auld noted that limited tickets for Thursday, Friday and Saturday were still available.

"The record-breaking number of pre-registrations and the rate of today's sales demonstrate that fans are just as excited as us for next year's F1 event in Melbourne," said Auld.

The F1 Australian Grand Prix 2024 will come back to Albert Park in Melbourne from March 21 to 24, 2024. **Xinhua**
