### Water Utilities Corporation to roll out smart meters

#### FRANCISTOWN

Water Utilities Corporation (WUC) is in the process of rolling out smart meters to the general public.

The initiative is aimed at modernising the country's water distribution system.

Addressing a kgotla meeting in Somerset Extension kgotla on Monday, Francistown South Member of Parliament, Mr Wynter Mmolotsi said the programme would address the many concerns that hadbeen raised by many Batswana, chiefly high water bills.

He said through the initiative the corporation would install smart meters to provide real time data on water usage and leaks. The meters will also allow for remote metre reading and bill payment.

"Hopefully this will not only improve water conservation and efficiency, but also address the issue of high water bills across the country," he said, adding that such was an innovative and potentially transformative programme for Botswana's water sector.

The MP also briefed residents on proposed constitutional changes, such as the direct election of the president, the increase of specially elected Members of Parliament from six to 10, reinstatement of corporal punishment in schools, the death penalty, the legalisation of commercial sex work, as well as the appointment of the Independent Electoral Commission (IEC) secretary by the president, amongst others.

He said the proposed constitutional amendment changes would be discussed in the next parliamentary session. MP Mmolotsi said a lot of Batswana had proposed for the direct election of the president, but Cabinet resolved that the status quo remain.

He said constitutional amendment review report also proposed that corporal punishment be reinstated in schools, which Cabinet supported. He said the status quo regarding the death penalty remained, and the commission suggested a national referendum so that Batswana could air their views.

In their comments, residents said the constitutional review commission had given the president too much powers. One resident, Ms Keneilwe Siska said concentration of power could lead to abuse and corruption, and it would limit the ability of other branches of government to hold the president accountable.

She said it was important to give the president authority to govern effectively, while also ensuring adequate checks and balances were in place. She supported the suggestion that corporal punishment be re-introduced in schools, saying indiscipline among school children was a concern.

She also called for legalisation of commercial sex work, to help alleviate poverty in some families, a suggestions that other residents opposed.

Another resident, Ms Sophie Galegake also supported the reinstatement of the corporal punishment in schools, adding that it was important to identify the root cause of bad behaviour and find effective ways to address it.

Mr Ezekiel Mfananyana rejected the proposal to increase specially elected MPs, saying such MPs in the past played a crucial role in parliament because they brought in special skills and expertise which were now possessed by many elected members of parliament.

He said even the six was too many and a waste of government

resources, noting that they were also given constituency allowance when they did not have constituencies.

In response to some of the issues raised by the residents. MP Mmolotsi said it was true that initial purpose of specially elected members of parliament was to bring certain skills and expertise into parliament that might not otherwise be represented.

He was of the view that increasing their number might not necessarily achieve the intended goal. He said some MPs argued that the system was outdated and no longer served its intended purpose.

He also said the constitutional review commission proposed that the president should also enjoy a constituency allowance of P232 000 000 per annum. BOPA

# **Summits present opportunities**

**KAMPALA** - President Dr Mokgweetsi Masisi is expected to attend the 19<sup>th</sup> summit of the Non-Aligned Movement (NAM) and the third South Summit of Group 77 and China in Kampala, Uganda, this week.

Speaking on the sidelines of the senior officials meeting yesterday, acting permanent secretary in the Ministry of Foreign Affairs, Mr Clifford Maribe said the two high level engagements provided Botswana with another opportunity to attract investment from a larger and wider community of international actors.

"NAM is a useful platform as it provides us with opportunities to meet with other countries, discuss and take position on global issues. We discuss, among others, global challenges such as peace and security, and where they feel threatened we come together as countries to discuss and come with resolutions," he said.

Mr Maribe said NAM was formed to promote multilateralism, peace and security. He said challenges facing the movement included the reform of the United Nations Security Council and the Middle-East conflict.

He said the senior officials

meeting and the ministers meetings were preparatory sessions for the summit, which would be attended by over 50 heads of state.

Mr Maribe said the NAM summit would transit to the G77+China summit, and that it was a platform that provided countries with an opportunity to discuss global issues.

He explained that Botswana's foreign policy was anchored on multilateralism and that the country needed to work with others to open opportunities for trade.

He added that President Masisi came up with the Reset Agenda and that it was focused on among others, production of goods and services and adding value to the country's natural resources to generate more revenue to develop the country.

Mr Maribe also said Botswana needed friends to trade with and to get foreign direct investment.

He said NAM provided such an opportunity.

He noted that Uganda would assume the chairmanship of NAM for three years and that of the G77+China for one year.

NAM was founded in 1961 at the height of the Cold War between the West and East global blocs.

It has a membership of 120

countries and Botswana joined in 1970.

Mr Maribe said the G77+China summit would be held under the theme: Leaving No One Behind, and that the summit brought together developing countries that were members of the United Nations.

He said the two summits

would also boost cooperation in trade, investment, sustainable development, climate change, poverty eradication and the digital economy. *BOPA*

### Over 200 000 register in two weeks

**GABORONE** -Over 200 000 people registered in the first two weeks of the national voter registration exercise.

The Independent Electoral Commission (IEC)'s update on Monday showed that 130 157 new voters registered in the second week, as compared to 75 566 in the first week , bringing the total number of registered voters to 205 723.

According to the update, Good Hope/Mmathethe and Nkange constituencies had the highest number of registered voters with 7 715 and 7 584 respectively between January 5 and 12.

"Tswapong North and Tswapong South also recorded significant numbers, with 6 451 and 6 681 voters respectively."

However, several other constituencies had less than 4 000 registered voters, with Chobe, Maun West, Francistown East, Mogoditshane East and Takatokwane having less than 2 000 registrations for the two weeks period. In an interview, IEC Chief Public Relations Officer, Mr Osupile Maroba said the ongoing registration was progressing well except for few minor challenges such as some registration clerks reporting late for duty and others pulling out, adding that the commission was addressing such challenges.

He also expressed hope that the number of people registering to vote would increase as the registration deadline approached.

The IEC aims to register as many eligible voters as possible from the more than 1.7 million eligible Batswana as per the Department of Civil and National Registration records.

The exercise, which started on January 5 will end February 3. *BOPA*

# **Board gears for debt collection drive**

**MOCHUDI** - Kgatleng Land Board plans to launch a massive P20 million debt collection drive owed in lease arrears, says the land board chairperson, Mr Mothusi Molefi.

The arrears, he said, were owed by companies and individuals who had been allocated business plots or land and were expected to pay annual lease rentals.

Speaking during the land board's meeting on Monday, he said they would notify debtors with deadline dates to settle their arrears.

He also said they would conduct house-to-house campaigns and business premises for collections.

Furthermore, he said they would do all it took to simplify paying methods as well as to activate social media advertisements that encouraged defaulters to pay and the importance of paying for leases.

"We will go all out to work on the modalities of making people to pay and to keep on following the debtors until they settled their bills," he stressed.

Mr Molefi also appealed to board members to expedite the 193 appeals and deferred land transfers that were before the land board.

He regretted that they failed to reach the set target of allocating 3 719 plots in the 2023/24 financial year which had been set for land boards to achieve 100 000 plot allocations.

"As at 2023/24 we are at zero. How do we reach this set target by end of April?" he asked.

Mr Molefi also called land

board members and staff to manage customer queries and to improve relations with members of the community.

"We should serve our clients with utmost 'botho' and always put them first," he said.

Mr Molefi also briefed land board members on the slow progress in dispensing secure land title certificates to residents across the four Kgatleng sub land boards.

He noted that Artesia Sub Land Board had distributed 665 certificates, Mmathubudukwane zero while Oodi and Mochudi distributed 26 and 63 respectively.

For her part, Kgatleng district commissioner, Ms Kolobetso Sejakgomo encouraged land board members to work on reforms or customer focused strategies that would turn around the tarnished image of the land board.

said her office was She inundated with queries from members of the community who complained about the laisse faire attitude of some officials when serving them.

District Council Kgatleng chairperson, Mr Daniel Molokwe also encouraged land board members to mend their relationship with the community and to liaise with other district authorities about their challenges so that there was support.

### Fate awaits murder convict as CoA sets to deliver judgement February 23

GABORONE -The Court of Appeal is set to deliver judgment on February 23 regarding the fate of murder convict, Moses Kanika, who is appealing the death sentence issued by the Francistown High Court.

Kanika, through his lawyer, Mr. Reneetswe Rabosotho, expressed no objections to the conviction. He was sentenced to death in 2021 by the Francistown High Court for the murder of his exgirlfriend, Palalani Tafila, in June 2016. The autopsy report presented during the judgment indicated that Kanika had stabbed Tafila 12 times in the chest and breasts.

Mr Rabosotho argued that the trial judge had failed to properly consider the extenuating factors presented.

He pointed out that Kanika was intoxicated at the time of the offense, and that there was no evidence of premeditation.

"We are convinced that the trial judge did not fully consider the absence of premeditation and intoxication. We have filed our arguments to support our appeal," he stated.

Mr Rabosotho further argued that if the high court had considered these factors, it would have reduced the moral culpability of his client. "Failure to consider these factors heavily influenced the sentencing," he added.

He emphasised the importance of fair trials that take into account all relevant factors while also acknowledging the need for the courts to protect society.

On the other hand, Mr. Moatlhodi Macheng, representing the Directorate of Public Prosecution, contended that the Court of Appeal should only intervene if the lower court had made errors in its sentencing, which he argued was not the case here.

Although the trial judge did not extensively address the presence or absence of premeditation, Macheng noted that the evidence in the case suggested premeditation.

However, Justice Johan Froneman of the Court of Appeal raised questions. He inquired whether the convict's attempted suicide nine days after the incident indicated remorse, potentially suggesting that he had no intention to kill.

Additionally, he questioned whether the offense could have occurred after a family meeting, where it was resolved that Kanika should end his relationship with the deceased if it was premeditated. BOPA

On Monday, Seretse's lawyer, Mr Kgosietsile Ngakayagae, argued before a three-panel of the Court of Appeal judges that the properties were acquired from his client's other sources of income. As such, he said the case against his client was unduly judged by the High Court Judge, Justice Omphitlhetse Motumise as he relied on hearsay evidence.

"This case fails the very most basic hearsay rule.

You cannot make judicial findings on non-admissible evidence," Mr Ngakayagae said. In 2021, Justice Motumise ruled against Mr Seretse and his company, Basis Point (Pty) Ltd that the properties in question amongst them, houses and top-

and Rolex date just 41 watches, among others.

"It is denied that they are proceeds of crime. The state has failed to show evidence of how the said properties are related to crime," Mr Ngakayagae said.

He said Justice Motumise's judgement relied on the state hearsay evidence, which was inadmissible, adding that such information was not even authenticated by its originating sources.

However, the state attorney, Mr Dumisani Marapo from the Directorate of Public Prosecutions (DPP) said Mr Seretse and one Mr Kenneth Kerekang without being sanctioned by the Fund moved P60 million from the NPF

moved from the NPF account, the money was used for personal gains by the two and hence the state had demonstrated that the properties in question were proceeds of crime.

"If the court finds that the P60 million was tainted, then anything that comes out of the P60 million follow suit," he said. He also stated that the documents before the court were procedurally submitted as per the law, hence they were able to assist the court in dealing with the matter.

The case is before Justices Johan Froneman, Singh Walia and Edwin Cameron and judgement has been reserved for February 23. BOPA

He pointed out that another milestone achieved was construction of a new primary school at Mhiko adding that work commenced last year and considerable progress had been made.

Mr Letsholo shared that through the constituency funds, the district had successfully completed the bridge at Ranaka and Ntlhantlhe, adding that both bridges were now bin use and had made life easier for the residents in those villages.

He added that currently the water networking construction which is intended to improve the water supply with the village has begun, adding that Estate Construction Company has been awarded the tender.

Mr Letsholo implored the residents not to despair as the government was committed to solving the water challenge so that all can have access to water.

Mr Letsholo further advised his constituents to take advantages of various government programmes meant to economically empower citizens.

Village Development Committee Chairperson, Ms Kedibonye Ntokonyane decried the shortage of water in the village.

She also noted that implementation of constituency projects tended to take longer time than scheduled, which negatively impacted other planned projects. / **BOPA**



# **China-Namibia** relations poised to deliver significant benefits

WINDHOEK China-Namibia ties are expected to enhance the southern African country's economic growth in 2024, bringing opportunities to generate tangible and significant benefits for the two peoples, said an independent economic and business researcher Thursday.

Over the years, the two sides have developed a strong economic and political partnership, with China emerging as Namibia's largest source of foreign investment and second-largest trading partner, said Josef Sheehama in an interview with Xinhua.

"Opportunities arising from the relationship include increased investment and infrastructure development," he said.

"As Namibia's economy is projected to grow by 3.4 per cent in 2024, according to the Bank of Namibia, the smart partnership with China will elevate Namibia's anticipation to exceed the desired economic growth." Sheehama noted that China has become Africa's largest trading partner, significantly increasing trade volume and allowing Namibia to diversify its export markets.

Furthermore, China's investments in mining, manufacturing and agriculture sectors have the potential to bolster Namibia's industrial capacity and promote economic diversification. From January to June 2023, the trade volume between China and Namibia US\$750 reached million, representing a year-on-year growth of 31 percent, according to China's Ministry of Commerce. Among these, China's imports from Namibia amounted to US\$430 million, showing a year-on-year increase of 21.5 per cent. As of the end of 2022, the cumulative direct investment by Chinese enterprises in Namibia reached US\$180 million. "This cooperation can lead to technology transfer, skills development and increased productivity in these industries," he said.

He said the growing middle class in China has shown increased interest in international travel. Namibia's diverse wildlife, natural beauty and cultural heritage make it an attractive destination.

"By promoting tourism exchanges and collaboration, Namibia can benefit from increased tourist arrivals, generating revenue and employment opportunities," he said. The latest Tourism Arrival Statistical Report published by the Namibian Ministry of Environment, Forestry and Tourism showed that the number of Chinese visitors to Namibia increased to more than 1,500 in 2022.

Namibia also welcomed its first group of 20 tourists from China in May 2023 after a three-year hiatus due to the COVID-19 pandemic.

Sheehama also highlighted the Belt and Road Initiative (BRI), which can further boost trade, strengthen relations between the two countries, and promote the partnership between the Chinese community and Namibians.

"If fully explored, the BRI could contribute to the country's economic growth and create employment for Namibians. Improved infrastructure tends to attract more foreign direct investment and supports longterm economic growth," he concluded. Xinhua

They were successfully rescued on the fourth day. Zimbabwe is expected to experience a "short and sharp" rainfall season this year owing to the El Nino weather phenomenon. Authorities said the rains, which started in late December, could end by February. Xinhua

### WEF urges cooperation amid global economic uncertainty

For the economist, China-Namibia relations also offer opportunities for Namibia's tourism sector.

**DAVOS** - The World Economic Forum (WEF) on Monday called for a boost to global cooperation, to meet the demands of economic uncertainty. More than half of chief economists said in their outlook for this year, released during the 54th Annual WEF meeting, that they expect the global economy to weaken in 2024.

Meanwhile, seven in 10 said the pace of geoeconomic fragmentation will accelerate.

"Uncertainty is the key word for most economies around the world, including China. The positive is that China is one of the very few large economies in the world that is not struggling with inflation, that is not struggling with very high interest rates at present," said Saadia Zahidi, managing director of the WEF. In the face of escalating global

division and uncertainty, the 54th WEF meeting has assembled leaders from around the world for a week of dialogue aimed at enhancing cooperation and cultivating partnerships.

Under the theme "Rebuilding Trust," the meeting will focus on four priorities: achieving security

and cooperation in a fractured world; creating growth and jobs for a new era; harnessing artificial intelligence as a driving force for the economy and society, and formulating a long-term strategy for climate, nature, and energy.

Klaus Schwab, founder and executive chairman of the WEF, underlined the urgency of rebuilding trust in a fragmented world with growing social divides.

He emphasized the need to move beyond crisis management and address root causes.

The forum will showcase

the latest proposals on global security, trade, economic growth, jobs, climate and nature action, energy transition, technological disruption, and health and wellbeing.

WEF President Borge Brende highlighted the necessity of innovative public-private collaboration, saying that "the Forum provides the structure for developing research, alliances, and frameworks that promote cooperation throughout the year." The annual meeting will serve to deepen connections between leaders, he added. Xinhua

## **UN chief calls for humanitarian cease-fire**

**NEW YORK** - UN secretary general Antonio Guterres on Monday again called for an immediate humanitarian ceasefire in Gaza as the conflict turns 100 days.

There is one solution to help address all the issues of the unprecedented level of civilian casualties and catastrophic humanitarian conditions in Gaza, the fate of the hostages, and the tensions that are spilling over across the region, he told reporters.

"We need an immediate humanitarian cease-fire." Apart from the atrocities in Gaza, the cauldron of tensions in the occupied West Bank is boiling over with heightened violence compounding an already dire fiscal crisis for the Palestinian Authority.

Tensions are also sky-high in the Red Sea and beyond and may soon be impossible to contain, he warned.

"I have serious concerns about daily exchanges of fire across the Blue Line.

This risks triggering a broader escalation between Israel and Lebanon and profoundly affecting regional stability," said Guterres. "I am profoundly worried by what is unfolding. It is my duty to convey this simple and direct message to all sides: stop playing with fire across the Blue Line, de-escalate, and bring hostilities to an end in accordance with Security Council Resolution 1701."

One hundred days into the conflict, the humanitarian situation in Gaza is beyond words. Nowhere and no one is safe. Traumatized people are being pushed into increasingly limited areas in the south that are becoming intolerably and dangerously congested, said the UN chief.

While there have been some steps to increase the flow of humanitarian assistance into Gaza, life-saving relief is not getting to people who have endured months of relentless assault at anywhere near the scale needed.

The long shadow of starvation is stalking the people of Gaza, along with disease, malnutrition and other health threats, he said. An effective aid operation in Gaza -- or anywhere else, requires certain basics. It requires security.

It requires an environment where staff can work in safety. It requires the necessary logistics disrupting the flow of critical supplies and the resumption of basic services. The aid operation also faces major impediments to distribution within Gaza, he said.

"We are seeking to ramp up the response. But we need basic conditions in place," Guterres said.

The parties must respect international humanitarian law, respect and protect civilians, and ensure their essential needs are met.

And there must be an immediate and massive increase in the commercial supply of essential goods. The UN and

humanitarian partners cannot alone provide basic necessities that should also be available in markets to the entire population," he said. Nothing can justify the violence by Hamas.

At the same time, the onslaught on Gaza by Israeli forces over these 100 days has unleashed wholesale destruction and levels of civilian killings at a rate that is unprecedented during his years as UN secretary-general.

The vast majority of those killed are women and children. Nothing can justify the collective punishment of the Palestinian people, said Guterres. *Xinhua*

# Zambia receives cholera vaccine

**LUSAKA**- Zambia on Monday received the first batch of 1.4 million doses of oral cholera vaccine to be administered to people in cholera hotspots in the country.

The vaccines will be administered to eligible people aged one and above in selected high-risk areas in Lusaka, the country's capital, which is the epicenter of the current outbreak. The vaccine is part of the 1.7 million doses pledged by the World Health Organisation (WHO), United Nations Children's Fund (UNICEF), and Gavi, the Vaccine Alliance. Minister of Health Sylvia Masebo said the other batch would soon arrive in the country, and the

## Presidential primary kicks off in Iowa

**WASHINGTON DC** - The 2024 US presidential primary kicked off on Monday night as Iowans prepared to caucus for their Republican presidential candidate in extreme cold weather.

Republican voters are caucusing in school gyms, churches, and community centers across Iowa, a Midwestern state, as recordlow temperatures are gripping the Hawkeye State and have caused concerns about turnout.

"Today is turning out to be the coldest Iowa caucus day in history, dating back to 1972," the National Weather Service office in Des Moines, Iowa, wrote on X, formerly Twitter.

The frigid conditions have affected the presidential campaign in Iowa, with several stops cancelled ahead of Monday's caucuses.

Former US President Donald Trump, who seeks to return to the White House, is leading by a wide margin in national and Iowa polls of potential Republican nation caucuses on Monday are an early litmus test of a presidential contender's viability, as well as an initial signal of where the election is headed.

Since President Joe Biden is running for reelection, the Democratic Party's 2024 primary will be mostly a formality and not have much bearing on the race.

Iowa Democrats are also meeting on Monday but will focus on only party business with delegate-determining voting underway via mail-in ballots until early March.

The 2024 presidential election "feels both sleepy and explosive at the same time," Kyle Kondik, managing editor of Sabato's Crystal Ball, a politics-focused publication of the University of Virginia's Center for Politics, wrote in an analysis earlier this month. "The former faciling stems from

"The former feeling stems from a primary season that does not seem all that competitive," Kondik explained."The latter feeling comes from the unprecedented specifics of the potential Biden versus Trump rematch."

The US primary season will last through June. The Republican National Convention, in which delegates will officially select the party's presidential nominee, will be held in July, while the Democratic National Convention will take place in August.

The 2024 Election Day falls on November 5.

Earlier this month, Eurasia Group, a political risk consultancy founded by American political scientist Ian Bremmer, published 'Top Risks' predictions for 2024, with 'The United States versus. itself'' on the top.

"The United States is already the world's most divided and dysfunctional advanced industrial democracy.

The 2024 election will exacerbate this problem no matter who wins.

With the outcome of the vote essentially a coin toss (at least for now), the only certainty is continued damage to America's social fabric, political institutions, and international standing." Bremmer said. *Xinhua*  vaccine would be given to people in cholera-prone areas.

She said the government would not conduct mass vaccinations but would conduct targeted vaccinations due to the limited vaccines available, adding that each person would be given one dose, unlike the recommended two doses, so as to cater to more people.

"The vaccines we have received are not adequate for a countrywide non-selective response.

Therefore, they will be deployed in a phased manner in targeted high-risk areas for us to achieve impact in controlling transmission, illness, and death from cholera," she said.

The minister thanked the cooperating partners that have worked with her ministry to secure the vaccines and other resources necessary for the fight against cholera.

According to the minister, government was committed to ensuring that the current outbreak was swiftly controlled. Cissy Byenkya, the acting UN resident coordinator, said the successful implementation of the vaccine program was key in addressing the waterborne disease.

She said the UN family in Zambia would continue to support the country in the ongoing efforts to contain the disease, adding that the support was being provided in many areas, such as the provision of volunteers, distribution of chlorine and oral rehydration solutions as well as technical support.

She, however, said the UN family was concerned that the current outbreak was more severe compared to previous outbreaks with more cases and deaths. The UN official further expressed concern that most of the affected people were young.

Zambia has been battling cholera since the waterborne disease broke out in October last year, with 45 out of 160 districts being affected.

So far, the cumulative cases stand at 9 580 following 418 new cases in the past 24 hours, while a total of 374 people have died following 12 new deaths in the past 24 hours. *Xinhua*

### Nottingham Forest, Everton breach Premier League financial rules

**LONDON** - Premier League clubs, Everton and Nottingham Forest both face being deducted points after admitting breaches of the competition's Profitability and Sustainability rules.

The Premier League explained the charges on Monday in a statement reading, "Everton FC and Nottingham Forest FC have each confirmed to the Premier League that they are in breach of the League's Profitability and Sustainability Rules (PSR).

This is as a result of sustaining losses

be charged with breaking financial fairplay regulations this season and they have already been docked 10 points, which they

are currently appealing against. Everton point out that the new charges relate 'to a period which covers seasons 2019-2020, 2020-2021, 2021-2022 and 2022-2023. It therefore includes financial periods (2019-2020, 2020-2021 and 2021-2022) for which the Club has already received a 10-point sanction."

"The Club is currently appealing that sanction. The Premier League does not Slam titles before falling to a focused Garcia 6-4, 7-6 (2) in 86 minutes.

The 26-year-old Osaka enjoyed strong crowd support in her long-awaited comeback, but could not sustain the pressure against an assured Garcia.

Reigning US Open champion and fourth seed Coco Gauff brushed aside unseeded Anna Karolina Schmiedlova 6-3, 6-0 to win her sixth straight match of the season.

There is much expectation on the 19-year-old American, who is bidding to become the first women's player in five years to win the US Open and Australian Open back-to-back.

"I think I did well returning and then I found my serve towards the end," said Gauff, who hit 15 winners.

"She's a tough player to play but I'm happy with how I was able to manage my emotions today."

Sixth seed Ons Jabeur also cruised in her comprehensive 6-3, 6-1 victory over Ukrainian qualifier Yuliia Starodubtseva.

Marketa Wimbledon champion, Vondrousova crashed out after a 6-1, 6-2 defeat to qualifier Dayana Yastremska in 76 minutes.

The world No. 7 was completely outplayed by an aggressive Yastremska of Ukraine, who is ranked 93 having reached a career high of 21 in 2020.

It was the latest disappointment for the 24-year-old Vondrousova at Melbourne Park, where she has never progressed past the fourth round.

Men's seventh seed Tsitsipas started slowly against Belgian lucky loser Zizou Bergs before storming to a 5-7, 6-1, 6-1, 6-3 win.

Tsitsipas was supposed to play former Wimbledon finalist Matteo Berrettini, but the Italian withdrew with an injury.

The 129th-ranked Bergs stepped up in

his place and he proved no pushover, but Tsitsipas turned things around to reach the second round in Melbourne for the sixth straight year.

"I was very focused, especially after losing the first set," Tsitsipas said, "I knew that this is my time to change things up and move on with better tennis...with better power and movement on the court." "I think I outplayed him as well physically. I was stronger physically today, at least that's the way I felt."

Third seed Medvedev was pushed hard by qualifier Terence Atmane in hot daytime conditions before the teary-eyed Frenchman retired from the match with cramps.

Medvedev, a two-time tournament finalist, had wrested control after losing the first set before Atmane was unable to continue when trailing 5-7, 6-2, 6-4, 1-0.

"The conditions were brutal," said former US Open champion Medvedev.

"I'm just happy to be through. I played bad at the beginning in the first set, but I was happy I could regain momentum."

Chinese top men's player Zhang Zhizhen lifted his level in the key moments to prevail against Federico Coria 6-4, 7-6 (3), 7-6 (5).

Zhang, ranked No. 54, will face No. 21 Ugo Humbert in the second round. Australia's main hope Alex de Minaur, the 10th seed, was left relieved after former No. 3 Milos Raonic retired mid-match due to a hip injury with the contest locked at one set apiece.

Grand Slam champions Andy Murray and Stan Wawrinka were knocked out.

"It's a definite possibility that will be the last time I play here," said former No. 1 Murray after he fell to Argentina's Tomas Martin Etcheverry in straight sets. s Alcaraz. Xinhua

Both of the clubs also issued statements, with Nottingham Forest saying they acknowledge 'the statement from the Premier League confirming that the club has today been charged with a breach of the league's Profitability and Sustainability Rules' adding they 'intend to continue to cooperate fully with the Premier League on this matter and are confident of a speedy and fair resolution.'

This is the second time for Everton to

have guidelines which prevent a Club being sanctioned for alleged breaches in financial periods which have already been subject to punishment."

Everton believe this means the second charge 'results from a clear deficiency in the Premier League's rules,' and insists they will 'continue to defend its position during the ongoing appeal and should it be required to do so, at any future commission'.

Everton are currently 17<sup>th</sup> in the Premier League, with 17 points from 21 games (although they would have 27 points but for their first 10-point penalty of the season). A further 10-point deduction would leave them bottom. Nottingham Forest are 15th with 20 points and a 10-point penalty would also drop them into the relegation zone. Xinhua
