## Tsogwane launches Leobo La Dingaka

**PALAPYE** - Traditional healers are esteemed individuals within the community, utilizing cultural and holistic methodologies to support the well-being of community members. Their accessibility plays a crucial role as a bridge to enhance the quality of care through community-based practices.

Vice President, Mr Slumber expressed the Tsogwane, significance of traditional healers during the official launch of the Botswana Traditional Health Practitioners Association (Leobo La Dingaka) in Palapye. This association, registered in July 2022, has garnered attention from various organizations, including the World Health Organization (WHO), emphasizing the incorporation of traditional medicine within national health systems with appropriate regulations.

Reflecting on the Alma Ata Conference of 1978, Mr Tsogwane highlighted how the adoption of

Primary Health Care (PHC) as a strategy by countries like Botswana underscored the importance of recognising cultural beliefs and values for a successful and dynamic primary health care approach.

Acknowledging traditional healers as primary points of contact for health care seekers, Mr Tsogwane emphasised their strategic positioning and influence in promoting positive health-seeking behaviors within communities. The government's efforts, through the Ministry of Health, have furthered the revitalisation of PHC to address current global health challenges.

The recent COVID-19 pandemic reinforced the significance of community-based approaches in safeguarding public health.

Recognising this, the establishment of the Leobo la Dingaka association marks a pivotal moment in fortifying a resilient health care system deeply rooted in community engagement.

Quoting the UNAIDS 2023 report, Mr Tsogwane highlighted Botswana's successful HIV programs, attributing achievements to collaborative efforts with health facilities. These efforts have led to remarkable milestones such as the 95-95-95 achievements, positioning Botswana as a model for evidence-based policies and effective responses in combating HIV and AIDS.

While progress has been made, global challenges persist, as highlighted by UNAIDS reporting a life lost to AIDS every minute in 2022 and significant gaps in access to treatment, especially among children living with HIV.

Collective action and continued collaborations are essential to address these challenges on a broader scale.

Tsogwane Mr additionally emphasised that in the Botswana context, Leobo La Dingaka could play a significant role in tackling Non-Communicable Diseases (NCDs), often known as lifestyle diseases. He mentioned that faith leaders could have a positive impact

by encouraging healthy eating habits and physical activities. Mr Tsogwane highlighted Anti-Microbial Resistance (AMR) as another emerging pandemic, underscoring the importance of involving the faith sector in addressing this issue.

AMR directly results in over 1.3 million deaths and contributes to another 3.7 million deaths globally. He noted that more people die from AMR than from HIV/AIDS, Malaria, or any single form of cancer besides lung cancer.

"The advocacy of faith leaders for the responsible use of medicines has become increasingly crucial, he said.

Tsogwane observed a Mr growing global interest in traditional medicine and acknowledged that numerous herbs traditionally used in African medicine have influenced contemporary drug research. This led to partnerships between Botswana Faith Based Organisations Network on HIV/ AIDS (BOFABONETHA), Leobo La Dingaka, and Research Xcellas to establish a center of excellence for traditional medicine research in Botswana.

This initiative, he said was pivotal in promoting good healthseeking behavior. For his part. Mr. Malema Malema, Chairperson of the Botswana Traditional Practitioners Association. recognized the government's support and highlighted the purpose of launching traditional healers into the public eye to enhance collaboration with modern medical practices.

During the launch, the United States Ambassador to Botswana, Mr Howard Van Vranken, emphasised the enduring partnership with traditional leaders since the onset of the HIV pandemic, underscoring their significant influence and contributions to public health. **BOPA**

## Estonia president visits Botswana

**GABORONE** - President Mr Alar Karis of Estonia is expected in the country today (Monday, March 4) at the invitation of President Dr Mokgweetsi Masisi.

President Karis and his delegation are due to arrive at the Sir Seretse Khama International Airport to start a four-day state visit, commencing on Monday until departure on Thursday.

According to the Ministry of Foreign Affairs, the state visit will allow Botswana and Estonia to strengthen bilateral relations and explore areas of cooperation.

Botswana, which established diplomatic ties with Estonia in 2003 cooperates with the European Union (EU) member state on information communication technology (ICT), digital transformation and e-taxation.

In a press release, the Ministry of Foreign Affairs further noted that Estonia has made remarkable progress in transforming into one of the world's most digitally advanced societies, boasting Europe's most start-ups per capita with successful companies such as Skype, Bolt and Wise, and 99 per cent of public services available online.

A small nation of 1.4 million people, Estonia has historically worked to assert its territorial integrity and sovereignty, and has been ruled at separate periods by neighbouring Swedish monarchs and was later invaded by Tsar Ivan the Terrible of Russia.

After a brief period of independence from Russia between 1919 and 1940, Soviet Russia under Josef Stalin annexed Estonia, which later regained independence as a modern republic in 1991 after the fall of the Iron Curtain.

Estonia quickly established itself as a parliamentary democracy and a thriving economy, with oil energy, telecommunications, banking, food, fisheries, timber and electronics as key sectors of the economy. With a gross domestic product (GDP) purchasing power parity of US\$ 46 385 in 2023, Estonia is ranked number 40 in the world by the International Monetary Fund (IMF).

The country has held democratic elections since independence in 1991 and President Karis, who assumed office in October 2021 is the country's sixth president.

A former university professor, President Karis also served as the Auditor General of Estonia

million in the next financial year.

Speaking in a post conference media briefing, the Minister for State President, Mr Kabo Morwaeng indicated that the proposals would inform a bill that was to be presented before Parliament, possibly during the current sitting.

"Since it is a political year, the idea is for the bill to pass as soon as possible, but without flouting the laid down due processes," he said.

Mr Morwaeng also hailed the holding of the All Party Conference, the first one since March 2019.

"This is good for our democracy, especially that all the 21 registered political parties were invited. The meeting was fruitful and the plan is to hold this meeting as often as

the criteria for appointing members of the electoral commission could have been interrogated.

Botswana Democratic Party secretary general, Mr Kavis Kario also commended the return of the All Party Conference and its outcome.

"Although it took long, we are happy with the way discussions went, and that it was important for political party funding to be disbursed as quickly as possible to allow parties to fund their campaigns ahead of the general elections.

Mr Kario also said that parties have also agreed that other issues such and electoral reforms would be discussed in the next meeting. Botswana Congress Party (BCP)

He however, said that caution should be exercised to ensure that the funding does not lead to unnecessary mushrooming of political parties.

Mr Kekgonegile also said that the issue of women representatives also should be addressed, and suggested that a formula was needed to encourage women participation at both council and parliamentary level.

Other issues on the agenda were the readiness for the general elections by the Independent Electoral Commission, as well as the appointment of members of the electoral commission. BOPA

Currently ranked 31 out of 191 countries by the United Nations Development Programme (UNDP) Human Development Index (HDI), which calculates the standard of living in countries using a measure of per capita income, life expectancy and education, Estonia has attained good quality of life for its citizens since attaining independence from Russia in 1991. The country has also consistently been ranked high by international agencies on democratic governance,

## Botswana, Kenya to partner in beef, dairy industries

**GITHUNGURI** - Botswana and Kenya will soon establish a working partnership to boost beef and dairy industries in both countries.

This came to the fore during President Dr Mokgweetsi Masisi's visit to some dairy farmers on the outskirts of the Kenyan capital Nairobi on Friday.

President Masisi who was in Kenya for the week-long United Nations Environment Assembly (UNEA-6) also visited the Githunguri Dairy Farmers Cooperative Society before completing his visit to the Kenya Animals Genetics Resource Centre (KAGRC).

"There is a lot of hope and I yearn for the cooperation you talk about because back home cooperative movements started back very well then got weakened and I suspect we took our foot off the pedal and we need to put it back. I have seen it succeed because those who drove it were mission-driven and they succeeded. I wish you well, I have visited some of the members of the cooperative, using very little land and getting the most out of it. I am impressed by how Kenyan farmers have compressed land and gotten value out of it," added President Masisi.

to expand products lines and share knowledge with Batswana farmers. At the KAGRC Kenyan Secretary for Cooperatives, Micro and Small Enterprises, Mr Simon Chelugui told President Masisi that there was plenty of opportunity for collaboration between the two countries.

"We can exchange between Kenya and Botswana on areas of research, disease control, and production as we are good in dairy and relatively better than Botswana and you are much better in beef than Kenya, so there is an opportunity for partnership," said Mr Chelugui.

He said in terms of beef they had Africa, Europe, Middle East all markets which were looking up to Africa to produce.

"Imagine all the beef in the Middle East and even in Europe majority of all that comes from Australia and Brazil flown 18 hours yet here in Africa we have the opportunity to harness the notential and serve these markets So we can approach this as a region, we can collaborate, we can work together in producing the right amount of beef to serve our region and serve our neighbours," added Mr Chelugui. In terms of dairy production, Mr Chelugui said his government was targeting to produce 10.2 billion litres of milk annually against the current 5.2 billion

litres. He said all that could not be achieved without science, research and the right breeds.

For his part Botswana Foreign Affairs Minister Dr Lemogang Kwape reiterated the need to forge strong bonds between the two countries.

He said exploring potential areas of cooperation was a call Botswana had been taking notes on and was ready to work on.

Kenya is one of the leading producers of milk in Africa and dairy is the largest agricultural sub-sector in the country in terms of income and employment creation.

With Botswana producing less than 10 million litres of milk per year the dairy industry is one of those that President Masisi had encouraged farmers to venture into and had recently donated some dairy bulls.

The success of Kenya's dairy industry could be traced back to the establishment of the KAGRC which focuses on improving dairy cattle genetics.

## Countries to review travel requirements

**NAIROBI** - Botswana and Kenya are on the brink of a high level consultative meeting on the possible exemption of Botswana citizens from the Kenyan Electronic Travel Authorisation (ETA) requirements.

President Dr Mokgweetsi Masisi made the announcement during a meet and greet dinner hosted in honour of Batswana living and working in Kenya on Friday.

Despite Kenya's announcement of granting visa-free access to African visitors last year, the introduction of new ETA requirements, such as the need for Botswana travellers like Ms Gaoletlhoo Gaitsewe to obtain an ETA each time they enter Kenya, has brought about unexpected costs.

Under new rules, travellers must get an ETA every time they enter Kenya which is valid for 90 days and costs over P400.

President Masisi made an assurance that he together with his counterpart, Dr William Ruto would engage in their official talks, possibilities of reviewing the ETA requirements before travel.

He said the Ministry of Foreign Affairs was on the ground and would take it up on a high level consultation and give a 'good report'.

Dr Masisi told Batswana living in Kenya that meeting them away from home was always the best part of his travel schedule and that it was a privilege and priceless for congregating as Batswana to meet a Head of State. He introduced Mr Mathew Njenga and his wife, Ms Cathrine Wambugu of the Wambugu Apple Empire in Kenya and said the couple was an inspiring entrepreneurship story that Batswana should emulate.

Theirs, he said was a beautiful African story and a true identity of a family brand.

President Masisi highlighted some promises made and delivered to Batswana and some which were not done to the levels expected.

He said he was impressed by the digitisation drive and some projects such as the water evacuation projects which was the biggest treatment plant in Southern Africa.

President Masisi said government was busy implementing its transformational strategy and urged Batswana to embrace the Mindset Change philosophy.

He said it was good that some of them were in Kenya because Botswana was a good friend of Kenya.

"President Ruto is a good friend and we talk deep and meaningful on your behalf. We put timelines on what we discuss because we are in a hurry. We want to deliver on a programme that is a win-win between Kenya and Botswana," he said.

For his part, Botswana High Commissioner to Kenya, Mr Andrew Sesinyi said Batswana living in Kenya were a special community.

"You are in your individuality in whatever you do. You are ambassador in your own right, represent yourselves as best as you can," he added. *BOPA*

## Citrus fruits project: Ray of hope

SELEBI PHIKWE - When the BCL Mine closed in 2016, dreams and hopes of thousands of residents who viewed the undertaking as a lifeline for communities in the SPEDU region were shattered.

Four years later after the closure, a new initiative was launched, the Selebi Phikwe Citrus project, by President Dr Mokgweetsi Masisi.

Residents of the township and those from surrounding villages then had their hope renewed as they looked forward to the success of the project, which promises to bring a turnaround of lives and economic activities in the region.

Once fully operational, the

project sparks the light in the dark tunnel of some residents who have had to endure the impacts after the mine was closed, particularly of unemployment.

In random interviews to get a view of what the community expected from the Selebi Phikwe Citrus project, BOPA met with some who have already nailed job opportunities at the citrus farm.

One Jowapi Moyo, aged 45, could not hide his excitement to have been among those called for a job.

She shared how he was blessed and looking forward to working hard because such an opportunity he would always treasure.

"I've been tossed from pillar to

post looking for a job.

Sometimes I made ends meet with temporary work, but the money never got me any far.

My troubles with money were evident.

I'm happy that being called to serve on a permanent basis in the orchard will make a difference," Moyo said.

For Bame Phane, aged 20, it was a dream come true.

Phane is among those that have been employed and could not hide the tears of joy.

He shared how he already had a clear vision about such an opportunity and in the main, his intention to save part of his monthly salary to advance academically for another possible opportunity with the project.

"The farm offers a wealth of handy skills that one may constantly take advantage of.

As such I wish to undertake a skills training in order to be relevant in one of the areas of competence here and maybe be promoted in the future," he said.

Kefilwe Makwate, a 42-year-old resident of Bobonong, said he was aware that not all would be called for job opportunities.

Nevertheless, Makwate said he was excited that in addition to employment, the project presented some business opportunities he would certainly want to tap into, especially the in areas of food processing and supplies of other essentials such as stationery.

"I am pleased with the transparency with which employment vacancies had been announced thus far, giving all eligible applicants the opportunity to apply," he added.

Kgosi Ishmael Legwaila of Botshabelo, narrated how many were left jobless when the BCL Mine closed in 2016, something he said had exacerbated crime and other social ills within the town.

He said the advent of yet another promising opportunity was a welcome development for his area, which was known for extreme poverty.

He said the project presented opportunities for empowerment and therefore urged Botshabelo residents to fully take advantage of.

Kgosi Tlhako Motlhasedi of Tobane applauded government and investors for what he termed a good job, bringing yet another lifeline initiative to a community that had lost hope after the BCL Mine closure.

"We need to embrace and protect this project as our next possible effort to shift the narrative about lack of employment here.

We are aware that some people may be encouraged to engage in inappropriate behaviour such as common theft and corruption, once such projects are fully operational. We are keeping an eye on you,"

he said.

He said it was therefore up to the communities from nearby villages to work effortlessly for continued success of the project.

The project's production assistant manager, Tlhonolofatso Ogolotse said currently, more than 200 people from nearby areas had been engaged for permanent employment and expected the number to increase during the harvesting period and after.

Meanwhile, President Masisi is expected to conduct the official launch of the harvest period on March 21. BOPA

## Selebi Phikwe Citrus Farm suitable learning facility

**GABORONE** - Farmers have the opportunity to benchmark on the success story of the Selebi Phikwe Citrus project, which is expected to commence its first fruit harvest on March 21.

In an interview on Friday, minister of Agriculture, Mr Fidelis Molao said the citrus farm could be used as a training facility for farmers in the SPEDU region, where Batswana could be taken in groups and learn about citrus production in depth.

Minister Molao further encouraged citrus farmers around the Selebi Phikwe and other areas such as the Tuli Block to exchange notes on how to better production. "This could help improve economic growth in the SPEDU region and the country as a whole," he said.

He said such efforts could also assist the agricultural sector in improving its contribution to the GDP as it currently stood at two per cent against the five per cent target.

According to the Ministry of Agriculture, Botswana currently has 172 citrus growers and 90 per

cent are small-scale farmers who produce in under five hectares of land while the remaining 10 per cent falls under the category of medium-sized farmers.

The citrus sector only provides more than 1 000 jobs, but Mr Molao indicated that currently Selebi Phikwe Citrus farm employs 1 275 people and is expected to engage a minimum of 1 500 workers during primary production.

He added that other people could benefit from Selebi Phikwe Citrus production farm through value chain development. BOPA

"Our journey with Selebi Phikwe Citrus started in 2018 after receiving investors from South Africa, who were keen on investing in our region by producing citrus fruits on a large scale," said SPEDU acting director - strategic projects, Mr Maiba Samunzala in an interview.

Mr Samunzala said facilitating a project of such a magnitude came as a big shock that challenged the company to get off the comfort zone and go an extra mile to deliver on its mandate.

"Delivering a project of this magnitude was not a walk in the park for the company as it involved a lot of things including adequate water supply and a large chunk of land, which at the time were not available.

We scouted around to look for the most suitable place to set up this project.

We went to Talana Farms and the Thuli Block area, but we could not find adequate land to accommodate this project," he said.

After moving around, pondering their next move, it suddenly dawned on the company that Mmadinare Multipurpose Cooperative Society had a large chunk of land that had been idle for 18 years.

The investor was taken on an inspection tour of the 1 700-hectare Mannaesi Farm and after satisfying himself with the proposed land for the project, he gave the company a green light to start negotiations with Mmadinare cooperative society.

"We approached Mmadinare cooperative to deliver the good news.

Since the land had been lying idle for 18 years, the cooperative did not hesitate to grab this opportunity to enter into agreement with the investor to lease out 1 500 hectares of their land, an exercise that went smoothly due to the dedication and the zeal displayed by the SPEDU team and other stakeholders," he said.

He explained that Mmadinare Cooperative Society benefitted a great deal from the citurs project as it generated income through rental and also gave them the opportunity to purchase 10 per cent shares from the project.

"We are currently helping the cooperative to source funds from local financiers to purchase the 10 per cent stake," he added.

He said in addition, the cooperative had been given the leverage to create other spin offs such as juice production and transportation, among the few opportunities.

He added that after securing the land, the team was faced with another mammoth task of finding adequate water supply of around 48 million cubic metres to water more than 800 000 trees.

He said SPEDU approached Water Utilities Corporation (WUC) to assist.

"Through fruitful deliberations and thorough assessment, WUC came to the conclusion that Letsibogo Dam with a capacity of 100 million cubic metres had the potential to be used for irrigation of the citrus farm," he said.

He added that since raw water supply was pricey and likely to hurt the investor's pockets, SPEDU engaged with the Ministry of Lands and Water Affairs and WUC to reduce the water tariffs from P7 to P1.61, resulting in the construction of a 12-kilometre pipeline from the dam to the project site.

He further indicated that just when the project was about to take off, COVID-19 emerged and forced government to restrict movement, which made it impossible for the concerned parties to meet.

However, he said SPEDU fought tooth and nail to reach out to the investor through online platforms so that the project could be implemented irrespective of the circumstances that prevailed at the time, leading to the official ground-breaking by President Dr Mokgweetsi Masisi in December 2020. "This is the biggest project in the SPEDU region and we are proud to have delivered it successfully. We are happy because it is going to make a positive impact in our local communities and also contribute to the economic growth of our country. We also appreciate the efforts by government departments and parastatals in removing any impediments that affected the delivery of the project," Mr Samunzala said. BOPA



# Access to quality education priority - Letsholathebe

**GABORONE** - Access to quality education from preprimary to tertiary is one of the key government priorities, says Minister of Education and



Dr Letsholathebe said his ministry continued to support access to education through the implementation of reception class programmes in 714 out of 764 primary schools with over 29 000 children enrolled

Skills Development, Dr Douglas Letsholathebe.

Presenting the education and skills development 2024/2025 budget proposal recently, Dr Letsholathebe said his ministry continued to support access to education through the implementation of reception class programmes in 714 out of 764 primary schools with over 29 000 children enrolled.

He said the use of mother tongue as a medium of instruction for lower classes was another initiative geared towards improving and promoting early childhood education.

"The Botswana Languages Policy in education is to guide the use of local languages as a medium of instruction at the lower levels of primary education as well as the teaching of such languages as subjects over time," he said.

He said the use of 13 local languages was introduced in lower primary classes in 154 of the targeted 170 public primary schools in January 2023.

The 13 languages, he said included Afrikaans, Chikuhane (Sesubiya), Ikalanga, Naro (Sesarwa), IsiNdebele, Otjiherero/Otjimbanderu Shekgalagari, Shiyeyi, Shona, Thimbukushu and sign language.

Dr Letsholathebe added that the aim was to roll-out the programme to 120 more schools and to finalise the orthography for the phase 2 languages for the 2024/25 financial year. Additionally, Dr Letsholathebe stated that the net enrolment rate for secondary education increased from 71 per cent in 2019/2020 to 73.1 per cent in 2020/2021, but decreased to 63.1 per cent in 2022.

He said transition from junior secondary to senior secondary over the last four years showed an upward trajectory, rising from 53.7 per cent in 2020 to 58.5 per cent in 2022.

To prepare for the growing number of pupils seeking admission into senior secondary schools, Dr Letsholathebe said the ministry was undertaking a review of existing schools to accommodate expansion of teaching and learning space.

In addition, he said the drive to expand enrolment within budget constraints demanded a review of infrastructure design and utilisation to maximise intake with minimal expenditure.

"This requires a re-thinking of the classroom design to foster enhanced learner centeredness and practical engagement," said the minister, adding that as they prepared for NDP 12 the focus would move towards a more hybrid design of teaching and learning spaces as well as smarter digital solutions to foster remote approaches.

Despite all the effort to improve the education sector, Dr Letsholathebe admitted that the ministry continued to face challenges to provide basic resources for education at all levels, including furniture, text books and stationery.

"In addition the ministry has been facing escalating costs of utilities and is taking steps to reduce water and electricity usage across all institutions and has instigated a programme of digitisation, which will see a reduction in the cost of providing stationery and text books as e-materials become the norm," he said.

He acknowledged that the state of school facilities was appalling and in need of urgent attention.

Dr Letsholathebe also acknowledged that the ministry had been having challenges in replacing worn furniture at schools for both classrooms and hostels, but assured Parliament that they were working around the clock to improve the situation.

Ministry aims to align education with labour market

**GABORONE** - Minister of Education and Skills Development, Dr Douglas Letsholathebe has emphasised the importance of ensuring alignment between education and the labour market.

Requesting Parliament to approve his ministry's budget estimates for the 2024/2025 financial year recently, Dr Letsholathebe said the alignment of education and market labour would be achieved through the Labour Market Information System (LMIS), which was expected to be completed by labour market performance signals was expected to be completed before the end of the 2023/24 financial year.

He explained that the LMIS portal contained content on economic sectors, occupations, career advice, education and training and labour market indicators while the job seekeremployer matching platform had functionalities for job seeker registration, employer registration, job posting, job search and job applications.

He said it was against that background and as part of the ongoing rationalisation that ministry would continuously look into its mandate and operations to improve service delivery and academic performance through the review and development of policies.

Dr Letsholathebe requested Parliament to approve P16 billion, out of which P15 billion was for the recurrent budget while the remaining P1billion was for the development budget.

He noted that the recurrent budget reflected an increase of P493.7 million or 3.3 per cent of the ministry's 2023/2024 budget.

## Rakgare proposes over P1 billion budget

**GABORONE** - The Minister of Youth, Gender, Sports and Culture has requested over P1 billion for recurrent budget and over P147 million for the development budget for the 2024/2025 financial year.

Presenting the budget proposal before Parliament, Minister Tumiso Rakgare said the recurrent budget represented an increase of 19 per cent compared to the 2023/2024 approved budget.

He said over P161 million would be allocated to the Botswana National Sports Commission whilst over P154 million would go towards the payment of national service allowances.

He also stated that over P100 million would go towards sports development programmes.

Over P10 million, he said, was required for constituency sport tournaments while constituency arts competitions required over P20 million. The minister informed the house that over P22 million would be used for the

National Arts Festival.

Regarding the gender affairs department budget, he stated that over P53 million would be allocated towards gender mainstreaming and over P3 million to women's voluntary organisations. With regard to the development budget, Mr Rakgare said the P147 million budget had been apportioned across three programmes with the development of cultural infrastructure and programmes receiving 12 per cent, strengthening ministry operations 19 per cent and and 69 per cent allocated for MYSC infrastructure.

Mr Rakgare highlighted that about 70 per cent of the proposed development budget amounting to over P101 million was earmarked for implementing the ministry's infrastructure programme, which would be made up of major projects such as community sport stadia, state theatre and the construction of the Francistown stadium roof and the installation of the Mosadi Thari statue. **BOPA**

## MPs approve MYSC budget

**GABORONE** - Parliament has adopted the Ministry of Youth, Gender, Sport and Culture budget proposal of over P1 billion recurrent budget and over P147 million development budget for the 2024/2025 financial year.

Debating the budget earlier on, Specially Elected MP, Ms Beauty Manake raised concern over youth unemployment and urged allocation of more funds in the upcoming financial year to address the concern, particularly within the creative sector.

Ms Manake also said the ministry should consider constructing a state-of-the-art multimedia studio in Selebi Phikwe. "Selebi Phikwe has produced stars such as DJ Oneal, Ezra Neethings, Phologolo, the list is endless and such a studio would provide opportunities for local creatives to further develop their talents and become renowned stars, benefiting both the region and the country as a whole," she said.

Regarding sports, Ms Manake noted the significance of grassroots development and suggested creation of a development fund to enable sports agencies to access resources and empower children at the grassroots level.

"The investment, I believe, would contribute to the holistic development of youth and promote excellence in sports from the grassroots," she said.

Selebi Phikwe West legislator, Mr Dithapelo Keorapetse said government should consider sponsoring high performing athletes to international academies.

This, he argued, would be a game-changer for aspiring athletes, offering them access to top-notch training facilities, expert coaching and invaluable competition opportunities on the global stage.

Mr Keorapetse also said government should amend existing laws to facilitate monetisation of talents within the creative sector through various social media platforms.

"We are told that we need to have a Youtube partner programme and make corresponding amendments to our tax and cyber laws and antimoney laundering controls to ensure that all regulators are on top of their game to enable our young talented entrepreneurs to thrive through social media entrepreneurship," he said.

Furthermore, Mr Keorapetse proposed the introduction of tax incentives for organisations which employed the youth and adequately compensated them.

He said it would not only incentivise the employment of young people, but would also ensure fair remuneration, thereby addressing concerns of youth unemployment and underemployment.

Meanwhile, MP for Palapye, Mr Onneetse Ramogapi said government should introduce tax rebates for organisations who lended a helping hand towards sports development.

He also said there was a need for a stadium in Palapye.

### Parliament accedes to agric. budget proposal

**GABORONE** - Parliament has acceded to the Ministry of Agriculture's P3.58 billion budget request amid reservations that it was inadequate to address challenges besieging the sector.

The budget comprises P1.56 billion for recurrent budget and P2.02 billion for development budget. Proposing the budget, Minister Fidelis Molao said the ministry was, among others, in the process of refurbishing the Ramatlabama National Artificial Insemination Laboratory and Training Centre into a centre of excellence.

He said part of the works such as the upgrading of cattle artificial insemination, training centre and other facilities were implemented using the development manager model. He noted that the ministry had engaged Botswana Housing Corporation to refurbish the old laboratory into a small-stock artificial insemination laboratory and embryo production, adding that the project was at roofing level. and that a consignment of 3 000 Droughtmaster semen straws and 1 000 Wagyu semen straws were expected from Australia at the end of March.

He said the ministry also procured 161 live breeding cattle to be used for semen and embryo production for both local and export markets.

Mr Molao said his ministry continued to train farmers with the aim of facilitating and improving production, adding that 212 participants had received training on artificial insemination techniques against a target of 180 trainees.

However, the minister said shortage of fodder and quality dairy cows remained a hindrance to increase dairy production.

He also said the ministry had planned to refurbish the milk pasteurising plants in Serowe and Pitsane to facilitate milk marketing for smallholder dairy farmers.

"This will cover existing packages as well as other components of the agricultural value chain such as production of propagation material and technologies," he said. BOPA

Minister Molao also said in an effort to increase the national herd and improve its genetic merit, the ministry was investing in assisted reproduction technologies.

He said during the 2023/2024 financial year, 13 672 straws of beef semen were purchased from Germany, France and Switzerland He said the intended purpose of the plants was to facilitate milk collection and marketing for small holder dairy farmers.

He noted that government continued to commercialise the traditional livestock sector through the implementation of sectoral cluster strategies such as beef and small-stock clusters, and through the transformation of Lobu small stock farm into a centre of excellence.

Also, he said, the digitisation

He said the restocking relief programme included cattle, sheep, goat as well as donkeys for all eligible beneficiaries in Bobirwa and that the total cost of the relief programme was P36.4 million. The minister said government was investing on aquaculture, noting that the industry remained In response to the legislators' debate, Minister of Youth, Gender, Sport and Culture, Mr Tumiso Rakgare said government had plans for construction of a stadium in the Tswapong region. He said government was already sending some local athletes to international academies.

"However, it is high time that world class academies are set up locally," he said.

In addition, he expressed support for the idea of building a state-of-the-art multimedia studio, stating that if funds allowed it would be considered in the near future. **BOPA**

## **Moroka calls for review of DCEC Act**

#### By Marvin Motlhabane

**GABORONE** - There is urgent need for review of Directorate on Corruption and Economic Crime (DCEC) Act to inject provisions of security of tenure of its leaders, says Francistown High Court's Justice Lot Moroka.

He expressed this during a panel discussion session held alongside the Commonwealth Corruption Centre Africa (CAACC) 10+1 Anniversary held in Tlokweng recently.

Justice Moroka said the DCEC should remember that they were tasked with the power to investigate even those at the helm of the law despite the powers vested upon them.

"In Botswana we say nobody is above the law, and therefore we are a government of men of flesh and blood susceptible to committing corruption, even economic crime," he said.

He said members of the society were critical partners in the fight against corruption and economic crime.Justice Moroka said society formed the first and fundamental partner in the fight against corruption, adding that second to the society would be the private sector. He said third to follow would be the intelligence agencies due to their role in the

fight against corruption and economic crime, adding that the essence of partnerships should be understood as collaborative efforts by the listed agencies involved in the fight against corruption.

"Successful prosecution of corruption is a result of successful evidence presentation of before court and not successful of intelligent presentation information before court," he said.

Therefore, Justice Moroka said intelligent information must translate into evidence, citing that various jurisdictions had a tendency for intelligence to lead.

He said for partners to coexist they must first exist as individual components that form the relationship toward ending corruption and economic crime.

Notably, he said an anticorruption agency as a key partner in the fight against corruption and economic crime was the oversight institution, which had basic characteristics that defined its existence.

In the context of Botswana, Justice Moroka said the oversight institution would be the DCEC, adding that a key partner in the capacity of DCEC should exhibit independence and autonomy.

## **Official warns adults** against selling drugs to children

**SEROWE-** Coordinator of Child Protection Unit at Serowe Police Service has warned adults against selling drugs to learners as doing so could destroy their lives.

Sgt Oarabile Tome has also called upon parents to join forces with other stakeholders to fight alcohol and drug consumption amongst children, monitor and report any suspicious behaviour of children.

Sgt Tom, who was addressing a kgotla meeting called by the Acting Tribal Authority, Kgosi Serogola Seretse in Serowe recently, said some adults worsened the situation by selling drugs to pupils at schools' entrance points pretending to be selling fat cakes, sweets and

influence of drugs.

He also expressed concern about criminal activities in the district including rape, defilement, assault, murder, lack of maintenance of children and child neglect.

He said 2022 they registered 132 rape cases, 117 defilement cases, 10 femicides, 500 assaults, and 17 child neglect cases.

Mr Tom voiced concern that some cases were withdrawn without valid reasons, while others went unreported.

He indicated that most assault cases and rape incidents occurred at unlicensed drinking places.

concurred Residents that consumption of drugs and substance abuse were widespread in Serowe and surrounding villages.

Mr Alfred Mosweu expressed concern about some parents who are in the business of selling drugs, and the prevalence in the use of a drug called Cat powder, also known as Katse by the youth.







## Malnutrition rises in Sowa area

#### By Goitsemodimo Williams-Madzonga

**SOWA TOWN** - The Sowa Town catchment clinic has of late been recording a high number of malnutrition cases.

Addressing a full council session on Wednesday, Sowa Town Mayor, Mr Oliphant Mfa highlighted that the total prevalence of malnutrition for the clinic stands at 3.9 percent which is higher than the national target of 2.9 per cent.

He stated that this called for responsibility from parents to see to it that they take necessary measures to feed their children adding some children lack nutrients due to negligence of the parents or caregivers.

He noted that although the prevalence rate of 3.9 percent was too high, the district did not qualify to be allocated rations for direct feeding which is only provided when the prevalence stands at 10 percent.

Nevertheless, Mr Mfa disclosed that all the malnourished children are seen by a dietician on monthly basis at the clinic and a paediatrician when need arises.

He explained that drug availability at the health facility stood at 84.44 percent on vital drugs while on essential and necessary ones they are at 85.6% and 52.9 percent respectively.

He indicated that in comparison to the previous quarter, this accounted for a slight decrease most significantly on the necessary drugs availability which has decreased by almost 16 percent.

However, Mr Mfa assured that there was no need for alarm as on overall the clinic was faring well in terms of drugs availability adding that the facility continues to source out of stock commodities from other facilities.

"Lets us put more emphasis on changing of lifestyles to avoid non-

communicable diseases which are now at the centre-stage of taking lives," he said.

He stated that apart from the situation of malnutrition, the town had also been struggling with continued high rates of Sexually Transmitted Infections (STI's) and that on February 17 Sowa Men Sector held an STI campaign in the form of a soccer tournament to spread awareness on the effects of STI's. He said such an effort was commendable and showed that communities need to work together towards improved health and lifestyle choices.

He disclosed that in an effort to improve public service delivery the government had introduced Community Based Monitoring (CBM) which was piloted at district level in 2017 and has now been rolled out to towns.

He stated that two surveys have already been conducted and the third one, which will be done this year, will include Sowa Town.

"CBM is a tool for the community to give us feedback and identify gaps in public service delivery," he said. *BOPA* 

## Lack of funds halts projects

**MOSHUPA** - Lack of resources and financial distress have resulted in most of 2022/23 financial year Moshupa District Council projects being paused.

Delivering his speech on Tuesday during full council meeting, Moshupa District Council Chairman, Mr Sonny Phiri said frequent breakdown of resources had a negative impact on the implementation of the projects.

However, he said the district was working around the clock to come up with various initiatives to increase revenue so as to augment the already low Revenue Support Grant (RSG).

He implored members to work

together with project officers to ensure that projects were sped up.

Mr Phiri also called for team work, stating that it was the only way that could transform the lives of the communities, adding that it was imperative to ensure that the inequality gap was closed through economic and social inclusion.

The chairman further said the construction of new Moshupa hospital was nearing completion as it had reached 78 percent.

Meanwhile, Mr Phiri also decried the overwhelming debt of Village Development Committees (VDCs) rentals saying it was one of the elements that impede the growth of VDCs.

He confirmed that the entire District were owed rental arrears

amounting to P212, 436.96 as at January 2024.

"The department of Community Development has engaged the Magistrate Court in collaboration with the Bye- Law Enforcement department.

This was sought after realising that summons in Kgotla took longer times for debts to be cleared," said Mr Phiri.

With regard to the introduction of the Temo-Letlotlo tractor scheme, he said "We have been seeing a lot of farmers showing interest in acquiring tractors.

A total of 16 farmers have been recommended for purchase, eight approved for purchase while two farmers have confirmed buying." *BOPA*.

### Botswana Rugby Union elects new committee

**GABORONE** - Botswana Rugby Union (BRU) outgoing president, Sean Irish says his love and support for rugby remains intact.

Irish appreciated the 10 years he spent at the helm of the union but said was at a point where he was overwhelmed with personal commitments though promising to continue serving as a coach which was his passion.

Addressing the BRU Annual General Meeting which also elected a new committee on Saturday in Gaborone, he said the future of the sport was in grassroots development.

"I have laid down the foundation, our development structures are now on track. Grassroots development is more important to us. I have seen many young players graduate from junior teams to ultimately play in the senior national team," he said.

Irish said BRU was not owned by committee members and instead, their role was to guide and drive the vision of the code as per the interests of its member clubs in alliance with the requirements of the governing structures.

Irish said the AGM was to elect a new committee, closing a chapter of his team which came into office February 2020. He said it was a norm that clubs would over time change leaders due to various reasons and expressed profound gratitude for the contribution made by those who had left various committees at club and union level.

The AGM he said was equally an interactive platform to carry out a postmortem of the union and chat way forward. "We will also look at our challenges and successes," he said.

BRU has taken a decision to reserve two slots for women in the board, this being part of developments to align with the statutes of the World Rugby governing body.

Irish said some new board committees were constituted to enhance governance of BRU including referees, technical, financial, women and disciplinary committees.

Irish said inadequate funds in the last four years of his tenure was the biggest challenge for BRU and because of that, key projects failed to take off as the sporting code started experiencing drastic reduction in funding from BNSC, making it impossible to among others review the constitution.

He said at the beginning of his term, the board tried to institute review of the constitution which he said needed an overhaul to align with that of BNSC, an exercise that remains urgent.

One of the latest developments to comply with is a request from government for all societies to reregister before May 24 deadline, Irish said and requested clubs to comply and avoid contradiction with Registrar of Societies.

He said clubs not duly registered would not associate with entities like BRU, whose existence was dependent on their membership. As for world rugby requirements, he said clubs were informed of changes to comply with, prior to commencement of the 2024 rugby season.

He said clubs must have a Level II medical personnel, coaches and match officials among others and non-compliance would result in

severe punishment, top of the list being reduced financial assistance from World Rugby and deduction of points from non-compliant clubs.

"As of today, only one clubs has submitted a list of all its registered players. Any movement that happens after the list has been submitted must be communicated to BRU in writing, to confirm any amendments to the original submission," he said.

Failure to comply he said had consequences with a direct bearing on the level of funding the BRU received from World Rugby.

"This are some of the low hanging fruits that BRU can capitalise on to get its funding increased," said Irish. The last funding that BRU received from World Rugby was 35 000 pounds and P479 000 from BNSC.

Despite financial constraints, he said BRU was able to provide training and education, noting that a total of 364 certificates were used of which 40 per cent (145) were issued to women. He said training included Level I, Level II in coaching and match officiating among others.

In relation to developing the game at grassroots level, he said BRU started the development of the game with three Re Ba Bona Ha centres in 2020, in Selebi Phikwe, Jwaneng and Maun. However, he said Selebi Phikwe centre had collapsed because the trained teacher who was manning the facility was transferred.

He said closure of the centre reduced development activities and negatively impacted on development funding which was reduced from P352 000 to P120 000 though the technical committee was working round the clock to find replacement coaches. reserves league. Currently, he said only four clubs managed to comply with the requirement. Meanwhile, Farid Pandor was elected BRU president, defeating Boitshoko Tsiane. He received 17 votes against Tsiane's five. Other committee members are vice president technical -Elijah Kokoro, secretary Osi Kopano, treasurer -Tobedza Gobona, Women's representative, Keneilwe Modise was unopposed. The position of vice president administration remains vacant as it was not contested. The AGM also managed to fill three of the four

# Botswana gears up for games

**GABORONE** - Botswana will send 54 athletes to compete at the 13<sup>th</sup> edition of the African Games that will be held in Accra, Ghana from March 8-23.

Team Botswan general manager Obakeng Ngwigwa said in an interview that the teams reported for camp last Sunday.

He said nine sporting codes would be competing being; athletics, basketball 3x3, boxing, beach volleyball, swimming, weightlifting, tennis, judo and taekwondo.

He said athletics had 23 athletes, boxing and basketball 3x3 had six each, beach volleyball, taekwondo, tennis and swimming had four each, judo had two and weightlifting had one.

In the last edition, Botswana won 13 medals; five gold, five silver and three bronze.

This time around, he said they had set a target of eight medals, which were not colour coded.

Currently, he said boxing team was the only code that went on a training camp in Zambia, where they featured in some tournament, while others had been training locally.

"Basically, Team Botswana is prepared and to date we do not have injuries and almost everyone is on camp apart from athletes who are based outside the country.

They will join the rest of the team in Ghana," he said. Ngwigwa said the games were important to Botswana as they wanted to use them as a precursor for the Paris Olympic Games, which was their main focus.

"We selected the sporting codes that we know were in the Olympic Games. Remember, some of the codes such as athletics, swimming and tennis athletes will stand a chance to qualify for the Paris 2024 Olympics at these games," he said.

He said those who had already qualified for the Olympics, would use the games to gauge their readiness to participate the Olympic Games.

As part of their preparations for the Los Angeles 2028 Olympics, he said they took a deliberate decision to select younger athletes for the African Games. "This year's edition means a lot to us, we have changed the way we do things. We do not want athletes to prepare for 2028 Olympics in 2027.We are going to start preparations in earnest," he said.

On doping issues, Ngwigwa said all the nine sporting codes had been competing locally and anti-doping officers had been attending the events teaching athletes about the implications of doping and conducting random testing as well.

Meanwhile, teams will leave for Ghana

in different batches. The first group, which comprises of beach volleyball, judo and swimming departs tomorrow.

Boxing team will leave Zambia for Ghana on Sunday, while tennis will leave on March 11. Athletics will leave on March 14.

Team athletics include, Thapelo Monaiwa (100m, long jump), Thuto Masasa (100m, 200m), Calvin Omphile (100m) Kevin Lobatlamang (200m), Jayson Mandoze (100m/200m), Victor Ntweng, Kemorena Tisang 400m Hurdles, Tshwanelo Aabobe (high jump), Tumo Nkape (800m), Omphile Seribe, Ernest Kumevu, Boitumelo Masilo, Bayapo Ndori, Collen Kebinatshipi and Leungo Scotch 400m/4x400m, Tsaone Sebele and Nancy Budzani (100m), Lydia Jele, Golekanye Chikane, Motlatsi Rante, Kamberuka, Tlhomphang Obakeng Basele (400m, 4x400m) and Oratile Nowe (800m, 4x400m).
