COUNT ONE: (As to the Defendant, Heather Lopez)

2. At said time, and for some time prior thereto, said dog (Kingston) was owned and/or kept by the Defendant, Heather Lopez.

3. At said time the Plaintiff was not engaged in the commission of a trespass or tort and was not teasing, tormenting or abusing said dog.

4. As a result of the conduct of the Defendant's dog, the Plaintiff, Lynn Tompkins, sustained the following injuries, consequential losses and expenses, all or some of which may be permanent in nature:

- (a) An injury to the face;
- (b) Pain, suffering and discomfort;

- (c) Emotional distress and mental anguish;
- (d) Headaches, anxiety, fatigue, apprehension and inconvenience;
- (e) The Plaintiff has in the past been and may in the future, be obligated to expend sums of money for medical care, hospital care, x-rays, surgeries, medicines, physical therapy, and other medical related services;
- (f) The Plaintiff has in the past been, and may in the future, be deprived of many of the usual pleasures, activities, and recreations of life; and
- (g) Said injuries and consequences have adversely affected the Plaintiff in the past and will continue to do so in the future.

5. Lynn Tompkins is the minor child of Ronda Tompkins and brings this action through her mother and next of friend, Ronda Tompkins.


