Both WBS elements can't be settled Any insights pl ? Hi, Can anyone please explain the reason why i get the error message: "AA617 Acquisition value negative in area 01" when doing asset transfer in trasnaction AIBU? During test in Dev environment, i got this error message. I was able to resolve it by ticking the "Neg. Values Allowed" in the AUC Depreciation area. However, when i test again in Quality system, i do not have this error.



The data i have processed in Dev and Quality are replicates. The only difference is that in Dev i am posting transfer in periods already in previous fiscal year. While in Quality, the asset transfer and asset creation date are all in the current fiscal year. Is this the reason why? Hi All I m having this error 'Acquisition value negative in area 01-Message no. AA617'. I know this can be solved by two ways- a) By activating 'Negative values allowed in asset master in respective depreciation area. b) By Tcode OADB- Allowing all values in respective depreciation area. By question is 1) Which among (a) & (b) is the best method. 2) How to see those negative values/any specific table. I m not able to see through asset explorer.
