In Art. 7 for the provisions of the Cabinet Secretaries, "Full-time service 17 persons; full-time service 134 persons' shall read "Full-time service 18 persons; Full-time service 141 persons", and in the same Article for the provisions of the Cabinet technical officials, "Full-time service 3 persons, Second class; Full-time service 11 persons, Third class" shall read "Full-time service 1 person, First class; Full-time service 9 persons, Second class; Full-time service 25 persons, Third class". Imperial Ordinance No. 524

The Enforcement Ordinance of the Temporary Special Instances of the Pensions Law.

- Art. 1. The Officials prescribed in par. 4 of the supplementary provisions of the Imperial Ordinance No. 435 of 1946, who are not applied to the provisions of Art. 1 of the said Ordinance (hereinafter to be called the applicable), shall be in accordance with the following Special Instances, for the purpose of the application of the Law concerning the Temporary Special Instances of the Pensions Law (hereinafter to be called the Law).
- 1. With regard to the application of the provisions of Art. 1 par. 2 of the Law, the amount corresponding to that of 400 per cent (in the case of the educational personnels of the National Schools and the schools of the similar kind, or the Police or Prison personnels, 200 per cent) of the salary which the applicable received actually on June 30, 1921 (hereinafter to be called the former salary), shall be regarded as the amount of salary which may be received by the applicable.
- 2. With regard to the application of the provisions of Art. 3 of the Law, the amount corresponding to that of 130 per cent (in the case of the applicable who has been received of office or is dead on account of the wound or sickness caused by official service, 140 per cent) of the monthly amount of the former salary, shall, respectively be, notwithstanding the provisions of the Table No. 1 of the Annexed Table of the Law, the monthly amount of the provisory salary of the applicable.
- 3. With regard to the application of the provisions of Art. 4 and Art. 6 inclusive of the Law, in the columns of grades and classes of the Tables Nos. 2 to 7 of the Annexed Tables of the Law, "monthly amount of salary at the time of retirement", "1,050 yen", "850 yen", "800 yen", "700 yen", "580 yen" and "390 yen", shall read respectively "Monthly amount of the provisory salary of the preceding item", "260 yen", "190 yen", "175 yen", "145 yen", asd "65 yen".

Art. 2. The increase of the pensions prescribed in Art. 8 of the Law, shall be made without the claim of the pensioners.

Art. 3. With regard to the application of the provisions of Art. 25 of the Enforcement Ordinance of the Pensions Law, "130 yen" and "800

yen" shall read respectively "800 yen" and "390 yen". However, it shall be applied to those persons prescribed in Art. 1.

Supplementary Provision:

The present Imperial Ordinance shall be applied as from July 1, 1946.

Imperial Ordinance No. 525

The Ordinance for the Dissolution of the Central Foodstuffs Corporation.

Article 1

The Central Foodstuffs Corporation shall be dissolved.

Article 2

The Ministry of Agriculture and Forestry is required to entrust the registry offices at the seats of the principal and branch offices of the Central Foodstuffs Corporation with the registration of its dissolution.

The registry offices must effect the registration without delay when they are entrusted with the registration as stated in the preceding paragraph.

Article 3

The President of the Central Foodstuffs Corporation must without delay give public notice of its dissolution.

Article 4

The Minister of Agriculture and Forestry must appoint liquidators from among the President, Vice-president, and Directors of the Central Foodstuffs Corporation.

The Minister of Agriculture and Forestry may, if he deems it necessary to do so for public interests, remove any of the liquidators.

In cases where a vacancy occurs among the liquidators or it is needed to increase their membership, the Ministry of Agriculture and Forestry shall appoint a liquidator, or liquidators. In such

cases, the appointment may also be made from other persons than those mentioned in par. 1.

Article 5

The liquidators must not engage in other occupations, except in case where the approval of the Minister of Agriculture and Forestry has been obtained.

Article 6

The liquidators must not effect a transaction with the Central Foodstuffs Corporation for themselves or a third person. However, this shall not apply in case the approval of the Minister of Agriculture and Forestry has been obtained. In this case, the provisions of Article 108 of the Civil Cole shall not apply.

Article 7

The liquidators must, without delay after assumption of office, inquire into the actual state of the property of the Central Foodstuffs Corporation, prepare an inventory and a balance sheet, and submit them to the Ministry of Agriculture and Forestry for acknowledgement.

The liquidators must effect the liquidation in accordance with the plan for liquidation as determined by the Minister of Agriculture and Forestry.

The Minister of Agriculture and Porestry may, if he deems it necessary issue to the liquidators orders as may be necessary with respect to the liquidation.

Article 8

The liquidators must obtain the approval of the Minister of Agriculture and Foretry for doing any of the acts mentioned below:

- 1. To dispose of the property of the Central Foodstuffs Corporation;
- 2. To undertake acts of procedure;
- 3. To make compromises or agreements for arbitration:
- 4. To waive their rights.

If the liquidators have contravened the provisions of the preceding paragraph, the Central Foodstuffs Corporation shall also be responsible for a third person acting in good faith.

Article 9

The surplus assets must be distributed among the investors in proportion to the amounts of their contributions.

However, the amount so distributed to each investor must not exceed the amount calculated by adding to the amount paid up by him the amount equivalent to its five percent per annum for the period from April 1, 1946 to the time when said distribution is made.

The surplus assets which may remain after the

distribution as mentioned in the preceding paragraph was made shall devolve on the National Treasury.

Article 10

The liquidators must obtain the approval of the Minister of Agriculture and Forestry for the distribution of the surplus assets.

The distribution of the surplus assets may, with the approval of the Minister of Agriculture and Forestry, be effected with other things than money.

Article 11

When the work of liquidation has been completed, the liquidators shall without delay prepare a report of the final accounts and sulmit it to the Minister of Agricuture and Forestry for approval.

Article 12

When the liquidation has been completed, the liquidators must effect the registration of the completion of the liquidation at the seat of principal office within two weeks and at the seats of branch offices within three weeks after the approval mentioned in the preceding Article has been obtained.

Article 13

The liquidators must submit the books of the Central Foodstuffs Corporation and important papers relating to its business and the liquidation to the Minister of Agriculture and Forestry without delay after the completion of the liquidation has been registered.

Article 14

Any registration of the Central Foodstuffs Corporation shall be made by the application of the liquidators, except in case the registration of its dissolution is made.

Article 15

The provisions of Art, 73, 78, and 81 of the Civil Code, Art. 123 pars. 2 and 3, 125, 128, 131, 254 par, 2, 266, and 421-424 of the Commercial Code, and Art. 176 and 177 par. 2 of the Law of Procedure in Non-contentions Matters shall apply with the necessary modifications to the liquidation of the Central Foodstuffs Corporation; provided, that in Art. 125 par. 3 and 423 par. 2 of the Commercial Cole for the reference to "the Court" there shall be substituted a reference to "the Minister of Agriculture and Forestry".

Article 16

The Minister of Agriculture and Forestry may, if he deems it necessary for the supervision of the figuidation, order the liquidators to make a report

on the state of the work of liquidation and property, or cause the officials concerned visit the business offices, working places, and other places, and examine the state of the work of liquidation and property.

Article 17

The Superintendent Committee for the Liquidation of the Central Foodstuffs Corporation shall established in the Ministry of Agriculture and Forestry, whose object is in compliance with the inquiry of the Minister to inquire into and deliberate on the appraisal of the property of the Central Foodstuffs Corporation and other important matters relating to the liquidation.

Article 18

The Superintendent Committee for the Liquidation of the Central Foodstuffs Corporation shall be under the supervision of the Minister of Agriculture and Foresty.

The committee shall consist of a chairman and members not exceeding 30.

The chairman and members shall, through the recommendation of the Minister of the Agriculture and Forestry, be appointed by the Cabinet from among officials of First or Second class in the Government Offices concerned, the investors of the Central Foodstuffs Corporation, and men of knowledge and experience.

The Committee shall have some secretaries.
They shall, through the recommendation of the Minister of Agriculture and Forestry be appointed by the Cabinet from among officials of Second class in the Government Offices concerned and men of knowledge and experience.

Other necessary matters concerning the Committee than those provided in this Imperial Ordinance shall be determined by the Minister of Agricultur eand Forestry.

Article 19

If any of the liquidators has neglected to make a report in accordance with the provisions of Art. 16, made a false report, or refused, obstructed, or evaded an examination conducted by the officials concerned, he shall be liable to imprisonment with hard labour for a term not exceeding six months or a fine not exceeding two hundred yen.

Supplementary Provision:

This Imperial Ordinance shall come into force as from the day of its promulgation.

Imperial Ordinance No. 529

Article 1. With regard to each of the following ems, any one who has violated the restrictions r prohibitions designated by the competent Minter in accordance with the provision of paragraph of Article 35 of the Fisheries Law, shall be subsect to penal servitude for two years or less, or a ne-of ¥30,000 (thirty thousand yen) or less, espite the provision of the former part of Article 9 of the same Law:

- 1. The species, size or number of whales to be taken (excepting size of sei-whales).
- The sea areas (excluding seas north of 20 North Latitude) or whaling period in which whales are taken.
- The operation of factory ships used for treating baleen whales on seas south of 40 South Latitude.
- 4. The utilization of whales taken.
- 5. The remunerations for the crews of factory ships or whalers.
- 6. The use of land stations for taking or treating baleen whales.

Article 2. Any one who has violated the restrictions or prohibitions of the preceding Article Laay be subject to simultaneously penal servitude and fine according to circumstances.

Article 3. In case a representative of a juridical person, an agent, an employee or any other worker of a juridical person or an inlividual has offended against the provision of Article 1 in the performance of the business of a juridical person or an individual, not only the actual offender shall be punished, but the juridical person or the individual shall also be subject to the monetary penalty of

the same Article.

Supplementary Provision:

The present Ordinance shall come into force as from the day of its promulgation.

Special accounting companies who desire to obtain the approval on the Transfer of the company's assets from the new account to the old account shall file with the competent Minister an application stating the following particulars through the head office, branch office or other place of business of the Bank of Japan.

- 1. Address and trade-name of the company.
- 2. Amount of capital stock and of paid-up -capital stock.
- 3. Main business of the company.
- 4. Kinds of the company's assets to be transferred from the new account to the old account and the book-value.
- 5. If the company's assets to be transferred is utilized on the new account, its operation
- 6. Kinds of security claim existing prior to the designated hour over the company's assets to be transferred its amount and address, name, trade-name or title of the
- creditor. .
- 7. If the security claim is established after the designated hour on the company's assets to be transferred, kinds of the security claim, trade-name or title of the creditor.
- 8. Reasons necessitating the transfer.
- 9. Other references.

The regulations concerning the Inquiry into the Acceptability of the Principal, Members and Instructors of the Foreign Service Officials Training Institute have been decided as follows:

Regulation concerning the Inquiry into the Acceptability of the Principal, Members and Instructors of the Foreign Service Officials Training Institute.

Article 1. The inquiry into the acceptability of the Principal, Members and Instructors of the Foreign Service Officials Training Institute shall be entrusted to the Inquiry Committee for Educational Officials' Acceptability and the Central Inquiry Committee for Educational Service Members' Acceptability under Article 1 of the Ministry of Education Instruction, No. 5, of 1946.

Article 2. A person who has been judged as non-acceptable by the Inquiry Committee for Educational Officials' Acceptability, and who is discontented with its decision, is entitled to apply through the Vice-Minister for re-investigation to the Central Inquiry Committee for Educational Service Members' Acceptability.

Article 3. In case the Vice-Minister considers the decision of the Inquiry Committee for Educational Officials' Acceptability to be unjust, he may request the Central Inquiry Committee for Educational Service Members' Acceptability through the Vice-Minister of Education for re-investigation of the case.

Article 4. A person who has been judged as

non-acceptable by the Central Inquiry Committee for Educational Service Members' Acceptability, and who is discontented with its decision, is entitled to apply for special investigation to the Minister of Education through the Minister for Foreign Affairs.

In case of the preceding paragraph, the Minister of Education may judge the person as acceptable when he considers the said decision unjust.

Article 5. In case the Vice-Minister for Foreign Affairs considers unjust the decision of the Central Inquiry Committee for Educational Service Members' Acceptability, he may apply through the Minister for Foreign Affairs for special investigation to the Minister of Education.

In case of the preceding paragraph, the Minister of Education may judge the person as acceptable or non-acceptable when he considers unjust the said decision.

Article 6. The Minister for Foreign Affairs shall, Members and Instructors of the Foreign Service Officials Training Institute, compile and preserve the following papers:

- I Questionnaires.
- II Records of Investigations.
- III List of the acceptable.
- IV List of the non-acceptable.
- V List of the discharged and the re-instated.
- VI Other papers relating to investigations.

- 5. Concerning the affairs of supervisions inside of the Price Board.
- Concerning the affairs of welfare of the personnel.
