CABINET & MINISTERIAL ORDINANCE

Cabinet and Ministry for Home Affairs Ordinance No. 8

April 11, 1947

Part of the Cabinet and Ministry for Home Affairs Ordiance No. 1 of 1947 (Ordinance concerning the Enforcement of the Imperial Ordinance of the same year pertaining to the exclusion, retirement, etc. from Public Office) shall be amended as follows:

Prime Minister

YOSHIDA Shigeru Minister for Home Affairs

UEHARA Etsujiro

In paragraph 4 of the Appendix 1, the following shall be added after "Chief or influential deputy chief of a section of the National Headquarters or of the Central Training Institute":

President (Tôri) and Secretary-General (Honbu Cho) of the Asia Development Headquarters (Kôa Sô Honbu)

Chief of a bureau (Kyoku Cho) of the Asia Development Headquarters Chief (Bu Cho) or influential Deputy Chief (Fuku Bu Cho) of the Asia Development Headquarters.

In 5 of the same paragraph, "member of Council for Establishing the Imperial Rule Assistance Political Structure" shall read "member of Council for Establishing the Imperial Rule Assistance Political Structure (including the local branches thereof)."

Supplementary Provision:

The present Ordinance shall come into force as from the day of its promulgation.
