MINISTERIAL ORDINANCE

Ministry of Finance Ordinance No. 67

July 9, 1947

The Regulations of the Mutual Aid Association of the Mint shall be partially amended as follows:

Minister of Finance
KURUSU Takeo

In Article 5-2, "spouses of those members who have been belonging to the Association for more than six months" shall read "lineal ascendants and spouses of the members."

In Article 6, Paragraph 2, "workmen (*shokko*)" shall read "workmen (*koin*)," in Paragraph 3 of the same Article, "a bonus of 1,820 yen a year" shall read "a salary of 1,200 yen a month," and in Paragraph 4 of the same Article, "higher officials, those officials receiving due honour to higher officials, *hannin*-rank officials (including superintendants) and those officials receiving due honour to *hannin*-rank officials" shall read "second class officials, those officials receiving due honour to second class officials, third class officials and those officials receiving due honour to third class officials."

Item 4 of Article 7 shall be deleted.

In Article 11, "salaries, wages or allowances (hereafter called wages)" shall read "salaries or wages (hereafter called wages)" and in Item 3 of the same Article, "twenty-six times as much as their daily wages" shall read "thirty times as much as their wages."

Item 1 of the same Article shall be deleted, Item 2 and Item 3 of the same Article shall read Item 1 and Item 2.

Article 12. All members shall pay those amounts in instalments every month that shall be given by multiplying their monthly wages by the following rates, provided that, should those members, who have been belonging to the association since the preceding month, lose their memberships, they need not pay the instalments of the month when they lose their memberships.

If those amounts, counted according to the above paragraph, are less than ten *sen*, they shall be ten *sen*.

If their wages are increased or decreased for the time being according to special or temporary reasons, their instalments shall not be increased or decreased.

The text of Article 13, Paragraph 1 shall be revised as follows:

If those members, who have been belonging to the Association since the preceding month, come under one of the following items, they need not pay their instalments from the present month on to the month, after which they come out of it. If the members come under one of the following items in the month when they get their memberships, they need not pay their instalments from the next month on to the month after which they come out of it, provided that, if they come out of it in the month when they come under one of the following items, this shall not be applied.

Item 4 of the same Article shall be revised as follows and Paragraph 2 of the same Article shall be deleted.

4. When they have been outside of Japan Proper more than three months.

In Article 16, Paragraph 1, Item 3, "those higher officials and other officials receiving due honour to higher officials, who are receiving more than 1,820 yen a year (excluding superintendants)" shall read "third class officials and other officials receiving due honour to third class officials, who are receiving more than 1,200 yen a month."

Article 19-(2). The amounts to be given for mutual aids (excluding secede lump sums) shall be the same as one-sixth of wages (hereafter they are called assumption wages), are standards of instalments in the time when the causes of mutual aids happen, provided that, if assumption wages are less than monthly wages of June 30, 1946, the latter shall be considered as assumption wages.

Amounts of sanitation aids shall be counted according to wages which are standards of instalments in the time when causes of sanitation aids happen, provided that, wherever amounts of instalments are revised, amounts of injury and disease allowances and birth allowances shall be counted according to wages which are revised standards of instalments.

In Article 20, Paragraph 2, "yearly wages" shall read "monthly assumption wages."

Article 22 shall be deleted.

The proviso of Article 28 shall be deleted.

In Article 34, Paragraph 1, "Article 13, Paragraph 1," shall read "Article 13," "Items 1-3 inclusive of the same paragraph of the same Article" shall read "Items 1-3 inclusive of the same Article," in Paragraph 2 of the same Article, "Article 13, Paragraph 1, Item 4," shall read "Article 13, Item 4," and "outside of Japanese Empire" shall read "outside of Japan Proper"

In Articles 43, 44, 47, 50, 51, 52, 56 and 57, "wages" shall read "assumption wages."

In Article 62, Paragraph 2, "Items 4-6 inclusive of the above paragraph" shall read "Item 5 and Item 6."

Item 2, Article 64 shall be revised as follows and Item 3 of the same Article shall be deleted.

2. When they receive diagnosis or medical treatments by physicians, dentists or others who are not designated by the Association, and the Association finds it necessary.

Article 66. Aids about medical treatments and expenses shall not be given for more than two years from the time when they begin to be given, in accordance with one injury or disease or another disease caused by them, excluding an injury or disease caused by official duties.

In Article 68, Paragraph 2, "the text of Article 66, Paragraph 1," shall read "the text of Article 66."

In Article 71-(2), "two-tenth" shall read "four-tenth."

Article 71-(3). The term of giving injury and disease allowances shall not be longer than six months from the day when a member becomes to be unable to serve, in accordance with one injury or disease or another disease caused by them.

Notwithstanding the above paragraph, injury and disease allowances relative to one injury or disease or another disease caused by official duties, shall be given until returning to offices, and the term of giving them shall be longer than the term provided for in the above paragraph, but not longer than one year, concerning tubercular diseases.

The term for giving injury and disease allowances shall be longer than six months from the time when a member becomes to be unable to serve, in accordance with one injury, disease or another disease caused by them.

Article 72. When a member is brought to bed of a child, she should be given the same amount as much half of her monthly wage as a birth-expense, provided that, if it is less than 100 yen, it shall be 100 yen.

The above paragraph shall be applied to a member who is brought to bed of a child within six months from the time when she secedes from the Association.

Article 73, Paragraph 2 shall be revised as follows:

The amount of a birth-expense to be given to a member in a maternity hospital, hospital or clinic shall be much as half of the amount that is provided for in the above Article.

Article 76 shall be deleted.

In Article 76-(2), "10 yen" shall read "50 yen."

In Article 8, Paragraph 1, Item 1, "national bonds of Manchukuo" shall be deleted.

In Article 86, Paragraph 2, "higher officials and hammin-rank officials" shall read "officials of the Mint."

Supplementary Provisions:

The present Regulations shall be applied as from November 1, 1946.

The former Regulations shall be applied to the treatments between July 1 and October 31, 1946, and to those members who receive continuously salaries or wages which were existing on June 30, 1946.

The present Regulations shall be applied to the mutual aids to be given to those members provided for in Paragraph 3 of the supplement provisions of the Ministry of Finance Ordinance No. 32, 1943, provided that they shall pay those amounts as mutual aid

instalments that are designated by the Director of the Mint.

Ministry of Justice Ordinance No. 61

In compliance with the provisions of the second paragraph of Article 25 of the Notary Public Law, the Rules relating to Preservation and Abandonment of Documents of Notary Public are provided as follows:

Rules relating to Preservation and Abandonment of Documents of Notary Public

Article 1. The preservation and abandonment of documents prepared and kept by Notary Public shall be governed by the provisions of the present Ministerial Ordinance.

Article 2. The documents of notary public under-mentioned shall be preserved in compliance with the following discrimination:

- (1) Original of deed, ledger of deeds 50 years;
- (2) Article of corporation, certification register, and book of denotation of trust kept by notary public 30 years;
- (3) Book of incontrovertible dates, documents in compliance with the provisions of the second paragraph of Article 21 of the Detailed Regulations for the Enforcement of the Notary Public Law, inventory in compliance with the provisions of Article 8 of the Law concerning Emergency Measures for the Accounts of Financial Institutions, detailed statement in compliance with the provisions of Article 8 of the Law concerning Emergency Measures for the Accounts of Companies 20 years;
- (4) Receipt book, file of copy of protests, file of copy of protests for non-payment of bill of hypothec 10 years.

The calculation of the period of preservation for ledger of deeds, certification register, book of denotation of trust, book of incontrovertible dates and receipt book shall be computed from the following year of the last entry having been made to those books, that for file of copy of protests and file of copy of protests for non-payment of bill of hypothec from the following year of the last filling having been made to those books, and that for the other documents from the following year of the fiscal year concerned.

Article 3. Documents mentioned in the preceding Article, even after the period of preservation thereof has matured, shall be preserved, if the preservation thereof is necessary owing a special reason, as long as there exists the said reason.

Article 4. In case a notary public wants to abandon documents whose preservation period has matured, he shall get permission from the Minister of Justice through the Chief of the Judiciary Bureau to which he is attached, with the presenting of list thereof.

Supplementary Provision:

The present Ministerial Ordinance shall come into force as from day of its promulgation.

2. (1) The controlled prices of this list shall be for those which have qualified the regulations of inspection by Reito Seikabutsu Kyokai. In the above case a certificate of qualification or disqualification shall be attached to the goods, and controlled prices of those which do not carry the said certificate, or those disqualified, or those which do not undergo the said inspection shall be amounts deducted by 50% from the controlled prices of this list.

5. a. The controlled prices shown in the present list shall be for those which without any container. In case of sale with receptacle, 5.50 yen per bottle of containing 630 cc and 3.50 yen per bottle of containing 350 cc may be added respectively.

b. The controlled prices mentioned in the present list shall be for those which have come under the standard stipulated by the Zenkoku Seichoinryo Kogyo Kyodokumiai Rengokai and also have shown clearly the address and name of producer on the receptacle. The controlled prices of which do not fall under the standard of the aforementioned *Kumiai* or of which do not shown clearly the producer's address, and name on the receptacle shall be subject to the controlled price "Other drinks" mentioned in this list.
