MINISTERIAL ORDINANCE

Ministry of Agriculture and Forestry Ordinance No. 62

July 29, 1947

According to the Designated Rationed Commodities Distributing Procedure Regulation, Cabinet Instructions No. 3, issued in 1947, the following Processed Marine Products Distribution Regulation shall be enacted under the Temporary Demand Supply Adjustment:

The Processed Marine Products Distribution Regulation

Chapter I

General Provisions

Article 1. Except those as otherwise provided, the processed marine products demand and supply adjustment shall be effected by this Regulation.

Article 2. Whenever used in this Regulation, the term

"designated marine products" shall mean as follows:

 Processed sardine (boiled and dried sardine, boiled, dried, and smoked sardine, salted and dried sardine, salted sardine, and slightly dried sardine);

 Processed herring (dried herring ("Migakinishin"), "hokawari" herring, dried herring eggs, and salted herring);

 Processed cuttle-fish (dried outtle-fish, salted cuttle-fish, and pickled cuttle-fish);

 Processed cod (salted cod, salted and dried cod, and slightly dried cod);

5. Roasted fish-cake (including frozen one).

6. Edible pulverized fish (including "soboro" and oil extracted edible pulverized fish);

7. Frozen fish (excluding frozen roasted fish-cake);

8. Tangle;

9. Agar-Agar;

10. Raw sea-weed of agar-agar ("tengusa," "ogo," "ego," "igisu," "onikusa," "toraishi," "hira-kusa" and "dorakusa");

 Other marine products as may be designated by the Minister of Agriculture and Forestry.

Whenever used in this Regulation, the term "processed marine products" shall mean all marine products as mentioned in the preceding paragraph which have been processed and all sea fish and animals which have been processed for food use, except, however, such processed marine products as are provided in Article 2, item 3-5 of the Fresh Fish and Shellfish Distribution Regulation and canned or bottled marine products.

Chapter II

Collection and Shipment

Article 3. The Minister of Agriculture and Forestry shall designate some important producing areas for each article of designated marine products in order to facilitate the collection and shipment of designated marine products for the consumption of great urban districts or other needed regions, or to improve the exportation thereof.

If a prefectural governor deems it necessary to do so, he may designate one or more important producing areas other than those designated by the Agriculture and Forestry Minister under the preceding paragraph.

Article 4. Any person who makes it his business to purchase the designated marine products in a producing area designated by the Agriculture and Forestry Minister under the preceding Article (hereinafter referred to as A-class designated producing area) or in a producing area designated by the prefectural governor under the same Article

(hereinafter referred to as B-class designated producing area) from any producer thereof in said area or any person carrying the same into said area, to be consigned to sell the same in said area by such producer or person, or to consign to sell the same at said area, shall obtain a licence as a collection agency from the Agriculture and Forestry Minister in case of A-class designated producing area or from the prefectural governor in case of B-class designated producing area.

A person who may be granted such licence as mentioned in the preceding paragraph shall be a corporation of producers of the designated marine products or other persons who are equipped both in materials and labor for fulfilling a minimum quantity held responsible for collection designated as to A-class designated producing area, by the Agriculture and Forestry Minister, and designated, as to B-class designated producing area, by the prefectural governor. Standard for qualification as a licensed collecting agency shall be determined and announced in public notice by the Agriculture and Forestry Minister for A-producing area and by prefectural governor for B-producing area.

Any person who wishes to obtain a licence mentioned in Par. 1 shall submit an application for a licence of collection agency to the Agriculture and Forestry Minister or to the prefectural governor concerned, specifying his name, name of producing area, locality of his business office, estimated quantity of collection by the kind of Articles to be collected, and other matters deemed necessary by the Agriculture and Forestry Minister or by the prefectural governor concerned, (in a case of a corporation, its name and the name of its representatives shall also be stated in said application, together with its Articles of corporation and other kind of documents similar thereto.)

The minimum quantity held responsible for collection or shipment as mentioned in Par. 2 shall be fixed for all interested agencies on equal basis by the Agriculture and Forestry Minister in case of A-class producing area, or the prefectural governor, in case of B-class producing area and the instruction thereof shall be made by means of public notice, instruction regarding other necessary administrative matters as mentioned in preceding paragraph shall be fixed and notice given in the same manner.

Article 5. Any person who has obtained a license as mentioned in Par. 1 of the preceding Article (hereinafter called "licensed collection agency") shall submit every quarter year a report on his estimated quantity of collection by the month, on his monthly shipped quantity to receiving agencies at the destination, and on such matters as may be instructed by the Agriculture and Forestry Minister or the prefectural governor, as to A-class producing area, to the Agriculture and Forestry Minister through the prefectural governor, as to B-class producing area, to the prefectural governor concerned directly.

The form, manner, and term of such report as mentioned in the preceding paragraph and other necessary matters shall be fixed by the Agriculture and Forestry Minister or the prefectural governor.

Article 6. The Agriculture and Forestry Minister shall,

based upon the report submitted under the preceding Article, Par. 1 and an estimated production quantity submitted to the prefectural governor concerned by the licensed collection agencies at A-class producing area, issue an order to said agencies through the prefectural governor concerned with respect to the destination, shipping quantity, and term of shipment of the designated marine products for each month and other necessary matters for shipment.

The prefectural governor shall issue an order to the licensed collection agencies at B-class producing area with respect to the destination, shipping quantity, and term of shipment of the designated marine products and other necessary matters for shipment.

Article 7. Any person who produces the designated marine products in the designated producing area or carries the same into said area shall sell or consign to sell such products produced or carried into to the licensed collection agencies at said area; provided, however, that this shall not apply to the following cases:

- 1. In case where the designated marine products are transported through the designated producing area as a certified approved shipment;
- 2. In case where the designated marine products are used as raw materials for processing purpose in accordance with official allocation made by the Agriculture and Forestry Minister under the provision of Article 24, or by the prefectural governor under provision of Article 16;
- 3. In such other cases as may be approved by the Agriculture and Forestry Minister or the prefectural governor with expressed approval of the Director-General of Economic Stabilization Board.

Article 8. No person other than a licensed collection agency, a person who ships the designated marine products according to his allocated quota, or a person who is entrusted with the transportation thereof by the formers shall carry the designated marine products out from the area of city, town, or village where the same was produced or where the same was carried into: provided, however, that this shall not apply to the following cases:

- 1. In case where the designated marine products are carried out, in such quantity not in excess of 1 "kan" as may be permitted for one's own family consumption by the prefectural governor;
- 2. In case where the designated marine products carried out as a continuation of transportation through the designated producing area as certified approved shipment;
- 3. In such other cases as may be approved by the Agriculture and Forestry Minister or the prefectural governor with expressed approval of the Direct-or-General of Economic Stabilization Board.

Any person who carries the designated marine products out from the area of city, town, or village other than the designated producing area shall be given a certificate by the prefectural governor concerned; provided, however, that this shall not apply to the case where he carries out the same in such quantity not in excess of 1 "kan" as may be permitted for his own family consumption by the prefectural governor concerned.

Receiving and Distribution in Consuming Area

Article 9. The special designated consuming area for frozen marine products shall be the same as those designated under the provision of Fresh Fish and Shell Distribution Control Regulation.

The prefectural governor may designate a consuming area to be supplied with frozen marine products other than such consuming areas as may be designated by the Agriculture and Forestry Minister under the preceding paragraph and he may also designate a consuming area to be supplied with designated marine products other than frozen marine products.

Article 10. Any person who makes it his business to purchase or to be consigned to sell by wholesale the designated marine products in a consuming area designated by the Agriculture and Forestry. Minister or the prefectural governor under the preceding Article (hereinafter called designated consuming area) shall obtain a licence as a receiving agency from the prefectural governor concerned.

A person who may be granted such licence as mentioned in the preceding paragraph shall be equipped both in materials and labor for fulfilling a minimum quanity held responsible for collection which is designated by the prefectural governor under the provisions of this Article, Par. 4.

Any person who wishes to obtain a licence mentioned in Par. 1 shall submit an application for a licence of receiving agency to the prefectural governor concerned, specifying his name, locality of his business office, names of the designated marine products handled by him, estimated quantity of collection by the kind of articles to be collected and by the producing areas thereof, and other related matters necessary for proper administration by the prefectural governor concerned, (in a case of a corporation, its name and the name of its representatives shall also be stated in said application, together with its Articles of corporation and other kind of documents similar thereto).

The minimum quantity held responsible for collection as mentioned in Par. 2 shall be fixed for all interested agencies on equal basis by the prefectural governor and the instruction thereof shall be made by means of public notice.

Article 11. Any person who makes it his business to retail processed marine products to individual consumers in the designated consuming area shall be granted a licences a processed marine products retailer by the prefectural governor (hereinafter called licensed retailer).

Any person who is qualified to register as licensed retailer shall be a person who has received standard number of electoral votes based on the expressed will of the consumer established by the prefectural governor in the designated district concerned.

The prefectural governor shall establish standard number of electoral votes as prescribed in the preceding paragraph impartially and equally to all persons concerned and shall give a public notice thereof.

The prefectural governor shall cause the election of selecting licensed retailer as prescribed in Para-

graph 1 at least once in every six months and from any licensed retailer who does not receive standar number of electoral votes as prescribed in the preceding paragraph, shall revoke his license.

Any person who wishes to obtain a licence mentioned in the preceding paragraph shall subman application for a licence of retailer to the prefectural governor concerned, specifying his name locality of his shop, name of retailed articles; an if any, name of other business which he carries o concurrently with his proper business.

Any person who wishes to manage two or mor shops in carrying on the business as mentioned i Par. 1 shall obtain said licence for each one of them

In granting a licence mentioned in Par. the prefectural governor may issue an instruction necessary for the distribution of processed marin products with respect to facilities for distribution quantity to be rationed to individual consumer an distribution methods.

Article 12. The licensed retailer, shall keep a licenc certificate issued by the prefectural governor an shall display his licence number, official fixed reta price of processed marine products retailed at hi shop, retailed quantity of the designated marin products on a sale day, and other matters designate by the prefectural governor at the front of his sho on other visible places.

Article 13. The licensed receiving agency shall submi a monthly report on the plan for receiving by th collection agency in the designated producing are to the prefectural governor on and before the dat designated by him.

The prefectural governor shall, based upon the plan for collection in the preceding paragraph designate a monthly quantity held responsible for collection and other necessary matters pertaining thereto to each licensed receiving agency.

Article 14. Any person who produces the designate marine products in the designated consuming are or carries the same into said area shall carry sucl designated marine products into a place designate by the prefectural governor concerned (hereinafte called the designated market) and shall sell or consign to sell the same to the licensed receiving agenc which has its shop at said designated market provided, however, that this shall not apply to the following cases:

1. In case where such designated marine product are used in such quantity not in excess of 1 "kan" as may be permitted for one's own family con sumption by the prefectural governor concerned

2. In case where such designated marine product are transported through the designated consuming area on a certified approved shipment:

3. In case where such designated marine product are used as raw materials for processing purpose in accordance with official allocation made by the Agriculture anh Forestry Minister under the provision of Article 24.

Article 15. Whenever the licensed receiving agencies receive the designated mrine products at the designated market, they shall report the received quantity thereof by the kind of articles and by the shipper thereof to the prefectural governor without delay and it shall undergo inspection of the kind, quantity quality, etc. of the same.

rticle 16. The prefectural governor shall work out a plan in which the designated marine products underwent inspection in the preceding Article are equitably allocated according to their uses for family ration, district large consumers, processing purpose, and other purposes except food and may issue to the receiving agencies an order, with respect to the sale storage and transmission of said designated marine products, specifying the kind, quantity, transferee of the same and other Administrative particulars.

rticle 17. The prefectural governor may, based upon the planned allocation in the preceding Article, deliver an allocation certificate for distribution specifying the kind, quantity, transferee, and other administrative matter to licensed retailers, large consumers, processors, and others.

Such persons as mentioned in the preceding paragraph shall not receive the designated marine products from the transferee specified in the allocation certificate for distribution without an exchange

of said certificate.

rticle 18. The prefectural governor shall issue a coupon for purchase by subscription to consumers in the designated consuming area.

A consumer may, in accordance with the regulations fixed by the prefectural governor, subscribe for the purchase of the designated marine products at a licensed retailer which he chooses according to his own will, submitting his purchasing coupon mentioned in the preceding paragraph.

The licensed retailer shall submit all the purchasing coupons which he collected from consumers who subscribed at his shop to the prefectural governor and shall receive an allocation certificates

for distribution from him.

The licensed retailer shall sell without delay the designated marine products which he purchased in exchange for the allocation certificate for distribution mentioned in the preceding paragraph to the consumers who subscribed for the purchase thereof at his shop.

rticle 19. The prefectural governor may, with the approval of the Agriculture and Forestry Minister, issue instruction to producers, dealers, or consumers of the designated marine products with respect to administrative matters necessary for receiving or distribution of the designated marine products in areas other than the designated consuming area, such as facilities for receiving or distribution, quantity of ration to each consumer, and receiving and distribution methods.

rticle 20. The Agriculture and Forestry Minister may, with respect to some of the designated marine products, issue an instruction on basic amount of ration for each consuming category, distribution amount for each area, and other administrative matters necessary for distribution methods to the prefectural governor.

Upon his receipt of an instruction as mentioned in the preceding paragraph, the prefectural governor shall, in accordance with said instruction, take necessary steps, such as an instruction on shipment in Article 6, Par. '2, an instruction on assortment in Article 16, delivery of an allocation certificate for distribution in Article 17, Par. 1, and issuing of a

coupon for purchase by subscription in Article 18, Par. 1.

Article 21. The prefectural governor shall cause the licensed retailer of fresh fish and shell-fish to take charge of the distribution business of frozen marine products and as well cause him to distribute said products in the same manner as fresh fish and shell-fish is distributed.

Chapter IV

Miscellaneous Regulations

Article 22. All matters necessary for receiving and distribution of imported marine products shall be determined by the Agriculture and Forestry Minister.

Article 23. Producers or dealers or designated marine products shall not, with the exception of a case by which they have received allocation of designated marine products for specific raw materials, use designated marine products in their possession as the raw materials for the manufacture of other products.

Article 24. Person, association, or company who manufactures other products using designated marine products as raw materials, and national large consumers of designated marine products who wish to receive directly from licensed collecting agency a necessary amount of designated marine products shall apply to Agriculture and Forestry Minister for allocation of designated marine products.

Exporters of designated marine products who ish to receive designated marine products which they handle directly from licensed collecting agency, shall apply to the Agriculture and Forestry Minister for allocation of designated marine products.

The Agriculture and Forestry Minister shall equitably allocate the designated marine products to the applicants provided for in Pars. 1 and 2 of this Article. All allocation made by the Agriculture and Forestry Minister shall be published by public notice.

The Agriculture and Forestry Minister shall determine necessary administrative matters regarding method of application, procedure in buying, method of distribution of designated manufactured marine products, and publish the same by supplementary instruction.

Article 25. No one may engage in the production of the designated marine products unless he has received an allocation from the Agriculture and Forestry Minister under provisions of Article 24 or the prefectural governor under the provisions of Article 16.

No designated marine products other than those allocated by the Agriculture and Forestry Minister under the provision of Article 24, or the prefectural governor under provision of Article 16 may be used in production of manufactured marine products.

Article 26. Standard for qualification as a producer of fish-mill for food will be determined and announced in public notice by the Agriculture and Forestry Minister.

No one may engage in the business of producing fish-mill for food without meeting standard provided for in the preceding paragraph.

Article 27. The Agriculture and Forestry Minister or the prefectural governor may, if he deems it necessary to do so, for demand and supply adjustment, order producers, collecting agencies, or receiving agencies of the designated marine products to preserve or store said products.

Article 28. Whenever any licensed collecting agency, licensed receiving agency, licensed retailer, national large consumer who receive allocation prescribed in Article 24, any exporter who receive an allocation prescribed in the same Article, any person who violates any one of provisions of this Regulation, any designation, instruction, or order issued pursuant to this Regulation, any law or ordinance regarding price control, the Agriculture and Forestry Minister or the prefectural governor may withdraw a licence or allocation from such violator, order to suspend his business or take other necessary steps.

Article 29. Any collecting agency, receiving agency, retailer, larger consumer, exporter, producer who could not be granted a licence or an allocation by the Agriculture and Forestry Minister or the prefectural governor without any reasonable cause, or any person who is not satisfied with the disposition or steps, as prescribed in the preceding Article, may appeal to the Director-General of Economic Stabilization Board not later than 20 days from the day when such disposition or steps were taken.

All plans, instruction, directions, order, or decision made under the provision of this Regulation are subject to review at any time by the Director-General of Economic Stabilization Board.

Supplementary Provisions:

Article 30. This Ministerial Ordinance shall come into force as from the day of its promulgation.

Article 31. Any agency which, being designated by the Agriculture and Forestry Minister in accordance with the provisions of Article 5, Par. 1 of the Marine Products Control Ordinance (hereinafter called the Ordinance), has continued to control designated marine products or any person who, being designated by the Agriculture and Forestry Minister, has continued to issue an insturction on the distribution of designated marine products, up to the day of enforcement of this Ministerial Ordinance, is allowed to continue business as ever for a period of one month from the may of enforcement of this Regulation, regardless of provisions of Article 4, Par. 1 of this Regulation.

Article 32. Any distribution area which has been designated by the prefectural governor under the provisions of Article 7 of the Ordinance before the day of enforcement of this Ministerial Ordinance and which continues to be as such on said day shall be deemed a designated consuming area under this Regulation, until any designation reagrding a consuming area will be made by the Agriculture and Forestry Minister or the prefectural governor pursuant to Article 9, Par. 1 or Par. 2 of this Regulation.

Article 33. Any receiving agency of the designated marine products which has been designated by the prefectural governor under the provisions of Article 7 of the Ordinance before the day of enforcement of this Ministerial Ordinance and which continues to be as such on said day is allowed to continue its business as ever for a period of one month from the day of enforcement of this Regulation, regardless

of provisions of Article 10, Par. 1 of this Regulatio Article 34. Any person who, being permitted by the prefectural governor under the provisions of Article 9 of the Ordinance has continued to make it business to retail processed marine products consumers up to the day of enforcement of the Ministerial Ordinance is allowed to continue business as ever for a period of one month from the day of enforcement of this Regulation, regardles of provisions of Article 11, Par. 1 of this Regulation.

HOUSE OF REPRESENTATIVES

The Visitors Regulations

On July 11, upon consultation with the House Management Committee, the President has instituted the Visitors Regulations as follows:

The Visitors Regulations

Article 1. Regarding the visitors the provisions of these Regulations shall be followed except provided for by the provisions of Chapter 17 of the Rules of the House of Representatives.

Article 2. Those who occupy the seats for the visitors with the introduction of the Members or those who occupy the seats for the general public shall be in possession of the introductory admission tickets or the admission tickets for the general public issued by the order of their arrivals as the case may be.

Article 3. A Visitor shall enter his name, age and address on the admission ticket.

Article 4. When the visitors enter the gallery, they shall show their tickets to the guards.

Article 5. The visitors shall be subject to the examination of their bodies by the guards and the police

Article 6. Those who are under twelve years of age shall not be admitted to the visitors gallery.

Article 7. Those who carry firearms or other dangerous weapons, those who are under the influence of alcohol and those who considered undesirable to be admitted for the sake of maintaining order may be forbidden to enter the visitors gallery.

Article 8. When the number of visitors to be admitted is limited for the sake of maintaining order or when there is no further room in the visitors' gallery, even the holders of admission tickets may be refused

admission into the gallery.

Article 9. The visitors shall not enter into the floor of the House.

Article 10. The visitors shall observe the following while in the gallery:

1. They shall not wear strange dresses;

- They shall not carry or wear hats, overcoats, umbrellas, sticks, satchels and wrappers and the like:
- 3. They shall neither eatnor smoke;
- They shall not express their approval or disapproval or clap their hands to the utterances on the floor of the House;
- 5. They shall keep quiet and not interfere with the proceedings of the House;
- They shall do nothing that may annoy the other visitors or shall not behave improperly.
- Article 11. When it was decided to have a secret meeting, the visitors shall get out of the gallery immediately following the indication of the guards.

Article 12. The visitors shall not refuse to show their admission tickets to the guards, when asked.

Article 13. The visitors shall generally obey the direction of the guards.

Article 14. The visitors who violate these Regulations may be expelled from the gallery.

Article 15. The provisions of Article 3 to 14 inclusive shall be applied mutatis mutandis to the visitors to the Committee meeting.
