## INSTRUCTIONS

### Ministry for Home Affairs Instructions No. 9

September 12, 1947

To: Metropolitan Police Board, Hokkaido, Urban Prefecture and Prefecture

Minister for Home Affairs

KIMURA Kozaemon

The following amendments shall be made to a part of the General Provisions for the Disposition and Service of a Policeman prescribed in the Ministry for Home Affairs Instructions No. 16 of July, 1897:

In Article 9, Paragraph 1, "eliminating the hours of rest" shall be added next to "the hours of service," "for a policeman of service with four shifts, from 27 hours to 35 hours" shall be added next to "28 hours" respectively; "from 8 hours to 12 hours" shall read "from 7 hours to 10 hours" and the following proviso shall be added to the same Paragraph:

"However, the hours of service for a week shall not be able to be exceeded 60 hours."
