Law No. 108

Part of Law No. 11 of 1946 shall be amended as follows:

In Article 1 there shall be inserted the following paragraph:

The provision of the preceding paragraph shall apply to those who were in the position of judge or public procurator of Manchukuo after passing the examination mentioned in Article 3 of the Lawyer's Law (in Japan) and qualified through the selection of the Examining Committee of the preceding paragraph:

In Article 2 "the preceding Article" shall read "Paragraph I of the preceding Article."
Supplementary Provisions:

The present Law shall come into force as from the day of its promulgation.

A person who was qualified as a lawyer after May 3, 1947, in accordance with the provision of Art. I, Par. I, and has been in office of lawyer for 3 years, shall be deemed as completed the study as a judicial apprentice on the very day of expiration of term of 3 years.

A person who has the qualification for a lawyer in accordance with the provisions of Art. 1, Par. 2, shall be deemed as completed the study as judicial apprentice, upon obtaining the said qualifications.

The denomination of face value and the term of interest of 4% Reconstruction Treasury Bond shall be determined as follows:

Art. I The face value of 4% Reconstruction Treasury Bond shall be, except those cases as designated by the Minister of Finance, devided into the four denomination of 1,000 yen, 5,000 yen, 10,000 ... yen and 100,000 yen.

Art. 2. The term of interest shall be twice a year, and decided on all such issues by the Minister of Finance, and on each term the interest accruing during the period for six months on and before the

date shall be paid. Provided that, in case of redemption of principal before the term of interest, the interest for the current term shall be paid at the time of the redemption of the principal.

Ministry of Justice Ordinance No. 73

Part of the Ministry of Justice Ordinance No. 78 of 1946 shall be amended as follows:

In Article 3 "Those who wish to apply for the selection" shall read "Those who are qualified for lawyers according to the Korean Government Ordinance of Lawyers and wish to apply for the selection" and to the said Article shall be added the following new paragraph:

Those who were in the office of judge or public procurator of Manchukuo and wish to apply for the selection must present application through such formation as specified in the preceding paragraph together with the curriculum vitae, the copy of the census register or its abstract, the certificate of social standing, the paper which proves that the applicant is the repatriated person and the photograph as mentioned in the said paragraph and the papers which prove that he passed the examination mentionel in Article 3 of the Lawyer's Law and that he was in the office of judge or public procucurator of Manchukuo.
