CABINET ORDERS

I hereby promulgate the Cabinet Order concerning the partial amendments to the Regulations governing the Organization of the Ministry of Communications and others.

Cabinet Order No. 55

Article 1. The following partial amendments shall be made to the Regulations governing the Organization of the Ministry of Communications.

In Paragraph 1 of Article 13, "Full time 273", shall read "Full time 315," "Full time 7,621" shall read "Full time 7,550," "Full time 452" shall read "Full time 525" and "Full time 2,315" shall read "Full time 2,379."

Article 2. The following partial amendments shall be made to the Regulations governing the Organization of the Post Office Life Insurance Bureau.

In Article 3, "Full time 3,448" shall read "Full time 3,401" and "Full time 62 3rd class" shall read "Full time 61 3rd class."

Article 3. The following partial amendments shall be made to the Regulations governing the Organization of the Electro-Technical Laboratory.

Article 4. The following partial amendments shall be made to the Regulations governing the Organization of the Bureaus of Communications.

Article 5. The following partial amendments shall be made to the Regulations governing the Organization of the Communications Offices.

I hereby promulgate the Cabinet Order concerning the Abolition of the "Shokutaku" System.

Cabinet Order No. 56

Article 1. The "Shokutaku" system in all government offices (including the Special Supply Office and all "Kodan"; the same shall apply hereinafter) shall be abolished not later than March 31, 1948.

Article 2. The heads of all government offices shall not appoint "Shokutaku" after the enforcement of the present Cabinet Order.

Article 3. "Shokutaku" who are in the employment of all government offices at the time of the enforcement of the present Cabinet Order shall be dismissed as soon as possible. Any "Shokutaku" who has not been dismissed by the date provided for in Article 1, shall be deemed to have been dismissed on the said date.

Article 4. Temporary, full or part-time employees may be appointed in all government offices in accordance with the following provisions:

 The type of service and length of appointment shall be specified;

(2) Appointments shall be formalized in writing and the letter of appointment shall indicate (a) the title, grade and compen-

sation of the position; (b) the title and grade of the supervising official; (c) the scope of responsibility or authority of the position; and (d) an enumeration of the duties to be performed.

Temporary employees provided for in the preceding paragraph shall be government employees of equal status to First, Second or Third Class official as the case may be, and receive compensation similar to that of government officials.

No temporary employees shall be appointed to any position, unless the duties of such position are authorized by law and in accordance with the budgetary procedure, nor shall they be compensated beyond the limit provided for in the budget.

Article 5. The appointment or dismissal, suspension from office or reinstatement thereto of all temporary employees shall be made by the competent Minister or the head of an independent government agency with the approval of the Prime Minister.

Article 6. Full-time temporary employees shall be subject to the provisions of the Government Officials Service Regulations.

Part-time temporary employees shall be subject to the provisions of Articles 4 and 5 of the Government Officials Service Regulations.

In the case of two preceding paragraphs, "Government official" in the provisions of the Government Officials Service Regulations shall read "Temporary employee," with the exception of the phrase "Any other government official" in Article 4 of the same Regulations.

Article 7. Temporary employees shall not, under any name whatsoever, be compensated from any other source for services rendered while in the employment of the government.

Article 8. All temporary employees shall be subject to the provisions of the Government Officials Disciplinary Punishment Regulations, provided that, in the provisions of the Government Officials Disciplinary Punishment Regulations, "Government official" shall read "Temporary employees"; "Dismissal from office" shall read "Dismissal from position"; "Reduction of salary" shall read "Reduction of compensation"; and, in Articles 6 and 9 of the said Regulations, "First (Second or Third) Class official" shall read "Temporary employee of equal status to First (Second or Third) Class official" respectively.

Supplementary Provisions:

Article 9. The present Cabinet Order shall come into force as from the date of its promulgation; provided that, with respect to "Kodan," "March 31" in Article 1 shall read "April 15."

Article 10. The respective provisions of the present Cabinet Order shall become null and void from the time when the provisions of the National Public Service Law or the Regulations of the National Personnel Commission which correspond to or conflict with them become effective.

It is necessary for applicants to have completed the High School Senior Course or the University Preparatory Course, to be qualified, as prescribed by the Minister of Education, to be recognized as, in scholastic attainments, equal to or higher than those who have finished either of the said courses, or to have passed the Higher Civil Service Preliminary Examination; provided that no person who falls under any of the following items can take the examination:

- (1) A person who has been sentenced to imprisonment or a heavier punishment.
- (2) A person who has been declared bankrupt and who has not yet been rehabilitated.
- (3) A person who was dismissed from Government service by a disciplinary measure, and of whom a period of full two years has not yet passed since such dismissal.
- (4) A person whose age exceeds full thirty years on the closing day for the receipt of applications
- 2. Procedure for Application:

For application, the following documents are required:

- (1) Letter of Application and Curriculum Vitae in own handwriting (For forms, see the Ministry for Foreign Affairs Notification No. 1 published in the Official Gazette of March 15, 1948.)
- (2) Documents proving that applicants fall under the provisions of Article 4 of the Regulations concerning the Examination for the Appointment of Diplomatic and Consular Officers.
- (3) In the case of any person in Government or public service, a written permission by his superior for his taking the examination.
- (4) Photograph (quarter size, with the date of its taking and the person's full name written on the back).

3. Date and Place of the Examination:

The date and place of the examination will be made known later in the Official Gazette. It is intended, however, to hold the written examination in Tokyo and Kyoto in early July, 1948, and the oral examination in Tokyo in late August, 1948.

4. Subjects for Examination:

No person who has failed to pass the written examination and the physical examination shall be eligible for the oral examination.

- (1) The written examination will be held with respect to the following compulsory and optional subjects:
 - a. Compulsory Subjects:

The Constitution, international law, political economy, modern political and diplomatic history, and foreign languages (composition in foreign languages, translation from foreign language into Japanese and vice versa).

One foreign language shall be chosen beforehand from among English, French, German, Russian, Spanish, and Chinese; provided that, in addition to the foreign language so chosen, an applicant may, at his request, also take the examination in other foreign languages.

b. Optnioal Subjects:

Administrative law, finance, economic policy, and international private law.

From among those optional subjects, one subject shall be chosen beforehand and mentioned in the letter of application.

(2) The oral examination will be held with respect to the following subjects:

International law, the international situation, economics in general, and foreign languages (dication and conversation).

5. Miscellaneous:
