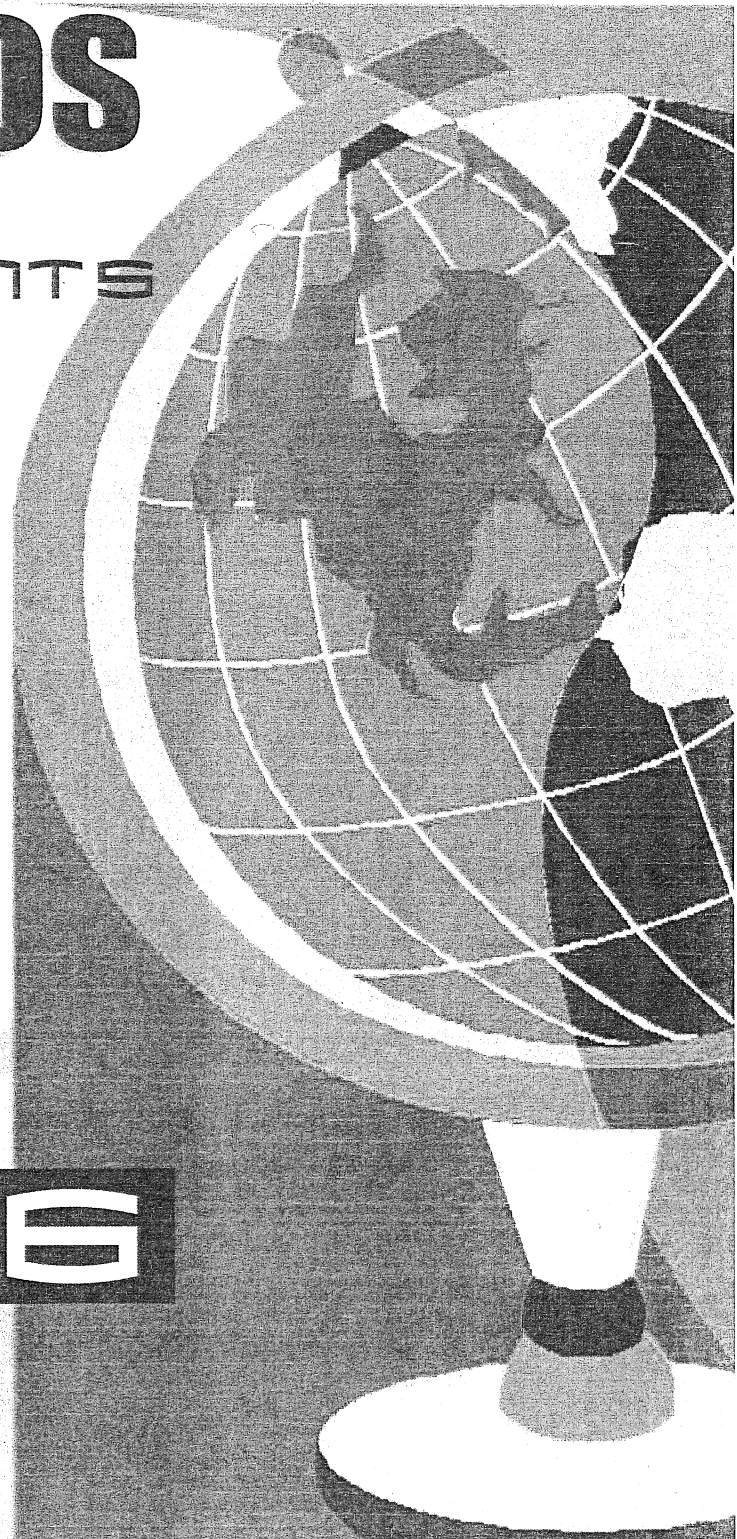

## **PREFACIO**

La Balanza de Pagos de Puerto Rico registra las transacciones entre los residentes de Puerto Rico y del exterior. Esta consta de dos componentes principales: la cuenta corriente y la de capital. La cuenta corriente se compone de las ventas netas al resto del mundo, que son las ventas y compras de mercancías y servicios relacionados directamente con la producción; de las transferencias unilaterales netas, que representan recibos y pagos con el exterior que no están relacionados con transacciones de mercancías y servicios y que no constituyen movimientos de capital por concepto de esas transferencias; y el interés neto del gobierno central y los municipios. La cuenta de capital registra los movimientos de fondos que han ocurrido como resultado de las transacciones de la cuenta corriente. Estas se subdividen en movimientos a largo y corto plazo.

La publicación **Balanza de Pagos de Puerto Rico 2006** presenta datos históricos para los años fiscales 1997 a 2006. En la cuenta de capital no se presentan estadísticas para las inversiones directas, las cuales esperamos incorporar próximamente.

Esta edición está dividida en tres secciones. La primera incluye quince (15) tablas con la información que constituye la Balanza de Pagos de Puerto Rico. La segunda es un suplemento que consiste de seis (6) tablas con datos que originan, derivan o complementan la balanza de pagos. La tercera contiene gráficas para un mejor análisis y entendimiento visual de la balanza de pagos.

Agradecemos a las entidades públicas y privadas que proveyeron los datos utilizados para preparar esta publicación.

## **PREFACE**

Puerto Rico's Balance of Payments records the transactions between Puerto Rico residents and abroad. Its two main components are the current account and capital account. The current account contains net sales to the rest of the world, which are sales and purchases of merchandise and services directly related to production; net unilateral transfers, which are receipts and payments to and from abroad not related to the sales and purchases of merchandise and services and which do not constitute a capital movement because of these transfers; and the net interest of the central government and municipios. The capital account records the movement of funds, which have taken place as a result of the current account transactions. These are subdivided in long and short term movements.

The **Balance of Payments of Puerto Rico 2006** presents historical data for fiscal years 1997 through 2006. The capital account contains no statistics on direct investments, which we expect to include in the future.

This publication is divided into three sections. The first section presents fifteen (15) tables with information concerning Puerto Rico's Balance of Payments. The second section is a supplement of six (6) tables with information that originates, derives and complements the balance of payments. The third section contains graphs, for visual support and understanding.

We acknowledge the public agencies and private organizations, which provided the information, used in the preparation of this report.

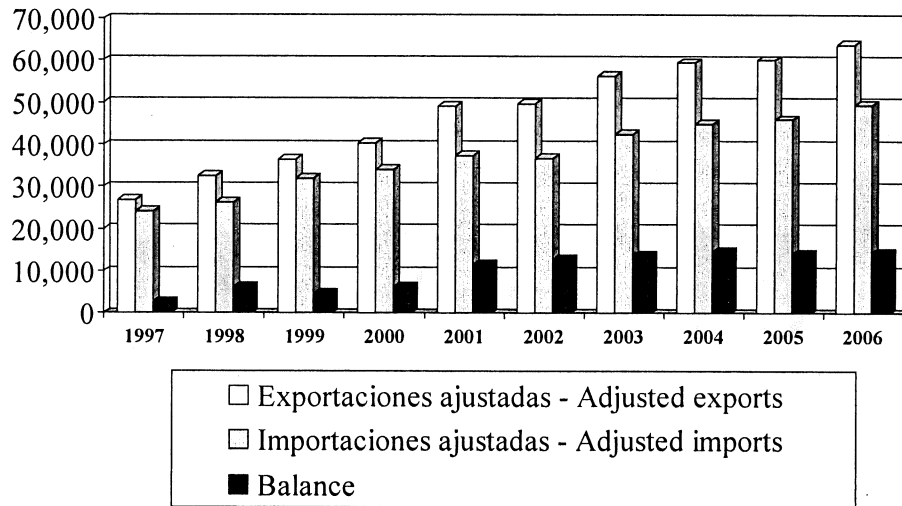

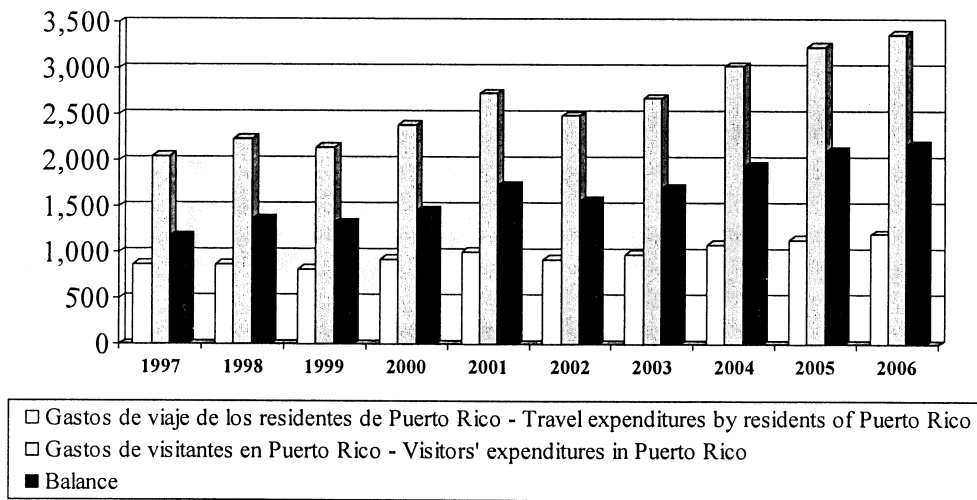

 (En millones de dólares - In millions of dollars)

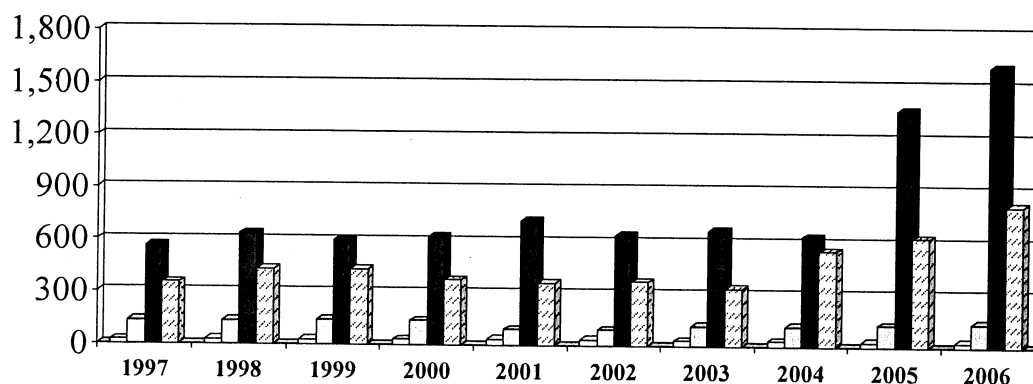


GRAFICA 2 - GASTOS DE VISITANTES Y DE VIAJE: AÑOS FISCALES

 (En millones de dólares - In millions of dollars)



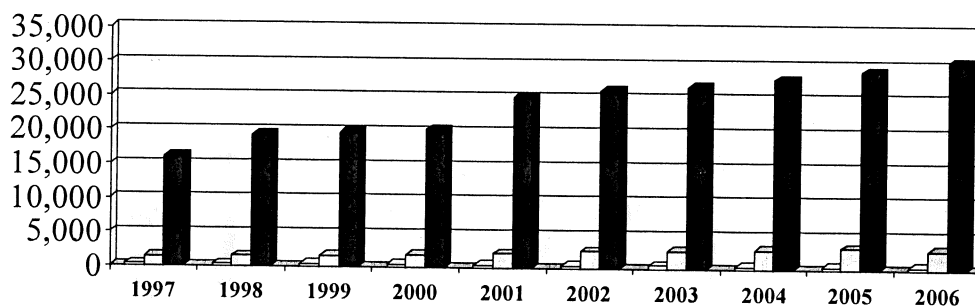

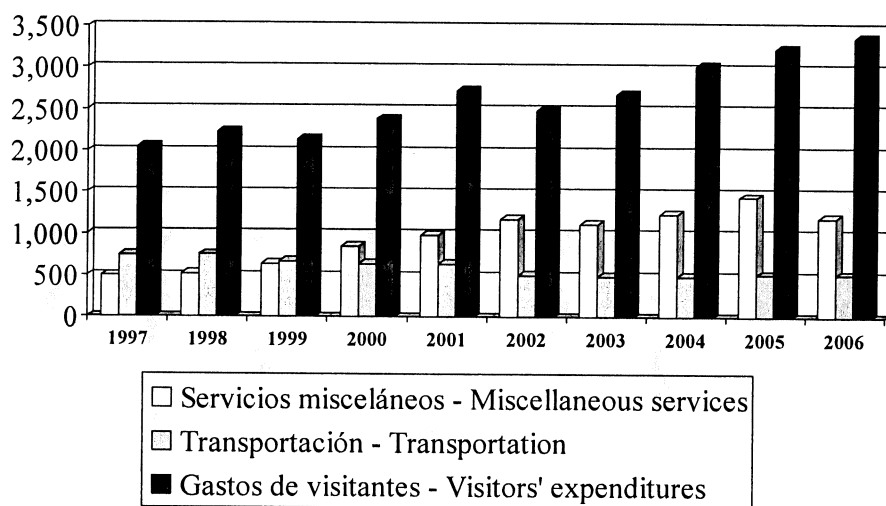

 (En millones de dólares – In millions of dollars)



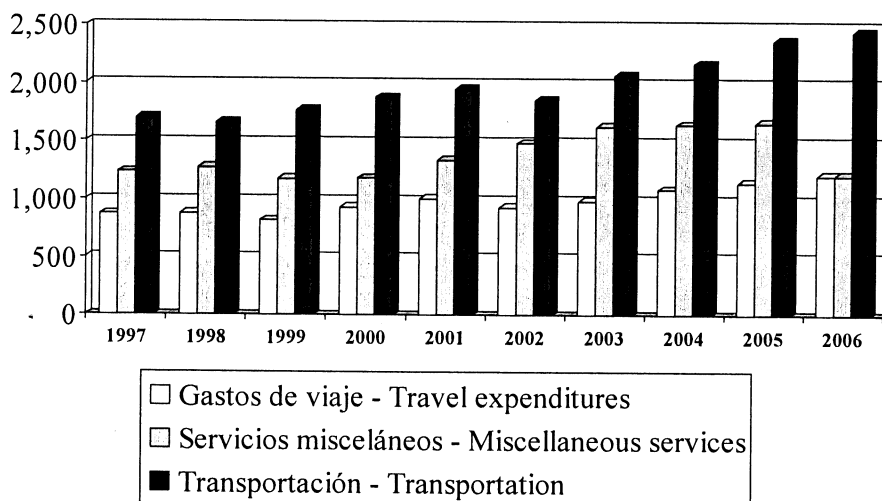

 (En millones de dólares – In millions of dollars)

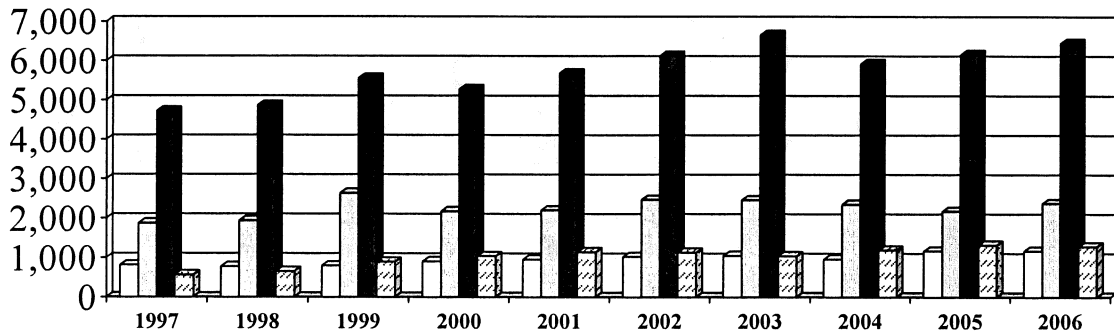


GRAFICA 6 - COMPRAS DE OTROS SERVICIOS: AÑOS FISCALES
