PREFACIO

La publicación Balanza de Pagos de Puerto Rico realizada por la Junta de Planificación registra las transacciones entre los residentes de Puerto Rico y del exterior. Esta consta de dos componentes principales: cuenta corriente y de capital. La cuenta corriente se compone de las ventas netas al resto del mundo, que son las ventas y compras de mercancías y servicios relacionados directamente con la producción; de las transferencias unilaterales netas, que representan recibos y pagos con el exterior que no están relacionados con transacciones de mercancías y servicios y que no constituyen movimientos de capital por concepto de esas transferencias; y el interés neto del gobierno central y los municipios. La cuenta de capital registra los movimientos de fondos que han ocurrido como resultado de las transacciones de la cuenta corriente. Estas se subdividen en movimientos a largo y corto plazo.

Esta publicación presenta datos para los años fiscales 2007 a 2017. Esta edición está dividida en tres secciones. La primera incluye quince (15) tablas con la información que constituye la Balanza de Pagos de Puerto Rico. La segunda es un suplemento que consiste de seis (6) tablas con datos que originan, derivan o complementan la balanza de pagos. La tercera contiene gráficas para un mejor análisis y entendimiento visual de la balanza de pagos.

La información para las exportaciones e importaciones de mercancía no ajustada estacionalmente es revisada por el Negociado del Censo de los Estados Unidos para redistribuir los datos mensuales que no llegaron a tiempo para ser incluidos en el mes en que ocurrió la transacción, pero fueron incluidos inicialmente en el mes en el que los datos fueron recibidos.

Una vez que se completa la redistribución y las correcciones o ajustes de los datos para el mes correcto de las transacciones, los datos de años anteriores se vuelven a compilar y son divulgados por Censo. La revisión inicial de las estadísticas de comercio de Puerto Rico indica que estas cifras representan menos del 3% de las totales anteriores. Sin embargo, cuando se complete el análisis los datos requeridos, estas revisiones serán incorporadas a nuestra base de datos.

Agradecemos a las entidades públicas y privadas que proveyeron los datos utilizados para preparar esta publicación.

PREFACE

Puerto Rico's Balance of Payments records the transactions between Puerto Rico residents and abroad. Its two main components are the current account and capital account. The current account contains net sales to the rest of the world, which are sales and purchases of merchandise and services directly related to production; net unilateral transfers, which are receipts and payments to and from abroad not related to the sales and purchases of merchandise and services and which do not constitute a capital movement because of these transfers; and the net interest of the central government and municipios. The capital account records the movement of funds, which have taken place as a result of the current account transactions. These are subdivided in long and short term movements.

The Balance of Payments of Puerto Rico 2017 presents data for fiscal years 2007 through 2017. This publication is divided into three sections. The first section presents fifteen (15) tables with information concerning Puerto Rico's Balance of Payments. The second section is a supplement of six (6) tables with information that originates, derives and complements the balance of payments. The third section contains graphs, for visual support and understanding.

The information for exports and imports of not seasonally adjusted goods is revised by the U.S. Bureau of the Census to redistribute monthly data that arrived too late for inclusion in the month of transaction but were initially included in the month in which the data were received. Once the redistributions of data to the proper month of transaction and any corrections or adjustments are completed, data for prior years are recompiled and released by the Census. The initial review for the Puerto Rico trade statistics indicate that these revised figures represent less than 3 percent of the previous totals. Nonetheless, when the required data analysis is complete, these revisions will be incorporated into our database.

We acknowledge the public agencies and private organizations, which provided the information, used in the preparation of this report.






GRAFICA 1 - COMERCIO EXTERIOR DE PUERTO RICO: AÑOS FISCALES
GRAPH 1 – PUERTO RICO'S EXTERNAL TRADE: FISCAL YEARS




GRAFICA 2 - GASTOS DE VISITANTES Y DE VIAJE: AÑOS FISCALES

RECEIVED FROM ABROAD: FISCAL YEARS




GRAFICA 4 - RENDIMIENTOS DE CAPITAL E INTERESES PAGADOS AL EXTERIOR
GRAPH 4 - INCOME ON INVESTMENTS AND INTERESTS PAID ABROAD




GRAFICA 5 - VENTAS DE OTROS SERVICIOS: AÑOS FISCALES
