 a.k.a. George Hueu Davis, son of Isaac Davis.
 "Inherited lands"

Received his portion of the lands inherited from his father Isaac *

Waikoloa, ahp. Waimea, Kohala, Hawaii

Kukuau 2, ahp. Hilo, Hawaii

Kiilae, ahp. Kona, Hawaii.

*For the apportionment of Isaac Davis' lands among his three children, Hueu, G.D. (George Hueu Davis), Kale (Sarah Davis), and Peke (Becky Davis), see letter of George Hueu Davis ((Signed) G.D. Hueu) to Minister of the Interior John Young Jr., 30 December 1847 (AH); translation [?by E.H. Hart] reads:

"I received your letter dated the 8th day of this December, regarding lands that I reported to you on and calling my attention to certain errors contained in said report in not making a distinction between an Ahupuaa from an Ili. In reply would say that Waikoloa is an Ili within Waimea, better described in the following manner.

"Waimea be the Kalana ["district"], like Lahaina for instance. Now we have several small lands in Lahaina, Waikoloa is the same in Waimea.

"All other lands belonging to our parents received direct from the King are all Ahupuaas, as specified in my report to you.

"There is only one land that the King gave to our parents* jointly, that is Halawa, in Ewa, on Oahu; now it belongs to someone else.

"Here is another. In regard to your inquiry as to how are we to make a division with Kale and Peke, I propose to be all by myself, as follows:
 [lists lands for Kale and Peke and then his own:]

G.D. Hueu: Kiilae in Kona, Hawaii

Waikoloa in Waimea, Hawaii

Kukuau in Hilo, Hawaii

That is my proposition, but nothing has been done. They are occupying our lands on Maui and I am staying on Hawaii. It is thus that you may hear. It is up to you.

We are all at Kailua here on the Governor's work.

May the good will be continued between us until we meet again and God have us in his keeping. I am with respect," (signed) G.D. Hueu

**"Our parents" here means the parents of Hueu and Keoni Ana, Isaac Davis and John Young, who each received a part of Halawa from Kamehameha I (Ii 1959: 70). Isaac Davis died in 1810; his children reared by John Young.

159: George HUEU Davis, the son of Isaac Davis and his second wife, Kalukuna, was born on January 10, 1800 (BM 17).

HUEU to Kahaanapilo had 19 children (according to Cartwright genealogy of the Davis family in AH)

HUEU to Kalapuna had 4 children (Probate 41, 3rd CC)

For his descendants SEE George Davis Hueu Genealogy, arranged by Bruce Cartwright, and Geo. Awai's Genealogy of Hueu Davis, both in AH. Also Bishop Mus. Gen. Bk. 17, and 17a, and Probate 41 (3rd CC).

PROBATE 41 (3rd CC). George Hueu Davis died December 31, 1873.

Heirs: Kalapuna, widow, and a large number of children. Fifteen children by Kahaanapilo are named, and 4 by Kalapuna.

Geo. Hueu Davis Jr., witness says: My father owned the land of Waikoloa in S. Kohala. I think it is worth \$10,000.00....He also had a land of Kiilae in S. Kona, assessed at \$150.00. He had cattles & horses, but I don't know how many. Also a house at Kawaihae worth about \$100.00.
