NR 491.5, 1/26/48: claims

ili Keole, Kaneohe "and a small kula also" from Kamehameha III;

ili Kihewa, at Waihee, kula and upland;

ili Kupapaulau in Waiahole, from Kamehameha 2nd.

FT 64.14 [in Hawn.] Laeloa, witness, knows the land of Hueu, the ili of Keole, at Kaneohe; partly kula. Recd. from Kamehameha III; has held from the time Boki left [December 1829]. "See P 187"

FT 187.14 "From Page 64"

Laeloa, sworn: I know claimant's land; it is an ili (in Kaneohe), Keole and consists of taro land a little upland. Clt. had his land from the King Kamehameha III in the time of Liliha [Boki's widow; "time of" = 1830-1845] and has had it in peace up to the present time. Claimant has his land as Konohiki and the above includes the lands of Pukaia and Ilimele, whose claims have been heard. Konohiki objects to the claim of Ilimele because of his not willingly going to the Konohiki days. Kekiekie sworn says the evidence is true.

Claim 776

NR 431.2 claims pahale on Beretania St., Honolulu.

FT 243.2 March 2, 1847. Apii, witness, testifies to houselot in Honolulu: mauka, Kawelookalani's kalo lands; Waikiki, Beretane fence; makai, Beretane street; Ewa, Mr. Dudoit's place. Fenced; 3 houses in it. One is Clt's., one is Kalauhala's, and one is Kahananui's, all holding under Clt., who received the place from Kauhau [/Kauhao], when Boki was here--in 1827 or 28. Hueu II confirms.

NT 578.2 March 20, 1847: Apii witness: knows Hueu's houselot in Honolulu...enclosed and 3 houses. Hueu's interest from Kauhao/Kauhao during the time Boki was living here. Hueu II confirms.

LCA 776 Kaakopua, Honolulu 0.20 ac/1 ap.

Greer Map mauka/ewa corner of Alakea & Beretania Sts.

PROBATE 327 (1st CC, 1863) HUEU died in 1863, before August 15.

Meheuole, widow, petitions for Letters of Administration.

Kekoanui, Hueu's sister's son, claims to have a will.

Samuel Kahimoku claims to be adopted son of deceased. He is the son of the younger brother of Kapu. He was adopted 28 June 1851, at age 13.

Kapu, witness, says he lived with Hueu for 5 years. Hueu was blind near death. Nounou is presently on his property Kiolo [Keole] at Kaneohe. They are not related.

Will presented by Kekoanui says "1/2 the lot on which sugar cane is growing" to Kekoanui; half with house on it to Samuela Kahimoku.

Land in Koolau [Keole] is for Nounou, the nephew.

Court's decision: will not proved.

DEED. 19 March 1881: S. Kahimoku husband of Kamealani, for \$423.00 deeds to Robert Maikai the land of Keole.
