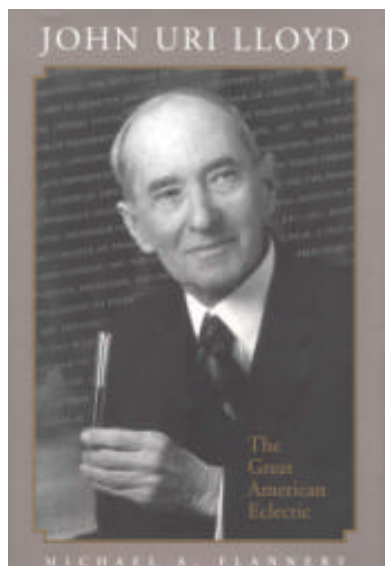


**THE JOHN URI LLOYD BIOGRAPHY PROJECT:  
MICHAEL FLANNERY PAPERS  
Collection No. 13**



Although Corinne Miller Simons published a biography of John Uri Lloyd (1849-1936) in 1972, there remained no comprehensive study of this pharmacist's life and work that represented exhaustive research into the available resource materials with full references. The following records represent my efforts at developing a thoroughly documented, book-length manuscript on Lloyd.

The first step in this process involved submission of a Fischelis Grant to cover translation, travel and other expenses. All of the pertinent material related to the Fischelis Grant are included in this collection.

While many of the citations in the finished work are clearly taken from the Lloyd Library archives (as evidenced in "LLM" in the respective notes), some were taken from other sources. Some of the most important were those drawn from the American Institute of the History of Pharmacy (hereafter AIHP), Edward Kremers Files, in Madison, Wisconsin. These were gathered in August of 1995 following receipt of the Fischelis Grant and comprise the bulk of material in the Flannery papers. Other materials from the University of Delaware, the Filson Club, the Kentucky Historical Society, the Ohio Historical Society, and the Public Library of Cincinnati and Hamilton County are also included.

Two important components of these papers not to be overlooked are the translations of German works commissioned from Mary Jo Fasold and the correspondence with Dr. Patrick Belcastro, Professor Emeritus of Pharmaceutics at Purdue. Ms. Fasold was recommended to me by Dr. Thomas Leech, Assistant Professor of German at Northern Kentucky University. Ms. Fasold verified her translations with Dr. Leech prior to sending out the final typescript and were extremely valuable additions to my biography. Dr. Belcastro was kind enough to read an early draft of Chapter 5 which involves technical discussion of Lloyd's work in colloidal chemistry. I

found his comments to be insightful and extremely helpful in confirming and/or modifying my technical discussion of Lloyd's contributions in chemistry.

This collection has been put together so that subsequent researchers may examine more carefully my citations. In so doing they will see not only pertinent material related to Lloyd but also my methodology and process of discovery. It also represents an effort at consolidating pertinent primary resources related to John Uri Lloyd otherwise scattered in several locations. An examination of the computer printouts in several databases may save future historians considerable time and effort from duplicating searches.

On the use of the files one caution is in order. All of the materials contemporaneous with the project itself should be cited by collection number, box number, folder number, Lloyd Library and Museum. **Materials contemporaneous with Lloyd must be credited to the institution from which they came, and permission should be sought before the publication of any quoted or cited material.** All documents marked "A2" or with a pencil mark identifying the file number are from the Kremers Reference Files at the F. B. Power Library, University of Wisconsin. Permission to use these items must be requested from the AIHP, 425 N. Charter Street, Madison, WI 53706-1508. Permission to use other items not originating with the Lloyd Library or Michael Flannery must be obtained as appropriate. Permission to use original Flannery/Lloyd Library material in this collection is granted provided the source is fully cited and acknowledged "courtesy of the Lloyd Library and Museum, Cincinnati, Ohio."
