# MOTION FOR CHANGE OF VENUE

# TO THE HONORABLE JUDGE OF SAID COURT:

Joe Smith moves the Court for a change of venue, and in support of such motion shows the following:

I.

The defendant states under oath that there exists in Bexar County, Texas, so great a prejudice against the defendant that the defendant cannot obtain a fair and impartial trial in that county. Specifically the publicity generated about this case has been so widespread, inflammatory, adverse and prejudicial as to raise a substantial doubt that defendant can obtain a fair trial in Bexar County. A change of venue is therefore required under article 31.03(a)(1) of the Texas Code of Criminal Procedure.

II.

The defendant states under oath that there is in Bexar County, Texas, a dangerous combination against him instigated by influential persons, by reason of which he cannot expect a fair trial. A change of venue is therefore required under article 31.03(a)(2) of the Texas Code of Criminal Procedure.

III.

Because of the nature and extent of the inflammatory and prejudicial publicity disseminated in Bexar County, a change of venue is also required pursuant to the Due Process Clause of the Fourteenth Amendment to the United States Constitution, and the due course of law provision of Article I, §§ 13 and 19 of the Texas Constitution.

III.

Defendant requests an evidentiary hearing pursuant to article 28.01 § 1(7) of the Texas Code of Criminal Procedure at which he can prove his entitlement to a change of venue under the previously cited constitutional and statutory provisions.

For these reasons, the defendant prays the Court grant this motion and change the venue in the cause to a county in which defendant may receive a fair and impartial trial.
