You are part of a caring community, one that stands up for our neighbors in need. And together, we accomplished some impressive things last year. We were able to do more, for more Marylanders than any other of our nearly 40 years of being Maryland’s food assistance safety net.

We fed more kids at more locations during the summer when they are most at risk. We continued to increase the output of fresh produce and healthy proteins. We launched an entirely new program — HEART Markets — to help Maryland families turn those fruits, vegetables, and meats into meals that they can enjoy together.

We launched more than 50 workforce-ready graduates into Maryland’s culinary industry. We debuted an upgraded and renovated Salisbury location, which now gets more food to more of our hungry neighbors on the Eastern Shore, faster than ever before.

2019 will mark our 40th year of leading the fight to end hunger in Maryland, and one that will see us expand our impact even further, through a new five-year strategic plan. We will continue to provide access to healthy food while helping more Marylanders become self-sufficient by providing pathways out of hunger to build a stronger Maryland for all.

With you by our side, I can’t wait to see how many more lives we can change, together.

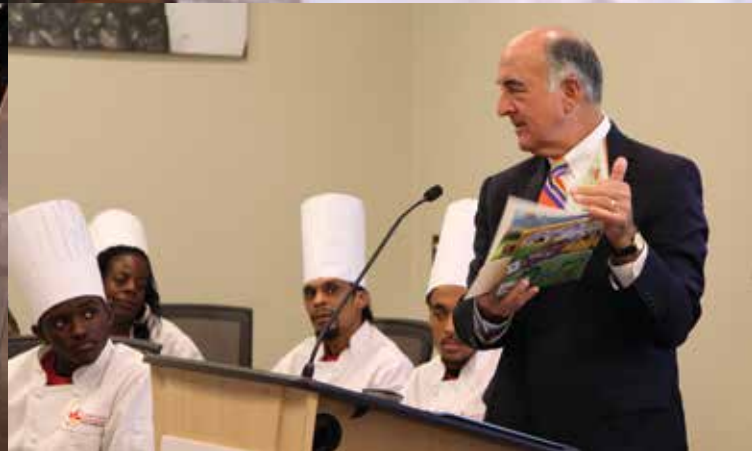

Brandon Williams, MFB spokesperson and Baltimore Ravens defensive tackle, gave hope to hungry kids across the state by sharing his own personal experiences growing up with food insecurity at our Summer Club kickoff and on #GivingTuesday 2017.



The Ravens and the Orioles raised not only much-needed food and funds for us, but also awareness by hosting drives during rivalry games versus the Bengals and Yankees, respectively.



Maryland State Attorney General Brian Frosh helped elevate the stature of the 30th Annual Lawyers Campaign Against Hunger, which raised \$478K last year, enough to help provide about 1.5 million meals.



Long-time food bank friend Giant Food has continued to champion our MFB Kids programs, which are instrumental in ensuring our next generation of leaders are primed to succeed.



7,489 volunteers gave more than 40,000 hours of their time last year, which saved us more than \$1M. Special thanks to Jack O'Hara, who personally volunteered 700 hours, and Northrop Grumman, whose employees spent nearly 1,000 hours in our Baltimore warehouse. Together, they saved us \$46,750!

Our innovative Farm to Food Bank Program partners with local farms to ensure a steady supply of fresh, local produce for kids, seniors, veterans, and hard working families.

Thanks to you, we were able to increase the amount of fresh produce (and healthy protein from meat, fish, and chicken) we distribute to our hungry neighbors by 13 percent. These foods now make up 35 percent of our total distribution!

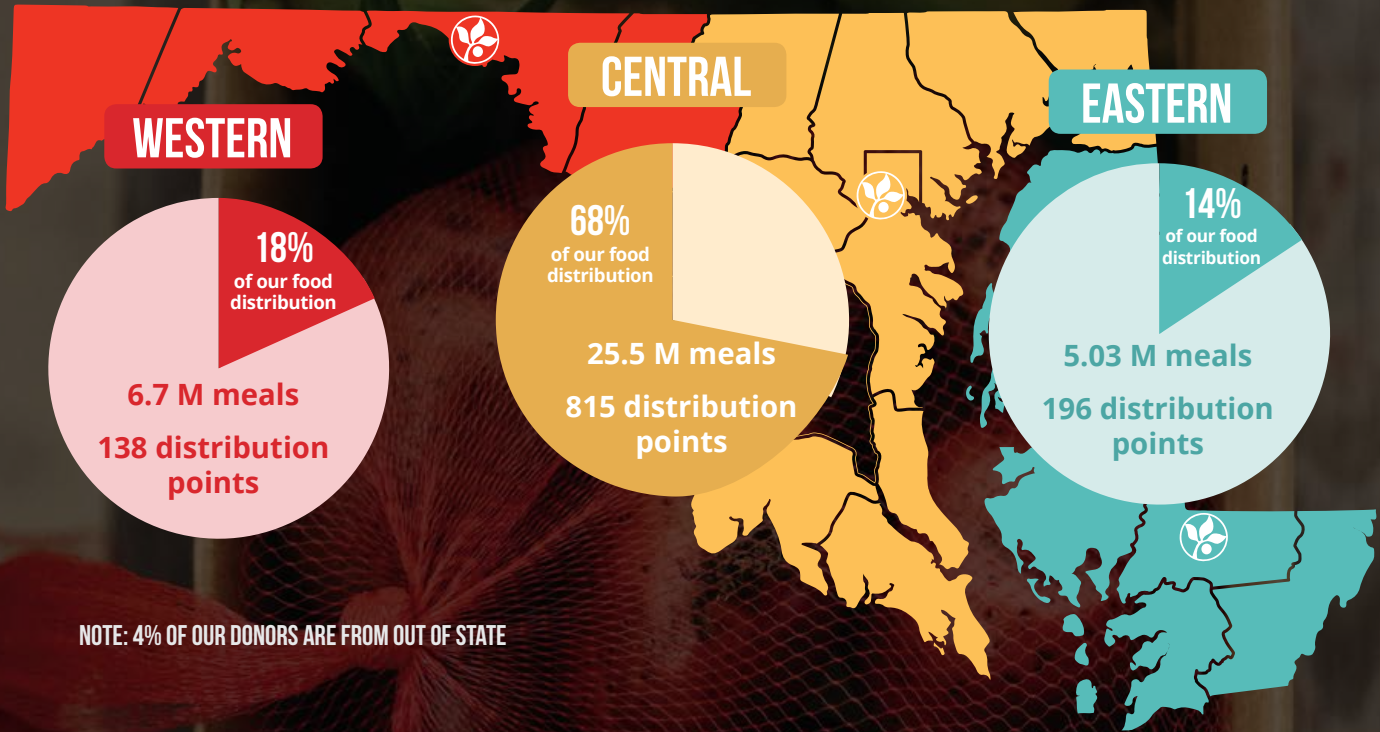

Meals in FY18



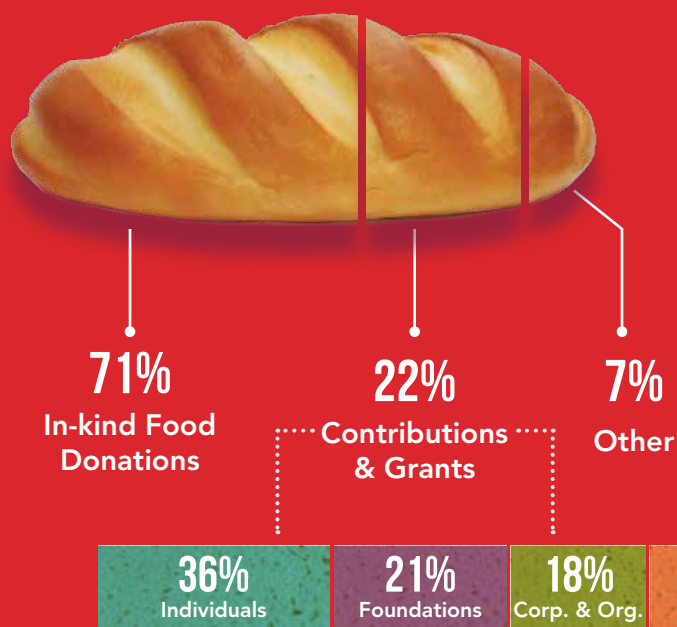
Distribution Points



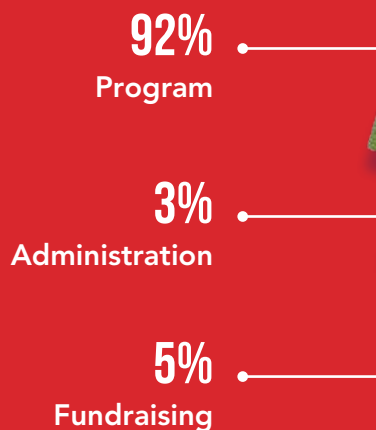
