NORMATIVE INSTRUCTION No. , OF , 2010

THE SECRETARY OF ANIMAL AND PLANT HEALTH AND INSPECTION FROM THE MINISTRY OF AGRICULTURE, LIVESTOCK AND FOOD SUPPLY, exercising the powers conferred upon him by arts. 10 and 42, of Attachment I, of Decree no. 7,127, of March 4, 2010, having in view what is disposed in Decree no. 885, of August 30, 2005, in Decree no. 5,759, of April 17, 2006, in Decree no. 1,355, of December 30, 1994, in Decree no. 24,114, of April 12, 1934, in Normative Instruction no. 23, of August 2, 2004, in Normative Instruction no. 6, of May 16, 2005, considering also the result of the Pest Risk Analysis and what is in Process no. 21000.00824/2009-04, resolves:

- Art. 1 Approve the phytosanitary requirements for the importation of fresh cashew nuts (**Anacardium occidentale**) (Category 3, Class 10) produced in Ivory Coast.
- Art. 2 The cashew nuts must be stored in new bags, of first use, and must be free of soil material and plant residues.
- Art. 3 The sending specified in art. 1 must be accompanied of Phytosanitary Certificate CF, issued by the National Plant Protection Organization NPPO from the Ivory Coast, with the Additional Declaration DA2: the sending was fumigated with (specify: dose or concentration, temperature, exposition time) for the control of the insects, Anoplocnemis curvipes, Riptortus dentipes, Clavigralla tomentosicollis, Helopeltis schoutedeni, Helopeltis bradyi, Planococcoides njalensis, and Dysdercus superstitiosus, under official supervision.
- Art. 4 The imported consignments which art. 1 deals about will be inspected at the point of ingress (Phytosanitary Inspection IF) and, in case of interception of pests, procedures contained in Decree no. 24,114, of April 12, 1934 will be adopted.
- Sole Paragraph. In case of interception of quarantine pests, the NPPO of the country of origin will be notified and the NPPO from Brazil will be able to suspend the importations of cashew nuts until the review of the Pest Risk Analysis.
- Art. 5 In case of not fulfilling the requirements established in this Normative Instruction, the product will not be internalized.
- Art. 6 The NPPO from the Ivory Coast must communicate to the NPPO from Brazil any occurrence of new pest in that territory.
- Art. 8 This Normative Instruction enters into force on the date of its publication.
