HF-L Unveils Rebuilt Original Facade at High School

On Wednesday, October 30, 2019, the Honeoye Falls-Lima Central School District unveiled the newly restored 1929 facade which stands on the rebuilt original front entrance of the High School.

On March 13, 1929, the High School located on East Street opened in Honeoye Falls. In 1969, the District merged with Lima and the original facade was covered.

The Clamor was a publication written by the junior class of the Honeoye Falls High School in 1929 where the students described the newly built high school as "an addition of an extraordinary building. The publication goes on to say "as one approaches the building the impression of vastness and dignity is imparted. A

combination of soft multicolored brick and tan stone was used in the construction. The building is three stories high; long windows mark the floors. Such inspirations as "Seek Knowledge and "Choose Instruction" appear at the end of the porches."

Lupini Construction Inc. restored the front of the High School. Some of their specialties include repointing, terracotta repair, brick repair, brick replacements, concrete epoxy injection, masonry cleaning, stone replacement, stone repair, and concrete repair.

The restoration of the front entrance and facade is part of the District's Phase II Capital Project

ROESER'S RUSH REMEMBRANCES: CIVIL DEFENSE I

RESET ~ An HF-L classmate of ours Randy Roeser shared with us a book his father Walt Roeser wrote in 2000 about growing up in Rush in the 1930's-1940's. Following up our series on the Rush hamlets, we have written a compilation of articles highlighting Rush history inspired by Walt Roeser's book, supplemented with our modern day perspective.

In the months after Pearl Harbor the United States got very serious about civil defense. Rush High School principal George Yackel was appointed the director of the Civil Defense Organization in Rush. A concise definition of the purpose of the Civil Defense program would be to say that it was an organized non-military effort to prepare Americans for military attack. Because our country's response in general was to do whatever it took to help the

war effort, recruiting people to fill the various positions related to this cause was no problem whatsoever.

Jobs in place as components of the civil defense strategy included air plane spotters, air raid wardens, auxiliary fire & policemen, and rescuers & first aid personnel. It was required that all the aforementioned positions be assumed by adults. There was however one job that could be assumed by a teenager and we'll cover that next week.

AIR RAID DRILLS ~ Air raid drills were held quite often, especially at first. The initial siren was sounded from the fire hall. It was used to inform the community of the first alert, the various stages of the "raid" and of course the "all clear". They occurred mainly at night when more people were able to participate.

As the name would imply, air raid drills were conducted to prepare for the possibility that a foreign country might be able to successfully launch an airborne attack somewhere in the United States. There were two components in the air raid drill protocol that come up in the story we are about to tell. Upon hearing the air raid siren, all lights (homes, cars, streets) were to be immediately turned off in order to make it more difficult for an attacker to locate his target. There was also a messenger system put in place should phone service be compromised.

Next week we'll lead off with the story of the messenger system which included the only job in the Civil Defense program that could be performed by a teenager.

HF-L swimmers take fourth at sectionals

The Honeoye Falls-Lima Girls Varsity Swim team had a great meet at the Section V Class B Swim preliminaries and kept that momentum going in the finals a week ago.

HF-L compiled 261 points to take fourth at the Section V Class B finals on November 9, just one point behind third-place Canandaigua. On the heels of a great preliminary meet on November 6 that saw 31 season-best or life-best times, the Lady Cougars started out with a sixth-place in the finals of the 200 medley relay as Kathryn McRae, Emily LeFrois-Heath, Abigail Baum and Kate Tanner combined for a time of 2 minutes, 0.96 seconds. That was nearly three seconds faster than the prelims time of 2:03.85 turned in by the group of Lana Fisk, LeFrois-Heath, Tanner and Baum which was two seconds better than HF-L's qualifying time for the event. McRae clocked 2:10.08 to place seventh in the 200 freestyle and Chloe Brassie was right behind in eighth at 2:10.78 as both erased nearly a second off their prelims time after dropping three seconds and five seconds, respectively, off their qualifying times during prelims.

Baum turned in a time of 2:28.26, a drop of two seconds from her prelims time, for ninth in the 200 individual medley. Ella Beutner was 12th (2:31.48, a drop from her 2:32.01 in prelims) and Samantha Picciotti 13th (2:37.22). Grace Norvell was 14th (2:38.33) after she had a 10 second drop in the prelims to 2:37.43 from her seed time in the IM. Ryann Tanner led the Cougars in the 50 freestyle as she came in 11th in 26.76 seconds while Kate Tanner wound up 13th in 27.02, Aurore Lambert 17th in 27.23 and Mackenzie Kettlehone 19th in 27.58 seconds. All four girls wound up beating their seed times in prelims.

Jenna Bovenzi compiled 324.40 points for 11th in diving and, although she did not qualify for the final round of 16, Asha Hotaling amassed 192.30 points which made her 20th. Beutner claimed eighth in the 100 butterfly with a 1:08.62 after dropping her life-best time by six seconds to a 1:05.47 in the prelims. Norvell clocked 1:07.77 for 10th in the butterfly, a drop of two seconds from her 1:09.06 in prelims, which was five seconds better than her seed time. Baum turned a time of 1:07.82 for 11th in the butterfly after her 1:06.75 in prelims was almost six seconds faster than her seed time. Picciotti swam a 1:08.37 for 14th, besting her prelim time by one second and her seed time by nearly four seconds. Emma Kidd clocked 57.60 seconds for sixth in the 100 freestyle after her time of 57.56 seconds in the prelims marked the first

time she broke the 1 minute mark. Ryann Tanner also broke the 1 minute mark for the first time in the 100 free as she posted 57.94 seconds in the finals for 10th after recording 58.65 seconds in the prelims. Lambert finished 15th in the 100 free at 1:00.46 after clocking a 1:00.40 in the prelims which was her life-time best in the event. Kettlehone was 25th at 1:02.63, which was her life-time best in the 100 free. LeFrois-Heath claimed second in the 500 freestyle in 5:23.76, a drop of nearly five seconds in the event. Brassie finished seventh with a life-best 5:47.86, a drop of almost 13 seconds from her seed time. Hannah Zornow was ninth in 5:52.89, a drop of nearly 38 seconds from her seed time. Isabelle Dague came in 25th (6:26.66, a life-best by eight seconds), Ava Stefanou 26th (6:27.11, a life-best by seven seconds) and Elisabeth Kenny 29th (6:43.51).

Kate Tanner, Lambert, Kidd and Ryann Tanner registered a 1:46.04 for fifth in the 200 freestyle relay, knocking a second off their time in prelims, for their season-best in the event. LeFrois-Heath churned the water for a 1:03.04 and second place in the 100 backstroke after a 1:04.70 in the prelims. McRae clocked 1:10.11 for 13th after recording a life-best 1:08.56 in the prelims. Lana Fisk placed 18th (1:12.70), Zornow 23rd (1:14.82, a drop of three seconds from her seed time), Dague 30th (1:16.32) and Stefanou 34th (1:21.51). Kidd notched 10th in the 100 breaststroke with a life-best 1:17.70, knocking nearly a second off from her prelims time and three seconds from her seed time. Kate Tanner was 22nd (1:23.49). The quartet of Baum, Ryann Tanner, Kidd and LeFrois-Heath closed out the Cougars' season with a third place in the 400 free relay and a time of 3:49.63, just over seven seconds faster than their time in the prelims.

"The girls had a fantastic prelims, statistically the best prelims of any team at the meet in terms of improving their prelims time from their seed times," coach Ari Freedman-Weiss said. "We knew going in that Brighton and Spencerport would be 1-2 and that it would be a three-way fight for third-place between Canandaigua, Brockport and us and to finish only a point behind Canandaigua was great for us. There's not a lot of time between the 500 and the backstroke so for Emily to take second in both is a testament to the hard work she put in during the offseason. Chloe also worked hard and it showed in her results. Emma, Sam and Kathryn, among many others, also had fine performances. It is exciting to see how the girls did and, with only two girls graduating, to think of the potential for next year."

The Honeoye Falls-Lima Girls Varsity Volleyball team gave New York State powerhouse Syracuse Westhill all it could handle in the regional round of the New York State Class B Tournament, but came up just short as the Lady Cougars ended a terrific season that included a Section V title.

HF-L beat #4 seed Livonia 25-25-25 to 12-11-13 in the semifinals of the Section V Class B Tournament on November 7. Kara Balmer hammered 10 kills to lead the top-seeded Lady Cougars. Danielle Fisk added seven, Leah Samson six and Teagan Kamm five as the club totaled 29 as a team. Kelly Taylor set for 27 assists to go with five digs and two aces. Allison Millard chipped in 15 digs and Samson six. Balmer had two of the team's three blocks. HF-L served six aces as a team.

The Cougars overwhelmed #2 Wayne 25-25-25 to 15-21-20 as they captured the Section V Class B title on November 9. Balmer pounded 16 of the team's 36 kills. Kamm notched 10 kills and Samson six. HF-L served three aces, one each by Ella Peters, Samson and Millard. Taylor collected 32 assists and 12 digs. Millard paced the defense with 21 digs. Samson followed with 12 digs, Peters nine, Fisk seven and Kamm five. Balmer was named Most Valuable Player for the tournament. Millard and Taylor were named to the All-Tournament team.

The victory propelled the Lady Cougars into the New York State Public High School Athletic Association Class B Tournament. HF-L defeated Olean (the Section VI, Buffalo-area champ) by 25-25-25 to 22-21-13 in the subregional round on November 12. The first two games were close, but the Lady Cougars jumped out to a 15-8 lead in game 3 and never looked back. Balmer tallied 13 kills, Samson nine kills and Kamm seven kills as the club accumulated 35 as a team. Kamm added six digs and one block. Fisk and Millard both notched two aces for the team's total of four. Millard led with 28 digs, Peters 12, Samson 11, Fisk 10, Brynn Mooney six and Hailey Sackoor five. Taylor finished with 31 assists and nine digs.

Brassie received the Monroe County Sportsmanship Award.

HF-L finished with a 9-6 record in addition to the fourth place at the Section V Class B Championships. Two members graduate.

Asha Hotaling was on the varsity for three seasons. Although listed as a junior, Hotaling will be graduating early. She was a diver and was 20th at sectionals, accumulating 192.30 points.

Aurore Lambert competed on varsity for six years. A co-captain, Lambert swam the 50 freestyle, 100 freestyle, 200 freestyle and 200 free relay. She was 17th at 27.23 seconds in the 50 free, 15th at 1:00.46 in the 100 free and helped the 200 free relay to fifth place in 1:46.04 at sectionals this fall.

The Cougars' hopes of a return to the state finals were derailed by Syracuse Westhill 25-25-25 to 16-20-23 in a state Class B regional match on November 16. After a bit of a tough time in the first set, although even that was fairly close, HF-L stayed right with Westhill in the second set and also in the third set. Balmer garnered 10 kills while Kamm followed with six and Samson five as the trio accounted for all but eight of the team's 29 kills. Samson, Taylor and Sackoor each served one ace. Millard notched 27 digs, Samson 16 and Peters 10. Taylor set for 25 assists and had seven digs.

"In the first set, I think the girls were a bit nervous," coach Rene Monks said. "We played better in the second and third sets, but you can't give a good team like Westhill any kind of advantage and we just were not able to come back. I think the girls knew we didn't play as well as we could and the girls were frustrated by that because we still were competitive with Westhill. We had a great season though and I am proud of this team. We will miss our four seniors as they are great girls and great leaders."

HF-L concluded the season with a 19-3 record as it won the Section V Class B championship. Four seniors graduate.

Kara Balmer competed on varsity for three seasons. A co-captain, Balmer led the Lady Cougars with 214 kills and also in blocks with 43 while adding 39 digs, five assists, three service points and one ace.

Danielle Fisk played on varsity for three years. A co-captain, Fisk was second with 24 blocks, second with 33 serving aces, third with 141 service points, third with 142 kills, fifth with 91 digs and added five assists.

Last year, the Wheatland-Chili Girls Varsity Soccer team did not face Marion and its star forward Chloe DeLyser until the state qualifier round. This year, the two squads met in the Section V Class C2 championship game and the game was a great one.

To get to the championship contest, the second-seeded Wildcats edged #3 Geneseo 3-2 in the Section V Class C2 semifinals on October 29. The two teams battled to a scoreless tie at halftime, although W-C had possession of the ball much of the time. Wing made seven saves.

"I thought we had the better of play in this game as well," Ward said. "We had a 2-1 lead, but Marion played really well. Chloe is much more of a complete player this year than she was a year ago. One of her goals was a great shot that no goalie could have made a save on and the other was on a direct kick that Ali was screened off on and did not see the shot coming. W-C finished with an 18-2 record. Seven seniors graduate.

On Being a Father in America

Another Fork in the Road
(Conclusion)

As this conclusion carries Maelani to the end of several more roads, News must detour to acknowledge a friendship. As if forged by the once-ubiquitous village blacksmith, it is ironclad and lifelong.

Sachi Morimura and Mel started a Business class at the U. of San Diego with standup introductions to the other newly-assembled classmates. When both young ladies noted horses and riding as their paramount interests, the smithy pulled out his anvil. Chatting up their mutual interest, envision that smithy, lighting up his forge... for their first trail ride, making them friends straightaway.

Figuratively speaking, bellows pumped a red-hot glow into strips of iron. Subsequently, strong hands hammered and shaped two nearly identical horseshoes. Technically, while one represents Sachi, who is Japanese, and the other Maelani, rooted in both Thailand and America, they are of one mind when it comes to their love of horses.

Although 9,000 miles separate them nowadays, Sachi in Los Angeles, with Maelani in Australia, the ladies still find ways to ride together. The photo shown here is from Spain, with other trails they've blazed in Greece, Colorado and California. (That's in addition to Mel's solo rides in Morocco, Portugal, Argentina, New Zealand and, of course, Thailand.)

Next up is a riding reunion with Sachi set for Oman, a hot, arid nation on the Arabian Peninsula. Emulating Lawrence of Arabia is not a bad way to see that part of the world, wouldn't you say?

With designs on staying in San Diego after her USD days, Maelani found employment with Norfield's, one of the nation's top small breeders, and later became an agent for Air Equine Services, a firm that flies horses great distances. The positions led to attendance at two of the Triple-Crown races of 2003, the Kentucky Derby and the Belmont Stakes, and, so it was thought, at Smarty Jones' third leg of the Triple Crown win at the 2004 Belmont.

There was one glitch in that last scenario, however. Botching a five-length lead coming out of the final turn (and directly in front of us), Smarty was outsprinted to the finish line by Birdstone. We (Maelani, her brother, James, and the writer) numbered among the 120,000 fans who collectively swallowed their tongues at the shocking finish. Albeit still crystal clear in my mind, it has been over fifteen years... fifteen!

During her tenure with Air Equine, it was often Mel's task to accompany horses on long flights. People with deep pockets buy and sell horses at famous auction houses – the annual Keeneland Yearling Sale in Lexington, Kentucky being most notable – and various other points of sale. Unlike the old-time cattle drives we see in the cowboy movies, these valuable commodities require luxury. Oftentimes, you can't just trailer these investments from Point A to Point B.

Working from major airport shipping hubs, Fed-Ex is a major carrier of entirely portable stalls, in which the animals travel in comfort. Rochester is one of those hubs, where it can handle the movement of horses with apparent ease. Since money is no object, these rich folks often transfer potential stakes winners to their home turf, or even trail-riding horses and family ponies to vacation getaways that may be hundreds of miles from home (just ask Mitt Romney or Bill Gates).

During one particularly interesting business trip, Maelani represented Air Equine at the Tattersall's Sale in Newmarket, England. The leading bloodstock auctioneer in Europe, Tattersall's sells about 10,000 horses yearly and most need to be shipped somewhere. Not only was she able to check out the ancestral hometown on her dad's side (Ashwell,

Hertfordshire, just thirty miles away), she met a man with a funny accent. That bloke was Sheamus Mills, a bloodstock agent from Melbourne, Australia.

Over English ale and Shepard's pie at a Newmarket pub, the two distant travelers started an acquaintance that blossomed into marriage three years later. Their vows were exchanged overlooking the Pacific Ocean at La Jolla, California, and their subsequent wedding reception transpired overlooking the creek at Honeoye Falls, N. Y. With mutual interests in anything equine, their roads converged in Frost's wood, somewhere between hither and yon.

That union, in which Maelani relocated, lock, stock and barrel to Australia, set off a series of routes that took them to countryside farms, breeding stables and far-famed racing venues. Sheamus, who, amazingly, had never ridden one until Maelani entered the picture, was already accomplished in assessing the pedigree and value of most any horse put before him.

As one capable of designing plans for broodmares and stallions, Sheamus facilitated the creation of "Vow and Declare," the aforementioned winner of this year's \$7M+ Melbourne Cup. Though it may be his penultimate accomplishment in the field, with every racing season and every yearling sale, there is always room to travel new roads to scale ever higher in the equine world.

Along with many of the great races in America, such annual events as the Royal Ascot meeting, just west of London, has already measured the degree of Shea and Mae's involvement with the horse. "As Britain's most valuable race meeting," noted its website, "Royal Ascot is revered across the globe and attracts many of racing's finest horses to compete for millions of pounds in prize money, with six world-class races on the card each afternoon."

And then there's Lucas, the little scamp of a son, who came to them in 2014. With a loving heart and treasure trove of curiosity, one might find him playing with his trucks at a table in the shadow of an auction ring or spread-eagled on the back of "Toto," the family horse.

And don't think the mother figure, Maelani, has been using her horse aptitude in a frivolous manner. In 2016, she introduced yoga with horses, setting up Australia's first paddock studio that integrates equine therapy, mindfulness and yoga. After selling the brick-and-mortar studio at a tidy profit, enough Aussies, already considered the most physically fit people on earth, embraced the concept to the point where she continues building the combined horse/yoga business.

Not stopping there, Maelani is currently setting her sights on developing "Equine Ananda" (Ananda is Sanskrit for "joy"). Therefore, she is back in college, seeking, in her words, "Equine Assisted Psychotherapy Certification in conjunction with a Master's Degree in Counseling."

A what? Well, putting it in simple terms, it's using the curative powers of an agreeable horse to create a soulful mind-body experience for harried homo sapiens. Yup, and she adds that it may lead to her being "the first to offer this Australian model training in the U. S. in 2021." 'Tis a far cry indeed, from mucking out all those stalls when she was a kid.

A qualified voter is one who is: (1) a citizen of the United States of America, (2) eighteen (18) years of age or older, and (3) resident within the School District for a period of thirty (30) days preceding the special election.

Any qualified voter may, upon examination of such list, file a written challenge to the qualifications of any person whose name appears on the list of absentee voters stating the reasons for the challenge therefore known to the School District Clerk prior to the election for transmittal by the School District Clerk to the Inspectors of Election on the date of the vote before the close of the polls or directly to the Inspectors of Election on the day of the vote before the close of the polls.

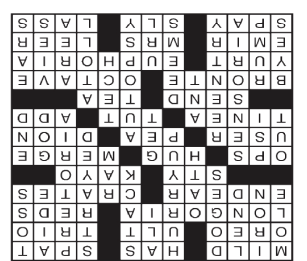

RESET - Welcome to halftime of our "Endangered Babies" piece. If you were a bit uncomfortable with the potential danger to which the babies were subjected last week when costumed devils were jumping over babies in the streets of Spain, you may want to bail completely at this point.

Whatever the Child-Eater of Bern was originally meant to represent, the result we are left with today is the culinary nightmare of every kid in the world.

LITHUANIAN BABY RACING - Set your calendar. Every year on June 1st the world acknowledges International Child Protection Day. Depending on your individual schedule, you may, or may not, have missed the celebration of this one last year. But if you lived in Lithuania it would have been a whole lot harder to miss. Every country has its quirky celebrations. Look in the mirror. Your country, the good old U.S.A., celebrates the Coney Island hot dog eating contest every 4th of July. So don't come down too hard when you hear that every June 1st Lithuania is totally caught up in a fervor of excitement over the annual Lithuanian Baby Races.

LOGISTICS - Here's how it works, as well as some highlights from previous competitions. The event was conceived in 1999 because no eastern European country wants to let a millennium slip away without showing how much wacky fun they've been having since achieving independence from the Soviet Union.

THE RACE IS ON - Let us close by sharing with you what, by most accounts, was the greatest race ever. Let's set our Wayback Machine with the following coordinates . . . Location: Vilnius, Lithuania; Time: June 1st 2003. We've never had a chance to call a Kentucky Derby before, but we'll give our best shot to this opportunity to describe that race. As previously stated, four babies compete per heat. We'll refer to these babies by number rather than by name to protect the innocent, as well as the guilty.

By the end of this race the sharpest knife in your kitchen isn't going to be enough to cut through the tension in the room. So we're going to do you one little favor here at the beginning. Teaser alert: Baby #4 never crosses the starting line and is subsequently a total non-factor. Baby #3 streaks out at a record pace, gets within inches of the finish line, comes to a complete halt, and turns 90 degrees facing sideways toward lanes #1 and #2.

Just when the audience feels certain the instant replay booth will need to be called in to judge a photo finish, Baby #2 hits the vomit pool and body surfs on to victory.
