

ADAMS. In Dansville on 1 Mar, Charlotte Adams, age 72. Wife of Christopher Adams. A Universalist for about 25 years. Also survived by one adopted daughter. (*Christian Ambassador*, New York NY, 26 Mar 1864) ALLEN. In York of scarlet fever, Mary Allen, age 10 years and 5 days. Daughter of Gideon and Hannah Allen. Funeral the 17th ult. by Justus Gage II, who wrote the death notice on 20 Oct 1834. (*Herald of Truth*, Geneva NY, 8 Nov 1834 and *Evangelical Magazine & Gospel Advocate*, Utica NY, 20 Dec 1834)

ANNIS. In Onondaga, Michigan on 11 Mar, Augustus B. Annis, age 79. Formerly of Livonia, Livingston Co., NY. Born in Vermont; came to Western NY in 1805. Settled in Livonia, MI in 1811 with his family and lived there over half a century. Funeral in Livonia in the Methodist Church "kindly offered for the occasion" by Rev. E. R. O. [Edmund R. Ottoway, Universalist]. (*Christian Ambassador*, New York NY, 5 May 1866)

ANNIS. In Livonia on 1 Apr, **Phebe Annis**, age 45 years and 8 months. Wife of Augustus B. Annis and daughter of Nathan Skinner of Cambridge, Washington Co., NY. A Universalist. The obituary notes that 2 infant children died the following day. Funeral the 2nd by Rev. O[rrin] Roberts. (*Evangelical Magazine & Gospel Advocate*, Utica NY, 23 Apr 1841)

ARNOLD. In Conesus on 2 May, Hon. Gardner Arnold, age 74. (*Christian Ambassador*, New York NY, 6 Jun 1868)

ASHLEY. In Portage on 28 Mar of consumption, Sarah E. Ashley, age 19. Funeral by Rev. S. R. W[ard]. (*Christian Ambassador*, Auburn NY, 2 May 1857)

ASPINWALL. In Nunda on Wed 24 Oct of dysentery, Rev. J. A. [Joseph Aikin] Aspinwall, age 47. Born and raised in Henderson, Jefferson Co. Had pastorates in South Hartford, Fort Plain, Saratoga Springs, Braman's Corners, Schenectady, Cooperstown, Rome, Clinton, and Nunda. Had been Standing Clerk of the New York State Convention of Universalists for 10 years. Survived by his wife, mother-in-law, and 4 sons, the oldest a 22 year old invalid. Obituary notes that the family was left "in straited circumstances." Funeral 27th in the Baptist Church at Nunda—the Society offered the use of their building as the Universalist Church was too

GOFF. In Virginia Settlement, McHenry Co., IL, Nancy Goff, age 59. Wife of David Goff and mother of ten. Formerly of Springwater, Livingston Co., NY. Funeral by Rev. Wheeler, Baptist. Obituary by W. Goff. (*Evangelical Magazine & Gospel Advocate*, Utica NY, 14 Sep 1838)

GORDON. In Lima on 25 Feb 1881, funeral of Mrs. Roxana Gordon, age 65. From the record of

Lewis Cresaba Browne. [Monument in Oak Ridge Cem. for Roxana Watkins Gordon, 1813-1881. Same side of monument has name of James S. Gordon with both date blocks blank. Another side has James T. Gordon, 1837-1905 and below it Grace Frost Gordon, 1844-1876. A third side has Garrett Gordon and Abigail Gibbs Gordon with no dates.]

GOULD. In Nunda on 24 Nov, William Gould, age 88. Survived by his wife of 50 years and 7 children. Theirs was the second family to settle in Nunda. Funeral by Rev. W. E. Manley. (*Evangelical Magazine & Gospel Advocate*, Utica NY, 30 Dec 1842)

GROVER. In Nunda, McHenry Co. IL on the 19th inst. of typhoid fever, **Silas Grover**, age 48. He died at the home of his brother-in-law Wm. Hoffman. Formerly of Nunda, Livingston Co., NY. Had left home the previous summer to build a house in Minnesota and was returning East to spend the winter, then return to his new home. His brother Salmon Grover of Wisconsin came to visit him before his death. Survived by his wife. Funeral and interment at Crystal Lake, Illinois; sermon by Rev. O. R. [Orrin Roberts] who had known him in Nunda, NY. (*Christian Ambassador*, Auburn NY, 6 Dec 1856)

HAWES. In Lima on the 5th inst., Col. Lyman Hawes, age 67 years and 5 months. Predeceased by 5 of his 6 children. Survived by his wife and a daughter. Funeral "Sunday" at the Methodist church by Rev. J. W. B. [James W. Bailey, Universalist], assisted by Rev. Knowles, pastor and Rev. Dr. Barnard of the Presbyterian church. (Christian Ambassador, Auburn NY, 27 Jul 1861). [G.S. in Oak Ridge Cem. for Lyman Hawes, 1794-1861]

HAWES. In Lima on the 9th inst., Rachel Hawes, age 66. Wife of the late Col. Lyman Hawes. (Christian Ambassador, New York NY, 3 Oct 1863). [G.S. in Oak Ridge Cem. for Rachel Hawes, 1795-1863]

HAWES. In Lima at Genesee College, Sanford Hawes. A member of the Sophomore class. (Christian Ambassador, Auburn NY, 27 Jun 1857). [G.S. in Oak Ridge Cem. for Sanford Hawes, 1836-1857]

HAWLEY. In Portage on 2 Nov 1856, Amelia Hawley, age 26. Wife of Wm. Hawley. Funeral by Rev. S. R. W[ard]. (Christian Ambassador, Auburn NY, 17 Jan 1857)

HEATH. In Nunda Valley on 27 Aug, Joseph Heath, infant son of James M. and Susan Heath. Funeral by [Rev. Townsend P. Abell]. (Herald of Truth, Geneva NY, 30 Sep 1836)

HEMENWAY. In Avon on 21 Jan, Emma Hemenway, age 41. Wife of Moses Hemenway. Funeral and interment 25th at Honeoye Falls; services by Rev. O. R. [Orrin Roberts]. (Evangelical Magazine & Gospel Advocate, Utica NY, 4 Mar 1842). [G.S.in Honeoye Falls Cem. for Emma Bartlett Hemenway, no dates]

HINKLEY. In Mount Morris on 9 Dec 1864, Lucretia Hinkley, age 80, of Rome, Oneida Co. She and her husband were among the first Universalists in Oneida Co. Funeral 12th in the Universalist church at Rome by Rev. T[heodore] D. Cook of Utica; interment in Rome. (Christian Ambassador, New York NY, 21 Jan 1865)

HOLMES. In Nunda on 7 Apr, Harriet Holmes, age 72. Wife of the late Simeon Holmes. Funeral 9th by Rev. S. C. (Christian Ambassador, New York NY, 11 May 1867)

HOLMES. In Mt. Morris on 22 May of consumption, Simeon Holmes, age 62. A trustee of the Universalist Society in Nunda. Funeral Sun the 24th in the Methodist church at Brooks' Grove. (Christian Ambassador, Auburn NY, 4 Jul 1857)

HOLMES. In York on 11 Mar, Sophia Holmes, age 38. Wife of Daniel Holmes and mother of four. Funeral by Rev. A[lanson] Kelsey at her previous request. (Evangelical Magazine & Gospel Advocate, Utica NY, 3 Apr 1846)

HORTON. In Springwater on 20 Feb, Charlotte Horton, age 55. Wife of Isaiah Horton. She converted to Universalism in 1840. Survived by her husband and 6 children, the youngest a daughter. (Christian Ambassador, Auburn NY, 25 Mar 1854)

HORTON. In Springwater on 22 May, Isaiah Horton, age "nearly 77." (Christian Leader, Utica NY, 7 Jun 1873)

HORTON. In Nunda on 14 Jul, Mehitable Horton, age 80. Mother of Judge Elijah Horton. Funeral Sun the 16th by Rev. A[lanson] Kelsey. (Evangelical Magazine & Gospel Advocate, Utica NY, 18 Aug 1843)



BURCHARD. In Lima on 27 Sep 1853, Asahel Burchard, Esq., age 92. Born in Norwich, Connecticut on 14 Jun 1762. Took his father's place in the Revolutionary War and was taken to England for six months as a POW, until the war ended. He then lived in the Susquehanna Valley area of Pennsylvania for two years. In the spring of 1789 he came to what became the town of Lima; "they opened a path with the ax through the wilderness." Predeceased by a large family of children. A member of the Universalist Society of North Bloomfield. His name appears in the <u>Pioneer</u> <u>History of the Phelps and Gorham Purchase.</u> (*Christian Ambassador*, Auburn NY, 21 Jan 1854)

CADY. In Littleville on 17 Sep, Mrs. Augusta Cady, age 23 years and 4 months. Formerly of Pompey, NY. Survived by her husband, 2 children, and parents. Funeral 18th in the Presbyterian church in Littleville by Rev. O. R. [Orrin Roberts, Universalist]. (Evangelical Magazine & Gospel Advocate, Utica NY, 25 Oct 1839)

CARGILL. In Portage on 1 Oct, Eudora Cargill, age 12 years and 8 months. Daughter of Nathan and Lovina Cargill. (*Christian Ambassador*, Auburn NY, 20 Dec 1862)

CHASE. In South Livonia at the home of her father John C. Coe on the 4th ult. of dropsy in the chest, **Almira Charlotte Chase**, age 31. Wife of Rev. Jacob Chase of Rochester. She had left Rochester on 18 Mar with the expectation of returning home in a few days. Funeral 6th by Rev. [Wm.] Queal. (*Evangelical Magazine & Gospel Advocate*, Utica NY, 25 Jun 1841) [She is buried in Oak Ridge Cem. at South Livonia in the family plot.]

CHASE. In Nunda on 23 Feb of dropsy on the

brain, Arthur Chase, age 1 year and 9 months. Son of Joel C. and Sarah M. Chase. Funeral by Rev. O. R. [Orrin Roberts]; burial in the village cemetery. (*Christian Ambassador*, Auburn NY, 12 May 1855)

CHURCH. In Portage on 22 Sep, Ennier Ann Church, infant daughter of Rev. L. Church. Funeral 23rd in Nunda by Rev. R. Van Campen. (Western Luminary, Rochester NY, 2 Nov 1844)

CLARK. In Conesus on 27 Dec 1874, Lewis Clark, age 77. Born 22 Dec 1798 in Westfield, NJ. A resident of Conesus since 1827. A founding member of the Universalist Church. Survived by his wife and 3 daughters. Funeral 29th at the church by Rev. Asa Saxe [of Rochester]. (*Christian Leader*, Utica NY, 16 Jan 1875)

CLARK. In Conesus on 15 Mar, Mrs. Sarah Clark, age 77. A native of Springfield, NJ but had lived most of her life in Western New York. Survived by daughters. Funeral in the Universalist church by Rev. Asa Saxe [of Rochester]. (*Christian Leader*, Utica NY, 21 Apr 1877)

CLOSE. In Conesus on 16 Oct, **Humphrey T.** Close, age 2 years, 4 months and 25 days. Son of Erastus and Caroline Matilda Close. (*Evangelical Magazine & Gospel Advocate*, Utica NY, 22 Dec 1848)

COE. In South Livonia on 17 Jul, Anna Coe, age 87 years and 5 months. Wife of the late John C. Coe, who died 24 years earlier. She lived over 60 years on the homestead. She became blind 7 years before her death. Survived by 8 of her 11 children, 11 grandchildren and 1 great-grandchild. (*Christian Leader*, Utica NY, 29 Jul 1876) Funeral by Rev. - Artemas Chapin was born in 1782 in Sturbridge, Mass., and lived with his father Samuel Chapin in Wardsboro, Vermont, according to "The Chapin Book," Artemas was in Easton, Washington Co. in 1810 and married Cyntha Hannon or Hammond in 1806, probably in Washington Co. In 1820 the family lived in the town of Galen, Seneca Co. New York, and then in Canada, possibly near Stanstead, Quebec. By 1840 the family were in Hartland, Huron Co. Ohio, where Artemas and Cyntha died.
- I need any information on Cyntha. She may have had sisters Hannah and Meribah, and a brother Lemuel Hammond. All may have been born in Washington County and later lived in Seneca and Wayne Counties, New York.
- I am looking for descendants of the six Chapin children: Alexander, who married Eliza Lamb, lived in Hartland, Huron Co., Ohio; Morris Governor, married Clarissa Granger, also lived in Hartland; Alpheus B., Betsey M., Phebe E.; and Lewis Chapin, who lived in Lee, Berkshire Co.





# Marriages from St. Patrick's R.C. Church

Extracted by Dick Halsey

A large percentage of RGS members say that they have Irish ancestry. The earliest Irish Church in Monroe County was St. Patrick's Roman Catholic Church. It was organized Apr. 29, 1822. It was located on the northeast corner of Platt and Frank Streets. By 1831 they had built a second, larger, building (pictured). An even larger edifice had the cornerstone laid on October 9, 1864 and dedicated in 1870. That structure was bought in 1937 by Eastman Kodak to expand Kodak Office and was demolished.

The earliest existing book of records for St. Patrick's Church is from 1833. These are the early marriage records. Note that as with any old records, it is difficult to interpret some of the correct spelling of names and places.



MUNSON. In Wolcott on the 10th ult., Mary Ann Munson, age 27. Wife of E. Y. Munson and daughter of Joseph Lord of Canaan, Columbia Co. (*Evangelical Repository*, Troy NY, 1 Mar 1828)

PARK. In Wolcott on 20 Nov of typhoid fever, Mrs. Jane Park, age 32. Daughter of Isaac Shaw of Genoa. "She leaves a husband to whom she had been united but a short time, and two daughters by a former marriage." A member of the Methodist church. Funeral by Rev. White, Methodist. (*Christian Ambassador*, Auburn NY, 4 Dec 1852)

PECK. In Butler on the 17th ult., Susan Peck, age 35. Funeral by Rev. T[heodore] D. Cook. (*Herald of Truth*, Geneva NY, 8 Jan 1836)

PECKHAM. In Clyde on the 22d ult. of consumption, Jesse W. Peckham, age 48. "He had been a firm Universalist for many years." (*Christian Ambassador*, Auburn NY, 9 Jul 1859)

PEER. In Newark on 12 Jul 1852 of consumption, Mrs. Lucretia Peer. Funeral by Rev. Charles Augustus Skinner, from his record.

PERKINS. In Macedon on 25 Oct of heart and lung disease, Ansel Perkins, age 69. Born in Victor. His wife died a year earlier. Survived by 5 children. Funeral by Rev. G[eo.] W. Montgomery; Masonic interment. (*Christian Ambassador*, New York NY, 18 Nov 1865)

PERRY. In Clyde of consumption, Miss Eliza A. Perry, age 25. Survived by her parents and a brother. Funeral by Rev. Geo. W. Montgomery [of Rochester]. (*Christian Ambassador*, Auburn NY, 21 Sep 1861) PETTIS. In Sodus on 7 Aug, Alexander Pettis, age 38. Survived by his wife and 2 small children. Obituary by Rev. A[lanson] Kelsey. (Christian Ambassador, Auburn NY, 18 Aug 1855)

POST. In Newark on 15 May 1853, funeral of Mrs. Lucy J. Post, age 25. From the record of Rev. Charles Augustus Skinner.

PRICE. In Newark on 14 Dec 1873, Perry G. Price, age 72. Funeral 17th by Rev. G. B. S. [George B. Stocking of Syracuse]. (*Christian Leader*, Utica NY, 17 Jan 1874)

PROSEUS. In Sodus on 28 Apr of consumption, Eliza Proseus, age 38. Wife of Joseph Proseus. She had requested that a Universalist clergyman preach her funeral sermon; Rev. N[elson] Sawyer of Wolcott complied. Funeral in the Episcopal church with "thanks for the liberality they exercised." (*Evangelical Magazine & Gospel Advocate*, Utica NY, 19 May 1843)

PROSEUS. In Sodus on 12 Feb 1864, funeral of **Thomas Jefferson Proseus**, age 20 years and 6 months. From the record of Rev. Lewis Cresaba Browne.

ROGERS. In Newark on 28 Mar, Mrs. Mary S. M. Rogers, age 23. Survived by her husband, her mother, a sister. Funeral 31st in the Universalist church by Rev. Day K. Lee. (Evangelical Magazine & Gospel Advocate, Utica NY, 3 Jun 1842)

ROSE. In Sodus on 23 Jul of scarlet fever, **Finette Rose**, age 19. Survived by her parents and siblings. "No ceremonies were performed at the funeral and burial of the deceased." A memorial service was held Sun 16 Aug with Rev. T. C. Eaton officiating. "The Episcopalians kindly offered their church for the services." (*Herald of Truth*, Geneva NY, 12 Sep 1835)

SMITH. In Newark on 10 Apr of chronic heart disease, Rev. M. B. [Moses B.] Smith. Born 4 Aug 1790 in Otsego Co. Married on 8 Oct 1812 to Mary Gaige and on 30 Jul 1854 to Melissa Gaige. Studied medicine and began practice in Cortland Co.; was a practicing physician for several years in Burlington, Otsego Co. Believed to have begun preaching in the county in the summer of 1836. Was ordained by the Otsego Ass'n. [of Universalists] in Aug or Sep of 1837. Preached in Cedarville and Newport, Herkimer Co.; Clinton, Oneida Co.; and Albion. Orleans Co. Moved to Newark where he was employed as a druggist and supplied the Universalist pulpit in the absence of the minister. "Entering the ministry at middle age, his success was probably never quite equal to his wishes; but his attachment to the profession continued to the end of life." Survived by an only son in Michigan. Funeral 19th by Rev. L. C. B. [Lewis C. Browne], who wrote the obituary. Interment in Albion, Orleans Co. (Christian Ambassador, New York NY, 18 Apr and 9 May 1863)

He died in 1895. Lucina died in 1918.

The Friends of Mt. Hope are looking for information when he lived in Canada and served in the British Army during the Canada Rebellion. If any one can help please contact me.



## Godfrey Memorial Library

by Edward Groszewski

The Godfrey Memorial Library, located in Middletown, Connecticut, houses a very large and wide-ranging collection in a very small space. One might think that a genealogical library in central Connecticut would be devoted to the records of that area, state, or possibly, New England. In fact, although its archives do contain town records and other materials peculiar to its locality, a panoply of useful information from every state and twenty-two foreign countries may be accessed there. The library is particularly rich in sources for African-American genealogy, and a quick search of the online catalog returned over 160 hits for this topic.

During my first visit I was searching for some of my wife's ancestors who lived in Connecticut in the 1600s and early 1700s. I was very pleased to find a treasure trove: compiled genealogies, journal articles, and town records. I had intended to stay for only one or two hours and continue on to another library further south in the state. Instead I asked a staff member to direct me to a good restaurant for lunch and spent the entire afternoon absorbed in the materials available to me. I will be returning there this summer, but this time I have no expectation of exhausting their resources!

The staff is small but very knowledgeable and all seem to be avid genealogists in their own right. I was delighted to find that my laptop was able to connect to the internet through the community wi-fi service. Workspace is very adequate and well lit.

I must also point out that the Godfrey Library has an excellent website that permits not only the usual catalog search, but has a very large and well-organized on-line collection of sources available to members. Not only does this collection provide access to a large number of city directories and photo archive collections, but also to specific resources such as the *Rochester Volunteer* (1841-1843) and the digital archives of the *London Times* for 1785 to 1985. The membership fee of \$35.00 is well worth the investment for any researcher who wants access to more than the genealogy megasites have to offer. #### **Records of the Webster Presbyterian** Church

In the Miscellaneous Records books at the Monroe County Courthouse it is noted that the Presbyterian Society of North Penfield (now Webster) first met at the brick schoolhouse #12 on August 27<sup>th</sup> 1825. Chosen as Trustees were the following gentlemen: J. **Patterson**, Henry J. **Sherman**, Michael **Dunning**, William **Hicks**, and Nathaniel **Abbot**. They met as a organization for a few years until they finally were organized as a Church on Aug. 11, 1829. The following officers were elected on that date:

Richard **Dunning** - Moderator William **Hicks** - Clerk William **Middleton** - 1<sup>st</sup> Class Trustee William **Hicks** - 1<sup>st</sup> Class Trustee Nathaniel **Abbott** - 2<sup>nd</sup> Class Trustee George **Mandaville** - 2<sup>nd</sup> Class Trustee Robert **Gregg** - 2<sup>nd</sup> Class Trustee Samuel **Preston** - 3<sup>rd</sup> Class Trustee James **Hawley** - 3<sup>rd</sup> Class Trustee

For the first few years all that are included are records of the meetings of the Trustees. Records of members only begin showing up in the Church record in Jan. 1841


