Public Disclosure Commission Staff,

Pursuant to RCW 42.17A.775, I write to report violations of the Fair Campaign Practices Act ("FCPA"), Chapter 42.17A RCW, by the Freedom Foundation.

In brief, the Freedom Foundation ("FF") has operated as a political committee for years without filing a statement of organization with the Public Disclosure Commission ("PDC") as required by RCW 42.17A.205. As an unregistered political committee, the FF has also failed to comply with the other provisions of Chapter 42.17A RCW governing the conduct and reporting requirements of political committees.

Additionally, the Freedom Foundation has disseminated communications during the past several months that qualify as electioneering communications. The organization has failed to comply with the reporting and disclaimer requirements that apply to electioneering communications under the FCPA. As such, the organization should be held accountable for its failure to comply with these requirements by the PDC.

#### **Factual Background**

In solicitations for donations to their organization, the FF uses explicitly political language to describe their mission. They also state that donations to the FF are used for political purposes, and that those donations will help the FF affect the outcome of upcoming elections, as evidenced by these excerpts from their fundraising documents.

#### From Exhibit A:

"This is the year everything is up for grabs, and we have to act fast to keep the radical Left from hijacking this country we love. We could be as little as nine months away from losing this country forever, and we must act fast to keep that from happening."

"Thanks to your generosity, no one is doing more to do just that than the Freedom Foundation."

#### From Exhibit B:

"If you want to level the political playing field so conservative ideas and leaders have a chance to win...this is your fight. And now is the time!"

#### From Exhibit C:

"With a new year and a new decade now well under way, a time for action has arrived! This is the year everything is up for grabs, and we have to act fast to keep the radical left from hijacking this country we love."

#### From Exhibit D:

"The year ahead offers a huge opportunity to defeat and discredit the Left for good – and the Freedom Foundation has a proven plan to seize this moment. Your generous support will allow us to take on the radical left..."

#### From Exhibit E:

"Your tax-deductible contribution today of \$25, \$50 or even \$100 will enable the Freedom Foundation to take this fight for fairness and freedom to the next level – and to finally level the playing field between taxpayers and out-of-control leftist government unions. Together, you and I are defunding the most virulent leftist lobbies and defending liberty and limited government."

Over the past several months, Freedom Foundation has disseminated numerous communications criticizing Governor Jay Inslee. These communications have included:

- 1) A fundraising event in October 2020 which discussed Governor Inslee's handling of the COVID-19 pandemic in Washington and detailing the organization's efforts to "fight back" against Governor Inslee (see **Exhibit F**);
- 2) A letter sent in September 2020 soliciting contributions to Freedom Foundation, criticizing the national response to the COVID-19 pandemic, and specifically singling out Governor Inslee for allegedly spreading "lies and fear during the COVID-19 panic" (see **Exhibit G**);
- 3) A periodical published in September 2020 claiming that Governor Inslee abused his emergency powers to "reward [his] friends," alleging that Governor Inslee has kept schools closed in Oregon because unions representing teachers donate to his campaign, and implying that Governor Inslee shut down a specific waterpark in Washington through his "accomplices in the Department of Labor" (see **Exhibit H**); and
- 4) A periodical published in October 2020 that further elaborates on Freedom Foundation's claim that Governor Inslee's order to shut down waterparks, but not state parks, was politically motivated and hypocritical (see **Exhibit I**).

#### **Violations of the FCPA**

## I. The Freedom Foundation is a Political Committee as defined by RCW 42.17A.005(40).

RCW 42.17A.005(40) defines "political committee" as "any person . . . having the expectation of receiving contributions or making expenditures in support of, or opposition to, any candidate or any ballot proposition." RCW 42.17A.205 requires every "political committee" to "file a statement of organization" with the PDC "within two weeks after organization or within two weeks after the date the committee first has the expectation of receiving contributions or making expenditures in any election campaign, whichever is earlier."

Three Washington court decisions have further clarified and interpreted this definition. In State v. Dan J. Evans Campaign Committee, the Washington Supreme Court determined that an entity satisfies the expenditures prong of the definition of "political committee" if affecting, "directly or indirectly, governmental decision making by supporting or opposing candidates or ballot propositions" is "the primary or one of the primary purposes" of the entity. 86 Wn.2d 503, 509 (1976). In Utter ex rel. State v. Bldg. Indus. Ass'n of Washington, the Court confirmed that an organization may be considered a "political committee" if one of its primary purposes is to engage in electoral political activity; electoral political activity need not be the primary purpose of the entity for it to fulfill the definition of "political committee." 182 Wn.2d 398, 427 (2015). To determine the primary purpose as established in *Dan Evans* and later affirmed in *Utter*, a court will examine the stated goals and mission of the organization and whether "electoral political activity was a primary means of achieving the stated goals and missions during the period in question." State ex rel. Evergreen Freedom Foundation v. Washington Education Association, 111 Wn. App. 586, 600 (Ct. App. 2002). The Court of Appeals in EFF v. WEA interpreted the term "political committee" as follows: "a person or organization may become a political committee by either (1) expecting to receive or receiving contributions, or (2) expecting to make or making expenditures to further electoral political goals." Id. at 598.

#### a. The Freedom Foundation Received Contributions in an Election Campaign.

The donations that the Freedom Foundation receives from citizens in Washington are contributions made in expectation of furthering electoral political goals. For example, on February 25, 2020 in Exhibit A, the Freedom Foundation cautions its supporters that "[w]e could be as little as nine months away from losing this country forever" before soliciting contributions to the organization. This language refers specifically to the presidential election and asks for contributions to support Freedom Foundation's goals in that election. Additionally, in Exhibit D, Freedom Foundation urges its supporters that this year "offers a huge opportunity to defeat and discredit the Left for good—and the Freedom Foundation has a proven plan to seize this moment," referring specifically to the fact that this is a presidential election year. This is also supported by Exhibit C ("This is the year everything is up for grabs, and we have to act fast to keep the radical left from hijacking this country we love."). It follows from the language used by Freedom Foundation, along with the dates and timeline on which the mailers were sent, that any contributions it receives are being made in expectation of furthering the organization's stated electoral political goals.

Such activities, without more, were sufficient to qualify Freedom Foundation as a political committee under the "receiver of contributions" prong. However, Freedom Foundation also fulfills the "expenditures prong" of the definition of "political committee" under RCW 42.17A.005(40).

#### b. The Freedom Foundation Made Expenditures in an Election Campaign

In *Evergreen Freedom Foundation*, the Court of Appeals expounded on the primary purpose test established by the Washington Supreme Court in *Dan J. Evans Campaign Committee*, including the following observations:

"an appropriate framework for determining whether electoral political activity is one of an organization's primary purposes should include an examination of the stated goals and mission of the organization and whether electoral political activity was a primary means of achieving the stated goals and mission during the period in question. Under this analysis, a nonexclusive list of analytical tools a court may use when evaluating the evidence includes: (1) the content of the stated goals and mission of the organization; (2) whether the organization's actions further its stated goals and mission; (3) whether the stated goals and mission of the organization would be substantially achieved by a favorable outcome in an upcoming election; and (4) whether the organization uses means other than electoral political activity to achieve its stated goals and mission."

#### 111 Wn. App. at 599-600.

The Freedom Foundation repeatedly describes its own purpose as "defeating the Left" and "defunding the radical Left." It follows that the stated goals and mission of Freedom Foundation would be substantially achieved by a favorable outcome in an upcoming election. Freedom Foundation also frequently uses language that refers to the election as a key event in achieving its goals. To be considered a "political committee" under the expenditures prong for the purposes of the FCPA, Freedom Foundation need only have influencing electoral political activity as one of its primary purposes. It meets this threshold without question.

#### II. The Freedom Foundation Failed to Report Electioneering Communications.

#### a. The Freedom Foundation made electioneering communications.

According to RCW § 42.17A.005(21), an electioneering communication is one that (1) clearly identifies at least one candidate for state, local, or judicial office; (2) appears within 60 days of an election in the candidate's jurisdiction; (3) appears in a specific form of media, including radio, television, postal mailing, billboard, newspaper, or periodical; and (4) either alone or in combination with other communications by the same sponsor identifying the same candidate has a fair market value of \$1,000 or more.

The Freedom Foundation's communications from September 2020 through October 2020 meet all four elements of the definition of electioneering communications and therefore qualify as electioneering communications. These communications clearly identify a candidate for state office, Governor Jay Inslee. The communications have all appeared within 60 days of the election

(in this case, after September 3, 2020). The communications have appeared in the required forms of media, specifically by postal mailing and by periodical. These communications, standing alone or when combined with other communications by the Freedom Foundation identifying Governor Jay Inslee, have a fair market value of more than \$1,000. Therefore, these communications constitute electioneering communications and are subject to the reporting and disclaimer requirements for such communications.

### b. The Freedom Foundation did not report its electioneering communications within 24 hours.

Electioneering communications are subject to strict reporting requirements. If an advertising expense qualifies as an electioneering communication, its sponsor must comply with certain reporting requirements. *See* WAC 390-16-063(4). Specifically, all electioneering communications must be reported within 24 hours of the time the communication is first transmitted, mailed, erected, distributed, or otherwise published by filing a Form C-6 report. RCW § 42.17A.305(2); WAC 390-16-060.

None of the Freedom Foundation's communications were ever reported to the PDC, much less reported within the required 24-hour period. Because these communications were electioneering communications, the Freedom Foundation's failure to report the communications violated the 24-hour reporting requirement of RCW § 42.17A.305(2).

## c. Freedom Foundation did not include the required "top five contributor" disclaimer on its electioneering communications.

Under the FCPA, political advertising undertaken as an electioneering communication is required to contain certain additional disclaimers. One such disclaimer is the "top five contributor identification." According to RCW § 42.17A.320(2)(b), a political advertisement sponsored by a political committee must include a "Top Five Contributors" heading, followed by a list of the names of the five persons or entities making the largest contributions in excess of \$700 to the committee during the 12 months before the advertisement runs.

#### **Conclusion**

The Freedom Foundation is a "repeat offender of [Washington] campaign finance laws" according to Washington Attorney General Bob Ferguson. Just as the Attorney General expressed, voters have a right to know who is influencing the election. To that extent, the "Freedom Foundation needs to start following the law". The Freedom Foundation's failure to register and report as a political committee and failure to comply with reporting and disclaimer requirements for electioneering communications as required by the FCPA has tangibly negative implications for the transparency of Washington elections. Currently, the citizens of Washington cannot account for expenditures from Freedom Foundation's pledged political mission to affect elections, nor can donors to Freedom Foundation know that their donations are being utilized for the political promise to which they donated.

Given the Freedom Foundation's status as a habitual offender of campaign finance laws, we respectfully request that the PDC perform an investigation into these allegations and take appropriate enforcement action. Please do not hesitate to contact me if I can be of assistance. I certify under oath, at the risk of penalty or perjury, that the complaint is complete, true, and correct.

Plenty of our friends and allies have been disappointed that the union membership declines haven't been a national trend. Well, that just shows the difference that the Freedom Foundation makes and why we need to take this fight to every corner of this country.

We knew all along that <u>Supreme Court decisions don't enforce themselves</u> and that <u>we must fight for every single opt-out</u>.

And that's exactly how things have played out. Rather than comply with the law, the unions have:

- ★ forged signatures on union cards;refused to honor resignation letters from members; and,
- \* used high-pressure scare tactics to keep members from leaving, such as telling them they'll lose their health insurance.

And that's just the beginning. They threaten our canvassers, protest our events and even show up at my house uninvited at dinnertime to try and intimidate me.

The list of bullying tactics keeps going and going.

They've organized boycotts of businesses run by our board members, put their faces on billboards and even sent unflattering letters to everyone in our neighborhoods, our church directories and every other group of contacts you can imagine.

They're not just throwing everything in the book at us—they're writing new chapters and new volumes on how to how to intimidate us and intimidate anyone who believes in what we're doing.

Here's still one more example of how the unions are clinging to power: Many unions have imposed arbitrary 10-day opt-out windows when union members can exercise their right to leave.

It's been a while since I took high school civics, but if memory serves, the Constitution is

in force 365 days a year—not 10 days per year.

With your help, we've built the country's largest public interest law firm dedicated to suing unions and forcing them to obey the law. I posed the question to them—and sure enough, they told me the Constitution is the law of the land every single day of the year.

So with your help, we filed suit in federal court to challenge the unions and their 10-day opt-out windows.

This case, *Belgau v. Inslee*, *et al*, was filed in August 2018 on behalf of seven Washington state employees who attempted to resign from the Washington Federation of State Employees (WFSE) shortly after the Supreme Court affirmed that mandatory union membership and dues in the government workplace violate a worker's First Amendment rights.

In December, we took this case to the 9th Circuit Court of Appeals. Should *Belgau* reach the U.S. Supreme Court — and regardless of which side prevails at the 9th Circuit, an appeal is all but inevitable — it will be heard by the same justices who affirmed the rights of workers two years ago.

This case is so important because it would put an end to the union stall tactics for good, placing the burden on them to prove that their "members" really want to belong to a union in the first place. As it stands now, most have been coerced into joining in violation of the Constitution, with only a 10-day window each year when the law actually applies.

We are excited about this case and will keep you posted on developments. It has potential to be a true "kill shot" that invalidates decades of union cards signed during the era of compulsory union membership in violation of the Constitution, dating back to a bad Supreme Court ruling in 1977.

The unions have never been challenged like this before. No one has dared to take them on, let alone sue them in federal court on the grounds that their whole enterprise is illegal and unconstitutional.

That's why they see the with hate for the Freedom Foundation.

But you know what? The unions can't stop us.

Despite everything they've thrown at us, the Freedom Foundation cost the government unions a cool \$53 million a year—more than \$1 million per week—in lost dues.

You can be proud of those numbers—they wouldn't have happened without you.

You can be proud of everything else we've accomplished too. To give you a full accounting of that, I have enclosed the **Freedom Foundation's annual report** for your review.



As a fellow American patriot, I can't help but wonder how this crazy Coronavirus pandemic might be affecting you. These are exceptional times, and I pray the best for you.

Five years ago, the Freedom Foundation struck boldly into the heart of darkness. We set up shop in Oregon—a state of magnificent vistas, creative and hardworking people. . . and the looniest left-wing government in America.

Expanding into Oregon was a priority for the Freedom Foundation because big unions and big-government fanatics have called the shots there for years.

In Portland, roving gangs of spoiled "Antifa" thugs beat up conservatives without so much as a slap on the wrist from the authorities. If anything, the mayor probably wants to give them a medal. Meanwhile, down the road in Salem, if the Big Labor bosses want something done in state government, they tell their errand boys in the Legislature to do it—and it gets done. Meanwhile, taxpayers and liberty take it on the chin.

In 2015, the Freedom Foundation marched into this madhouse, because that's what we do best—go right into the belly of the beast and take on the most hardened left-wing thugs we can find. We were determined to reverse the stranglehold government unions had on state and local policymaking because, unless and until we do that, we will not succeed in our mission of advancing individual liberty, free enterprise and limited, accountable government.

We have encountered nasty, ferocious and downright unconstitutional opposition from Oregon's leftist establishment every step of the way--but the most recent news concerning the powerhouse union SEIU 503 provides the most vivid and eye-opening evidence yet that you and I, working through the Freedom Foundation, are turning Oregon leftist government upside down. . . or should I say rightside-up.

Then in 2018, the U.S. Supreme Court handed down its landmark *Janus v. AFSCME* decision, which affirmed the right of public employees to opt out of union dues that had previously been funneled into government union coffers, often over the indignant protests of those employees.

Janus was a tremendous tool--but unless employees were apprised of their new rights, it would be useless.

Oregon's union-controlled government was determined to keep those employees in the dark.

#### The Freedom Foundation was even more determined to enlighten them.

Even before Janus, Oregon Gov. Kate Brown put all public employee records under lock and key in order to prevent the Freedom Foundation from accessing the data and informing union members of their rights under the Supreme Court's previous pro-worker freedom ruling in Harris v. Quinn.

The Oregon State Legislature, at the behest of unions like SEIU 503, actually rewrote the public records laws to keep the Freedom Foundation from contacting union members. They probably figured we'd throw our hands up and call it a day.

They didn't know us very well.

Instead, we redoubled our efforts—in the courts of law, in the court of public opinion and at the grass roots. We sued. We won. We forced the union to surrender its nonprofit corporation status in a desperate bid to avoid our legal attacks.

And we launched an aggressive freedom of information campaign to its members, the likes of which SEII 503 had never seen before.

Our onslaught consisted of personal canvassing, emails, direct mail, phone calls, social media, television, radio, newspapers and more.

Then came the Janus ruling. We were ready for it. And the floodgates opened.

Due largely to the Freedom Foundation's massive campaign of information and enlightenment, a whopping 33 percent of Oregon state employees represented by SEIU 503 and more than 36 percent of school employees represented by OSEA have exercised their constitutional right to opt out of union dues since the *Janus* decision was handed down.

This mass exodus of workers from union bondage has had huge financial repercussions.

Remember that figure of \$4.1 million representing SEIU 503's expenditures on politicking and lobbying in 2017? It plummeted to \$2.2 million in 2018, and we have just learned that it fell by more than another half-million dollars, to \$1.6 million, in 2019.

SEIU 503 is in freefall.

The union's political influence is shrinking dramatically. Its ability to buy politicians who will do its bidding has been sliced by 60 percent in just a few short years. And they're facing

long-overdue accountability for their lawless behavior.

Suddenly, the future of freedom in Oregon has taken on a brighter shade.

#### Your generous support of the Freedom Foundation has made this possible!

We have them on the run-but the unions are not going to give up their ill-gotten gains and unfair political advantages without a fight.

Believe me, they play dirty.

To counter our information campaign, the union-funded Northwest Accountability Project actually put our faces on signboards that they erected along the streets of Portland. They undertook a letter-writing campaign trying to cost our supporters their jobs. This hate campaign failed miserably—as it deserved to—but it revealed just how low the union will go.

SEIU is fading. Its best days are in the past. And we're holding them accountable for a long history of abuse. But its leaders are not going to give up their six-figure salaries without going even lower. Their strategy now consists of such dishonorable and illegal acts as:

--forging workers' signatures on membership cards; and,

--denying members their constitutional right to opt out by holding them hostage to so-called annual "opt-out windows."

With your help, the Freedom Foundation is fighting these and other nefarious practices. No one is above the law--and that's a lesson that SEIU 503 has yet to learn. Our powerful litigation team is now schooling them on that very point, holding unions accountable when they break laws like forging signatures and deterring them from further lawless action in the future. This work is so crucial because union money means those in power tend to look the other way—especially in liberal states—when unions break the rules.

The incredible shrinking union that is SEIU 503 is not only a victory for the Freedom Foundation; it is a victory for all Americans because unions harvest dollars in liberal enclaves and ship them to more competitive states, rigging elections everywhere. And, of course, it is particularly a victory for public employees who are no longer forced against their will to fund political causes to which they object, and finally have a champion to stick up for them when unions trample on their legal rights.

The ramifications go well beyond Oregon, and no one knows it better than the unions themselves. The Freedom Foundation is now active in five states—Washington, Oregon, California, Ohio and Pennsylvania. We are getting stronger while the union is getting weaker.

What we've done in Oregon is exactly what we seek to replicate in every state possible.

The national implications are tremendous. At the federal level, SEIU's spending on political activities and lobbying plunged from \$60 million in 2016 to less than \$45 million in 2018. We intend to drive it even lower in the critical election year of 2020.

As Jason Dudash, the Freedom Foundation's Oregon director, says, "Fewer union members means few dues dollars to spend on buying politicians and influencing public policy."

Let's keep striking while the iron is hot!

#### Tom McCabe (<u>00:00</u>):

... Press Secretary for the first three years of President Trump's first term. Sarah Huckabee Sanders knows that feeling only too well. Sarah's father, former Governor Mike Huckabee, was a smash hit as our guest speaker at the Freedom Foundation's Oregon banquet last year. And we were really looking forward to her filling his shoes this year.

#### Tom McCabe (<u>00:20</u>):

But because of COVID-19 restrictions, Sarah wasn't able to be with us in person, but she's able to join us via computer feed. And we're confident these improvised arrangements will only kindle her memory and her passion to advance the ideal she shares in common with all of you tuning in tonight. It should be quite an evening.

#### Tom McCabe (<u>00:41</u>):

Hey, I'd like to introduce Aaron Withe next. Aaron Withe is the national director of the Freedom Foundation. He's a big man with a big heart, and he's got great conservative values. This guy has done an awesome job, expanding the Freedom Foundation nationally into states like Pennsylvania and Ohio. He's also done an outstanding job this year of getting on TV and getting the message out to people that don't normally hear about the Freedom Foundation. Aaron's been on every single network you can think of Fox news, all the conservative news networks, and even some of the liberal ones. Here's Aaron Withe.

#### Aaron Withe (01:19):

Thank you, Tom, for that kind virtual introduction. Thank you all for watching. It's an honor to be representing the Freedom Foundation at our annual event.

#### Aaron Withe (01:28):

Due to the governor's response to COVID it wasn't possible to do an annual, in-person dinner this year. I'm so excited to be with you virtually. I'm so happy to be able to hear from Sarah Huckabee Sanders a little later on.

#### Aaron Withe (01:41):

I'm Aaron Withe, National Director of the Freedom Foundation. And as you're watching me online, remember the camera adds like 10 pounds. I see at least a couple of them on me right now. So, bear that in mind.

#### Aaron Withe (01:51):

I've been with the Freedom Foundation for five years now have helped us grow from a Washington-based think tank with 20 employees to a national organization of offices in five states, Washington, Oregon, California, Ohio, and Pennsylvania. And as you can tell from my accent, I'm not from around here. I'm from Birmingham, England, which I consider basically to be a socialist country today. When I moved to America eight years ago, I realized fairly quickly that this was the land of opportunity. But in liberal states, we have politicians attacking our freedoms and [trading 00:02:26] policies that reminded me of the socialist country that I had just moved from.

#### Aaron Withe (02:30):

What we do at the Freedom Foundation is simple. We fight for people's freedoms, but more specifically for the past five years, we've been working almost exclusively on freeing public employees from union bondage. That's what our hundreds of staff and volunteers around the country are dedicated to doing every single day.

#### Aaron Withe (02:50):

Government unions, over the course of many years, have figured out what I can only describe to be the biggest scheme in American history. They've actually figured out a way to take taxpayer dollars and funnel that money into their political candidates' campaigns. They do this by skimming union dues from public employees all across the country, and then use those dues to give to liberal political candidates who will agree to go into office and raise taxes on you and the rest of the private sector for the purposes of growing government, and the cycle just repeats. And now, their agenda even includes defunding the police, keeping kids out of schools, and assisting rioters and looters in destroying cities like Portland and Seattle.

#### Aaron Withe (<u>03:35</u>):

Government unions are the largest political machine in this country. And, if left unchecked, I believe that will destroy our states and ultimately this great country. That's why our fight is so critical.

#### Aaron Withe (03:48):

So, how are we doing in this battle? Well, as many of you know, we run a full-scale campaign to educate and assist every public employee with opting out of their union. We have teams of canvases going the doors and offices of public employees to tell them about their rights. On top of that, we send direct mail, emails, text messages, phone calls. We run a digital marketing campaign. Just about any way that you can think of to tell these employees that they can leave, we're doing it. The result? We've helped over 80,000 public employees leave their unions since 2018. That has put \$60 million back in the pockets of workers and out of the unions' radical political agenda.

#### Aaron Withe (04:35):

We have a great staff here at the Freedom Foundation. And I want to share with you a couple of victories that we've been able to achieve this year. There's nowhere near enough time to go through all of them, because it seems we have something new happening literally every day in one of our states.

#### Aaron Withe (04:49):

Here in Washington State, one union that we've targeted is the Teamsters union. They represent corrections employees across Washington, and they're also advocating for defunding the police. Well, you can imagine that doesn't go over too well with corrections employees like prison guards. Matthew Hayward, our Washington outreach coordinator, sent mailers and emails exposing the unions positions to the corrections employees, and we've now helped one in five of those employees to opt out of the Teamsters. One corrections employee wrote to us and said, "Although I support equal justice and respect for all races, I could not support the involvement of the Teamsters in the current violent affairs and civil unrest that is happening here in the United States."

Aaron Withe (05:37):

In California, where we've now been active for a couple of years, Bob Wickers and his team have now been able to help over 30,000 people opt out of their unions. One home care provider, Andrew, he takes care of his disabled wife, he had been trying to opt out of his union, SEIU, for 17 years. It was only until the Freedom Foundation came in and filed a lawsuit that he was actually able to have those dues stop being deducted from his paycheck. We continue to litigate and get back those dues from the past.

#### Aaron Withe (06:11):

In Oregon, we have a really great program led by Jason Dudash. There are two unions in particular that are feeling the wrath of our campaign over there. SEIU503, that's the largest union or the largest political entity in the state of Oregon, and when we expanded there, they were our primary target of outreach. We've now helped over a third of their members leave. They've had to sell their buildings. They've cut their operational budgets, and they're now spending less in Oregon's elections than they ever have. The Oregon School Employees Association, they represent classified school employees, such as bus drivers, janitors, and administrative staff. And, we've helped over 40% of those people opt out of their union. And so far, they haven't spent a single dollar in politics.

#### Aaron Withe (<u>06:58</u>):

On top of that. We've also opened offices in Ohio and Pennsylvania. And despite COVID restrictions, we've made a great start to our programs in both of these states, under the leadership of Lindsey Queen and Hunter Tower.

#### Aaron Withe (07:12):

When the COVID restrictions came down, I was fed up of watching people on TV from their homes. When their signal would drop, you'd be seeing the inside of their bedrooms. The sound would be horrible. And, this doesn't include you or your dad, Sarah, but I figured we could do a way better job than most of these guys. So we set up our own in-house studio, and we started to get our face out there with the TV networks. And I'd like to show you a short video of some of our recent highlights now.

#### Aaron Withe (07:40):

As you mentioned, government unions are the number one contributors to liberal politicians across the country.

#### Max Nelsen (07:46):

The basis for our report was all information that was provided to us by Governor Inslee's own Department of Health.

#### Sheila Sadovnik (07:52):

And, I think this is the kind of conflict and public opprobrium you're going to get from these mask edicts, neighbor turning against neighbor.

#### Aaron Withe (08:02):

One of the things that we advocate for at the Freedom Foundation is open collective bargaining. So, when the union sits across the aisle from government to negotiate contracts of things like police offices, but it also teaches other government employees, those types of negotiations should be open to the public.

Matthew Price (08:17):

If you got one word that sums up?

Sheila Sadovnik (08:20):

I would say, sheep.

Aaron Withe (08:22):

Yeah, the surveillance piece is the most worrying, as you mentioned. It notes that it's limited to federal crimes and riots, but that's really broad. And frankly, it's a slippery slope. There's no accountability.

MIke Huckabee (08:35):

The Freedom Foundation and others have won [his 00:08:38] case that says, if you don't want your personal money that you earned to go to a union, you don't have to pay for it.

#### Aaron Withe (08:45):

We have parents and students alike and even teachers, calling our phones here at the Freedom Foundation, practically daily, asking what can be done about this. My wife is a public school teacher herself. I can tell you this online learning platform does not work.

#### Aaron Withe (09:04):

Up until now, I haven't even mentioned our litigation victories. For those of you that don't know, we have 10 attorneys and 3 paralegals on staff. Believe it or not, I actually feel our legal team is understaffed because we have 65 ongoing cases against government unions. Many of them are on behalf of employees who have tried to opt out their unions, but the unions have denied their right to leave based on short, arbitrary windows that the union deemed they would allow public employees to leave in.

#### Aaron Withe (09:34):

Now, I read the US Supreme Court decision, Janice V AFSCME, from 2018, that granted public employees the right to leave their union. I must have missed the part that said, government employees have the right to opt out their union and stop paying union dues when the union lets them. A constitutional right is a constitutional right 365 days of the year, day and night. And Sarah, thank God for your former boss, President Trump. In my opinion, the best thing he's accomplished in his first term is appointing judges to federal courts, including the US Supreme Court. Let's see what he can do in his second time.

#### Aaron Withe (10:12):

We also have 12 lawsuits where we're representing public employees who have actually had their signatures forged by union employees. How low can these guys get? They're literally forging the signatures to steal a thousand dollars a year from teachers and other public employees. If you or I forged someone's signature on a check, we'd face jail time. These guys use it as their business model. If it weren't for our attorneys representing these employees free of charge, unions would actually get away with these slime-ball tactics.

Aaron Withe (10:45):

Now COVID has affected us all, but in my opinion, the cure has been far worse than the virus. We've witnessed government imposing on our freedoms past the point of imagination in the United States of America. This is the land of the free and the home of the brave. At least, that's how it was pitched to me when I moved here. Today, it seems we're the home of the free, as long as you wear a mask, socially distance, stay home from events, and don't send your kids to school to name just a few of the freedom-imposing laws that governors like Inslee, here in Washington, of forcing upon us. In fact, just this week, Governor Inslee surpassed his 350th edict on the citizens of Washington.

#### Aaron Withe (11:27):

We at the Freedom Foundation, frustrated that no other groups were taking action, decided that we were going to fight back on the overreach of power by Governor Inslee and these other liberal governors. We found four ways that we could make a difference without distracting from our core mission.

#### Aaron Withe (11:43):

First of all, we researched the governor's COVID deaths. No surprise to us, we discovered that both Governor Inslee and Governor Brown of Oregon were inflating their death rates. They were counting anybody that had COVID and subsequently died as a COVID death, regardless of how they actually died. In the most egregious instances, we found multiple people who died of gunshot wounds, being counted as COVID deaths. And, one guy fell off a ladder in Oregon was also counted as a COVID death.

#### Aaron Withe (12:16):

Two, we sued the governors over their face mask mandates. The bottom line on these cases is that governors can not force someone to wear a face mask. It's a violation of their first amendment rights. And furthermore, without legislation, it's not a law. I'd like to show you a short video of Governor Inslee, that our media team created and then promoted on social media.

Governor Inslee (12:39):

And, I'm glad to see you wearing masks today, and I only took mine off because of the First Amendment.

Speaker 8 (12:45):

I am not wearing a mask because it is also my First Amendment right.

Governor Inslee (12:49):

We're all leaders on this, and I'm glad to see you wearing masks today and-

Speaker 8 (12:53):

Governor Inslee, I'm not wearing a mask because that's also my First Amendment, right?

Governor Inslee (12:54):

I only you took mine off because of the First Amendment.

Speaker 9 (12:54):

I am not wearing a mask because it's also my First Amendment right.

Governor Inslee (12:58):

Because of the first amendment...

#### Aaron Withe (13:12):

I love that video. The third thing that we're doing, is we're suing governors on behalf of businesses that have not been allowed to open. One business that we're representing in Washington State is a waterpark called Slidewaters. Governors are picking winners and losers, and they're costing people their livelihoods. Part of our help includes a public education campaign. And here's just another short 30-second ad that our media team created, and we play it on TV stations across Washington.

#### Robert Bordner (13:44):

Governor Inslee's edicts are not saving lives. They're killing businesses. How is it possible that it in nine-acre park, I cannot have anybody here in a safe manner? Our employees are healthy. All our guests have been healthy. And the only thing unhealthy with this situation is Governor Jay Inslee's overreaching arm to shut us down, and that is what we're fighting for, to overrule a government that is trying to take over the lives of American citizens for their own benefit, for their own plans.

#### Aaron Withe (14:17):

Lastly, the fourth thing that we're doing, schools need to reopen. Even in England, they realize that kids need to be in schools. The data just does not support that kids' education should take a back seat for this virus. In fact, more kids died last flu season of the flu than they have a COVID in 2020. You never hear about that. In fact, if you're a school-aged kid in this country, your odds of dying from COVID are literally just under one in a million. But the teachers unions and governors that do their bidding will not consider allowing schools to reopen until they've traded enough havoc going into the November elections. It's a total sham.

#### Aaron Withe (14:59):

This is an unprecedented time for us, but if we don't push back on the overreach of power in order to get back, some of our freedoms, I fear for our future. The precedent we've set by allowing governors to pass "laws" without legislative approval in what they deemed to be a crisis is petrifying. To quote president Ronald Reagan, " Freedom is never more than one generation away from extinction." We didn't pass it on to our children in the bloodstream. It must be fought for, protected, and handed on for them to do the same.

#### Aaron Withe (15:31):

Now, Tom McCabe is our CEO. He worked under President Reagan, and he's teaching all of us every day what it means to fight for freedom. I've spent my whole life thus far fighting, and when it comes to fighting the left, government unions, and anyone else that wants to impose my freedoms, I'm unapologetically here to take you down.

Aaron Withe (<u>15:51</u>):

I want to tell you one more story before we have our keynote speaker, Sarah, come up. Fighting for freedom is a dangerous business in America today. Just look at Portland. Our board members and executive staff receive threats on a regular basis. We've had mailers sent to our neighbors' homes and our pictures, names, and addresses smeared all over the internet. And just a few months ago, we had somebody fire a lone bullet into our office. There are people logged onto this video right now that are taking notes, trying to defame us, and take me out of context. That's okay. We'll take their \$25 entry fee and put it to good use. This is how we measure success in this fight. There were very few groups that get attacked like we do. It's because what we do works.

#### Aaron Withe (<u>16:36</u>):

Thank you all for your support of the Freedom Foundation. I consider all of our donors to be freedom fighters. Because without your generosity, we wouldn't stand a chance in this fight.

#### Aaron Withe (16:46):

Now, I'd like to introduce our keynote speaker of the night. Sarah Huckabee Sanders is by any means, by any definition, a political machine. She's the daughter of former Arkansas Governor Mike Huckabee, the keynote speaker at Freedom Foundation's Oregon banquet just a year ago. And by the age of 10, she was heavily involved in his run for a seat in the US Senate. Mike said, when most kids are seven or eight years old, they're out playing jump rope. She was seen at the kitchen table, listening to political commentators analyze poll results.

#### Aaron Withe (17:18):

Sarah was a field coordinator for her father's 2002 reelection campaign for governor of Arkansas. She was the regional liaison for congressional affairs at the US Department of Education under President George W. Bush. She also worked as a field coordinator for President Bush's reelection campaign in Ohio in 2004. Following that, she worked on several successful campaigns all over the country. And then in 2016, after managing a father's Presidential campaign, she signed on as senior advisor to Donald Trump's 2016 Presidential campaign, handling the Trump campaign's communications for coalitions.

#### Aaron Withe (17:56):

With Trump's election, Sarah was named Deputy Press Secretary, and a year later, she replaced Sean Spicer as the White House Press Secretary, and quickly earned the respect of conservatives everywhere, with her combativeness and fierce defense of the President. After spending two years refusing to back down from the liberal mainstream media, she stepped down in 2019.

#### Aaron Withe (18:18):

Sarah followed in her father's footsteps to become a Fox News contributor. And there are those who hope her next move will be to follow in his footsteps again to the Governor's Mansion of Little Rock.

#### Aaron Withe (18:27):

We're so blessed to have you here tonight. Please welcome Sarah Huckabee Sanders.

#### Sarah Huckabee Sanders (18:31):

Aaron's a little taller than me. We'll give them a minute to get set up. All right. Thank you so much. It's such an honor to be here tonight. I wish that I was with everyone in a bigger banquet hall, but

unfortunately, we are not able to do that. But, it's so important that we continue to get our message out and continue to gather in whatever way possible, because this election and what's in front of us could not be more important.

#### Sarah Huckabee Sanders (19:14):

I'm so grateful for the work that the Freedom Foundation does. Aaron, thank you so much for a wonderful introduction and also a great speech, laying out the importance of the work that the Freedom Foundation does. A lot of people may not know, but I have pretty deep and long ties to some of the people at the Freedom Foundation. Bob Wickers actually gave me one of my very first jobs. While in college, I interned for him in his San Francisco office. I think we were two of the only Republicans in that area, but I was honored to learn from him and certainly picked up a lot of my skillset that I took to the White House from working from Bob, even back in college.

#### Sarah Huckabee Sanders (19:57):

Most people know me as the former White House Press Secretary for Donald Trump. And that's a job that I absolutely love. It's one I was honored to have. I worked for the President for three and a half years. And, even on the most difficult days, I loved that job. It's probably one of the best roles I'll ever have.

#### Sarah Huckabee Sanders (20:15):

But the best job that I will ever have, and best thing that I get to say as part of my title is that of a mom. I have three incredible kids, Scarlet, who is eight, Huck, who is seven George, who is five. I don't know if you caught those ages, but I'm going to run through those one more time. They're eight, seven, and five. So, my house is pretty chaotic at all times. But we loved it. And it's what keeps us going. It's what reminds me of what is so important about the work that the Freedom Foundation does, and also what gave me the strength and the confidence and the resilience to step up to the podium every single day.

#### Sarah Huckabee Sanders (20:55):

People would always ask me, Sarah, how do you find that balance of being a mom and working in the White House, a 24/7, all-consuming job? Some days it was harder than others. One of the things I learned very quickly is that it was important for us to take our kids with us. I wanted my kids to understand why we were serving, why we were making that sacrifice as a family to be in that role and for me to have that position.

#### Sarah Huckabee Sanders (21:20):

I learned very fast that taking all three kids to an event at the White House was not a very good idea. It was going to be really hard to manage my three kids, and actually get some work done, and not lose my job. So, I put my kids on a rotation system and I would take them one at a time. One particular event, and I was very excited about, was Bring Your Kid to Work Day at the White House. It was my son Huck's turn to go with me. And at the time, Huck was about four years old. Most of the kids that were coming were going to be 8, 9, 10, 11. And I debated whether or not Huck was going to be able to manage the day and last without getting my job taken away by the end. You name a kid Huck, you sort of set a certain expectation for him in life. And, Huck has lived up to that every single minute of every single day.

Sarah Huckabee Sanders (22:11):

But I decided at the end of the day, how many chances would I have to take Huck with me for Bring Your Kid to Work Day at the White House? So, I took Huck with me, and I had my husband Brian on standby. And if things at any point got out of control, I would call him, and he would come and save the day and take Huck home.

#### Sarah Huckabee Sanders (22:29):

We had actually had a perfect day. He had been on excellent behavior. He had his little sports coat and his bow tie. I took about 10 million pictures. I couldn't have been more proud of him. And the big moment of the day, is when all of the kids gather in the Rose Garden and the President comes out and takes pictures with the kids.

#### Sarah Huckabee Sanders (22:49):

We had done something slightly different this year with the President, and we had invited all of the press to bring their kids to participate in the Rose Garden picture ceremony as well. When that happened, I went into the Oval Office, and I was briefing the President, reminding him that half of the children were actually, their parents were members of the press. And he might want to watch what he says. He naturally completely ignored my advice, but as I was talking to the President and walking him through this, we noticed that the bushes in the Rose Garden started to violently shake. Thought, well, now that's strange. I haven't seen that before. And about the time I realized what's happening, this little blonde head pops up out of the bushes and runs full steam ahead directly to the glass of the Oval Office and presses his face completely up against it.

#### Sarah Huckabee Sanders (23:38):

The president also had never seen anything quite like that and jumped back and goes, "Oh my gosh, there's a little boy looking into the Oval Office." I said, "Yes, sir. That's my son Huck." He said, "Well, Sarah, at least he's handsome." Not to let that be Huck's only mark on the day, just as we finished that briefing and the president walked out onto that famous Colonnade there in the Rose Garden that you've seen hundreds of pictures of Presidents as they walk down, I followed the President about 20 feet behind him. That same little blonde-headed boys starts this time instead of running towards the window, running directly at the President of the United States. The president kind of crouched down, ready to receive Huck. And just before he got there and before Secret Service tackled him, he sidestepped went around the President and runs and jumps into my arms.

#### Sarah Huckabee Sanders (24:29):

The president kind of turns around and looks at me like, "This kid, again?" I just kind of nodded and smiled. Secondly, I reluctantly concluded the only hope of restraining their unprecedented, unconstitutional power grab was the judicial branch of government — which isn't supposed to be guided by politics but, in these three overwhelmingly liberal states, too often is.

With October already here, schools in Washington, Oregon and California still remain closed for one reason — because the unions representing teachers want it that way.

Using the same logic, the Three Union Stooges shut down dozens of private business and residential construction projects — the sort that would help the economy while allowing ongoing government and public works projects, which represent a net liability to the taxpayers, to continue.

His eloquent summation continued, "(T)he solution to a national crisis can never be permitted to supersede the commitment to individual liberty that stands as the foundation of the American experiment. The Constitu-tion cannot accept the concept of a 'new normal' where the basic liberties of the people can be subordinated to open-ended mitigation

measures.
"Rather," Stickman wrote, "the Constitution sets cer-tain lines that cannot be
