11. Item 9 (Other Events)

We disclose that at the meeting of the Board of Directors of PLDT Inc. (respectively, the "Board" and the "Company") held on September 26, 2017, the Board approved the Transformation Incentive Plan (the "Plan"), which is intended to provide incentive compensation to key officers, executives and other eligible participants who are consistent performers and contributors to the achievement of the long-term transformation strategy and financial goals of the Company. The incentive compensation will be given in the form of PLDT common shares of stock (the "Performance Shares"). The salient features of the Plan are as follows:

- 1. The Performance Shares will be released in three (3) grants on the condition that predetermined Consolidated Core Net Income targets are successfully achieved over three (3) annual vesting periods from January 1, 2017 to December 31, 2019.
- 2. A total of up to 860,000 Performance Shares will be awarded under the Plan.
- A trustee will be appointed to acquire PLDT shares in the open market through the facilities
 of the Philippine Stock Exchange, which will comprise the Performance Shares, and to
 administer their distribution to the eligible participants subject to the terms and conditions of
 the Plan.
- 4. The Plan will be administered by the Executive Compensation Committee of the Board.

Pursuant to the requirements of the Securities Regulation Code, the Company has duly caused this Report to be signed on its behalf by the undersigned hereunto duly authorized.
