
Available Area for Development


- The Seed Production Area (SPA) in the province of Camiguin was re-established in the year 2020 since the previous SPA was established within Mts. Timpoong Hibok Hibok Natural Monument Protected Area at sitio Danao, Baylao, Mamabajao, Camiguin.
- The new established SPA is now located at sitio Binabag, Pandan, Mambajao, Camiguin which is outside the Protected Area (PA), allowing the ENGP and SPA personnel to conduct removal of climbing non-woody vines and brushing.
- The Seed Production Area (SPA) in the province of Camiguin has been re-established with a total area of 11.67 hectares. A total of 815 indigenous trees species were classified as Individual Plus Trees (IPTs).


- Mts. Timpoong-Hibokhibok Natural Monument,
 MTHNM the pride of Camiguin Island is a declared
 PROTECTED AREA by virtue of Presidential
 Proclamation No. 570 signed last March 9, 2004 by
 Her Excellency, then President Gloria Macapagal
 Arroyo, pursuant to R.A 7586 known as the
 Integrated Protected Area System (NIPAS) Act, as
 amended by RA 11038 (ENIPAS Act of 2018).
- It became the 8th ASEAN Heritage Park in the Philippines last October 28, 2015 during the 13th ASEAN ministerial meeting on the environment, which was attended by environment ministers, in Hanoi, Vietnam.



ENHANCED BIODIVERSITY CONSERVATION

• It has a total proclaimed area of 2,203.39 hectares and is located in the municipalities of Mambajas Maniato, Sagay and Catanaa. It covers 25 barangays out of the 54 barangays of the Province and managed by its active Protected Area Management Board (PAMB). The area covers the mountain ranges of Timpoong and Hibokhibok.

Capacity-building/skills enhancement workshop re: Strengthening the knowledge and planning skills of Camiguin-Wide MPAN members based on the result of the performance assessment conducted using the CAT. Conducted several joint activities, such as;

- a). Deployment of Artificial Coral Reefs (ACR) and Mouring Buoy Sinkers at the Northern Part of Magsaysay (Mantigue) Island last September 18, 2021 and October 23, 2021;
- b). Inspection/Verification Re: Accidental Docking of M/V CELSA 3 Ship-Agrounding within the shallow waters of Mantigue Island last November 10, 2021;
- c). Initial assessment of the M/V CELSA 3 agrounding on the seagrass beds in the vicinity waters of Mantigue Island last November 15, 2021.

Endorsed the Memorandum of Agreement of the Camiguin-Wide MPAN to the Provincial/Municipal Local Government Units. Thus, there is an on-going signing of the said MOA.

These fecal coliform results are higher than the Class 'SA' Waters guideline of <1.1 MPN/100 mL (DAO 2016-08) but are still relatively low compared to other monitored water bodies like river.
