- Zebra's Z-Band wristbands are made of polypropylene. The direct thermal imaging chemistry is composed primarily of leuco dyes and developers. The inks/ varnishes used are UV varnishes and water based inks.  
**There is no metal content in or on these particular patient identification bands.** Therefore, Z-Band wristbands are considered to be MR-Safe.






