Susan Espenshade—St. Andrew's Church, Mount Holly



Karen G. Bemis—Christ Church, New Brunswick



*Canon Annette L. Buchanan—St. Augustine's Church, Asbury Park







*Karen G. Bemis—Christ Church, New Brunswick






Talbot B. Kramer, Jr., Esq. — St. Thomas' Church, Glassboro
