Outdoor Leadership Receives Gift of New Canoes

In May, Outdoor Leadership (OL) launched a fleet of 11 new canoes during the program's spring trip. Generous contributions from the community facilitated Hawken's purchase of the boats, trailer, paddles and personal flotation devices.

Since 2003, OL has taken students on at least one canoe or kayak trip annually. Students have paddled in the Georgian Bay, Assateague Island National Seashore, Laurel River Lake and the Allegheny River. The spring season draws the largest number of new participants to OL and the new canoes will provide the School with more capacity to take students out on rivers and lakes. Beyond supporting OL's spring trip, the Hawken-owned fleet will give the School the capacity to take 22 students and two teachers out to study field biology, river health or the history of the region from on the water. Additionally, the School can now support aquatic opportunities for Middle and Lower School students as well as summer camp.

Community Embraces New Challenge Course

In November, the Schneider Family Challenge Course, the largest of its kind among Northeast Ohio high schools, opened on the Gates Mills campus. **Mitchell and Kyla Schneider's** sons, **Sam '15** and **Keeva '16**, have been involved in Outdoor Leadership and cite their intellectual, emotional and experiential growth as a motivator in helping other Hawken students engage in the program. Kyla and Mitchell said, "We hope that this challenge course and the OL program continues to motivate and inspire students who would never think of themselves as OL potentials, to take the leap into self-challenge, self-development, and leadership that provides creative and positive engagement in the world." Constructed by Redpoint Adventures, the Goliath Series High Challenge Course uses 22 Class II 45' and 55' CCA treated utility poles. The structure features a climbing tower entrance with three climbing walls. Also outfitted with a zip line and an oversized platform, the zip measures 370'. Other features include a large group platform measuring 20' wide by 24' long, vertical playpen, catwalk dual belay, multi-vine dual belays, islands in the sky dual belay, silva swings dual belays, dangle duo, pamper pole, UFO trolley, cargo net, and four oversized platforms/transfer stations.





Sherwick Fund Supports Stirn Hall

As part of its last actions before dissolution, The Sherwick Fund Board of Directors made several impactful grants to organizations historically supported by the Fund. The Board awarded Hawken School a significant legacy grant in the amount of \$1 million for the construction of Stirn Hall. The philanthropic support of Stirn Hall underscores the passion and commitment of The Sherwick Fund and the Sherwin family to inspire in future generations of students “a higher plane of life.” Hawken School is proud to count The Sherwick Fund and the **Jack '53 and Clara Sherwin** family among its leadership benefactors to Stirn Hall. In acknowledgment of this legacy grant, the School named the second and third grade Commons in Hurwitz Hall on the Lyndhurst campus for Jack '53 and Clara Sherwin.

Capital & Endowment Gifts

The endowment helps fortify Hawken School's financial strength in preparation for the next 100 years, keeping tuition increases moderate, providing adequate student financial aid and scholarships, and helping to fund new programs and guard against unforeseen challenges. Income generated by the School's endowment is allocated according to specific guidelines. Some of the endowment's assets are unrestricted, while others are designated to particular funds, restricting the income for a specific use. For the past few years, a conservative 4% of the endowment's value has annually been used to support financial operations; the rest is reinvested to ensure growth of principal and increased earnings for future years.

Planned Giving

For many decades, planned giving has been a significant source of philanthropy for Hawken School. In the 1980s, the School formally recognized all those who had made planned gifts by establishing what was then known as the Hawken Heritage Society. As the School celebrated its Centennial in May 2015 and honored its past while looking forward to its second century, we rebranded this special group as the Hawken Sheffield Society in honor of Henry Sheffield, one of the School's first and most generous philanthropists. Since its inception, more than 160 members have joined the Sheffield Society and the School has realized almost \$9 million in estate gifts with another \$9 million having been made known as future legacy gifts.



Having secured the funding for our major building projects, we enter our second century ready to pivot to areas of focus which represent the heart and soul of Hawken School: people and programs. We will do this by building our endowment in the coming years. Hawken alumnus Russ Lincoln '64 and his wife Connie stepped forward with an extraordinary challenge to the Hawken community that can help accomplish this goal. They generously offered a \$1 million challenge with which they will match 10% of any new or increased planned gift made known to the School...and their match will go into Hawken's unrestricted endowment today.

The following members of the Sheffield Society have made a legacy gift to the School in the form of a bequest under a Will or trust agreement, assignment of an insurance policy, gifting of real estate or other planned giving vehicle. Giving Tuesday Momentum Continues

The Challenge set the foundation for a month of strong Annual Fund momentum yielding over \$425,000 in support of faculty, students and programs in one month.

Parent Participation boosted by New Parent Challenge

Inspired by the importance of parent participation in the Annual Fund, an anonymous new family to Hawken challenged other new families to 100% participation. At the close of the Fund on June 30, new parent participation exceeded that of the average participation rate of 65% by over 20 points! The challengee donated \$12,000 to the Annual Fund in celebration of participation momentum achievement.
