Retirement News January 2023

Greetings, fellow retirees. Hope you are all doing well and savoring the good life. Here we are in the middle of summer 2023, with the planet reportedly experiencing some of the warmest days on record, and with promises of more to come. Yet, setting aside climate change for a moment, what a pleasure to have sunshine and warmth, following a colder than usual winter and spring. Here is an update and a few items of interest from recent Board meetings.

Status of the Fund

At June 30, 2023, in a preliminary valuation, with private equity and real estate valuations lagging a quarter, the Fund closed at \$4.069 billion. It seems that we hit the bull's eye this year, with the preliminary return for the fiscal year ending June 30 coming in at 7%, meeting the 7% assumed rate of return. This return compares favorably with other public fund returns, such as CALPERS, which reported a 5.6% return for the same period.

Records Retention Policy

SBCERS sets a time frame for staggered review of all key policies. In this year's review, the Records Retention Policy, usually a routine item, generated some discussion at the June 28, 2023 Board meeting. There were two proposed amendments to the policy, the first regarding video recordings, with no audio, of persons entering the foyer and the office reception area in the new SBCERS offices at Robin Hill Road. The second was the addition of audio and video recordings for member counseling in the counseling room, to be retained or 24 hours, and longer if requested for security reasons, with recordings to be available to staff only. The policy allows for members to request not to be recorded, in which case they will be counseled in a different conference room. Both amendments were approved by the Board.

IT Cyber Security Presentation

At the June 28, 2023 Board meeting, the Board received a presentation on IT security from the firm of Miller Kaplan. Cybercrime is a big business and accounts for \$10

billion in losses nationally with pension plans and retirement systems targeted for the wealth of financial and personal data



in such systems. Recent security breaches occurred at San Francisco Employees' Retirement System and at CALPERS, both through third party vendors. The best defense: an Information Security Management Program to assess management and technical controls and current vulnerabilities. SBCERS currently has such a program and security protocols in place and is working with Miller Kaplan to strengthen these protocols.

ESG Presentation

Over the past few years, Environmental, Social and Governance (ESG) factors have increasingly been incorporated in the decision making process by many fund managers looking to mitigate risk in investment portfolios. More recently, the inclusion of ESG considerations in portfolio construction has become somewhat controversial. At the Board meeting held on July 26, 2023, SBCER's staff and general investment consultant presented a review of SBCERS' Fund managers' level of incorporation of ESG factors in their investment selection process. The presentation also included an update on laws governing fiduciary responsibility regarding the incorporation of ESG in public pension plan investments; legislative initiatives in some states to exclude ESG factors from consideration; and legislative initiatives in other states to divest fossil fuel investments in public funds. As for SBCERS' portfolio, in summary, 50.7% is managed by firms who have incorporated ESG factors in their selection process, 23.5% of the portfolio is managed by firms who might consider ESG factors and 25.8% by firms not using ESG data in their portfolio selection.

Health Insurance Renewal 2024

County Human Resources personnel and insurance consultant Alliant, recently met with the Health Advisory Committee comprised of representatives of labor unions and the RESBC and presented preliminary insurance rates for 2024. At the next open enrollment scheduled to begin in September 2023, County offered medical insurance administered by Blue Shield will increase by 12.2 % in 2024. United Health Care's rates will increase by 4%. Kaiser's rates will be available in early August. Dental Plan rates for the DHMO Plan will remain unchanged, while the DPPO plan will increase by 9.8%. Vision rates will remain unchanged. Keep an eye out for final rates in open enrollment materials to be sent by SBCERS in August.
















RESBC COLLEGE SCHOLARSHIP PROGRAM

In 2024, RESBC will again partner with Scholarship Foundation of Santa Barbara (SFSB) to sponsor two \$3,000 undergraduate college and vocational school scholarships. The children and grandchildren of RESBC members, including those living outside California, may apply.

The application period begins on October 15, 2023 and ends on January 15, 2024. New or continuing college students should apply directly through the SFSB website at www.sbscholarship.org. Next year's scholarships will be awarded on May 15, 2024.

SFSB will administer the application process and select the recipients. Applicants must have a 2.0 high school or college GPA to qualify. Applicants must be enrolled full-time at a college or university that is Title IV eligible for Federal financial aid. Students attending vocational education programs are also eligible to apply within these guidelines.

LIFE ON THE ROAD by Larry Appel



Camping has been a part of our life together from the beginning. Philis and I were married in 1977 and have been camping from those early years when sleeping on the ground with a thin mattress was tolerable. Over the years as we started a family and it grew, so did the size of our tents and amount of camping gear. Finally, after many campfire discussions and research, in late 1991, we purchased our first trailer, a 24-foot Terry (by Fleetwood). During the working years, trailer camping was somewhat limited to weekends plus a couple weeks in the summer when the kids were out of school. When the kids were still in grade school, we took "The Mother of All Vacations," a six-week trip around the country that included stops at Disney World, Cape Kennedy, a

family reunion in Kentucky, Washington D.C., Mt. Rushmore, etc. We used that trailer for almost 30 years and then retired it to a friend of our daughter.

Fast forward to 2020. I had been retired from the City of Santa Maria since December 2016 when Philis and I decided it was time to re-enter the trailer life. We began with research which was much easier this time with the use of the Web. After reviewing five serious contenders, we settled on a 2021 Montana High Country 330 RL (fifth wheel). Our best price by far came from a dealer in Muskegon, MI, so we loaded up the new truck and headed to Michigan the last week of December 2020. Our friends in Santa Maria told us we were crazy to be



going back in the middle of winter to pick up the trailer. Not only did we pick it up, but we stayed back east for a month before turning west. Our first campground had nine inches of snow and the temperature dropped to minus 12°. We stayed toasty with all the conveniences that were built into the trailer. It was quite a step up from our family tents and even our old travel trailer.

Since that inaugural trip, we have taken two other cross-country trips (up to 10 weeks each) and as this article is being written, we're on a 7+ week Pacific Northwest trip. Life on the road is wonderful. The fifth wheel has all the modern conveniences of home, even a double sink in the bathroom. My brother, Jim, calls our fifth wheel a C.O.W. (condo on wheels). Traveling with the trailer has given us a chance to visit family and friends all over the country. We've visited them in TX, OK, KY, OH, MI, PA, VA, DE, OR, and ID.



After three cross-country trips, we've learned a few things that make our life on the road more enjoyable. First thing is that back-to-back-to-back travel days were not very enjoyable, so over the past couple trips, we now stay at least two nights when we get to a campground and we have shortened our driving days to less than 300 miles. The third major thing we learned is that reservations are a must. As a



professional planner, I made sure that all our trips were routed and campgrounds reserved. With all the RVs sold during Covid, finding a campsite became difficult, especially during the summer months.


For now, since our long trips have to be planned during the summer, Philis and I talk about a general region to visit, or route, and then I begin mapping the route in January and usually have campground reservations secured by the end of February.



Our most unique camping trip was in November 2021 when we spent five days in the Mojave Desert for Thanksgiving with our daughter's family. We obviously had no utilities, but we took advantage of the built-in generator to refresh the batteries and have microwave popcorn occasionally. The twilight trailer picture shows our remote camping spot.

On travel days, Philis usually reads a book out loud that is of interest to where we are going to be visiting. We both are interested in the Civil and Revolutionary Wars, so that has been a focus so far.

We've had the opportunity to see many historically significant and beautiful places. These have included: Gettysburg and other battlefield sites, Mt. Rushmore, Atlantic Ocean, Upper Peninsula, Michigan, St. Louis Arch, Abe Lincoln's home and museum, Arches N.P., Amish and Mennonite communities, and the ARK (full size replica).









We're sure there will be more places to see as we explore new regions of the country. We are thankful to have opportunities to travel this great country.

Can you spot a scam? Five red flags! By Tony Manual

Hey, Retirees: Scams are constantly evolving. We need to be on our toes at all times. Here are a few red flags to help you remain alert and stop scammers in their tracks.





1. UNEXPECTED CONTACT

Scammers contact you about a charge, order, delivery, etc that you have not made or ordered



2. URGENCY

Scammers create a false, but very intense sense of urgency and pressure you to act immediately.



3. UNUSUAL WAY TO PAY

Scammers ask you to send money, or gift cards; use cryptocurrency, a payment app, or online wire; to pay for something, resolve an "issue," get "winnings," or get you a high return on your "investment."



4. THREATS

Scammers say you owe money and threaten to call the police if you don't pay immediately; or pressure you to quickly withdraw or transfer money.



5. A NEW ONLINE LOVE INTEREST

The scammer sweet talks you, but doesn't seem to want to meet in person; contacts you with a sudden hardship or emergency; asks you to send money.


