Designation: Peon, Pay Scale (S1 (15,000-47,600)

Place of Appointment / Office: General Administration Department, BIM, Headquarters, Mumbai.

Terms and Conditions regarding Appointment of Probationer (Peon) in the service of the Corporation:

1) Selection of the said candidate is being made in the supernumerary post of Government of Maharashtra, Urban Development Department Government Decision No. Thampa 2117/P.No.63/Navi-23, dt. as per the decision dated 18/09/2017.

2) Retirement after the said appointment or in case of incapacity to serve for any reason (death) Dismissal, leaving service c) The said post shall automatically lapse.

3) Travel and other incidental expenses incurred for joining the service are not allowable. The service of the candidate will be considered from the date of joining the service of the Corporation.
