ABSTRACT: The aim of this study was to synthesize silver nanoparticles (AgNPs) using Anthemis atropatana extract and evaluate their chemical characteristics, antimicrobial and cytotoxic effects. Results of UV-Vis, TEM, SEM, FTIR and XRD confirmed the synthesis of AgNPs. The MTT results indicated that the dose dependence of cytotoxic effects of AgNPs on cell lines. Moreover, Real Time PCR and flow cytometry results confirmed the apoptotic effects of AgNPs. According to the results, it seems that the green synthesis of AgNPs is an eco-friendly and cost effective approach and AgNPs had excellent biological activities.
