

Rules of participation in the prize game "I feel Slovenia L'Etape Slovenia ride with Matej Mohorič"

1. Introductory provisions

The rules of participation in the prize game determine the method and conditions of participation and the implementation of the prize game "I feel Slovenia L'Etape Slovenia ride with Matej Mohorič" (hereinafter "the prize game").

The organizer of the prize game is Sport Media Focus d.o.o. Fajfarjeva ulica 33 1000 Ljubljana (hereinafter Sport Media Focus d.o.o.).

Only a person who meets all the conditions for participation in the prize game and agrees to these rules can be a participant in the prize game.

Winner is a participant in the prize draw who has been drawn to receive a prize in accordance with these rules.

The winner is the raffle winner who actually receives or accepts the prize.

2. Conditions for participation in the prize game

All physical adults who have registered and paid the registration fee for the I feel Slovenia L'Etape Slovenia by Tour de France event by April 30 can participate in the prize game.

Employees of the organizer cannot participate in the prize game.

By participating in the prize draw, the participant accepts these prize draw rules.

The condition for participation in the prize game is the consent that Sport Media Focus d.o.o. can inform the participant about the offer, novelties and benefits, news, prize games and events.

3. How to participate in the prize game

To participate in the prize draw, participants must register and pay the registration fee for I feel Slovenia L'Etape Slovenia by Tour de France on the website

<u>https://slovenia.letapebytourdefrance.com/registration</u> and accept the rules of participation in the prize draw and give their consent Sport Media Focus d.o.o. for notifications about offers, news and benefits, news, prize games and events. One entry is valid for the entire duration of the prize draw.

4. Prize pool and draw

Prize fund: 10x training ride with Matej Mohorič

Cash payment of the prize is not possible. The prize cannot be exchanged for another prize, other goods, or other service. If the prize winner is drawn from abroad and cannot participate in the ride, the organizer will give him the opportunity to take a picture with Matej Mohorič and a L'Etape Slovenia by Tour de France T-shirt at the main event.

#letapeslovenia slovenia.letapebytourdefrance.com The prize draw is not public and takes place at the organizer's business premises at Fajfarjeva ulica 33, 1000 Ljubljana. The outcome of the draw is random. By fulfilling the conditions for participating in the prize draw, all participants have the same chance of winning a prize. The organizer reserves the right to exclude a participant who does not act in accordance with the rules and conditions of participation from participation in the prize game.

The draw will take place on May 3 at the company's headquarters in Ljubljana.

The result of the prize draw is final, appeals are not possible. The prize cannot be exchanged or paid out in cash, nor can the prize be transferred to another person. By fulfilling the conditions for participating in the prize draw, participants have the same chance of winning a prize.

5. Announcement and notification of prize winners and use of prizes

The prize winner will be informed about the prize, the method and deadline for accepting the prize, including the necessary information that he will have to provide to the organizer via the e-mail address that he enters in the online application form when registering for the event. The winner must send the necessary information to the organizer by the date specified in the e-mail at the latest for awarding the prize. If the entrants do not provide their information by the date specified in the especified in the email, they will forfeit their right to the prize.

The organizer is not obliged to award this prize to another participant. Each winner can receive the prize only once.

For prizes that exceed the total value of EUR 42, the winners are obliged to provide the organizer of the prize draw with information about their tax number and tax identification number. If the raffle winner does not provide the required information within the specified period, he/she loses the right to the prize.

The organizer reserves the right not to award a prize if there is doubt about the identity of the winner or if it is determined that participation in the prize game was in violation of the terms of this prize game.

6. Prize Taxes

For prize winners, the value of the prize above EUR 42 is included in the annual tax base for the assessment of income tax. In accordance with the Income Tax Act (ZDoh-2), winnings in the prize game that exceed the value of EUR 42 are taxed at the rate of 25% of the value of the winnings, increased by the withholding tax coefficient. Income tax is calculated and paid in advance by the organizer. If the amount of the calculated advance is lower than EUR 20, the income tax advance is not withheld and not paid. Withholding tax is deducted simultaneously with the calculation of other income in accordance with the applicable regulations. Any other tax obligations are borne by the prize winners. If the prize winner does not provide the information by the deadline specified in the organizer's invitation, it is considered that he does not want to accept the prize and it will not be awarded to him.

7. Notice on the protection of personal data

Fajfarjeva 33, 1000 Ljubljana, email: info@letape.si If you want to participate in the prize game, providing your personal data is mandatory; in on in the current case, you will not be able to participate in the prize draw or collect your prize. Participation in the prize game is voluntary.

The purposes for which we process your personal data, the legal basis for their processing, the retention period and your rights are listed in the table below:

Purpose

Legal basis for processing personal data

How long do we process personal data?

Rights of participants in the prize game (participants in the prize game can):

Implementation of the prize game, which includes:

- collection of applications,

- holding a prize draw,

- public announcement of winners

- notification of received prizes and the method of accepting prizes by e-mail and

- award ceremony.

Agreement (acceptance of the Rules of Participation in the Prize Game)

Until the withdrawal of consent or until the completion of the activities of the prize draw.

- revoke consent*,

- requires access to personal data,

- requests correction of personal data,

- requests restriction of processing of personal data (e.g. in case of disputing the accuracy of the data),

- requests deletion of personal data (only if legal reasons are given for deletion) and

- requests the receipt of the data provided to the controller in a structured, commonly used machine-readable format and the right to transfer data in such a format to another controller (the so-called right to portability).

* The revocation of consent does not affect the legality of personal data processing that was carried out on the basis of consent before its revocation.

Direct marketing, which includes:

- information about the offer, novelties and benefits, news, prize games and events Consent

Until consent is revoked.

Demonstrating compliance with legislation:

- the administrator keeps personal data after the cancellation of consent in order to be able to demonstrate a valid legal basis for the processing of personal data during the period of validity of the consent.

Legitimate interest of the controller

Four years after withdrawal of consent.

- requires access to personal data,

- requests correction of personal data,

- requests restriction of processing of personal data (e.g., in case of disputing the accuracy of the data),

- request deletion of personal data (if legal reasons are given for deletion, e.g., personal data are no longer needed for the purposes for which they were collected) and

- objects to the processing of personal data.

Asserting, Exercising or Opposing Legal Claims

Legitimate interest of the controller

Six years after withdrawal of consent.

- requires access to personal data,
- requests correction of personal data,

- requests restriction of processing of personal data (e.g., in case of disputing the accuracy of the data) and

- objects to the processing of personal data.

Assessment and payment of advance income tax (for this purpose, the controller only processes the personal data of the winners)

Compliance with legal obligations

Until the expiration of the statute of limitations in accordance with applicable tax regulations.

- requires access to personal data,
- requests correction of personal data,

- requests restriction of processing of personal data (e.g., in case of disputing the accuracy of the data).

Sport Media Focus d.o.o. will also forward the personal data of the winners who will receive prizes worth more than EUR 42 to the competent tax authorities for the purpose of assessment and payment of advance income tax.

8. Final Provisions

The rules of the prize game are published on the website

It is considered that the participants are familiar with the rules of the prize game, that they agree with them and undertake to follow the rules of the prize game and guarantee that the personal data provided in the context of the prize game are accurate and correct. In the event of any dispute or ambiguity, these rules shall prevail over all other postings, whether in print, electronic or any other form. The organizer can change the rules if this is required for reasons of a technical or commercial nature or for reasons on the part of the public. Participants will be notified of any changes to the rules on the same website. The organizer can suspend or end the prize draw at any time and without prior notice.
