573.6 (c) (3) Number of Vehicles Potentially Containing the Defect

920 R8 Spyder vehicles are affected by this recall in the United States.

573.6 (c) (4) Percentage of Vehicles Actually Containing the Defect

VWGoA is unable to estimate the percentage of vehicles in the United

States that are subject to the defect.

573.6 (c) (5) Description of Defect

Due to production tolerances, it is possible that the fuel supply line may contact and rub against the heat shield in the engine compartment. In rare cases, this could lead to a small fuel leak. Leaking fuel, in the presence of an ignition source, could lead to a vehicle fire.

Volkswagen has not identified any reports or allegations of fires resulting from this condition.

573.6 (c) (6) Basis for Determination

June 6, 2011: VWGoA received customer complaint about fuel smell after refilling the vehicle. Began analysis of the vehicle and communication to Audi AG

June - July 2011: Clarification of the technical situation and analysis of other vehicles by Audi AG

July 22, 2011: The product safety committee at Audi AG determined that a safety defect existed and decided to conduct a voluntary safety recall.

573.6 (c) (7) Noncompliance Test Result

Not applicable

573.6 (c) (8) Proposed Remedial Program

Volkswagen plans to notify all owners of affected vehicles and will instruct them to arrange for an appointment with an authorized dealer.

Dealers will inspect the fuel line for damage and replace it if necessary. Dealers will also inspect and, as needed, adjust the position of the fuel line and heat shield in order to ensure correct clearance between the two. This work will be performed free of charge.

Pending parts availability, mailing dates are anticipated as follows:

Dealers: on or about August 15, 2011 Owners: on or about August 22, 2011

A representative copy of all bulletins and other communications sent to dealers and owners will be submitted within five (5) days of dealer/owner notification.
