STUDENT VISA AND PROOF OF FINANCIAL SUPPORT

U.S. Immigration and Naturalization Services requires the College to obtain verification from the applicant that he has adequate financial resources to provide for his expenses without resorting to unauthorized employment. This is necessary in order for colleges to issue a Certificate of Eligibility Form (120) that will be needed for a student visa.

ALL DOCUMENTS VERIFYING FINANCIAL SUPPORT MUST BE ORIGINAL, SIGNED COPIES, WRITTEN IN ENGLISH WITH AMOUNTS SHOWN IN U.S. DOLLARS, AND MUST BE NO OLDER THAN SIX MONTHS.

1. If you will be funded by your parents, you must submit the following document in addition to completing the Declaration and Certification of Finances (DCF) Form:

An official document verifying the availability of funds. This must be either a bank statement or a credit reference from a bank indicating a specific dollar amount in the account <u>or</u> a statement verifying a minimum of the college costs, which is available for educational purposes.

- 2. If you will be funded by a family salary, you must submit an official letter from the employer validating the amount and duration of support.
- 3. If you will be funded by a government agency, a company, or an organization, you must submit an official letter from your sponsor stating exactly what your scholarship or loan will cover. For example: academic fees, living expenses (dollar amount), health insurance, travel, etc. The letter must also state for what length of time this support is guaranteed.

Copies of such documents will also be required when you apply for your student visa, and again when you enter the U.S. for the first time as a student.

Please return all required documents of financial support and the complete Declaration and Certification of Finances (DCF) with your formal application of Admission.
