

**Troy Township, Wood County, Ohio**  
**Resolution Establishing and Amending Permit Fees**  
**Resolution 15-2012**

WHEREAS, Ohio Revised Code Chapter 519 authorizes a Township to regulate building and land use within the unincorporated areas of a Township, and

WHEREAS, a Township may establish reasonable fees to accompany applications made to the Zoning Inspector, The Board of Zoning Appeals and Zoning Commission for zoning permits, variances or other special exceptions, and

WHEREAS, the Board of Township Trustees of Troy Township, Wood County, Ohio, after due deliberation and consideration, have determined that zoning permit fees are necessary for the purpose of defraying the costs of inspections, investigation, certification and maintenance of necessary records pertaining to the implication of the zoning resolution, legal notices and other expenses incidental to the determination of such matter.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TOWNSHIP TRUSTEES OF TROY TOWNSHIP, WOOD COUNTY, OHIO, that the following zoning permit fee schedule be established.

Section 1 – Each applicant shall pay a fee prior to the issuance of a zoning permit for uses as set forth under this section and the fee for said zoning permit shall be that which is set forth in this resolution or as set from time to time by a resolution passed by the Board of Trustees.

Costs of independent review shall be borne by the Developer and/or owner.

All fees are collected by the Troy Township Zoning Inspector and are deposited in the Troy Township general fund.

See attached Troy Township Zoning Permit Fees.

Section 2 – This resolution shall replace previously enacted resolutions establishing permit fees.

Section 3 – This resolution will take effect at the earliest time as permitted by law.

Section 4 – It is hereby found and determined that all formal actions of Troy Township Board of Township Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of this Troy Township Board of Trustees and that all deliberations of this Troy Township Board of Township Trustees and of any of its committees that results in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of Ohio Revised Code.






