AUTHORIZING A THREE-YEAR LEASE WITH THE UNITED STATES GENERAL SERVICES ADMINISTRATION FOR PREMISES AT SAN ANTONIO INTERNATIONAL AIRPORT FOR USE BY THE TRANSPORTATION SECURITY ADMINISTRATION FOR ANNUAL RENTALS IN THE AMOUNT OF \$871,212.00 PLUS REIMBURSEMENT OF FINISH OUT COSTS.

WHEREAS, the United States General Services Administration (GSA)has requested a three year lease for space at San Antonio International Airport (Airport) for the benefit of the Transportation Security Administration (TSA); and

WHEREAS, Aviation staff and GSA have negotiated a three year lease for premises within Airport terminals; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is authorized to execute a three-year lease with GSA for premises at San Antonio International Airport for annual rentals of \$871,212.00 plus reimbursement to City for finish out costs associated with the leased premises (currently estimated at \$570,643.17). The lease shall be in a form approved by the City Attorney's Office.

SECTION 2. Funds (rentals) generated by this Ordinance will be deposited into Fund 51001000 per the table below.

The amount of \$329,271.17 is authorized to be transferred from SAP Fund 51099000.

SECTION 7. The amount of \$6,372.00 is appropriated in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00151, NTE - Project 4 - Terminal B, SAP WBS Element 33-00151-05-13-02 entitled Construction - TSA Tenant Finish Out, SAP GL account 5201140.

SECTION 8. The financial allocations in this Ordinance are subject to approval by the Chief Financial Officer (CFO), City of San Antonio. The CFO may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 9. This Ordinance shall take effect immediately upon receipt of eight (8) affirmative votes; otherwise it shall be effective ten (10) days after its passage.


