Tier 1 Categorical Exclusion

The purpose of this project is to rehabilitate 10.7 miles of Interstate 40 in Lonoke County from Highway 31 to the Prairie County Line. This project will include mill and inlay of the roadway, polymer overlay of four bridges, and hydro-demolition of one bridge. All work will take place within existing right of way. A project location map is attached.

The project will not involve relocations, endangered species, prime farmlands, wetlands, underground storage tanks, hazardous materials, any environmental justice issues, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxic concerns. The Cultural Resources clearance is attached.

The official species list obtained through US Fish and Wildlife Service's (USFWS) Information for Planning and Consultation website identifies the proposed threatened Eastern Black Rail (*Laterallus jamaicensis ssp. jamaicensis*), the endangered Ivory-billed Woodpecker (*Campephilus principalis*), the threatened Piping Plover (*Charadrius melodus*), the threatened Red Knot (*Calidris canutus rufa*), the endangered Fat Pocketbook (*Potamilus capax*), the endangered Pink Mucket (*Lampsilis abrupta*), the threatened Rabbitsfoot (*Theliderma cylindrica*),

and the endangered Scaleshell Mussel (*Leptodea leptodon*). A "no effect" determination was made for the federally listed plant, bird, and mussel species.

After appropriate environmental review, it has been determined that the subject job is a Tier 1 Categorical Exclusion as described by the ARDOT/FHWA Memorandum of Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for this project.


No Section 404 permit will be required for the construction of this project.

The Arkansas Department of Transportation proposes to rehabilitate a 10.7-mile portion of Interstate 40 in Lonoke County. This project will affect five bridges:

All five bridges affected by this project are exempt from the Historic Preservation Review Process due to the Section 106 Exemption Regarding Effects to the Interstate Highway System. No further work is needed for any of the bridges.

An examination of the Arkansas Archeological Survey and Arkansas Historic Preservation Program databases was conducted for previously recorded archeological sites, projects, and historic properties located within or adjacent to the proposed right-of-way (ROW) for this job. General Land Office plats, the 1936 Lonoke County highway map, and the relevant topographic maps were reviewed for potential site locations.

No previously recorded archeological sites, projects, or historic properties were identified in the project area on the AAS or AHPP databases. The 1816 General Land Office (GLO) plat of Township 2 North, Range 7 West did not indicate any traces, roads, fields or structures in or near the project. The 1853 GLO plat of the same Township/Range shows

three agricultural fields ("Davis" in Section 15; "? Burciful's (?)" in Sections 16 and 17; and "McBride's" in Section 18) in or near what became the I-40 corridor. The 1853 plat also shows two roads – "Road from Little Rock to Memphis" and "Old Post of Arkansas Road" - crossing the corridor from the NW to the SE. The "Road from Little Rock to Memphis" parallels the interstate corridor in Section 15 and crosses it in Section 16. The "Old Post of Arkansas Road" crossed the interstate corridor in the northwest corner of Section 16. The 1820 GLO survey plat of Township 2 North, Range 8 West did not indicate any traces, roads, fields or structures in or near the project. The 1854 GLO of the same Township/Range shows agricultural fields ("Shouse's" in Section 15; "E Gray" in Section 14; and "G Gray" in Section 13) approaching what became the Interstate 40 corridor but it does not appear that they extended into the existing ROW. The 1936 Lonoke County highway map noted several secondary highways and a few structures located in what became the interstate corridor.

This project will occur in heavily disturbed areas on existing paved interstate surfaces located within the existing roadway. No additional ROW will be acquired for this project. As such, this activity does not have the potential to affect any undisturbed land surfaces or historic properties. Therefore, this project is subject to the 1999 Memorandum of Agreement and falls under the exempted category "Reconstruction." This project is requires no further work or Section 106 Review.

A Tier 1 Categorical Exclusion was completed for the subject job on September 17, 2019. The original job number was BB0608 and length was 10.7 miles. Since that time, the job number has changed to 061687 and the length has increased to 24.3 miles. The work will include a 2" mill and overlay of the Interstate 40 roadway, polymer overlay of five bridges, and hydro-demolition of four bridges. All work will be performed within the existing right of way and no additional environmental impacts are anticipated.



This job has been combined with job 061688 and supersedes Job BB0608 that was cleared under the 1999 MOA on January 24, 2012. The current job proposes a 2" mill and overlay on 24.3 miles of Interstate 40 in Lonoke and Prairie Counties. Bridge travel surfaces along the project will be repaired as follows:
