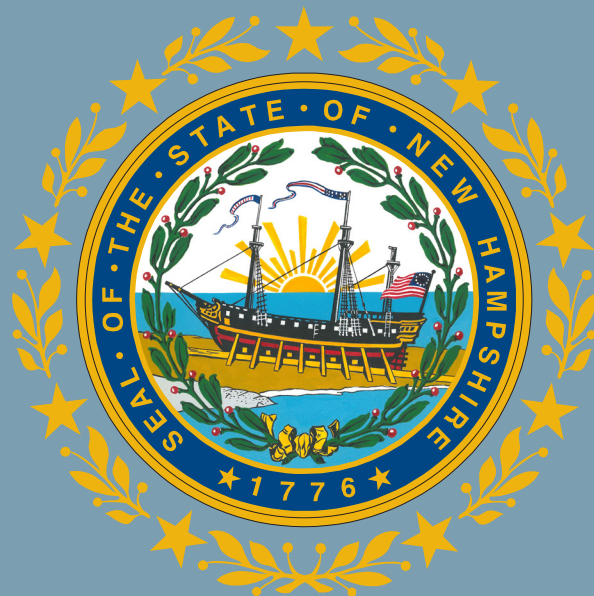

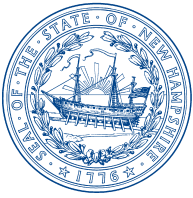

Dear Governor Sununu and Council:

I am pleased to present to you this 176th Annual Report of the Bank Commissioner. As required by RSA 383:15, this report contains background information on each entity under the supervision of the Banking Department, lists the significant events and issues we addressed during the year, and highlights important statistics and trends regarding the industries regulated by the department.

Responding to the COVID-19 pandemic was a major part of department efforts in 2020. Because the department had recently adopted a new technology-based Continuity of Operations Plan (COOP), protecting the health and safety of our staff was quickly accomplished by sending all but a few home to telework. Those that could not telework full-time kept our offices and the lines of communication open with consumers and the businesses we regulate. COOP-related technological upgrades made it possible to successfully conduct all of the departments' statutorily-required examinations of banks, credit unions, trust companies and licensees remotely and on time. Increased frequency of communication between the department and the senior managers and boards of directors of the institutions within department jurisdiction allowed us to confirm that they were being proactive in their efforts to continue serving the heightened financial service needs of New Hampshire's consumers and businesses during this difficult period. A streamlined process was created to allow state-chartered banks and credit unions to protect their employees by temporarily closing and then quickly reopening branch offices that experienced COVID contamination.

Economic, social and cultural upheaval caused by the Coronavirus notwithstanding, the financial condition of New Hampshire-chartered banks and credit unions remained strong with solid liquidity, capital and net worth positions that allowed generous payment forbearance when appropriate and very strong participation with the federal Paycheck Protection Program (PPP). The state's non-bank mortgage industry worked tirelessly through the pandemic to support a significant increase in home loan activity spurred by telework opportunities and the desire of many from densely populated areas of the Northeast to purchase homes and move to New Hampshire for its clean environment, rural character and quality of life. We can be proud of the efforts by NHBD-regulated entities to support NH during the COVID era.

Finally, I would like to thank the many members of our staff who volunteered for alternative assignments outside the department throughout the year to join their fellow state employees in determined efforts to battle the Coronavirus. In 2020 we saw clearly that the department's greatest resource is its people.

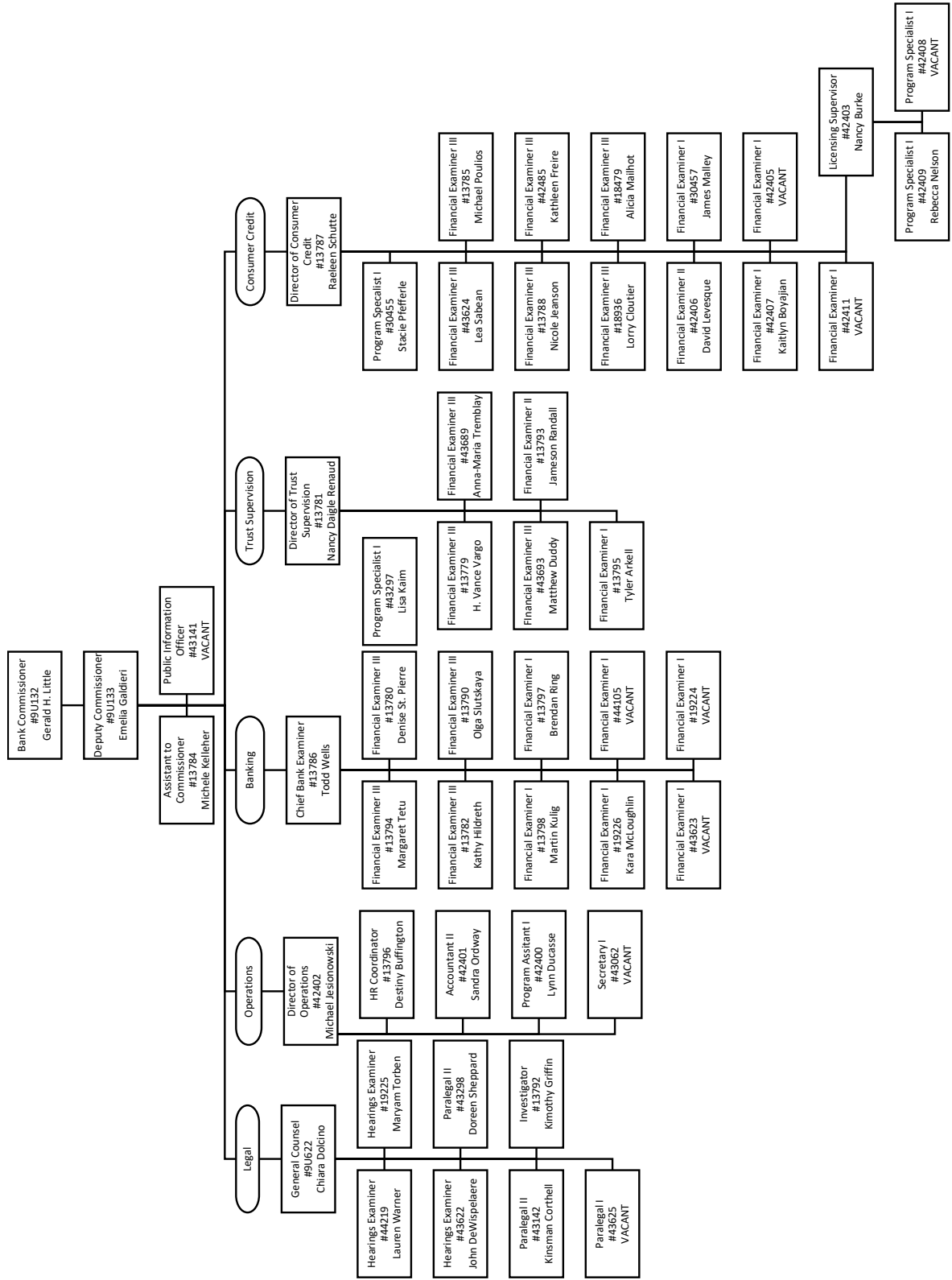

Foreword

The one hundred seventy-sixth annual report of the Bank Commissioner contains management, financial information and locations of banks, credit unions, and other financial institutions operating under state charter. This report also contains information concerning debt adjusters, money transmitters, mortgage bankers and brokers, mortgage servicers, retail sellers, sales finance companies, and small loan lenders.

Mission Statement

The New Hampshire Banking Department is committed to protecting the public's interest through the professional supervision of the financial services it regulates.

Functions of the Banking Department

The Bank Commissioner is responsible for the general supervision of all New Hampshire chartered and licensed financial institutions through the operation of the New Hampshire Banking Department. The Banking Department contains five divisions: Banking, Trust Supervision, Consumer Credit, Legal, and Operations.

The Banking and Trust Supervision Divisions charter, supervise, and examine all state-chartered banks, credit unions, trust companies, and family trust companies in New Hampshire.

The Consumer Credit Division licenses, examines, and regulates companies that provide consumer credit, such as mortgage bankers, mortgage brokers, mortgage servicers, retail auto sellers, sales finance companies, money transmitters, debt adjusters, and small loan lenders.

Working in conjunction with the Banking, Trust Supervision, and Consumer Credit Divisions, the Legal Division investigates consumer complaints and unlicensed or unchartered activity. The Legal Division may commence enforcement actions against financial entities that violate state or federal laws or regulations. The Bank Commissioner has the authority to order consumer restitution as part of those enforcement actions.

The Operations Division supports the daily functions of the Banking Department.

Legislation 2020 Session of the Legislature

The following bills were considered in the 2020 legislative session, however, none were ultimately enacted.

| Bill No. | Description | Affected Statute |

| HB 1695 | HB 1695 was a result of the work of the <i>SB 98 Committee to Study the Effects of Past New Hampshire Trust Code Legislation</i> . The bill would have required background investigations and criminal history checks for newly appointed trust company board members, with the cost of such investigation payable by the trust company. It would have required a trust company to report any material change concerning the background or criminal history of a director within 30 days of learning of that change. The bill would also have permitted the Commissioner to remove a board member or director of a trust company. THIS BILL WAS NOT ENACTED. | RSA 383-A:3-305(e)(6) RSA 383-C:6-601 RSA 383-C:6-604 RSA 383-D:8-801(a) |
| HB 1696 | HB 1695 was also a result of the work of the <i>SB 98 Committee to Study the Effects of Past New Hampshire Trust Code Legislation</i> . The bill would have increased the cost for filing an application for a new bank, credit union or trust company charter from \$10,000 to \$15,000, and would have authorized the Commissioner to charge additional costs if review of an application or notice exceeds the statutory fee. THIS BILL WAS NOT ENACTED. | RSA 383-A:6-609 |
| HB 1437 | HB 1437 was a bill requested by the Department and would have modernized provisions relating to restrictions applicable to the banking department commissioner and deputy commissioner in regard to their personal financial transactions. It would also have permitted the transmission of consumer complaints by email rather than certified mail, and would have required the use of NMLS systems for applications and reporting by money transmitters. THIS BILL WAS NOT ENACTED. | RSA 361-A:4-a, I RSA 383:6 RSA 383-A:9-904,I RSA 397-A:15-a RSA 399-A:12,I RSA 399-D:11,I RSA 399-G-1 RSA 399-G:4,I(a) RSA 399-G:12.O |
| HB 1501 | HB 1501 would have established a commission to study financial literacy in New Hampshire. THIS BILL WAS NOT ENACTED. | RSA 383:26 (New) |
| HB 1500 | HB 1500 would have established a student loan bill of rights and a student loan ombudsman within the Banking Department, as well as licensing requirements for student loan servicers and other regulatory provisions governing student loans. THIS BILL WAS NOT ENACTED. | RSA 383:26 (New) |
| HB 1588 | HB 1588 would have authorized a mortgage mediation program within the banking department. THIS BILL WAS NOT ENACTED. | RSA 479:31-39 (New) |
| HB 1471 | HB 1471 would have prohibited the re-ordering of transactions to increase overdraft fees. THIS BILL WAS NOT ENACTED. | 383-A:7-701(g) (New) |

| HB 1419 | HB 1419 would have required New Hampshire chartered banks to offer small dollar loans and credit building products. THIS BILL WAS NOT ENACTED. | RSA 383-B:3-301(g) (New) |
| HB 1476 | HB 1476 would have prohibited any requirement that a person purchase insurance coverage when buying an automobile, if that person had existing insurance coverage at the time of purchase. The bill would also have imposed a new \$100 fine for violating this prohibition. THIS BILL WAS NOT ENACTED. | RSA 361-A:7, IX (e) (New) |
