

### **MAJOR GIFTS**

The health care needs of our community are constantly changing. To ensure that these needs are met, Baptist Health Care Foundation is fortunate to have donors who graciously support Baptist Health Care through generous gifts this past year.

\$100,000 support for Infusion Center The Baptist Health Care Foundation received a \$100,000 contribution from **Quint and Rishy Studer** to support the expansion the Infusion Center at the Kugelman Cancer Center of Baptist Hospital. This project will separate chemotherapy infusions from the existing infusion center, allowing for more comfort, space and convenience in patient treatment areas.

**1,900** mammogram screenings received Donations to the Mammogram Fund from organizations such as **Pensacola Breast Cancer Association, Pink Pirates of Navarre** and **Pink Ribbon Pensacola** help to provide free mammograms to women in our community who are uninsured or underinsured. To date, nearly 1,900 women have received screenings through this fund.

**48** AEDs installed Baptist Heart & Vascular Institute installed 48 automatic external defibrillators (AEDs) throughout multiple Baptist Health Care locations. The portable electronic devices help automatically diagnose a life-threatening cardiac arrhythmia, which can lead to cardiac arrest. The funds to purchase the devices were provided by the Foundation's Leadership Giving Society.



### Annual Monetary Support

Scottish Rite Foundation of Florida U.S.A. is a longtime supporter of the Childhood Language Disorders Program at Baptist Health Care. Their gifts allow hundreds of children to receive free screenings, evaluations and group therapy sessions each year.

# HELPING HANDS - ALL IN FOR BAPTIST HEALTH CARE

During the month of August, the Baptist Health Care Foundation kicked off its annual All In Campaign to promote and educate team members about the Helping Hands team member assistance program. With generous team member contributions to Helping Hands, several projects and initiatives are made available in three main areas to assist team members and their families directly, as well as support our community and the Mission of Baptist Health Care.

Baptist Health Care team members are among the most generous individuals, contributing **\$273,000** in the last fiscal year. The Helping Hands program plays an integral role in supporting several initiatives that are specific to each of the three funds.

**BAPTIST HELPING HANDS** includes team member contributions from Baptist Hospital, Lakeview Center, Global Connections to Employment (GCE), Baptist Medical Park – Nine Mile, Baptist Medical Park – Airport and Baptist Medical Park – Pace.

- Baptist Helping Hands assisted team members financially through unforeseen and catastrophic events, totaling **\$61,914** in emergency assistance.
- Baptist Helping Hands partnered with Baptist Hospital Pastoral Services during the holiday season to provide food baskets and food cards to 47 eligible team members. Forty food cards were provided to eligible Lakeview Center team members.
- Fifteen \$1,000 scholarships were awarded to team members and their families to assist in furthering their education and career at Baptist Health Care.
- Three team members completed the adoption or foster care certification and qualified for the one-time \$1,000 payment, net of taxes.
- Baptist Helping Hands funded the annual **C.A. Weis Elementary School Christmas** project that provided gifts and a classroom party for 519 students during the holiday season.
- A contribution from Baptist's Helping Hands fund was made on behalf of team members to United Way of Escambia County to support several community organizations in their missions and initiatives.
- A contribution is made on behalf of team members to Baptist Health Care to support its Mission in helping people throughout life's journey. This year, the funding provided was used to purchase bed warmers and new thermometers for the **Baptist Hospital nursery**. The bed warmers are designed to provide maximum warmth to infants and improve patient safety, as well as resuscitation therapy needed for high-risk newborns.







**GULF BREEZE HELPING HANDS** includes team member contributions from Gulf Breeze Hospital and Baptist Medical Park – Navarre.

- Gulf Breeze Helping Hands assisted team members and their families financially through unforeseen and catastrophic events, totaling \$10,828 in emergency assistance.
- Nine scholarships were awarded to team members or their families to assist in furthering their education and career at Baptist Health Care.
- Gulf Breeze Helping Hands honored team members and their families with 29 memorial donations.
- Twenty-six boxes of food were collected and distributed during the Angel Tree Christmas Project, supporting 23 families, and 43 children received two gifts each.

JAY HELPING HANDS includes team member contributions from Jay Hospital.

• Jay Helping Hands assisted team members and their families financially through unforeseen and catastrophic events, totaling **\$2,700** in emergency assistance.

# **CASINO ROYALE AND BRAS ACROSS THE BRIDGE**







### Casino Royale and Bras Across the Bridge are

two annual fundraising events that provide an opportunity for the Baptist Health Care Foundation to secure philanthropic dollars for the many initiatives offered by Baptist Health Care.

The 4<sup>th</sup> annual Casino Royale, based on the Bond movie, Thunderball, brought the excitement and flare of James Bond to hundreds of donors at the Hilton on Pensacola Beach. The blacktie affair offered gourmet cuisine, dancing to a six-piece showband, Monte Carlo-styled casino excitement and a silent auction featuring oncein-a-lifetime trips. By the end of the evening, **\$214,315** was raised for the renovation of the Kugelman Cancer Center at Baptist Hospital.

**The Kugelman Cancer Center** facilitates infusion services for a wide variety of specialties other than oncology chemotherapy, such as cardiology, antibiotic, rheumatology, osteoporosis and gastrointestinal. This construction project will separate chemotherapy infusions from the existing infusion center, allowing for more space and convenience in patient treatment areas.





The 7<sup>th</sup> annual Bras Across the Bridge event was presented by Baptist Health Care Foundation and Pensacola Honda, in partnership with Cumulus Media and The Grand Marlin Restaurant & Oyster Bar. Hundreds of participants displayed their support for breast cancer awareness as they walked across the Bob Sikes Bridge on Pensacola Beach. This event raised more than **\$20,000** for the Baptist Health Care Foundation Mammogram Fund.

**The Mammogram Fund** provides mammograms to women who are not financially able to receive one on their own, as well as awareness and support for early detection. To date, the program has provided free screenings to 1,899 women. As a result of these screenings, 364 women required additional testing, 47 required biopsies and 18 were diagnosed with breast cancer. Donated bras were delivered to local organizations that support women and girls in need, including Lakeview Center and Gulf Coast Kid's House.









## WOMEN'S BOARD OF BAPTIST HEALTH CARE FOUNDATION

Established in 1976, the Women's Board of Baptist Health Care Foundation provides consistent support for the community through its commitment to health care initiatives. The Women's Board has raised more than **\$2 million** in support of various health care programs. Through the dedicated efforts of volunteers in this organization, the quality of health care has been improved for the entire community.

Women's Board memberships are open to any woman who is interested in serving her community. Membership meetings are held quarterly and provide members an opportunity to meet new friends, get the latest news on Baptist Health Care and learn through our fun and educational programs. In addition to the quarterly meetings, the board hosts Women's Night Out events to help engage its membership.

The 40<sup>th</sup> annual Stepping Out in Style Fashion Show, presented by the Women's Board of Baptist Health Care Foundation and Gulf Coast Health Care, had its best show to date. The show featured fashions from Bluetique, cabi by independent stylist Jennie Barrow, duh for garden & home, The Market and Mainly Shoes and South Outfitters. With more than 450 attendees, the event raised **\$121,545**. Proceeds were designated to **Totes for Tots**, a program at FamiliesFirst Network for children in foster care.

In the past, the Women's Board has raised funds for programs and projects including cancer services, heart and vascular services, women's health services, the Children's Building at Lakeview Center, the palliative care suite at Baptist Hospital and upgraded security cameras for the mother baby unit at Baptist Hospital.

Through hundreds of women and thousands of volunteer hours in service more than 40 years, our community members have access to better health care and quality of life.















# LAKEVIEW CENTER AND FAMILIESFIRST NETWORK

The Baptist Health Care Foundation supports several initiatives of Lakeview Center and FamiliesFirst Network, both affiliates of Baptist Health Care. Lakeview Center offers more than 60 programs in its network of behavioral health, vocational services and child protective services.

The Foundation provides philanthropic support for more than 30 programs of Lakeview Center and FamiliesFirst Network. Highlights from the last fiscal year include:

FamiliesFirst Network of Lakeview Center (FFN) is the community-based care agency contracted by the Department of Children and Families to support the well-being of abused and neglected children in Northwest Florida. FFN provides child protective services to families, independent living services for teens and youth who age out of foster care, adoptive services for children in the dependency system, and places foster children in licensed foster homes and residential facilities. Gifts to the **FamiliesFirst fund** support key initiatives for these children such as teen art camp, the adoption picnic, summer camps, tutoring, child abuse prevention activities and the spring fling community event.

In 2005, Child Guardian's Inc. received a donation that was specifically earmarked for "directly helping the children." Its board of directors created a special fund for these monies, and any future monies that were collected or donated with the intention of going directly to help the abused and neglected children and youth served in our district through the Baptist Health Care Foundation, FamiliesFirst Network's **Brandon Fund**. Named after its first donor, the fund provides financial assistance for "special circumstance" needs for children including glasses, church camps, sports uniforms, beds, musical instruments, tutoring sessions and school supplies.

FamiliesFirst Network's **Operation Santa** annual program provided gifts for nearly 2,000 foster care children this past year. The goal of Operation Santa is to bring the joy of Christmas to children of all ages – children in foster care, children living in residential treatment programs and older children who will soon age out of the foster care system and be on their own. The children in foster care are just like any other child; they want to experience the magic of gifts from Santa on Christmas morning. Through the generous gifts of our community, we are able to provide that Christmas magic for these children.









A \$100,000 gift from the **Melba Bayers Meyer Charitable Trust** provided funding to assist children who received care from a board-certified child psychiatrist. The children receiving these services are those who do not have insurance and/or do not qualify for Medicaid. Because of the generous gifts from the Melba Bayers Meyer Charitable Trust throughout the years, Lakeview Center has been able to provide mental health care to thousands of children in our community.

The **Hollinger Charitable Trust** was established by Mr. & Mrs. Pick Hollinger, long-time generous supporters of Baptist Health Care. Alberta and Pick Hollinger demonstrated an outstanding commitment to improving the quality of health care in Northwest Florida. Through their estate, the Hollinger Charitable Trust provided a generous gift to support the renovation and expansion of Lakeview's Century Clinic so the residents of Century who are in need would have access to primary health care services at little to no cost.

More than 150 individuals received services through a gift from the **D.W. McMillan Foundation**. The clients of the Lakeview Center Century Clinic cannot afford health insurance and do not qualify for Medicaid. These patients were able to receive mental health care treatment that would not be able to be provided without this funding.
