PRESERVE

BY THE CLOSE of 2020, the Trust had cumulatively saved more than 53,500 acres of battlefield land. This includes nearly 1,127 acres through 28 transactions at 22 battlefields in 10 states during 2020 alone. A full listing of those transactions follows.

One noteworthy victory in the competitive Richmond area was the preservation of 22.3 acres at the New Market Heights Battlefield. Here, 14 soldiers of the United States Colored Troops, including Sgt. Maj. Christian Fleetwood, received the Medal of Honor for their courageous actions at this battle in September of 1864. Fleetwood later described the battle as “a deadly hailstorm of bullets.”

Just around the 158th anniversary of the Battle of Antietam, Trust members answered the urgent call to save 2.7 critical acres at the heart of the battlefield. In just five weeks, the Trust raised the funds needed to acquire this West Woods tract. This achievement brings us one step closer to substantially completing the battlefield that marks the single bloodiest day in American history.

Turning to the Western Theater, the Trust also celebrated the preservation of two contiguous tracts totaling 48.3 acres at the Stones River Battlefield. Most of this land was once considered lost to a major industrial facility. Primarily with the assistance of government funding, including the single largest grant in the history of the Tennessee Civil War Sites Preservation Fund and an American Battlefield Protection Program grant, the Trust raised the formidable \$5.2 million needed to recover this historic property.

The Trust's Revolutionary War efforts also continued at full speed, including the Trust's first preservation victory at the Bennington Battlefield in New York, where 23.1 acres were preserved and destined for the Bennington Battlefield State Historic Site. In the Southern Theater, the Trust helped save 12.2 acres at the Port Royal Island Battlefield, where Gen. William Moultrie's band of Patriot militia defeated British regulars in 1779. This battlefield will be a part of the Trust's collaborative Liberty Trail project that aims to link 70 Revolutionary War sites across South Carolina.

The Trust will enter the new year with more than 1,000 additional acres in the process of being preserved. This includes the Trust's landmark “Gaines' Mill — Cold Harbor Saved Forever” Campaign launched this December, which targets nearly one square mile of the most important unprotected battlefield land in the country.★

BETWEEN JANUARY 1, 2020, AND DECEMBER 31, 2020, the American Battlefield Trust completed 28 individual transactions, protecting a total of 1126.8 acres at 22 battlefields in 10 states. Although this land is valued at \$20.7 million, thanks to a host of matching grants and other revenue sources, the Trust secured its preservation through a net cash outlay of only \$2.3 million — a leverage factor of 9-to-1.

EDUCATE

THE TRUST has long pursued variable approaches to impart history upon both young and lifelong learners. Twenty-twenty, in particular, was a year of unprecedented opportunity and growth for our educational initiatives. As COVID-19 forced school closures and social distancing, the Trust kept pace and pivoted to a digital focus. This swift shift ensured that our mission to educate Americans about our nation's founding conflicts did not suffer. In fact, we now reach a greater audience than ever before.

Already a leader in original digital content, the Trust has stepped up output to keep up with demand. This year, we saw a 70 percent increase in viewership for our hundreds of impressive online videos, with more added each week. Audiences have become especially fond of both the animated map series and the immersive four-part series *Civil War 1864: A Virtual Reality Experience*. And when physical classrooms closed their doors, the Trust was ready with thousands of articles on historical events and figures, virtual tours featuring 360-degree annotated photography, Crash Courses, primary sources, maps and quizzes to inspire minds at home and support teachers as they re-envisioned education in a virtual classroom.

This year, the Trust also explored new mediums. In April, we launched "Zoom Goes the History," an online series featuring discussions among historians, authors and preservationists. We partnered with the History Channel for the May release of its popular miniseries on Ulysses S. Grant, providing expertise and promotional videos shared on our social media. July's National Teacher Institute underwent a virtual transformation, allowing us to reach 784 educators — more than triple the usual number of attendees! Technical innovation has also empowered the Trust to step into the next generation of media with a groundbreaking augmented reality (AR) app, the Gettysburg AR Experience, released in November.

Most importantly, the Trust has been able to provide all of this at little or no cost to students of history around the world. This has only been possible with the enduring support of our donors, who stepped up to make 2020 our most successful year for educational program fundraising yet. With this generous support, we will carry the mission forward with an increasingly robust offering of powerful educational programming. ★

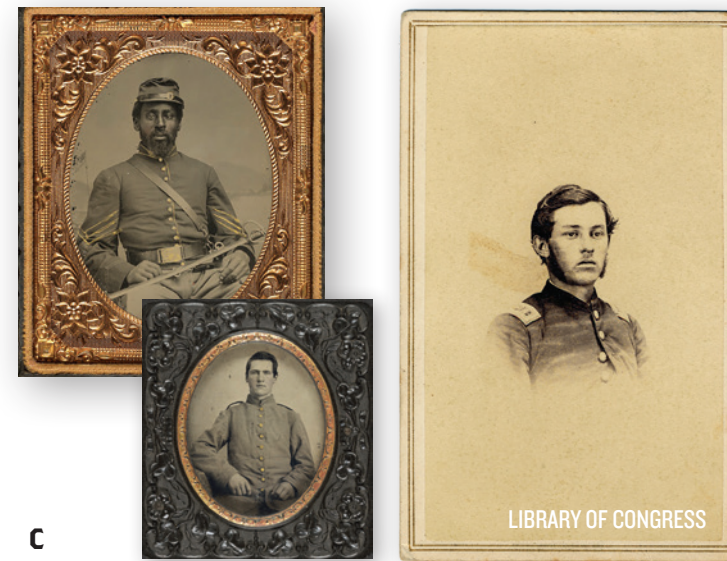

INSPIRE

THE AMERICAN Battlefield Trust continues to live out the three aspects engrained in our mission: Preserve. Educate. Inspire. We protect important landscapes and share the stories of what happened there, so that countless others can understand why those events matter today. We want that ongoing relevance to inspire this and future generations to action — to encourage civic pride and help build a better America.

Within 2020, the Trust launched Warrior Legacy, a unified home for our various programs designed to benefit the military community — veterans, active duty and military families. In doing so, we showcase the deep connections today's veterans and active duty military retain to their historical forebearers and emphasize how battlefields can be used to bridge those eras.

Always looking for innovative ways to explore the American story, the Trust has been fortunate to partner with organizations that unlock eye-opening doors. This year saw the beginning of a collaborative partnership with Ancestry® and Fold3®. Users on the platforms may now cross paths with the Trust's keen information on specific military engagements. Additionally, Ancestry® began supplying a regular column in the award-winning membership magazine, *Hallowed Ground*.

The Trust also continues to support young voices. The Trust's Youth Leadership Team welcomed its second cohort of young leaders to serve as the youth face and voice of the organization. Empowered by their enthusiasm for history and their newfound connections, members of this trailblazing group will work toward the creation of battlefield preservation, education or visitation projects in their local communities. Members of the inaugural cohort demonstrated just how compelling their voices can be: One member unveiled an ambitious audio drama to bring new life to the Revolutionary War's Battle of Kings Mountain, while another penned and published an opinion piece exposing the formative history tied to a battlefield in his "backyard" — at which the Trust endeavors to save land. By supporting this group, we create a ripple effect, fostering the next generation of preservation advocates that will tend to the places that make up our American story. ★

REVENUES, GAINS AND OTHER SUPPORT

The Trust is a cash-flow business and, as a result, looking at static revenues and expenses, like those seen here, can be misleading. As soon as land is saved, it is capitalized and goes straight to our balance sheet (assets), not shown in the expenses displayed here. Therefore, much of our land preservation activities are not represented in the expenses. The land that we've saved and currently own makes up the biggest portion of our assets.

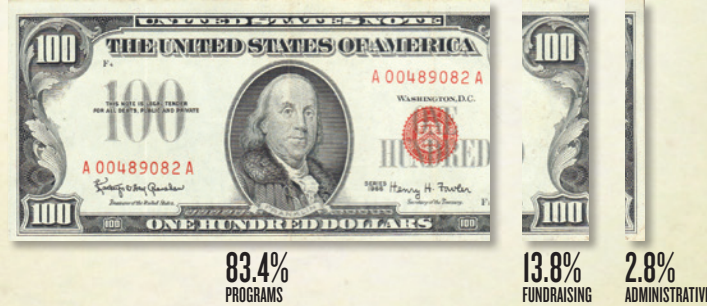
