RE: Petition for Rulemaking to Protect Endangered Species from Pesticides by Restricting Pesticide Use in Critical Habitat

Dear Secretary Ross and Acting Secretary Bernhardt,

Pursuant to the right to petition the government as provided in the First Amendment to the United States Constitution,¹ the Administrative Procedure Act,² and the Endangered Species Act,³ the Center for Biological Diversity (“the Center”) formally petitions the Secretary of Commerce through the National Marine Fisheries Service (“NMFS”) and the Secretary of the Interior through the U.S. Fish and Wildlife Service (“FWS”) (collectively the “Services”) to promptly initiate rulemakings to restrict the use of pesticides in designated critical habitat of wildlife and plants protected under the Endangered Species Act.⁴ This rulemaking is necessary because the facts and history overwhelmingly demonstrate that the Environmental Protection Agency (“EPA”) is both unwilling and unable to comply with the clear statutory requirements to address the harm caused by pesticides to threatened and endangered species by consulting with the Services prior to the approval of a pesticide as well as failing to comply with the Endangered Species Act on other discretionary agency actions taken under the Federal Insecticide Fungicide and Rodenticide Act (“FIFRA”).

This petition requests that the use of pesticides be prohibited in critical habitat, unless the EPA has completed a Section 7 consultation assessing its impacts on listed species, or if a private

party has entered into a Habitat Conservation Plan under Section 10 of the Endangered Species Act. Pesticides could also still be used to implement conservation activities essential to recover endangered species — such as the control of invasive species — or if the use of the pesticide was needed to protect human health or safety. In all other cases, the use of pesticides in critical habitat should be prohibited.

The Endangered Species Act is the world’s most powerful and effective conservation law. It has prevented the extinction of 99 percent of the species under its care and put hundreds of species on a path to recovery. The law’s clear and absolute command to prevent extinction at “whatever the cost,” its unambiguous mandate to base decisions on the best available science, and its precautionary approach to give threatened and endangered species the benefit of the doubt in federal agency decision-making have all contributed to the Act’s effectiveness and success.⁵ The Endangered Species Act mandates that all federal agencies, including the Services, have a duty to conserve species under 7(a)(1) of the Act. It also provides the Services the inherent authority to protect endangered species from being killed, injured, or harmed under both Section 4(d) and Section 11(f) of the Act. This mandate and authority must be used here in the face of the EPA’s continued failure to comply with the mandates of the Endangered Species Act. The Services have used their authority in the past to protect species like the North Atlantic right whale, sea turtles and the manatee in situations where other federal agencies and state agencies have failed to take sufficient action to address the harm caused by their activities. A prohibition on the use of pesticides in critical habitat is needed now because of the EPA’s continued intransigence and disregard of the harm it is causing threatened and endangered species nationwide.⁶

The Center is a non-profit environmental organization dedicated to the protection of native species and their habitats through science, policy, and environmental law. The Center has more than one million members and online activists dedicated to the protection and restoration of endangered species and wild places. For nearly 30 years, the Center has worked to protect imperiled plants and wildlife, open space, air and water quality, and overall quality of life. The Center’s Environmental Health Program and Pesticides Reduction Campaign aim to improve pesticide regulation in order to reduce the harms of pesticides to the environment as a whole, and to threatened and endangered species in particular.

I. HISTORY OF THE EPA’S FAILURE TO PROTECT THREATENED AND ENDANGERED SPECIES FROM PESTICIDES

Section 7(a)(2) of the Endangered Species Act requires that “each federal agency *shall*, in consultation with and with the assistance of the Secretary, insure that any action authorized, funded, or carried out by such agency is not likely to jeopardize the continued existence of any endangered species or threatened species or result in the destruction or adverse modification of habitat of such species which is determined by the Secretary... to be critical.”⁷ The Act’s language is clear that the EPA must initiate consultation with the Services to insure that its actions to register and approve pesticides for use under FIFRA do not harm any listed species.

The Act’s regulations and decades of caselaw make abundantly clear that the EPA must consult whenever its action “may affect” a listed species or critical habitat.⁸

Despite this clear command, over the past 25 years the EPA has steadfastly ignored the law’s requirement to consult with the Services regarding the approval and use of pesticides, which by definition are poisons designed to kill living things. During this time, the EPA has registered or re-registered over 1,100 pesticide active ingredients and 18,000 pesticide products — *all* of which were done without complying with the Endangered Species Act. It is not surprising then that recovery plans for over 250 threatened and endangered species list pesticides as known threats and obstacles to their recovery. Nor is it surprising that with over a billion pounds of pesticides being used in the United States each year, additional species continue to be added to the list of threatened and endangered species, including four butterfly species that are harmed by pesticides in 2014,⁹ the rusty patched bumble bee in 2017¹⁰ and the trispot darter, which was listed as threatened just one week ago in part due to the threat of pesticides.¹¹

The last time the U.S. Fish and Wildlife Service completed a biological opinion on pesticides was in 1993 when the Service analyzed the impacts of 16 highly toxic vertebrate control agents, 14 insecticides and one herbicide.¹² The biological opinion found that the vertebrate control agents were jeopardizing 189 listed species, while causing harm but not jeopardy for 57 species.¹³ As a result, the Fish and Wildlife Service set forth both Reasonable and Prudent Alternatives (“RPAs”) (for species that were jeopardized by the pesticides) and Reasonable and Prudent Measures (“RPMs”) (for species that were not jeopardized) as the Endangered Species Act requires.¹⁴ Many of the RPAs focused on restricting the use of pesticides in or near critical habitat. For example, the RPAs for the Carolina northern flying squirrel, Florida salt marsh vole, Fresno kangaroo rat, and Audubon’s crested caracara all prohibited the use of pesticides in and near occupied habitat.¹⁵ Likewise, RPMs for the giant kangaroo rat, Tipton kangaroo rat, Louisiana black bear, San Joaquin kit fox, and Stephen’s kangaroo rat also restricted pesticide use in occupied habitat.¹⁶

Since 1993, virtually all protections for endangered species from pesticides have come from litigation to enforce the requirements of the Endangered Species Act because there have been no successful consultations — where the EPA accepts and implements RPAs and abides by the terms of the biological opinion — since that time.

In 2001, a coalition of environmental groups filed a lawsuit against the EPA for failing to consult with NMFS on the impacts of pesticide on salmon and steelhead in the Pacific Northwest.¹⁷ The EPA admitted it failed to consult but argued that it did not have to comply with the Endangered Species Act if it followed FIFRA. The Ninth Circuit rejected the EPA's clearly erroneous argument and held that the agency was bound by the Endangered Species Act: "EPA retains ongoing discretion to register pesticides, alter pesticide registrations, and cancel pesticide registrations. Because EPA has continuing authority over pesticide regulation, it has a continuing obligation to follow the requirements of the ESA."¹⁸

In the years that followed, the EPA did initiate consultations with NMFS — although it often claimed that the pesticides at issue had either "no effect" or were "not likely to adversely affect" listed species.¹⁹ As of 2017, NMFS had completed approximately 676 effects determinations regarding the registration of pesticides in the Pacific Northwest (counting each pesticide product's effects on a separate listed species as a unique determination).²⁰ NMFS concluded that jeopardy and/or adverse modification of critical habitat to listed salmon and steelhead species would occur for 293 of those pesticide registrations. Of those 293 jeopardy/adverse modification findings, the EPA concluded for 49 of those actions that the pesticide would have no effect on a listed species and concluded for 40 registrations that the pesticide was not likely to adversely affect a listed species where NMFS found jeopardy/adverse modification of critical habitat.

In other words, over 30 percent of the time, the EPA reached the opposite (and less protective) conclusion than NMFS regarding the effects a pesticide would have on listed salmon and steelhead species. Even more disturbingly, of the 293 jeopardy determinations made by NMFS since 2001, the EPA has refused to implement a single RPA for any listed species under any circumstance for any pesticide.

In April 2002, the Center filed a lawsuit against the EPA for again failing to undergo consultation with the FWS regarding pesticide impacts on the California red-legged frog.²¹ The EPA agreed to assess and potentially initiate consultations on the impacts of pesticides on the frog, and the Center was able to secure interim restrictions on the use of pesticide in and near the frog's habitat. Similarly, in 2007, the Center filed a lawsuit against the EPA for failing to undergo consultation with FWS regarding pesticide impacts on eleven San Francisco Bay Area species. The Court entered an Order where the EPA agreed to a schedule of compliance for completing consultation, and to an injunction restricting pesticide use in and near the species' critical habitats and occupied habitats.²²

In 2011, the Center and Pesticide Action Network North America filed a comprehensive legal action suing the EPA for its failure to consult with federal wildlife agencies regarding the impacts of hundreds of pesticides known to be harmful to more than 200 endangered and

threatened species. The Center for Food Safety filed suit in 2013 regarding the EPA's decision to approve 59 pesticide products with the active ingredients clothianidin and thiamethoxam for failing to consult under the Endangered Species Act. In 2009, Defenders of Wildlife filed suit relating to the EPA's approval of Rozol (chlorophacinone), and the EPA's failure to consult on the pesticide's impacts on endangered species.

Most recently, as a result of litigation brought by Earthjustice on behalf of the Northwest Coalition for Alternatives to Pesticides, Pacific Coast Federation of Fishermen's Associations and Institute for Fisheries Resources, NMFS completed a nationwide biological opinion for chlorpyrifos, malathion, and diazinon on all marine and anadromous species nationwide, finding jeopardy for the southern resident killer whale and 37 species of salmon, sturgeon and steelhead.²³ This Biological Opinion was the result of an earlier nationwide biological evaluation (also produced through litigation) completed by the EPA on the impacts of these three pesticides on all threatened and endangered species nationwide. The Biological Evaluation found that chlorpyrifos and malathion are likely to adversely affect 97 percent of all listed species nationwide, while diazinon is like to adversely affect 79 percent of all listed species.²⁴ The Biological Opinion contains RPAs for each of the species that is jeopardized by the pesticides and includes restrictions on use of pesticides in and around aquatic habitats – including critical habitat.²⁵ Over a year has passed since the completion of the biological opinion. Rather than complying with the opinion or the Endangered Species Act, the previous EPA administrator stated that “the current Endangered Species Act pesticide consultation process is broken” and the EPA has attempted to reinstate informal consultations — a process that the Endangered Species Act and its regulations clearly do not contemplate.

Despite the EPA initiating consultations with the Fish and Wildlife Service in January 2017 on the Biological Evaluation for chlorpyrifos, malathion, and diazinon on wildlife and plants in its jurisdiction, two years have passed and the FWS has refused to release a draft opinion for public comment and input, despite the fact that it was essentially completed in the spring of 2017. Political pressure from industry and the EPA has stalled out all work on these consultations, and the FWS has stated that, at least for malathion, no work will be completed until 2021. This consultation has been thwarted despite evidence, obtained by petitioners via the Freedom of Information Act, that FWS finds that the use of these pesticides jeopardizes the continued existence of some listed species, a clear warning cry that urgent action is warranted. Consultations, also resulting from litigation, for carbaryl and methamyl, have also been indefinitely delayed, despite biological evaluations having been essentially completed in May of 2017.²⁶

It has become evident that despite clear statutory requirements and case law, the EPA will continue to approve pesticides for use in the United States without consulting with the Services

about potential effects on endangered species.²⁷ Given the EPA’s intransigence, the Services themselves must fulfill their duties under the Endangered Species Act and prohibit the use of pesticides in critical habitat in order to protect and save endangered and threatened species from extinction.

II. THE ENDANGERED SPECIES ACT PROVIDES THE SERVICES AUTHORITY TO PREVENT TAKE IN THE FACE OF AN INTRANSIGENT AGENCY

The Endangered Species Act gives NMFS and FWS the authority to promulgate all necessary regulations to protect species from pesticides. Section 11(f) of the ESA authorizes NMFS and FWS to “promulgate such regulations as may be appropriate to enforce [the Act].”²⁸ This sweeping power allows the Services to implement protective regulations for all species listed as “endangered.” Section 4(d) of the Act states that the Services “shall issue such regulations as [the Service] deems necessary and advisable to provide for the conservation of such species” and that they “may by regulation prohibit with respect to any threatened species any act prohibited under section 9(a)(1), in the case of fish or wildlife, or section 9(a)(2) in the case of plants, with respect to endangered species.”²⁹ The Services have used these authorities in the past to issue regulations to enforce the Endangered Species Act by enacting regulations regarding manatee speed zones³⁰, turtle exclusion devices,³¹ and ship speed rules to protect the North Atlantic Right Whales.³² For similar reasons, the Services again must exercise their authority and enact regulations that will prohibit the use of pesticides in and around critical habitat.

As an example, Florida manatee speed zones were enacted to reduce the amount of small vessel collisions between recreational boaters and manatees. The state of Florida possessed the inherent authority to regulate recreational boat speed and activities through its normal police powers, however because Florida was unwilling to take action on its own, the Fish and Wildlife Service used its authority under the Endangered Species Act to restrict boat speed in important manatee refuge areas.³³ These measures helped stabilize the population of the manatee and put it on a trajectory towards recovery.

Likewise, NMFS has used its authority to enact speed restriction regulations to protect the critically endangered North Atlantic right whale.³⁴ These vessel-speed regulations were needed because the right whales’ population was declining due to ship strikes. The U.S. Coast Guard was not remedying the situation and continued to authorize the use of shipping channels and failed to take protective measures for the species. In response to the Coast Guard’s inaction, NMFS was required to and did use its authority under the Endangered Species Act to pass additional measures to protect the right whale (other endangered whales in the Atlantic Ocean

also benefited from these regulations). NMFS' implementation of regulations restricting ship speed in order to lessen ship strikes will help stave off the extinction of this whale species.

Additionally, NMFS has implemented regulations requiring Turtle Exclusion Devices ("TEDs") on fishing vessels that allow threatened and endangered sea turtles to escape fishing nets and avoid becoming bycatch. NMFS passed these regulations because impermissible take was occurring when turtles were being hurt and killed in fishing nets and state fisheries management agencies — as well as the other branch of NMFS — had failed to implement sufficient regulatory protections to address sea turtles drowning in fishing nets.

A massive body of evidence demonstrates that there is no question that pesticides are a substantial threat to species protected under the Endangered Species Act. Perhaps most compelling are the biological opinions the Services wrote for chlorpyrifos, malathion and diazinon, which found that use of just these three pesticides, three of 1100 that the EPA has registered for use, jeopardize the continued existence of dozens, or perhaps even hundreds, of listed species.³⁵ For these critically imperiled species, and all the others that are likely jeopardized by other pesticides, time is of the essence and urgent action is needed to prevent pesticides from driving them extinct.

CONCLUSION

Decades of factual evidence conclusively show the overwhelming harm that pesticides inflict on endangered species. And it is equally clear that the Environmental Protection Agency is derelict in its duties to abide by the Endangered Species Act and protect our nation's most imperiled wildlife and plants from the harm that is caused by pesticides. We therefore request the following regulations be promulgated by the Services to proactively restrict the use of pesticides within critical habitat — the areas of land and water that are essential to the recovery of endangered species — before it is too late.

III. PROPOSED REGULATORY LANGUAGE FOR SPECIES UNDER FISH AND WILDLIFE JURISDICTION

Insert as follows:

* * * * *

50 C.F.R. § 17.200 Restrictions on Pesticide Use

17.201 Definitions — For the purposes of this section

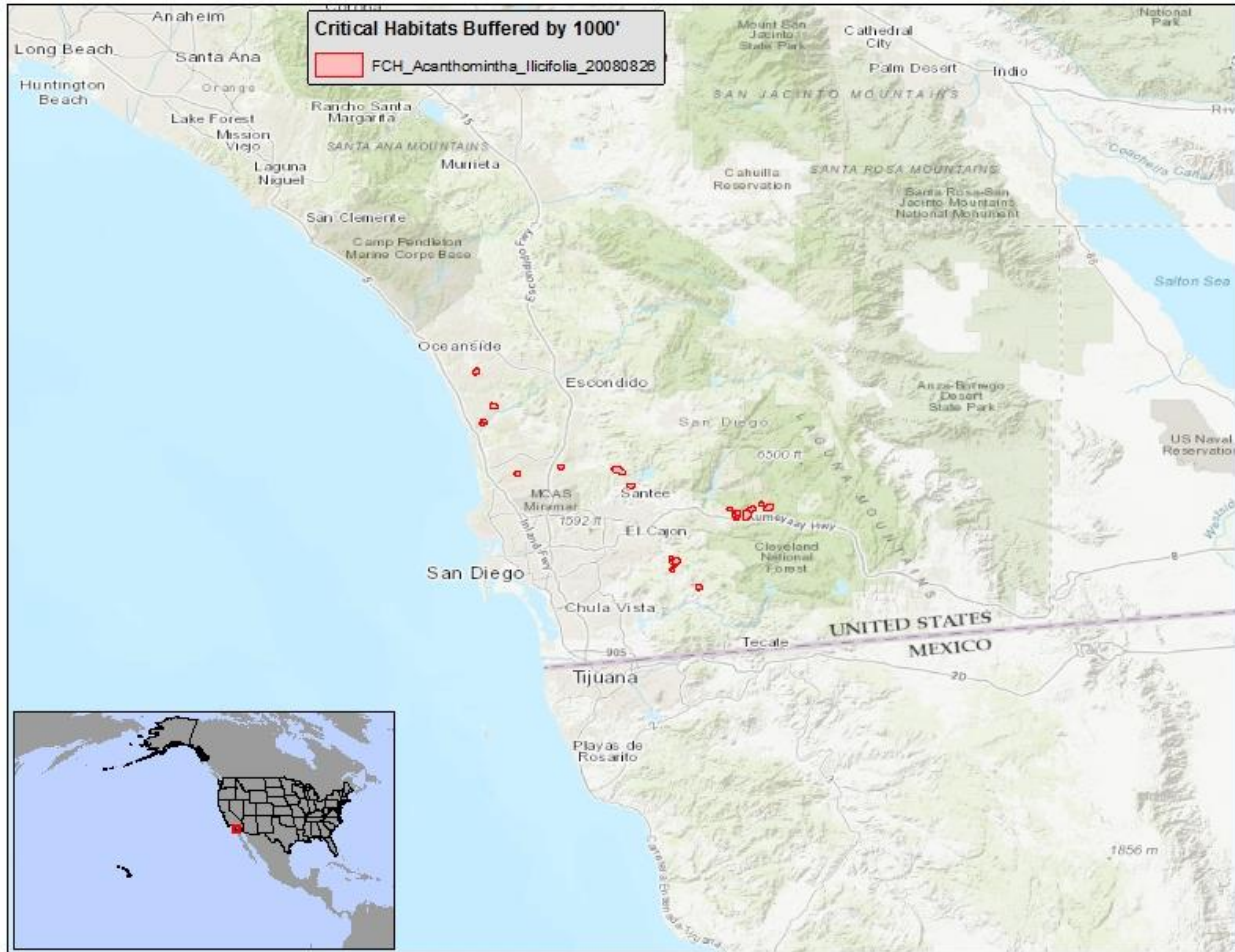
- (a) The term “critical habitat” is defined as provided in the Endangered Species Act at 16 U.S.C. §1532(5). Critical habitat does not include human structures or other parts of the human built environment to the extent that such features are already excluded from critical habitat designations for wildlife and plants by existing regulations.
- (b) The term “person” means an individual, corporation, partnership, trust, association, or any other private entity; or any officer, employee, agent, department, or instrumentality of the Federal Government, of any State, municipality, or political subdivision of a State, or any other entity subject to the jurisdiction of the United States.
- (c) The term “pesticide” is defined as provided in the Federal Insecticide Fungicide and Rodenticide Act at 7 U.S.C. § 136(u) and includes (1) all pesticides and pesticide products registered by the U.S. Environmental Protections Agency and (2) all pesticides and pesticide products which are not registered but otherwise authorized for use by a federal or state agency.

17.202 Restriction on Use of Pesticides

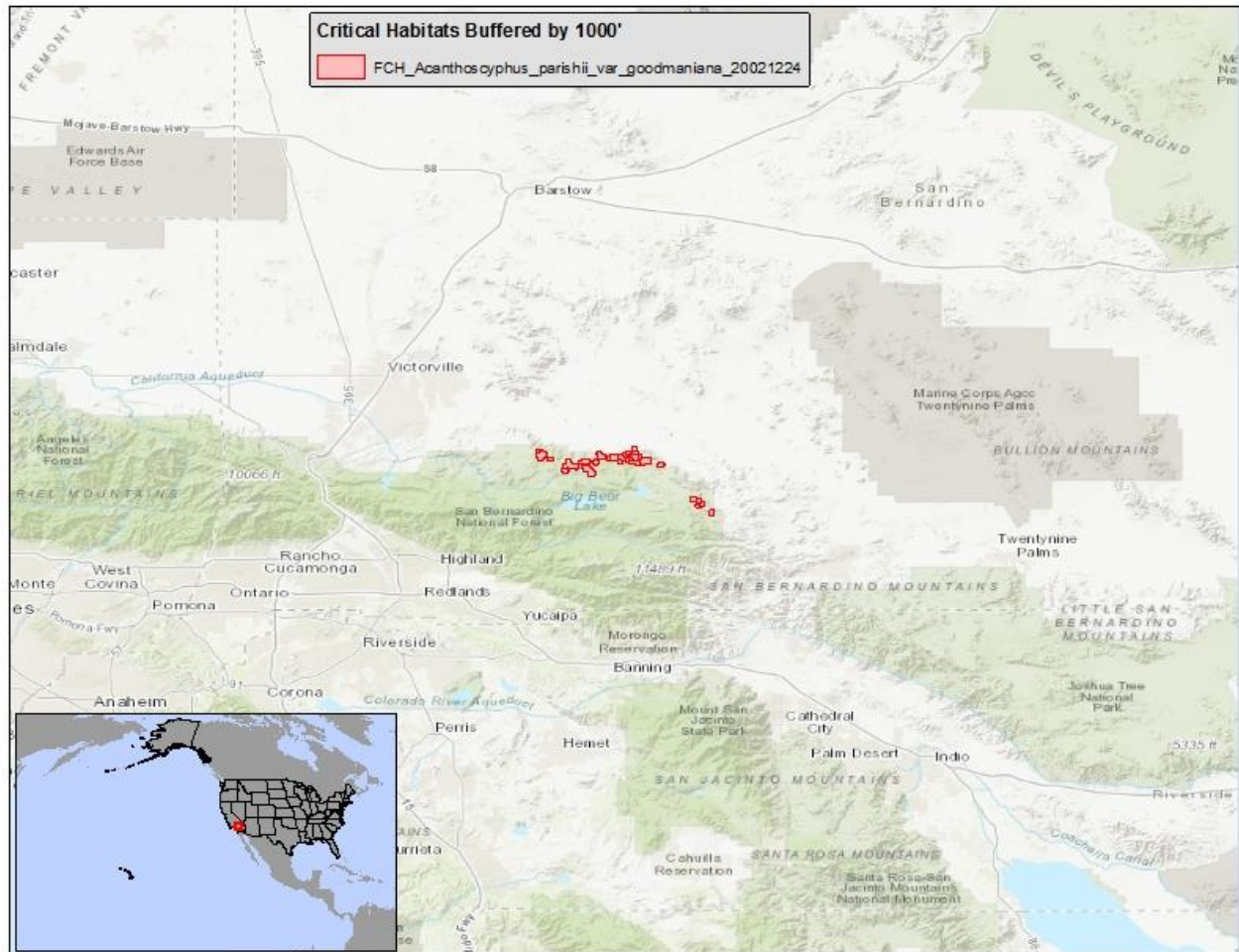
- (a) The use of pesticides by any person within any designated critical habitat or within 1000 feet of any designated critical habitat unit or area, or, is prohibited unless otherwise noted in part 17.203(a)-(zzzzzzzzzzzzzzzz). Refer to the Environmental Conservation Information Service for detailed information regarding critical habitat, the physical and biological features that are essential to the conservation of such species, and detailed high resolution maps and explanatory text setting forth areas where pesticide use is prohibited at <http://ecos.fws.gov>.
- (b) Notwithstanding paragraph (a), a pesticide may be used (1) in accordance with any Reasonable and Prudent Measures and Reasonable and Prudent Alternatives set forth in a completed Section 7 consultation or (2) in accordance with the Incidental Take Permit of a completed Section 10 Habitat Conservation Plan.
- (c) Notwithstanding paragraph (a), the use of a pesticide for an approved site-specific management action that is necessary to achieve a recovery objective for a threatened and endangered species is permitted.
- (d) Notwithstanding paragraph (a), the limited use of a pesticide to address a human health emergency or to protect human safety is permitted if the use of the pesticide is reported to the U.S. Fish and Wildlife Service within 48 hours of its application.

17.203 Species-specific Restrictions on Use of Pesticides

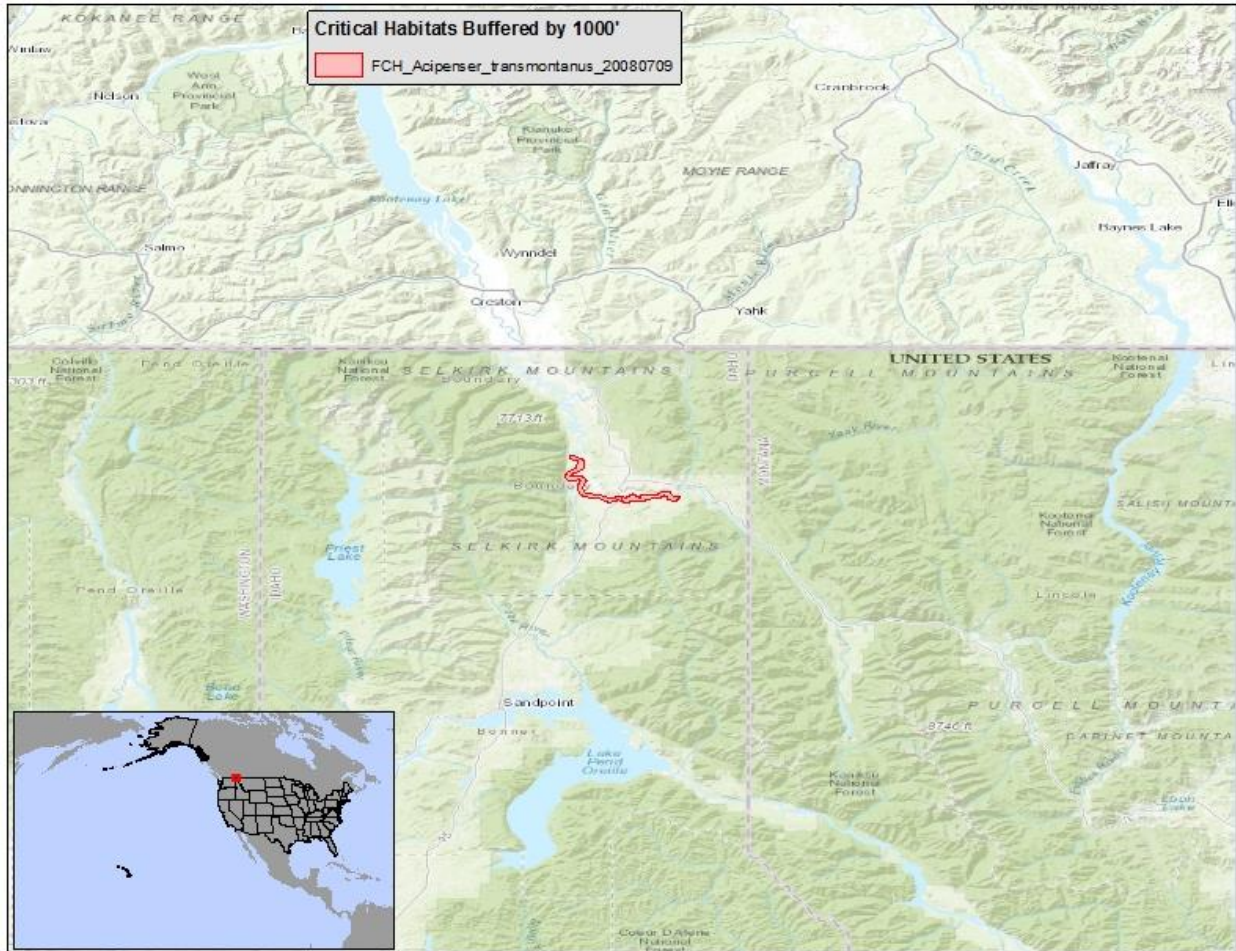
- (a) San Diego Thornmint (*Acanthomintha ilicifolia*) — It is unlawful for any person to use or apply a pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of critical habitat for the San Diego Thornmint.



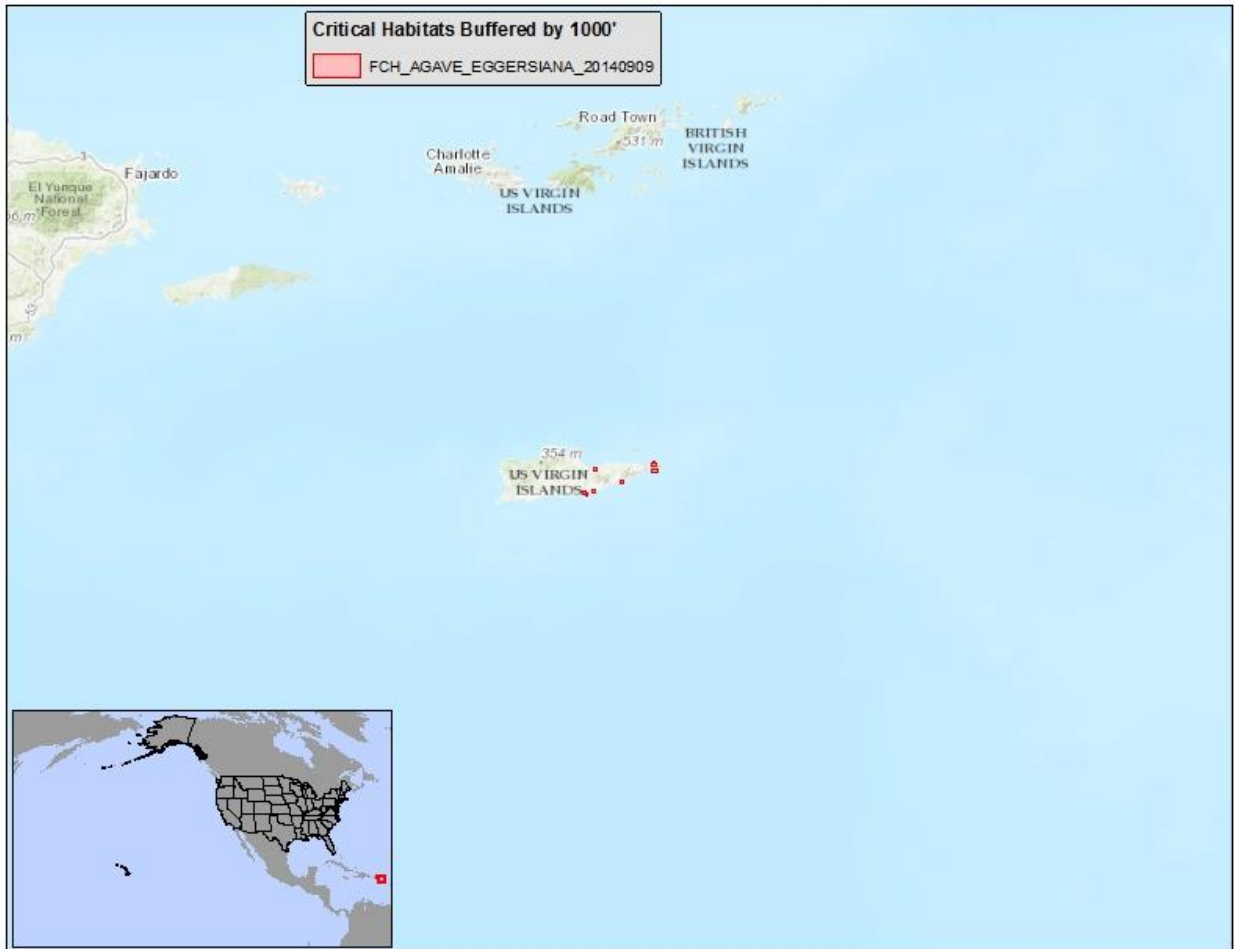
(b) *Oxythea* Cushenbury (*Acanthoscyphus parishii* Var *Goodmaniana*) — It is unlawful for any person to use or apply a pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of designated critical habitat for the *Oxythea* Cushenbury.



(c) White Sturgeon (*Acipenser transmontanus*)— It is unlawful for any person to use or apply any pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of designated White Sturgeon critical habitat.



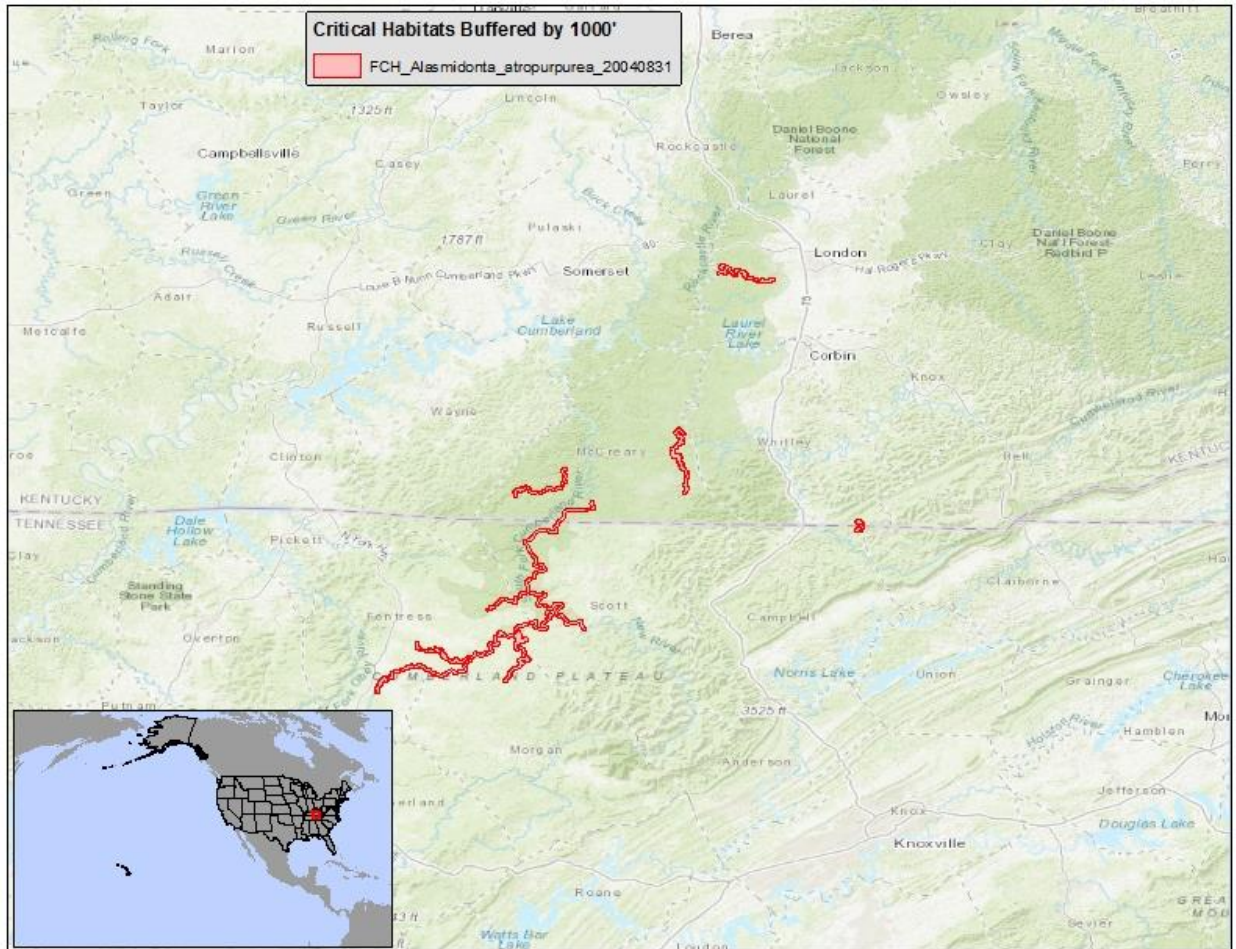
(d) *Agave eggersiana*— It is unlawful for any person to use or apply any pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of designated *Agave eggersiana* critical habitat.



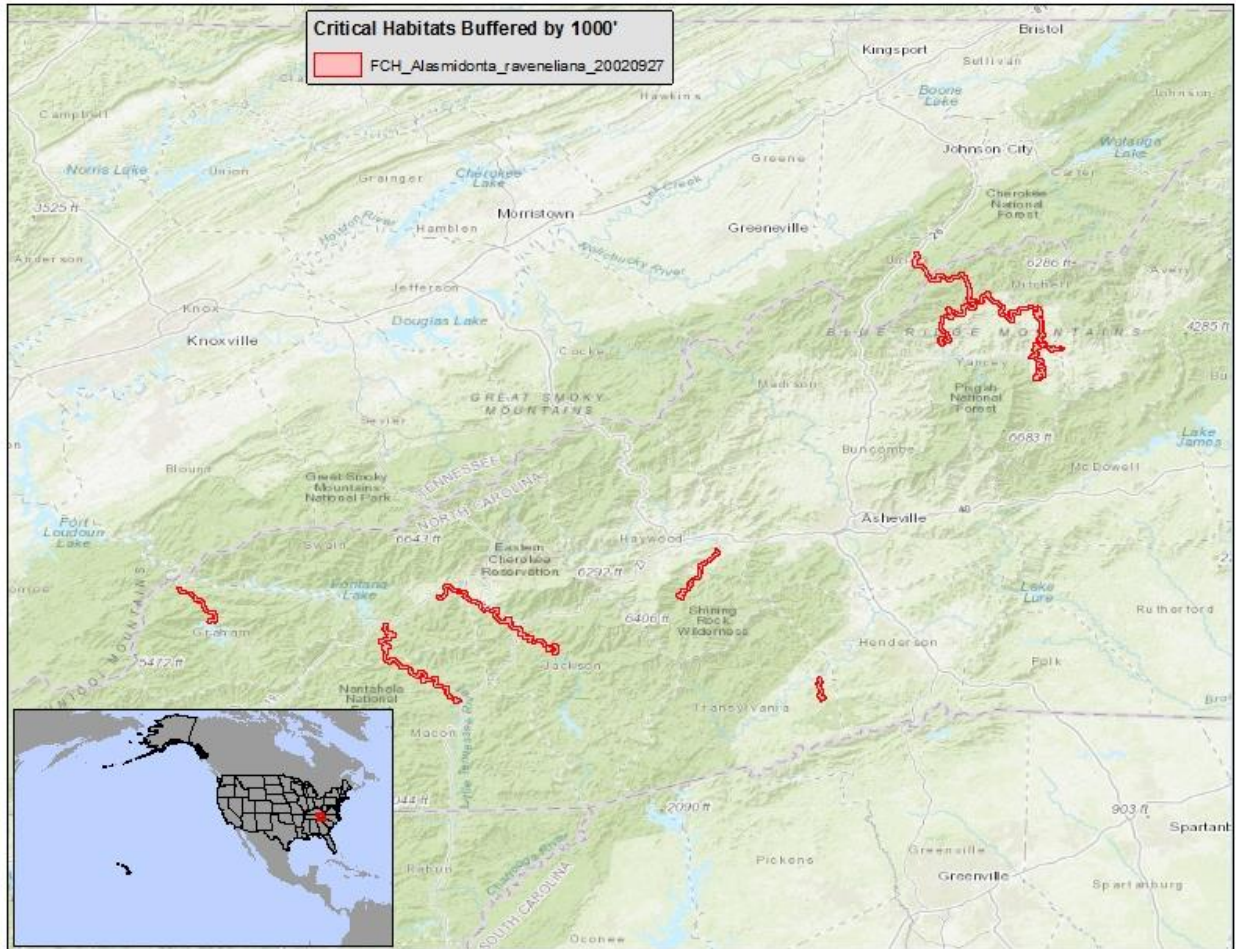
(e) Yellow-shouldered Blackbird (*Agelaius xanthomus*)— It is unlawful for any person to use or apply any pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of designated Yellow-shouldered Blackbird critical habitat.



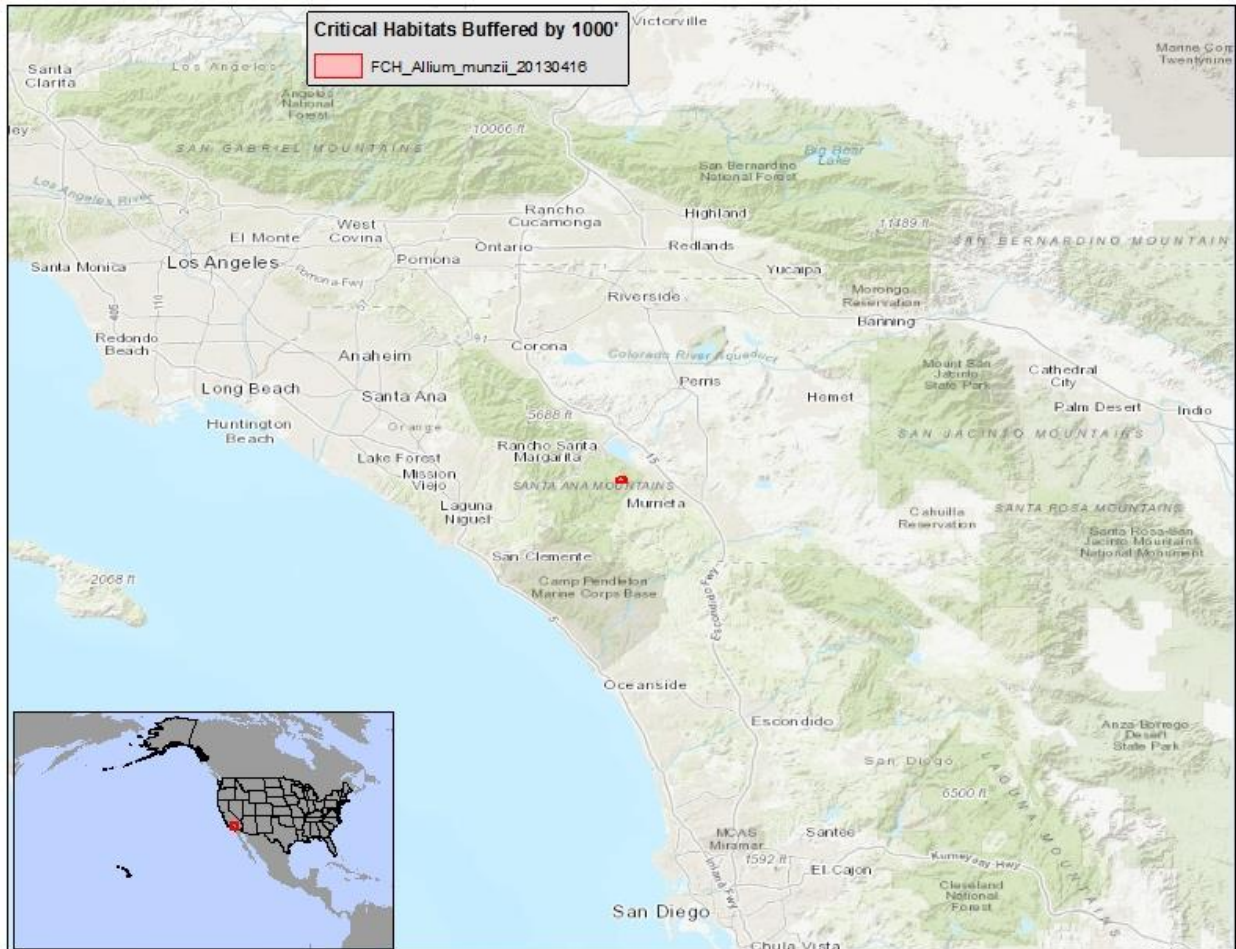

224.107 Definitions — For the purposes of this section:

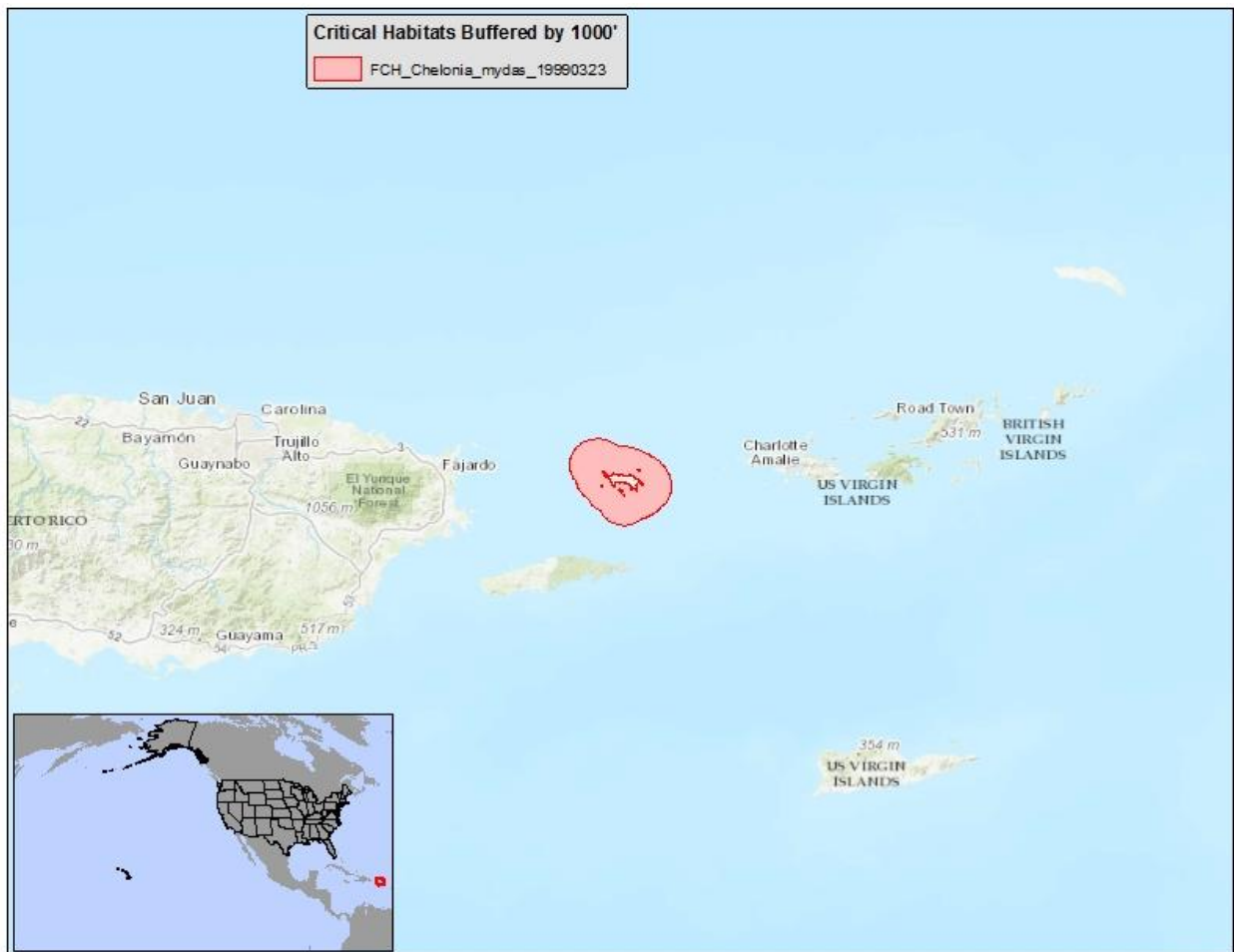
- (a) The term “critical habitat” is defined as provided in the Endangered Species Act at 16 U.S.C. §1532(5).
- (b) The term “person” means an individual, corporation, partnership, trust, association, or any other private entity; or any officer, employee, agent, department, or instrumentality of the Federal Government, of any State, municipality, or political subdivision of a State, or any other entity subject to the jurisdiction of the United States.
- (c) The term “pesticide” is defined as provided in the Federal Insecticide Fungicide and Rodenticide Act at 7 U.S.C. § 136(u) and includes (1) all pesticides and pesticide products registered by the U.S. Environmental Protection Agency and (2) all pesticides and pesticide products which are not registered but otherwise authorized for use by a federal or state agency.

224.108 Prohibition on Use of Pesticides

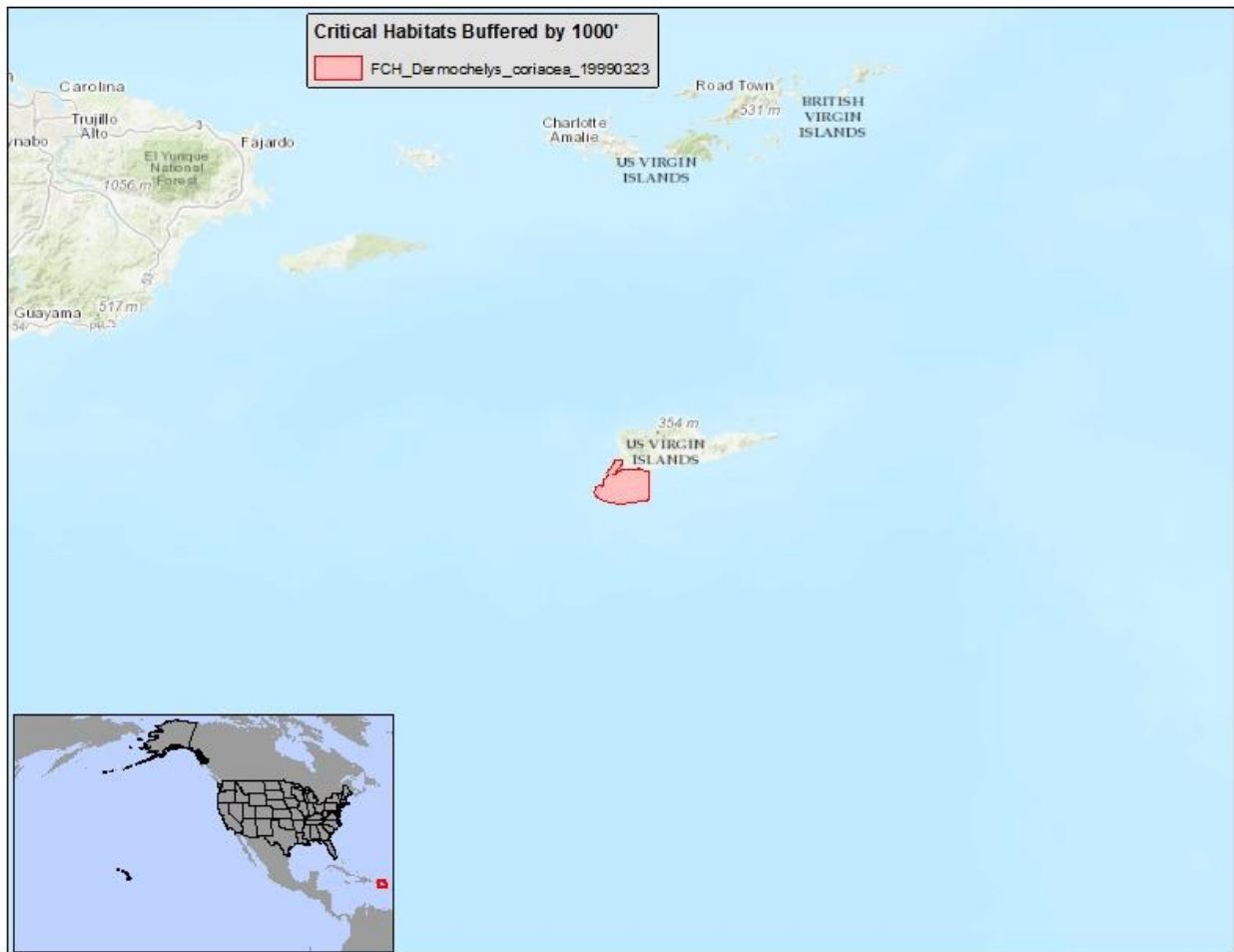
- (a) The use of pesticides by any person within 1000 feet of any designated critical habitat unit or area, or within any designated critical habitat unit or area, is prohibited unless otherwise noted in part 224.108(a)-(ZZ). - (b) Notwithstanding paragraph (a), a pesticide may be used (1) in accordance with any Reasonable and Prudent Measures and Reasonable and Prudent Alternatives set forth in a completed Section 7 consultation or (2) in accordance with the Incidental Take Permit of a completed Section 10 Habitat Conservation Plan
- (c) Notwithstanding paragraph (a), the use of a pesticide for an approved site-specific management action that is necessary to achieve a recovery objective for a threatened and endangered species is permitted.
- (d) Notwithstanding paragraph (a), the limited use of a pesticide to address a human health emergency or to protect human safety is permitted if the use of the pesticide is reported to the U.S. Fish and Wildlife Service within 48 hours of its application.

(cccccccccccc) Staghorn Coral (*Acropora cervicornis*)— It is unlawful for any person to use or apply any pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of designated Staghorn Coral critical habitat.



(dddddddddddddd) Elkhorn Coral (*Acropora palmata*)— It is unlawful for any person to use or apply any pesticide in a manner inconsistent with 50 C.F.R. 17.202 within 1000 feet of designated Elkhorn Coral critical habitat.
