# 4. DISCUSSION

The Southern Mail Wynberg Family Festival is a significant three-day community celebration that take over Maynardville Park each February and/or March. This annual event offers a diverse blend of gourmet food, fashion, a lively beer garden, amusement park rides, and top-notch local entertainment, making it one of the largest and most anticipated family gatherings in the Mother City.

Formerly known as the Community Chest Carnival, this festival has a rich history and has transformed from its original identity as a theatrical garden party into a vibrant carnival of food, local entertainment, and family fun. Over three days, festival-goers can expect continuous family-oriented entertainment with DJs, local artists, and entertainers taking center stage. With more than 100 stalls to explore, offering the finest in gourmet and street food, fashion, crafts, gadgets, and local exhibitors, there's something for everyone.

In 2023, over 17 000 people attended the event over the three days.

One of the festival's notable strengths lies in its role as an economic driver for local communities. It's more than just fun; it's a powerful means of empowerment. The return of the Wynberg Family Festival is not only exciting but also crucial for the support it provides to local businesses. With the potential to create over 1,000 part-time jobs, this event becomes a vital platform that showcases local businesses and their products, generating income for numerous families across Cape Town.

Beyond being a family-friendly event, it actively promotes community development and gives local businesses an opportunity to gain exposure within their own communities. As part of the festival's corporate social investment initiative, it sponsors and hosts Heinz Park Primary School's annual prom, serving as an incentive to keep learners engaged in their education.

The Special Events Committee (SPEV 24/10/23) has lent its support to this event for a three-year period. Consequently, this report seeks approval from the Council to establish a three-year agreement for the 2023/24, 2024/25, and 2025/26 financial years with the Cycle of Life to host the Wynberg Family Festival. This agreement is slated to commence on March 1, 2024.

In summary, the Wynberg Family Festival stands as a testament to the City's commitment to community events and the bolstering of local businesses, making it an essential and highly anticipated addition to the city's annual calendar.
