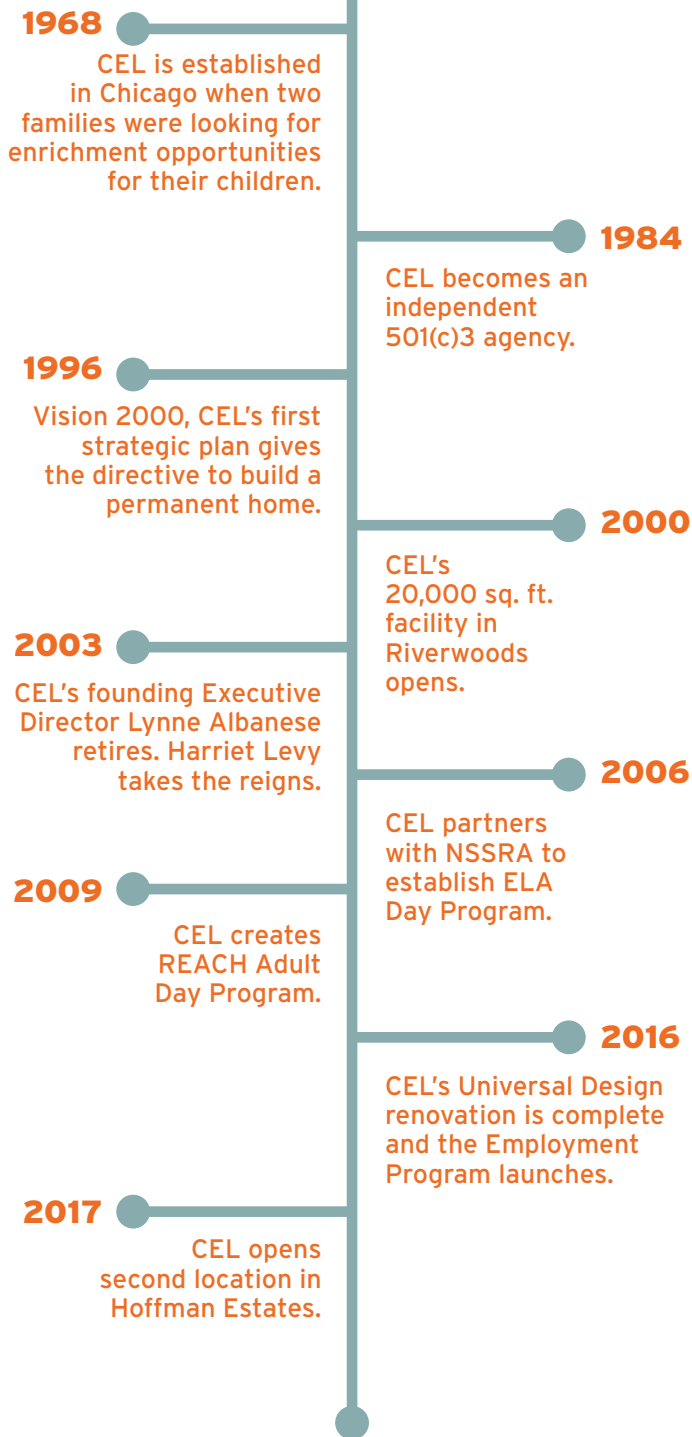

## When CEL opened its doors in 1968, there wasn't a lot of fanfare.

There was a young social worker who made certain that two children were accepted and successful in the Deborah Boys Club recreational program run by the Young Men's Jewish Council.

Word spread and a new social enrichment program on Sunday afternoons began - the Center for Enriched Living.

It hasn't always been easy. There were years when we didn't know if we would make it financially. The year we became an independent 501(c)3 we fought tooth and nail to stay solvent.

**Because of you, we survived, grew and built a beautiful building so that we have a permanent home.** A few years later, we renovated and retrofit that building with Universal Design, so that every person who enters, does so as equals.

**You have made 50 years of CEL possible. And you will keep us looking to what comes next.**

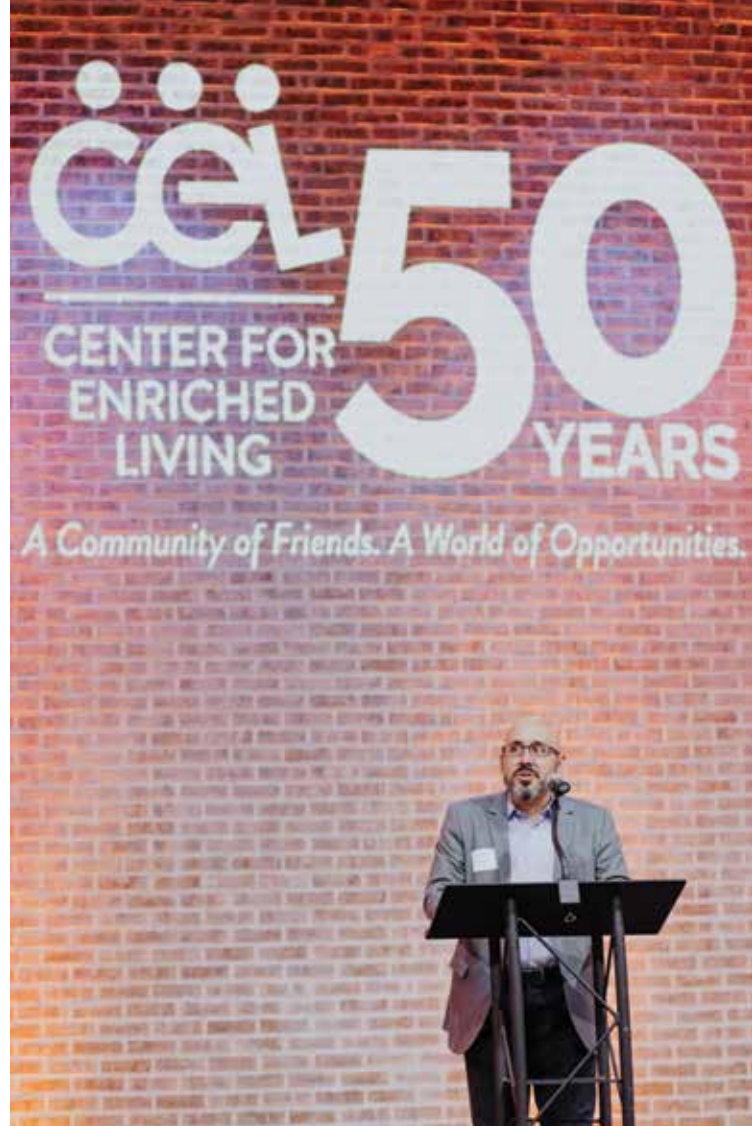

CEL programs include art, technology and fitness classes; summer camp; dances and even vacations. CEL also runs the REACH Adult Day Program to help members continue learning and growing after they exit the school system, and partners with NSSRA to run the ELA (Enriched Lifestyles for Adults) Day Program. CEL's Employment Program partners with local businesses to provide job opportunities and help reduce unemployment among adults with intellectual and developmental disabilities.

## **Social & Recreational Programs MEET MIKE**

**50 years ago, Mike was one of the first CEL members,** starting in the Sunday afternoon program in Albany Park. Today, Mike lives and works at Lambs Farm. As a member of the cleaning crew, Mike starts his day at 7:00 AM in the administration building, where he vacuums, empties waste baskets, cleans the public washrooms and then cleans the common areas of houses, doing 2 houses a day. However, when the weekend comes, you'll find Mike at CEL's Friday Night Program. He enjoys cooking and going to summer concerts with friends. "Mike wouldn't miss a Friday night at CEL for the world," says his mom, Fern.



## **REACH Adult Day Program MEET JOSH**

**When many young adults with developmental disabilities transition out of school at 22, their lives change drastically.** Many families liken it to falling off a cliff because there are so few options for people with intellectual and developmental disabilities. Josh transitioned out of high school as the site in Hoffman Estates was opening.

23-year-old Josh was there on Day 1 at CEL Northwest. A social butterfly, who loves to be in the community with friends, Josh found the REACH program got him out and about doing activities he loves. REACH connects members to community, friends and meaningful activities - which is just what Josh's family wanted for him. At REACH, Josh is part of the group and enjoys volunteering, continued learning, and exploring different places including the nature center, Auto Show and Sculpture Park!



## **Employment Program MEET TRICIA**

**Tricia has been coming to CEL for years.** She even met her husband Darin here. Last year when she was looking for a new job, she looked to CEL's Employment Team to help her. After a few short weeks, Tricia found a job that fits her needs perfectly - at her local Culver's! In February 2019, Tricia celebrated her one-year anniversary! Her manager at Culver's was so impressed with Tricia, and asked, "Do you have another Tricia we can hire?"

The unemployment rate for people with developmental disabilities is a staggering 85%. CEL's Employment Program exists so that any person with a developmental disability who wants to work can find a paid job in the community.



## WHAT A YEAR FOR LIZ

**Liz wanted to work, but she needed an employer who understood her needs and was willing to work with her. As the Center for Enriched Living was growing, our office needed a reliable Office Assistant to help with a variety of duties including answering the phones, greeting people and filing. With the launch of CEL's Employment Program, Liz was one of our first clients, and then, after interviewing, became CEL's Office Assistant.**

In her 2.5 years as CEL's Office Assistant, Liz has grown with the position and added more responsibilities. When we hired Katy, a morning receptionist, Liz trained both Katy and the Employment Specialist. Liz gave her first speech at a business Networking Group breakfast meeting. She was excited to share her story - and did so again at Chefs' Night, the Golf Outing, on the radio, TV, and in a video.

Liz loves her job. It has provided her with dignity and independence and the opportunity to blossom and grow.

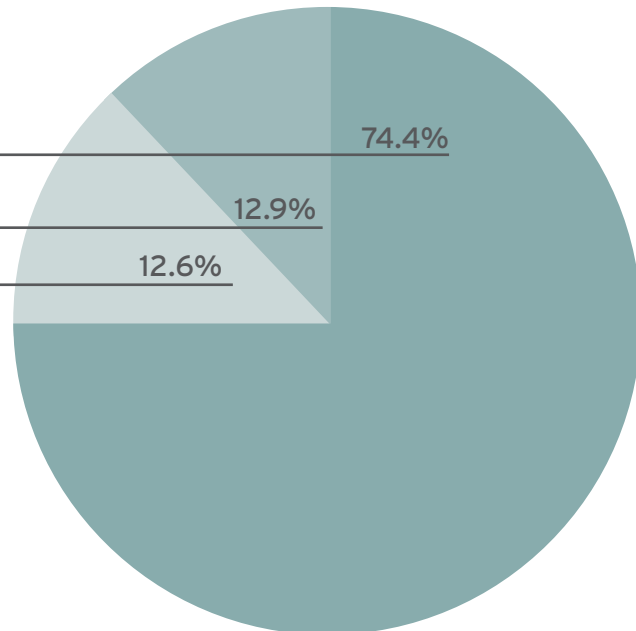
