This poem expresses so much in relation to what happens at The Center. Daily, I am inspired by the families and volunteers who come to The Center. The families, for their strength when they share their vulnerability, their dedication to coming for their children... or for themselves.

The volunteers - the "hearts with ears" - who give four plus hours a week to be with the families, listening, without judgment, with only love. Their gifts are many. I was reading that the equivalent rate of volunteer work is valued at \$18.04 per hour. If you take the number of hours volunteers give to support all aspects of The Center, it would equal over \$378,800 - and that figure is very conservative, for the value we receive from our volunteers is far greater than the national figure.

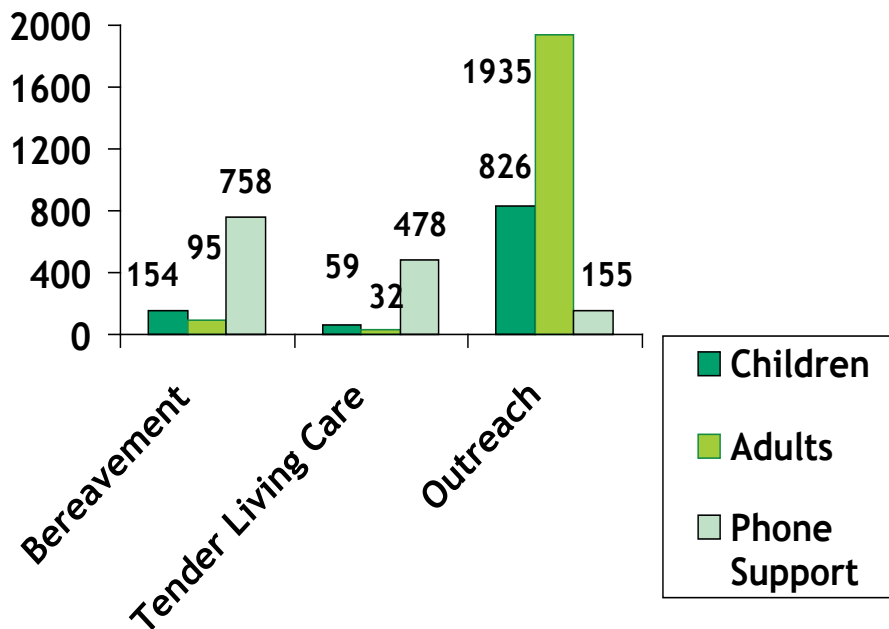

Longcreek Outreach Continues, Youth Give Back

At Longcreek Youth Development Center, eight young men gathered for a weekly session facilitated by two long-time Center volunteer facilitators. In these sessions, stories of loss filled the room, one young man sharing how his mother had died by suicide and his father was incarcerated and wouldn't be out for another 15 years.

The future seems bleak, but there is light - these sharing sessions help young people find hope, hope that they are not alone, that someone will listen to their story, when they thought all had stopped listening long ago.

In another group, eight young women, also shared their stories with facilitators. This work continues, in recognition that all children who grieve need to be heard. And in hearing each other's stories, they begin to relate to others in a way they hadn't before.

There will be no magic cure, no instant healing. But, over time, there will be light in young lives that had all but lost hope.

In fall 2005, one of the participants who was released from Longcreek brought a gift to The Center - a rocking chair

that the young men had painted a beautiful, sunny yellow. With sunflowers and a bright floral cushion, it was the perfect addition to an adult group room, where parents share their grief journey with others, while their children are in their own groups.

A successful art auction was held by the Longcreek youth, and the proceeds were given to The Center in addition to the rocking chair.

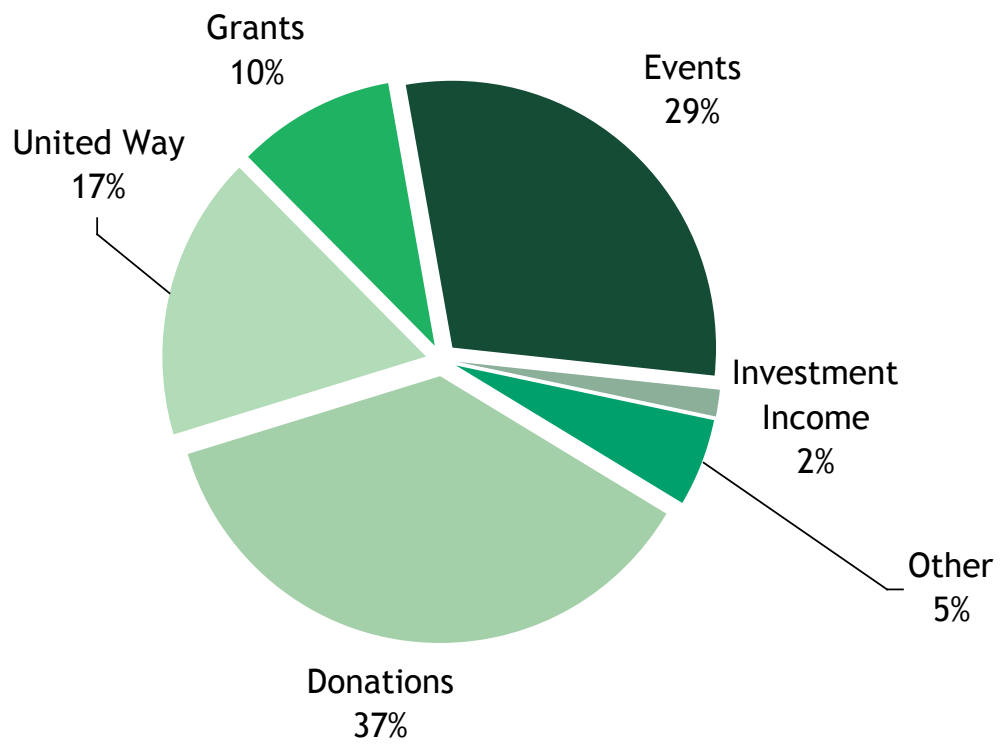
Groups continue as part of our Community Outreach and provide an important outlet for the young men and women who are incarcerated.

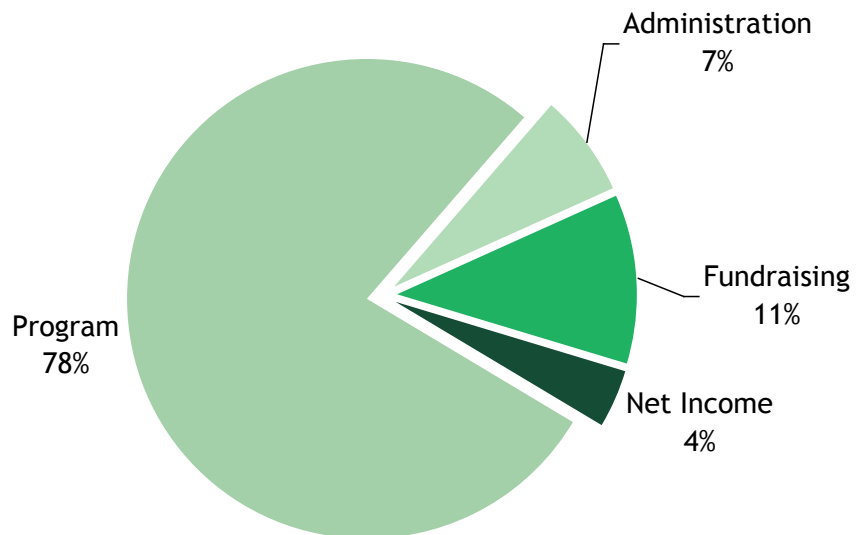
How We Are Funded

Ratio of expenses to income 2004 / 2005:

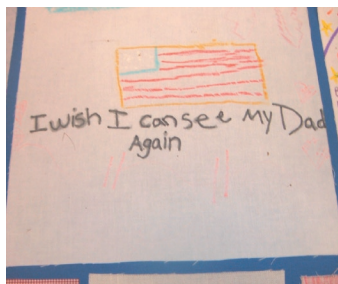

Children's Expressions of Hope Artwork Debuts at USM Glickman Library

In March 2005, The Center was proud to be a part of *Journeys of Hope - Art from Grieving Children around the World*. This collaborative art show featured art work by children of The Center for Grieving Children, Art Exchange for JustPeace, Advocates for Afghanistan, America's Camp, and was hosted by Dr. Paul Johnson and the School of Social Work at the University of Southern Maine. Over 100 pieces, including a quilt made by families who lost a loved one in the tragedies of 9/11 were displayed. Of this project, Dr. Bruce St. Thomas, Ph.D., A.T.R. and consultant to The Center writes:



"We observe the deeper sensibility and wisdom that children have in their ability to move beyond the confines of their own oppression and conflict. In this exhibit children's imaginative ability to move beyond the rational confines and understanding of their losses that they have experienced will transport the viewer into the multiple realms of where healing takes place."

Center Volunteers Return to America's Camp for the 4th Year.

Fifteen volunteers and staff attended *America's Camp*, for surviving children of 9/11. In 2002, The Center was asked to train camp counselors as the then *Twin Towers Fund* sponsored a weeklong camp experience free of charge to children of firefighters and other emergency personnel who died in the line of duty. Staff member Carol Sylvester shares two stories:

"(I remember) the five sons of the firefighter and police heroes that wanted to go into the volcano room together. I imagine they wanted to reenact what they had always done in groups of 2... to have the tower of mattresses collapse as they work frantically to save each other as they used the noodles to keep their air supply. These are 5 boys that have been there for the 4 years, proudly sharing many stories of what their dads had done over the years... and what they did the day they died..."

Three weather balloons ascended into the skies as they carried the children's letters to the heavens. The children had so much to say... and their letters were so important, and the balloons HAD to lift off and be carried away... and the clouds parted, and the sun shone and made way for the children's messages."
